ON APRIL 2, 1976, A CONFIDENTIAL SOURCE ABROAD WHO IS AN
OFFICIAL OF THE FEDERAL POLICE OF ARGENTINA (FPA) DEPARTMENT
OF FEDERAL SECURITY (INTELLIGENCE DIVISION), PROVIDED THE
FOLLOWING INFORMATION: ~~(S)~~ (U)

DURING THE WEEK OF MARCH 29, 1976, THE FPA DEPARTMENT OF
FEDERAL SECURITY RECEIVED INFORMATION FROM AN ARGENTINE CITIZEN
WHO WAS THE OWNER OF A SUBURBAN FARM LOCATED IN MORENO, BUENOS
AIRES PROVINCE, WHICH HAD BEEN RENTED TO A YOUNG MARRIED COUPLE,
INDICATING THAT SUSPICIOUS ACTIVITIES WERE TAKING PLACE AT THIS
FARM; SPECIFICALLY, THAT A LARGE NUMBER OF INDIVIDUALS HAD BEEN
ASSEMBLING AT THAT LOCATION. THE FPA DEPARTMENT OF FEDERAL
SECURITY DISPATCHED THREE FPA OFFICERS TO INVESTIGATE THE REPORT ~~(S)~~ (U)

IN MORENO. FPA FEDERAL SECURITY OFFICERS CONTACTED THE LOCAL
PRECINCT OF THE BUENOS AIRES PROVINCIAL POLICE (BAPP) IN WHOSE
JURISDICTION THE FARM IN MORENO FELL, TO ANNOUNCE THEIR IDENTITY
AND REQUEST BAPP ASSISTANCE IN CARRYING OUT INVESTIGATION. THE
BAPP PROVIDED EIGHT OFFICERS WHO ACCOMPANIED THE FPA FEDERAL
SECURITY OFFICIALS TO THE FARM IN QUESTION. ~~(S)~~ (U)

THE FPA FEDERAL SECURITY OFFICIALS, BAPP OFFICERS APPROACHED
THE FARM DIRECTLY AND WERE GREETED BY A HAIL OF BULLETS FROM A
LARGE NUMBER OF AUTOMATIC WEAPONS WHICH RESULTED IN A VIOLENT
SHOOTOUT. ~~(S)~~ (U)

FOURTEENS INDIVIDUALS IDENTIFIED AS MEMBERS OF THE PARTIDO
REVOLUCIONARIO DE TRABAJADORES-PARTIDO SOCIALISTA DE TRABAJADORES
(WORKERS REVOLUTIONARY PARTY-WORKERS SOCIALIST PARTY) (PRT-PST)
and THE PEOPLE'S REVOLUTIONARY ARMY (ERP), AN ARGENTINE TERRORIST
ORGANIZATION, WERE KILLED DURING THE SHOOTOUT. SUBSEQUENT
INVESTIGATION ESTABLISHED THAT THE FARM WAS BEING USED FOR A HIGH
LEVEL POLICY MEETING OF THE PRT/PST AND THE ERP WHICH WAS
~~XXXXXXXX~~ ATTENDED BY BETWEEN FIFTY AND SIXTY RANKING LEADERS OF ~~(S)~~ (U)

THESE ORGANIZATIONS, INCLUDING ERP LEADERS MARIO ROBERTO SANTUCHO AND DOMINGO MENA. BOTH SANTUCHO AND MENA MANAGED TO ESCAPE DURING THE SHCOTCUT. A LARGE VOLUME OF VALUABLE DOCUMENTS, INCLUDING TAPES, WERE SEIZED AT THE FARM AND ARE CURRENTLY BEING PROCESSED AND ANALYZED. (~~S~~) (U)

THE ARGENTINE ARMY, WHICH HAS THE PRIME RESPONSIBILITY FOR INVESTIGATING AND REPRESSING THE ERP, WAS HIGHLY CRITICAL OF THE FPA AND RAPPE OPEN APPROACH TO THE FARM WHICH PRECIPITATED THE SHCOUTOUT AND ALLOWED SANTUCHO, MENA AND OTHER RANKING PRT/PST AND ERP OFFICIALS TO ESCAPE. (~~S~~) (U)
