ARGENTINE TERRORIST ACTIVITIES; FPM-ARGENTINA.

ON MAY 8, 1978, A CONFIDENTIAL SOURCE WHO HAS FURNISHED RELIABLE INFORMATION IN THE PAST REPORTED THAT INFORMATION HAS BEEN RECEIVED THAT SIX GROUPS OF SPECIALLY TRAINED TERRORISTS WILL TRAVEL TO ARGENTINA PRIOR TO THE COMMENCEMENT OF THE JUNE, 1978 WORLD CUP SOCCER MATCH IN ORDER TO CARRY OUT ACTS OF TERRORISM. THE SOURCE REPORTED THAT THE SIX TERRORIST GROUPS WERE COMPOSED OF SEVERAL HIGHLY TRAINED INDIVIDUALS AND THAT THEY HAD RECEIVED TRAINING IN EUROPE. SOURCE REPORTED THAT IT WAS BELIEVED THAT TWO OF THE GROUPS HAD ALREADY CLANDESTINELY ENTERED ARGENTINA. (S) (U)

DIVISION,] PROVIDED THE FOLLOWING INFORMATION: (S) (U)

DURING THE EVENING OF NOVEMBER 13, 1976, TERRORISTS
MACHINE GUNNED AND SET OFF INCENDIARY BOMBS AT THE RESIDENCE
OF JAIME VALDEZ, PRESS ATTACHE OF THE CHILEAN EMBASSY IN BUENOS
AIRES. MODERATE DAMAGE WAS DONE TO THE VALDEZ RESIDENCE
WHICH IS LOCATED IN SAN ISIDRO, BUENOS AIRES PROVINCE.
VALDEZ' AUTOMOBILE, WHICH WAS PARKED OUTSIDE THE RESIDENCE,
WAS SEVERELY DAMAGED. VALDEZ WAS NOT AT HOME WHEN THE ATTACK
TOOK PLACE INASMUCH AS HE WAS ACCOMPANYING ARGENTINE PRESIDENT
RAFAEL JORGE VIDELA ON A STATE VISIT TO CHILE.

AS OF NOVEMBER 14, 1976, NO TERRORIST ORGANIZATION HAD
CLAIMED CREDIT FOR THE BOMBING.

On 10/20/76, a source, who is connected with one of the Argentine intelligence services, provided the following information: ~~(U)~~

On 10/18/76, elements of the Argentine Army Intelligence Service (SIE) operating with members of the Buenos Aires Provincial Police Intelligence Service, discovered and successfully raided a location in Buenos Aires Province, that housed the intelligence records of the ERP. ~~(U)~~

Voluminous documents and files were seized as a result of the raid. The ERP had gathered information concerning over 1700 Argentine Army officers, which included name, rank, residence and assignment. Much of the information regarding the aforementioned Argentine Army officers was several years out of date. In addition, documents were discovered indicating that the ERP had gathered information against personnel of various embassies in Argentina including the United States, Great Britain, Australia, Canada, France and Sweden. ~~(U)~~

Information concerning the U. S. Embassy related to JOSEPH DODSON, the former Agricultural Attache, General RICHARD ALLEN, the former Milgrp Commander, and Captain RAYMOND FORD, the former Naval Attache. All of these individuals departed post several years ago. Also included in the ERP material was a report setting forth the results of a casing operation against the residence of an unidentified U. S. Embassy individual, who held the rank of First Secretary and resided at Calle Dr. Guillermo Rawson 3271, La Lucila. This individual apparently had a son, who was missing his left arm as a result of a birth defect. The identity of this individual cannot be immediately established through available Embassy records. ~~(U)~~

The source made available photostatic copy of material taken from the ERP intelligence files relating to the aforementioned U. S. Embassy personnel. This photostatic copy will be retained in my office for future reference. The material as contained in the ERP intelligence file is set forth on the attached sheet. ~~(U)~~

Members of the family a) Head of the family (First Secretary of the Embassy): approximately 1.75 meters in height, race, white, short hair (American style), greying, 45 to 50 years of age, athletic build, wears glasses all the time. b) Wife: Typical "Gringa", approximately 1.75 meters in height, blonde, race, white, shoulder-length hair, 45 to 50 years of age. Oldest daughter, approximately 1.75 meters in height, race, white, shoulder-length reddish hair, dyed, thin, 20 to 22 years of age. Youngest daughter, approximately 1.65 meters, long, blonde hair, down to the middle of her back, about 16 to 18 years of age, weighing approximately 6 kilos. Youngest son, blond, 1.10 meters in height, 7 years of age, , missing left arm due to congenital defect. Automobiles: 69 Impala, green diplomatic plates. Guards: No special guards observed neither inside nor outside the house in the daytime nor at night. The only guard service observed has been a patrol car cruising every 15 to 20 minutes, green automobile, Chevrolet Cross Country being driven by two civilians who observe the residence from south to north and vice versa stopping and observing the interior of the residence each time they go by.

Reference my memo 9/3/76, which reported on the abduction and assassination of JESUS CEJAS ARIAS and CRESENCIO GALANENA HERNANDEZ, two employees of the Cuban Embassy in Buenos Aires, by Argentine security forces during August, 1976.

On 9/18/76, a source, who is connected with one of the Argentine intelligence services, provided the following information: ~~(S)~~ (U)

After CEJAS and GALANENA had been assassinated, their bodies were cemented into one large storage drum and thrown into the Rio Lujan near Puente Colorado in San Fernando, Buenos Aires Province. The location where the two bodies were dumped had been used in the past to dispose of other bodies by the State Secretariat for Information (SIDE). The bodies of CEJAS and GALANENA were recovered on or about 10/14/76 by members of the San Fernando Volunteer Fire Department and frog men from the National Maritime Prefectura. Because CEJAS and GALANENA had been immersed in water for such a considerable period of time facilitating rapid decomposition, it is doubtful that they will be identified. At the time CEJAS and GALANENA were recovered, several other bodies, apparent victims of SIDE operations, were also recovered from the Rio Lujan at the same approximate location. ~~(S)~~ (U)

CONNECTIONS OF ROCA, MACEDA AND PUIGGROS, ACCORDING TO SECRET RECORDS OF THE AAIS. (S) (U)

ROCA IS AN ATTORNEY FROM CORDOBA, ARGENTINA. HE IS A CLOSE ASSOCIATE OF MACEDA. IN 1949 ROCA WAS A MEMBER OF THE BOARD OF DIRECTORS OF THE POPULAR MOVEMENT FOR PEACE, A COMMUNIST PARTY OF ARGENTINA (CPA) FRONT. LATER IN 1949 ROCA WAS ELECTED AS A VOTING MEMBER OF THE POPULAR MOVEMENT FOR PEACE AND TOOK PART IN AN INTERNATIONAL CONGRESS OF THIS GROUP IN FRANCE IN 1955. HE WAS CONSIDERED TO BE A LEADER OF THE COMMUNIST PARTY OF ARGENTINA IN CORDOBA PROVINCE.
