DURING THE MORNING OF DECEMBER 18. 1975. THE ARGENTINE AIR FORCE CLOSED JORGE NEWBERRY DOWNTOWN METROPOLITAN AIRPORT IN BUENOS AIRES FOR UNEXPLAINED REASONS. SUBSEQUENTLY IT WAS REVEALED THAT JUNIOR MIDDLE GRADE OFFICERS OF THE ARGENTINE AIR FORCE WERE IN REBELLION AND HAD PLACED THE AIR FORCE COMMANDER IN CHIEF UNDER HOUSE ARREST. THERE ARE TWO CONFLICTING VERSIONS REGARDING THE PURPOSE OF THE AIR FORCE REVOLT. ONE IS THAT THE AIR FORCE JUNIOR OFFICERS HAVE INITIATED THE BEGINNING OF A COUP D'ETAT AND WILL BE JOINED BY THE ARGENTINE NAVY AND ARMY IN ORDER TO OVERTHROW THE INCUMBENT PERONIST GOVERNMENT. THE SECOND VERSION AND PROBABLY THE MOST PLAUSIBLE IS THAT JUNIOR AIR FORCE OFFICERS WERE EXTREMELY DISPLEASED OVER WHAT THEY CONSIDERED TO BE POLITICAL MANEUVERING IN THE RECENTLY PUBLISHED AIR FORCE PROMOTION AND REASSIGNMENT SCHEDULE.
