BOMB MADE UP OF APPROXIMATELY FOUR KILOS OF TNT, WAS DETONATED BY AN AUTOMATIC TIMING DEVICE NEAR A RECREATION ROOM IN THE "CIRCULO MILITAR" (MILITARY CIRCLE), AN EXCLUSIVE CLUB FOR ARGENTINE ARMED FORCES OFFICERS IN DOWN TOWN BUENOS AIRES. AT THE TIME OF THE DETONATION, APPROXIMATELY 114 PERSONS, INCLUDING MILITARY OFFICERS AND THEIR FAMILIES, WERE VIEWING A FILM. FORTY-NINE INDIVIDUALS WERE INJURED AS A RESULT OF THE BOMBING, 19 BEING HOSPITALIZED. AMONG THE INJURED, WERE MANY WOMEN AND CHILDREN. TWO WOMEN LOST THEIR SIGHT DUE TO EXTENSIVE INJURIES RECEIVED. SHORTLY AFTER THE DETONATION, THE MONTONERO GUERRILLA ORGANIZATION TOOK CREDIT FOR THE BOMBING.

DURING THE LATE EVENING HOURS OF OCTOBER 17, 1976, NUMEROUS BOMB ATTACKS WERE CARRIED OUT THROUGHOUT THE CITY OF BUENOS AIRES BY UNIDENTIFIED TERRORISTS. THE PRINCIPAL TARGETS OF THESE BOMB ATTACKS WERE PARKED AUTOMOBILES AND BUSES, INCLUDING A COLOR TELEVISION TRANSMISSION TRUCK. A VEHICLE BELONGING TO THE U. S. ~~(S)~~ (U)

DURING THE EVENING OF OCTOBER 7-8, 1976, IN COMMEMORATION OF THE CAPTURE AND DEATH OF ARGENTINE-BORN CUBAN GUERRILLA LEADER, ERNESTO CHE GUEVARA, ARGENTINE TERRORISTS CARRIED OUT A SERIES OF BOMBINGS IN THE FEDERAL CAPITAL OF BUENOS AIRES, PRIMARILY AGAINST THE SHOWROOMS OF FOREIGN CONTROLLED AUTOMOBILE COMPANIES. ONE OF THE SHOWROOMS OF THE FORD MOTOR COMPANY WAS BOMBED, AS WELL AS A BRANCH OF THE BANK OF BOSTON.

THERE WERE NO ~~XXXXXX~~ PHYSICAL INJURIES AS A RESULT OF THE BOMBINGS AND PROPERTY DAMAGE WAS GENERALLY REPORTED AS MODERATE.

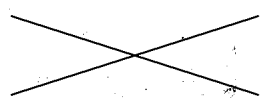

AT APPROXIMATELY 10:00 A.M., OCTOBER 4, 1976, A SUSPICIOUS VEHICLE WAS OBSERVED NEAR A PUBLIC PLAZA IN FRONT OF THE SHERATON HOTEL IN BUENOS AIRES, ARGENTINA. THE FPA BOMB SQUAD WAS CALLED AND ASCERTAINED THAT THE VEHICLE CONTAINED FIVE ARMED ROCKETS WHICH WERE AIMED AT THE SHERATON HOTEL AND WERE TO BE FIRED BY A TIMING DEVICE. THE ROCKETS WERE DEACTIVATED BY THE FPA BOMB SQUAD BEFORE THEY COULD BE FIRED. ~~(S)~~ (U)

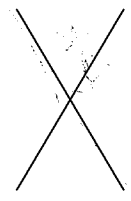

On 7/15/76, an official of the Federal Police of Argentina (FPA), Department of Federal Security (Intelligence Division), provided the following information: (U)

Recently the Argentine Army Intelligence Service (SIR) circulated information to all Argentine security units indicating that information had been obtained from captured Montonero documents indicating that the Montoneros were working on plans to set up roadblocks posing as military and police personnel. The Montoneros were planning to attempt to identify military and police personnel passing through the roadblocks and assassinate them on the spot. (U)

On 7/16/76, an official of the Buenos Aires Provincial Police Intelligence Service provided the following information:

Recently the ERP set up a roadblock on the Panamerican Highway at Kilometer 46 under the pretext of being plainclothes Buenos Aires Provincial Police officers. Approximately 50 motorists were stopped and a monetary contribution to the ERP was demanded from each motorist. The motorists caught in the roadblock were given a receipt for their donation to the ERP and a large red ERP star was affixed to their windshield before they were allowed to leave the roadblock area. One unfortunate motorist proceeded directly to a Buenos Aires Provincial Police Sub-station and was assassinated by Buenos Aires Provincial Police guards outside of the Police Sub-station, who upon viewing the ERP star on the motorists's windshield, opened fire believing that an ERP attack against the Sub-station was about to commence.

With regard to Montonero plans to set up roadblocks to facilitate the assassination of military and police personnel, the FPA and the Argentine military have been utilizing extensive helicopter patrols throughout the Federal Capital and Buenos Aires Province, in order to detect any fraudulent roadblocks or checkpoints. ITC addresses have been detected.

TERRORIST UTILIZATION OF ROADBLOCKS POSING AS SECURITY FORCES

The FPA source noted that should the Montoneros put their plan into operation, their roadblocks would more than likely be established during the evening hours in order to avoid the possibility of helicopter detection and to minimize the opportunity of close examination of uniforms and presumed police and military vehicles utilized in the roadblock. This conclusion was arrived at since military and police personnel have expert knowledge of the correct uniforms of their services and also would easily be able to recognize a fictitious military or police vehicle, or one that was brought from another district to the location of the roadblock, should the Montoneros steal a vehicle. The FPA source noted that generally speaking, combined police and military units manned roadblocks in the Federal Capital and the areas of Buenos Aires Province close to the Federal Capital. In most instances the source noted that plainly marked Federal Police or Provincial Police cruisers are present in the immediate vicinity of the roadblock, as well as military vehicles. Thus the source noted that a roadblock manned by individuals in uniform of either the police or military without the presence of a vehicle from either the military or police forces would be highly suspicious. Additionally, should combinations of uniforms be used, i.e. part of the individuals in street uniforms with others in combat dress, this should be viewed with suspicion. (S) (U)

The Buenos Aires Provincial Police source noted that his service conducted no roadblocks or checkpoints by police officers in civilian attire. Additionally, although unmarked police cruisers may be placed at a roadblock or checkpoint, there almost always is a marked cruiser on the scene. The source noted that any roadblock in Buenos Aires Province manned by individuals in civilian clothes with unmarked vehicles should be viewed with considerable suspicion and avoided if possible.

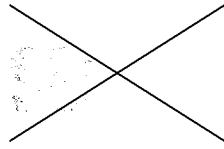

On 4/2/76, an official of the Federal Police of Argentina (FPA), Department of Federal Security (Intelligence Division) provided the following data: ~~(S)~~ (U)

During the week of 3/29/76, the FPA Department of Federal Security received information from a retired Argentine Army Major indicating that the quintero at the latter's rented quinta in Moreno, Buenos Aires Province, reported that his suspicions had been aroused by unusual movement and the arrival of a number of strangers at the quinta. The quintero reported that the leasees, a young married couple, had explained the foregoing by explaining that a family reunion was taking place; however, the quintero reported that the leasees had acted in an extremely nervous manner and that he doubted the family reunion story since only young persons in their early twenties and thirties had arrived with no older individuals falling into the age categories of parents, uncles, aunts, etc., or small children were in evidence. ~~(S)~~ (U)

The FPA, Department of Federal Security, dispatched three officers to investigate. These FPA officers traveled to Moreno in an FPA vehicle which had an inoperative FPA radio. Upon arriving in Moreno, the FPA officers checked in with the local Buenos Aires Provincial Police (BAPP) comisaria to identify themselves, explain the purpose of their mission and request BAPP support. The BAPP Comisario assigned eight BAPP officers to accompany the three FPA officers who proceeded directly to the Major's rented quinta. No neighborhood inquiries ~~(S)~~

were conducted and the officers approached the quinta openly. They were greeted by a hail of bullets from a large number of automatic weapons and a violent firefight ensued. The police officers soon ran out of ammunition and by the time reinforcements arrived the majority of individuals inside the quinta managed to escape. Fourteen terrorists were killed in the immediate vicinity of the quinta. (S) (U)

Subsequent investigation established that the quinta was being used for a high level policy meeting of the PRT/PST and the ERP, which was attended by between fifty and sixty ranking leaders of these organizations, including MARIO ROBERTO SANTUCHO and DOMINGO MENA (who escaped). Authorities did recover a large number of valuable documents, including tapes, which are being processed and analyzed. (S) (U)

The Argentine Army, which is responsible for ERP repression, was incensed over the bungling of the FPA operation at the quinta and the failure of the FPA to at least inform the Army of the information provided by the retired Army Major. (S) (U)

On 2/19/76, a ranking official of the FPA provided the following information: ~~(S)~~ (U)

During the past several days, there has been a flurry of rumors circulating at FPA Headquarters, indicating that General HARGUINDEGUY intended to appoint Argentine Army Colonel TEPELINO as the Chief of the FPA Estado Mayor. Additionally, rumors indicated that General HARGUINDEGUY intended to install Colonel RAO, who currently holds an intelligence function in the Argentine Army First Corps at Palermo, as the Director of Federal Security. The latter rumor was so definite, that several FPA officials reported that the installation ceremony for Colonel RAO would be held on 2/19/76. ~~(S)~~ (U)

General HARGUINDEGUY is holding off on any further action with regard to replacing career FPA officers with military personnel, inasmuch as during the morning of 2/19/76 a delegation of senior FPA Comisario Generales and Comisario Mayores informed General HARGUINDEGUY that should either Colonel TEPELINO or Colonel RAO replace a career FPA officer, then all career active duty FPA Comisario Generales and Comisario Mayores would resign en masse in order to protest. ~~(S)~~ (U)

It should be noted that the mass resignation of all FPA Comisario Generales and Comisario Mayores would leave the FPA in an unmanageable state, since the incumbent Comisario Generales and Comisario Mayores are relatively inexperienced in senior command functions due to the recent frequent turnover within these ranks due to the many changes of the FPA Chiefs over the past several years. However, although the incumbent Comisario Generales and Comisario Mayores are relatively inexperienced, they are veterans compared to those immediately junior in rank to them. The FPA sorely needs at least a year of stability in senior officer ranks, in order to allow middle grade officers sufficient seasoning to take over the senior grade positions when vacated. ~~(S)~~ (U)
