REFERENCE BUCAB INDICATED THAT IGNACIO NOVO SAMPOL TOLD NY 15583-C THAT A CONTACT OF CUBAN EXILES IN SHAXAXE WARTE GUATEMALA WAS ONE ADOLPH MOLENA ORTANAS (LAST NAME PHONETIC), WHO ALLEGEDLY WAS HIGH IN THE GUATEMALAN GOVERNMENT. [LEGAT, BUENOS AIRES, FILES INDICATE THAT NY 4114-S (BUFILE 134-1173) ABVISED ON JANUARY 10. 1972, THAT DR. ADOLFO MOLINA ORANTES, THE FORMER GUATEMALAN FOREIGN MINISTER, WAS A CLOSE PERSONAL FRIEND, AND THAT MOLINA ORANTES XNONED BE IN RIO DE JANEIRO, BRAZIL, BEGINNING JANUARY 8, 1972, TO ATTEND A MEETING OF THE INTERAMERICAN JURIDICAL COMMITTEE. NY 4114-S ADVISED THAT MOLINA ORANTES, IN ADDITION TO BEING AF KOREXON GUATEMALAN FOREIGN MINISTER. ALSO SERVED AS DEAN OF THE LAW SCHOOL AT THE UNIVERSITY OF GUATEMALA WHERE NY 4114-

THE FOREGOING INFORMATION WAS PROVIDED TO FORMER LEGAT, BRASILIA, SA WARREN C. DE BRUYS, WHO SUBSEQUENTLY CONTACTED DR. MOLINA ORANTES ON SEVERAL OCCASIONS IN RIO. DURING THESE CONTACTS WITH FORMER LEGAT, BRASILIA, DR. MOLINA ORANTES DISPLAYED A COOPERATIVE ATTITUDE AND PROVIDED INFORMATION OF VALUE WHICH WAS SUBSEQUENTLY FURNISHED TO FBIHQ.

IT IS BELIEVED THAT ADOLPH MOLENA ORTANAS REFERRED TO BY IGANACIO NOVO IS IDENTICAL WITH DR. ADOLEO MOLENA ORANTES. IF IT SHOULD BE DEEMED ADVISABLE, IT IS BELIEVED THAT DR. MOLINA ORANTES WOULD BE AMENABLE TO CONTACTS BY REPRESENTATIVES OF THE FBI CONCERNING HIS RELATIONSHIP WITH CUBAN EXILES IN GUATEMALA.

REBUCAB ALSO REPORTED THAT IGNACIO NOVO TOLD NY 15583-C THAT

"THEY" HAD CONTACTS WITH "TRIPLE A" PARTY IN ARGENTINA. AS THE

BUREAU HAS BEEN PREVIOUSLY ADVISED, THE "TRIPLE A" PARTY, ALSO KNOWN

AS THE AAA (ALIANZA ANTI-COMUNISTA ARGENTINA) (ANTI-COMMUNIST PARTY

ALLIANCE) DOES NOT EXIST. IT IS NOTED THATORLANDO BOSCH AVILA ALSO

CLAIMED HE HAD CONTACTS WITH THE AAA, SPECIFICALLY DURING A RECENT INTERVIEW WITH BLAKE FLEETWOOD IN CARACAS, VENEZUELA.

BOSCH AVILA CLAIMED THAT HE, TOGETHER WITH THE "RIGHT WING EXTREMIST AAA PARTY" IN CHILE, CONSPIRED TO KILL TWO CUBAN DIPLOMATS, WHO DISAPPEARED ON AUGUST 9, 1976, IN BUENOS AIRES, ARGENTINA. REFER TO BUE AIRTEL MAY 20, 1977, UNDER THE CHILBOM CAPTION FOR COMPLETE DETAILS ON THE AAA AND THE DISAPPEARANCE OF THE TWO CUBAN DIPLOMATS
