On January 4th, 2018, the Department of Transportation and District 5 Councilmember Paul Koretz's Office installed custom street name signs at the intersection of Morrison Street and Densmore Avenue in Encino to celebrate the "Day of the Doors". These signs act as a reminder of the Doors legacy on the streets of L.A., where music fans can stop by to get a photo. The Doors lyrics from "Roadhouse Blues", written in 1970, still resonate with today's Vision Zero program: "Keep your eyes on the road, your hand upon the wheel." ## **Progress Continues on MyFig**

Construction continues to move full speed ahead, with lots of underground utility work taking place. Now that the installation of LADWP water meters for landscaping is complete, the four bus platforms on the northern stretch of Figueroa St (between Olympic and 8th streets) are being built. Concrete is currently being poured for the curb and gutters of these bus platforms, with guardrails and foundations to follow. The foundations for the other five southern bus platforms will also be poured in the next few weeks.

Progress is also being made on the north side of 11th St., with new, wider sidewalks and ADA-compliant curb ramps now installed for several blocks. The majority of the northern sidewalk will be complete this month, and then the north side of 11th St. will be landscaped as construction shifts to the south side of the street.

The MyFigueroa project recently [topped the list](#) of 'LA Moments to look forward to in 2018' on Curbed Los Angeles, and crews will continue their work along Figueroa and 11th Streets, moving toward a project completion by Spring 2018.

## **#WalkinginLA: CD 13 Pedestrian Signal Activation**

Brandon Wong, Transportation Engineering Associate, shows us how a recent implementation of flashing yellow signal operation at night, is a useful tool in reducing speeds along a wide corridor when traffic is light. Aside from the flashing yellow replacing the steady green, the signals operate and change normally.
