Just want to let you know that mobilization will commence on **Monday, February 26<sup>th</sup>**. The construction work will be split into six total phases, with an end date of March 30<sup>th</sup>.

The first phase will include three locations where demo concrete, pour concrete, and mosaic installation will occur. I will be assigned to notifying businesses impacted at each phase of location prior to mobilization occurring.

Axiom Group will be coordinating special traffic control and restricting parking meters for construction.

I plan to begin notifying businesses mid to late next week.
