It has never made sense to me why a city would have street cleaning for 3 hours in a business district.

It makes about as much sense as street cleaning in a residential area at night, which would never happen.

We already have the 4:30 - 6:30am street cleaning on 2 or 3 streets so that also gives us an edge.

I know it probably wouldn't be easy with BSS but even a partial victory of some more streets would still be a victory.

Thanks for keeping this idea going. Just for the record, we have discussed it at Board level with much approval but never formally voted to have staff promote it.

At some point, I would like to see at least that happen.
