Jim,

We need some clarification as to who is interim BID Director for the Hollywood Media District BID. If that is to be you, we will need something on file from the BID's Board stating that is the case.

Section 35 (page 14) of the Hollywood Media District BID administration contract with the City requires signature authority for individuals signing for invoices and other BID documents that are submitted on behalf of the BID to the City. The authority is either granted by naming these individuals in the contract or by authority of the BID's Board. Mike Malick and Laurie Goldman are both officers of the Hollywood Media District Property Owners Alliance, were signers of the contract and have signature authority.

If you will be submitting signed documents on behalf of the BID we will need a letter from the Board on file in our office granting that authority. Otherwise, all documents submitted by the BID will require a signature from either Mike or Laurie.

I have attached an example of such a letter to use as a template if the BID's Board wants you to have that authority. The letter from the Board would need to be on BID letterhead and signed by a member of the Board.
