Laurie,

We can include the required notification regarding applications to the 2016 Board of Directors in our Fall newsletter. (see attached pg. 2) The double sided one-sheet can be folded into the newsletter. (application attached)

If we do this, the Newsletter needs to be mailed out no later that Oct. $8 \, \mathrm{th}$.

The Nominating Committee will need to meet during the first or second week of November. This is to conduct interviews.

FYI . . .

- * On or before the 2nd Thursday of November, the Nominating Committee will meet to interview and/or discuss the nominees, and come up with a slate of nominees for the Board.
- * On or before the 3rd Thursday of November, we must mail out a letter on behalf of the Nominating Committee announcing the slate of nominees and notifying each Parcel Owner of their right to nominate one or more additional persons before the second Thursday of December. This is called "contesting the slate" and hopefully, it will not happen! If a Parcel Owner contests the slate, they must submit a petitioned signed by no less than 20 Parcel Owners in good standing (not delinquent on their assessments) for each person nominated. Then this triggers a General Election. Otherwise:
- * If the slate is not contested, then the Slate of Nominees as chosen by the Nominating Committee will be declared by the Board of Directors at the annual Holiday Meeting in December to have been duly elected.
