Hello -

As you have probably heard by now, next Tuesday, March 29 at 1:30 p.m. the Senate Transportation & Housing Committee will take up SB 876 (Liu). This bill would create a new right for any homeless person to "sleep or rest" in any "public space." This bill's broad definition essentially declares the right to sleep or rest on any property that has a public easement. What's more, SB 876 creates a special set of exemptions, privileges and rights for the homeless to occupy public and private property, including sidewalks, without complying with laws that apply to everyone else. The public right-of-way is to be enjoyed by all, without being subject to intimidation, inability to pass, or lack of sanitary conditions.
