I have attached a photo of the trash receptacle that was just emptied yesterday and this morning it is already overflowing due to the motor homeless utilizing the BID's trash cans. The Hollywood Media BID has contracted with Sharyn Romano's group HBT to service our district - however with the influx of motor homeless the BID and HBT cannot keep up with the increased trash generated by the vehicles residing/living on our streets.

Particularly, Lillian Way is a popular street for the RV's because it is quasi industrial with studio uses. I have already requested through Councilmember O'Farrell's office to create an overweight parking restriction which will be a long term solution - But I am seeking Sanitation's creative problem solving to help our district in the interim.
