Hope this note finds you well. I have another parking question for you. Since they added the permit parking to the hood, we have always understood that there is one single space on Seward right in front of our front entrance that we (or anyone else for that matter) could park at after 6 pm. Well, we had parked our van there and we got a ticket. We have parked there many times and never gotten a ticket after 6 pm before. I wrote to the city to contest the ticket and they denied it and then I just took a closer look at the sign and it APPEARS that the one space only waives the restriction of the 2 hour parking between 8 am to 6 pm, however, as I said, this is not what we were told. (I could look for the email but it will take some time). Is there a way that you can find out exactly. As you can see from the attached photo that the arrow is placed on the sign stating 2 hour parking, not the no parking after 6 pm. I'm trying to contest the ticket and I have another week to do so, but it would also be good to get clarification (and perhaps another arrow on the no parking 6 pm to 8 am sign) so we/or anyone else doesn't get a ticket while parking there if they shouldn't.
