Hi Lisa, I did receive your voice mail, I was out of the office yesterday afternoon. Regarding the 2017 assessment data:

If you aren't increasing the assessments, there really isn't anything to do with the data except for changing the the year to 2017 and sending it back. Because of issues with the previous director not following through, I took care of the parcel changes and resulting new assessments last year (for the 2016 data). I believe I left the old and new parcels and notes in the version I sent to you. This is good to know for history, but the old parcels don't need to be present in the 2017 assessment list.

All you need to do at this point is to remove the old parcels (shaded grey), change the year to 2017 and send the data back to me. If there are changes to be made for 2017, the County will inform us when we submit the file in July. I will then notify you of the County report, and we'll go from there.
