It should also be noted that most of the large recreational vehicles that park at this location do not have septic takes installed for human waste and the waste is being dumped into local storm drains.

The local business were petitioned and they are requesting tow away no parking restrictions on Mansfield Avenue between Santa Monica Boulevard and Romaine Avenue during the hours of 12:00am and 6:00am.

The LAPD fully supports the imposed parking restrictions, in an effort to prevent parking and traffic congestion as well as prevent illegal dumping of hazardous waste.
