Hi Lisa,

Been out in meetings all day. We are billing for the full amount of \$163,000 (not sure if the actual amount is a round number, but I'll use it as a reference point), of which \$75,902.21 was billed to DMV and sent on May 27, 2016, and an invoice in the amount of \$87,097.79 is being sent to EDD in the next day or so. This covers 10 years of assessments for nine DMV parcels and one EDD parcel. We got the correct addresses to update the City's FMS system and corrected invoices accordingly.

A couple of weeks ago you took over our BID administration and I informed you that I was working on collecting approximately

\$163,000 in past due special assessments from two (2) State Agencies: Department of Motor Vehicles and Employment Development Department. Well after several calls and letters, we have prevailed in collection with the Department of Motor Vehicles in the amount of \$75,902.21. It is my understanding the DMV has requested from the City of Los Angeles a revised invoice for said amount. I am just checking in with you to verify that the Revised Invoices that have been requested have been sent to the DMV.
