Hello Team,

My apologies for the delayed response to this request. Last we left off, I was going to reach out to Metro to see about re-scoping the original grant to include elements that are feasible with minimal implementation hurdles. I did get a response from Metro, and it was not what I expected. The funds that were originally programmed for this project were what are referred to as STPL (don't really know what that stands for). But nonetheless, these funds are earmarked for rehabilitation and maintenance type of activities. With that, our original scope did not meet either one of these requirements. Having said that, I was advised by Metro, that if we indeed want to re-scope a project, let's go ahead and send them a revised scope. DO we have an identified scope of work that we should be sending to Metro? Please advise.

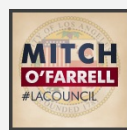

I may not be able to attend the meeting, but just want to give you some background info about this project. This is a Metro Call-for-project back in 2001. The scope of the project is to install wayfinding signage and gateway monument along Santa Monica Blvd between Vine Ave and La Brea Ave. After DOT received authorization to proceed with design from Caltrans, there has been several concepts regarding the signage and the gateway monument. However, since Santa Monica is a state highway, all design must be approved by Caltrans. When DOT tried to submit the conceptual design to Caltrans for approval, the gateway monument has been rejected. Also, the signage has also been limited to public entities only. As a result, if we want to move forward with the project, Caltrans must be on board on this. Also, since this is Metro Call-for-project, any change in scope must be approved by Metro as well.

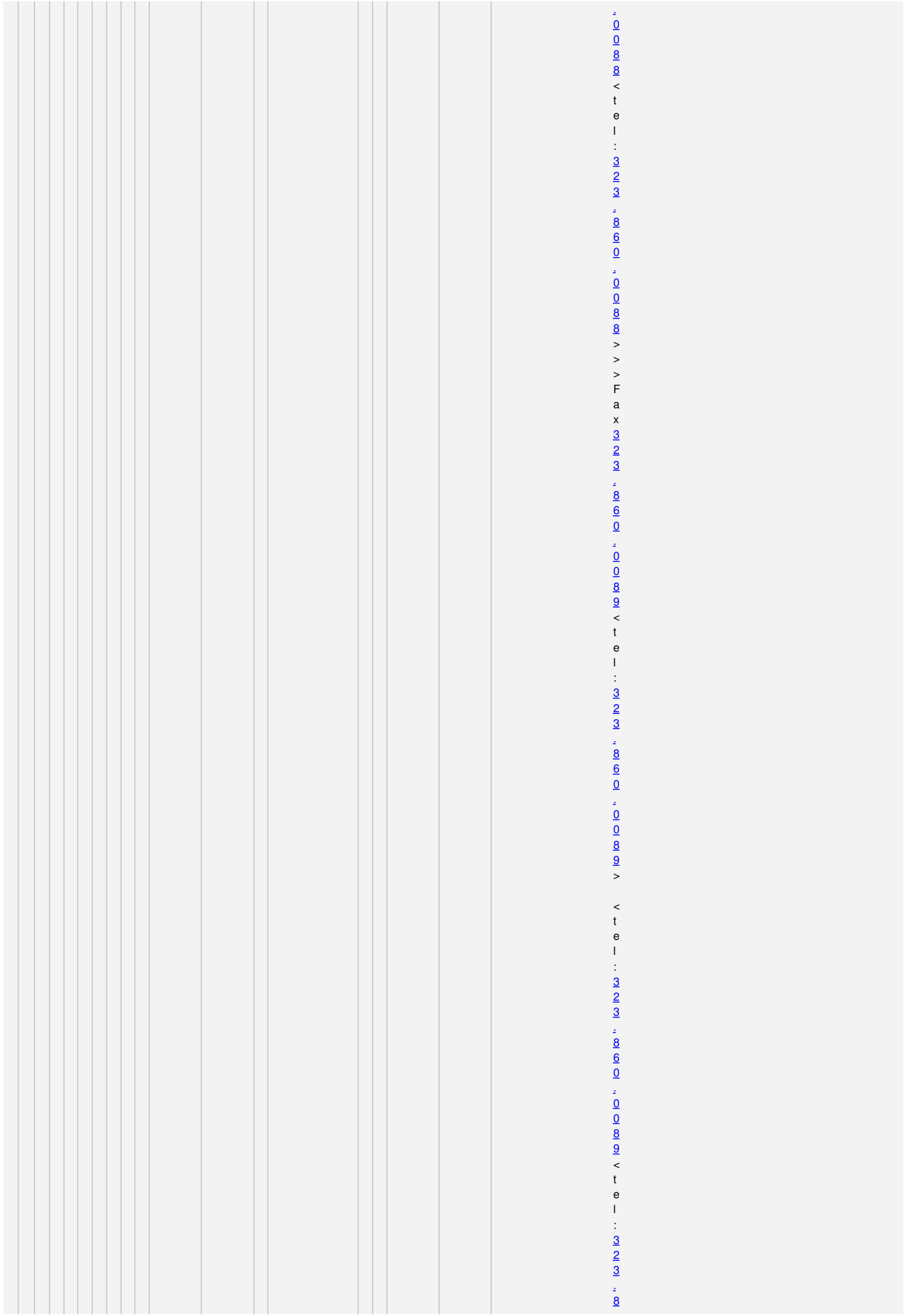
