
World Premiere of the Movie “Tesla Nation” in Belgrade, Serbia

“If I am fortunate enough to fulfill at least some of my ideals, that will do good for the whole of mankind. If that is achieved, I will be glad to say that a Serb has done it... I have as you may see and hear remained a Serb even overseas where I am engaged in testing. That is what you also should be and to raise the glory of Serbs in the world with your knowledge and work,” said Nikola Tesla (1856 – 1943), Serbian-American Scientist and Inventor, during his visit to Belgrade on June 1st, 1892.

These Nikola Tesla’s thoughts were a leitmotif of the new movie “Tesla Nation.” His achievements and moral integrity became the impetus which connects Serbs in the world. On October 27th, 2018, the world premiere of the documentary “Tesla Nation” by Zeljko Mirkovic was held in the great hall of Kolarac, Belgrade, Serbia. Inside the Hall, it was standing room only as an audience, curious to know more about the Serbian Diaspora and their contributions to the United States of America and the world.

Spanning more than 200 years, the film recounts the stories of many Serbian-Americans throughout the

history. As the narrator of the movie, Jack Dimich, Serbian-American Actor, plays Nikola Tesla. Tesla leads us throughout our history from the first famous Serb, Djordje Sagic, also known as George Fisher, Mihajlo I. Pupin, Serbian-American Scientist and Inventor, World War I and II immigrants up to the present time. It stresses overall Serbian-American contributions to building America and the world.

At its conclusion, the audience applauded the film. The team who worked on the movie stepped on the stage to hail the public. Aleksandar Slavkovic, the Author of the novel *The Immigrant: The Judge Fisher Story* and participant in the movie, retold the epic story of Djordje Sagic’s life and his adventurous spirit in building America. Sagic arrived in the United States through the port of Philadelphia. In the New Continent, he fought for the independence of Texas and Mexico. His contribution to building American society was so important that today we can find Sagic’s picture in the National Museum of Texas in Houston.

Zeljko Mirkovic, the Director and Producer, stressed the importance of making this movie: “‘Tesla Nation’ is a symbol which is recognized as

a possibility to connect people in order to achieve positive goals. Today, we have a chance to choose Tesla to be a symbol to reconnect us because Tesla is the name which everybody recognizes.”

On behalf of the Serb National Federation, I was present at the premiere. As the Screenwriter and person who talks about history of Serbian-Americans in the film, I highlighted the main idea of the movie: “When the first Serbian immigrants came to the “New land,” they brought not only their talents, readiness to sacrifice their lives for ideals, but also their soul. Their soul distinguished and raised them above others. Today, our soul is the magnet which connects Serbs in different countries and continents. Bishop Nikolai Velimirovic, who was also an immigrant in the United States, described Serbian-American history with the following words: ‘It is all an amazing epopee begun by those Serbian farmers who escaped from tyranny and came to this country of freedom not to enjoy, but to become more capable to carry worries of Saint Sava and helping their families in the homeland to carry out the same worries and thus for more than 100 years until today.’”

Through the lives of Nikola Tesla and Mihajlo I. Pupin, you can introduce stories of other distinguished Serbian-Americans such as Walt Bogdanich, Gordana Vunjak-Novakovic, Peter Bogdanovich, Karl Malden, Helen Delich-Bentley, Steve Tesich, Milana Bizic, John Martich, David Vuich, Branko Terzic, Branko Tujanjac, Obrad Kesic, Alex Machaskee, Michael Djordjevic, and Dr. Nenad Janicijevic among others.

The main producers of the movie are Radio Television of Serbia and Optimistic Film. Besides Milos Rastovic as main screenwriter, other screenwriters were Marko Lopusina and Zeljko Mirkovic. The Serb National Federation was also one of the sponsors of the movie. The Tesla Science Foundation initiated the filming of “Tesla Nation.”

“Tesla Nation” will be screened throughout Serbia’s cinemas and Radio Television of Serbia. The movie will have the premiere in the United States in Spring 2019. The premiere in Pittsburgh was planned at the Serbian Movie Festival at the University of Pittsburgh in Spring next year.

A FIRST FOR MALDEN – Karl Malden, originally **Mladen Sekulovic**, has received a posthumous honor that reaches a new height in the world of film. A monument to the Oscar-winning Serbian-American was unveiled in Belgrade on Tuesday. It's located at the entrance to the Yugoslav Film Archive, and was unveiled by the institution's Director **Jugoslav Pantelic** and **Dan Tana**, a friend of the late actor, according to reports by Tanjug. Among attendees: **Serbian Prime Minister Ana Brnabic**, **Minister of Culture and Information Vladan Vu-**



kosavljevic, Belgrade Mayor **Zoran Radojicic**, Deputy Mayor **Goran Vesic**, and US Ambassador to Serbia **Kyle Scott**. An article said he was born in Chicago, but we know he was raised in Gary, Indiana, where he attended St. Sava's and sang with the **SSS Karageorge**.

ANOTHER FIRST – As a genius inventor, **Nikola Tesla** is known for many "firsts" in science. We also believe he is the first and only scientist with an automobile named after him. Now, yet another first for him is part of the coin world as Serbia issued a silver bullion coin series honoring the late inventor who continues to grow in recognition and popularity. Our coin collector known only as **Dragi** tells us there are plans for multiple coins showcasing his inventions and the series is scheduled to run for several years. For more info, log on to coinworld.com or numismaticnews.net. As **Dragi** says, "These coins will make excellent gifts."

SMALL WORLD CATEGORY– If you suffer from separation pains, today's technology offers you wireless telephones, Face Time, and the Worldwide Web to help ease the longing to hear someone's voice, see their face or tune in to local radio that's half a world away. Each dot represents a radio station somewhere in the world to which you can tune in for free on your laptop or PC. Along the same

lines, there's a **Radio Serbia** app downloadable to your phone that hooks you into an abundance of stations across the country. Live radio, a world away, playing on your phone or iHome device. Nice.



SERBIAN GREAT MEN

Written by Simo Jelaca, Ph.D.

NOTE FROM THE AUTHOR: This paper presents an excerpt from the publication *Serbian Great Men* that have marked civilization, and includes sixteen Serbian giants, in the field of science and inventions, mathematics, botany, genetics, literature and poetry, and they are: St. Sava, Rudjer Boskovic, Dositej Obradovic, Vuk Karadzic, Petar Petrovic-Njegos, Joseph Pancic, Nikola Tesla, Mihajlo Pupin, Mihailo Petrovic-Alas, Mileva Maric-Einstein, Milutin Milankovic, Ivo Andric, Jovan Karamata, Pavle Savic, Bogdan Maglic and Dragan Skoric. There are cases in the literature surveys where the data is different for the same person in different sources, especially as it relates to the time data.

MILUTIN MILANKOVIC (1879-1958), Serbian astronomer

Milutin Milankovic is the scientist whose *Theory of Ice Ages* is accepted world wide and confirmed by the latest universal research.

He was born in Dalj. His technical studies took place in Vienna where he was recognized as one of the best students of his generation. In Austria, he worked as an engineer, stressing to his structures and some innovations, and then came to Belgrade where he became a professor at the university, working there until the end of his life. He produced works of lasting value. Russian scientists orbiting the moon named a crater on the far strain side Milutin Milankovica. Accuracy of Milankovic's calculation are the greatest proof of his theory, which he called the *Canon of Insulation*. He was vice president of the Serbian Academy of Science, yet relatively unknown in his country, which he endured in a gentlemanly way in silence with dignity. He had a brilliant writing style. Among his most important works are *The Canon of Insulation of the earth and its application to the Ice Age*; *Celestial Mechanics*; *History of Astronomical Science*; *Through the Realm of Science*, and more. He also worked as an astronomer and mathematician of the outstanding quality. His work *Through the Universe* and the *Ages*, was first published in German in large circulation, which showed him as a brilliant scientist. In this work he takes the reader on a very interesting way through ancient Babylon and Athens to visit Aristotle and Archimedes, the Alexandrian Library and Cleopatra. If Kepler's and Newton's laws of motion of celestial bodies are the first laws of the universe, then *Solar Radiation* by Milankovic is second. Milankovic was the first to calculate solar radiation of the earth and all the planets of solar system, which was confirmed as perfectly accurate. Milankovic did not deal with science in the order which he lived, but lived in order to do science. Milutin Milankovic combines astronomy, mathematics, physics and geophysics with literature, history and philosophy in his unique way. He also made the most accurate calendar in the world to date.

LENTEN DISH: PREBRANAC

Makes 6 servings • Prep Time: 15 minutes • Cook Time: 1 hour, 30 minutes

Ingredients:

1 pound Great Northern beans
1/4 cup + 3/4 cup canola oil
Fresh or dried dill
5 large chopped onions
3 minced garlic cloves
1 (16-ounce) can tomato sauce with bits of tomato
2 teaspoons sweet or hot paprika
Salt and pepper
1 1/2 cups water

Pick over beans and rinse. Place beans in 4 quarts water. When it comes to a boil, skim off any foam that rises to the top. Add salt to taste, 1/4 cup oil and 1 teaspoon dried dill or 1 tablespoon fresh dill. Simmer until beans are tender. Drain, rinse in cold water to stop the cooking process and set aside.

Heat oven to 350 degrees. In a large Dutch oven or lidded casserole dish or roaster, heat 3/4 cup oil and saute onions until translucent. Add garlic and saute until onions are tender. Add tomato sauce, paprika, salt and pepper to taste, dill to taste and water. Mix in the beans, cover and bake 45 minutes, adding more water, if necessary.





INSPIRATION FOR VRONSKY HAS TIES TO SERBIA


GORNJI ADROVAC, SERBIA - Russian Colonel Nikolay Raevsky, who inspired Leo Tolstoy to create the legendary Count Vronsky, lover of Anna Karenina, died defending Serbia from the Turks near the village of Gornji Adrovac. Reportedly, Tolstoy was inspired by Raevsky and may even have been related to him.

In the last dramatic pages of "Anna Karenina," Vronsky goes to the Serbian-Turkish war. It's no wonder the great Russian writer intended such an ending for Vronsky since Raevsky did actually go to the war and died in it in 1876.

When a letter from the Serbian King Milan Obrenović reached the estate of the Raevsky, his mother Anna didn't allow it to be opened. She felt it was bad news, and said only that her son died like a true Raevsky. Anna Raevsky left a large sum of money which was used twenty years later to build a colorful Russian church among the old lindens in the village of Gornji Adrovac. The church is near the town of Aleksinac where the heart of her son and Tolstoy's inspiration for count Vronsky stopped beating.

Metaphorically, Colonel Raevsky had three hearts. Two remained in Russia: one belonged to his homeland and the other to a mysterious woman who was the original cause of him leaving Russia, and the third belongs to Serbia because Raevsky wanted to be buried where he died but have his heart returned to his homeland.

Apparently, a Russian military surgeon misunderstood and took out the colonel's heart to be buried in Serbia while the masses of grateful Serbs sent the colonel's body to his homeland with full state honors.



SERBIA TO ISSUE TESLA COINS

Nikola Tesla is widely regarded today for his genius, which was often overshadowed in his own time. But now Tesla and his research into alternating current is being honored on current coins.

Tesla is the face of a new silver one-ounce legal tender bullion coin series issued by the National Bank of Serbia in honor of the world-famous native. The collection will feature a permanent portrait of Tesla on the obverse with an evolving reverse showcasing his inventions, patents and visionary concepts.

Tesla is viewed by many scientists and historians as one of the most notable inventors and visionaries of all time. He is credited exclusively or in part with technologies that changed the world, including the electric lighting grid, electric motors, remote control, hydro-electric power, turbine engines, magnetic propulsion, electromagnetic energy generation, x-rays, lasers, particle beams, solar power adaptation, weather manipulation, robotics, wireless transmission, radio, television, cell phones, and the internet. Many of these will be the subject of future coins.

In 1975, Tesla was inducted into the National Inventor's Hall of Fame at Alexandria, Virginia. The following year, the Institute of Electrical & Electronic Engineers established their annual award of the Tesla medal for contributions to the utilization of electrical power. In 2003, Tesla's concepts were acknowledged when a new electric automobile company was named

in his honor.

Tesla has been the subject of numerous documentaries in recent years. In 2018, the History Channel ran a five-part investigative documentary titled "The Tesla Files," which opened new considerations and suggested new revelations as to his life, importance, and associations in America. Applications of Tesla's accomplishments, those both long-noted and those previously suppressed, are still being rediscovered for evolving technologies.

Three Tesla coins in 2018

Three different issues of "Teslas" are scheduled for 2018. The first issue, which went on pre-sale Sept. 10, exhibits a prototype of his alternating current electric motor. The second issue, to be released in November, will commemorate his invention of remote control. The theme of the third coin is not yet public.

The coins are composed of .999 fine silver and carry a denomination of 100 dinara. The Alternating Current coin has a mintage limit of 50,000 circulation strikes and 3,327 Proof pieces. Mintages are set to increase with each issue as awareness of the collection builds.



He always carries with him a copy of the *American Srbobran*, the oldest and largest Serbian newspaper in America and Canada, and the official organ of the SNF.

BLAGO TRIP HELPS RESTORE ARILJE CHURCH

ARILJE, SERBIA - The church of St. Achillius, Bishop of Larissa, Greece, a staunch opponent of the Arian heresy and a participant of the First Council of Nicaea in 325 AD, located in a small city of Arilje, western Serbia, was the destination of the June 2018 BLAGO expedition. It is a foundation of the king Dragutin Nemanjic built in the Raska style and a masterpiece of Serbian medieval fresco painting.

There are many things done in advance of every BLAGO expedition, including obtaining appropriate permits, blessings from the local church and the Bishop, lodging reservations, secure transportation, and more. BLAGO's Serbian coordinator Gordana Kelic, an art historian, started working on these many months in advance to complete all prerequisites.

The trip from Belgrade starts at dawn on June 7th, driving to the town of Jagodina, the main starting point of every BLAGO expedition. All equipment in storage including scaffolding, tools, photo equipment, lights, and more is cleaned up and loaded on the trailer.

The trip itself through the heart of Serbia is uneventful but, everyone is excited upon our arrival as the town of Arilje, the surrounding landscape, and the church are beaming of tranquility and peacefulness.

The church, located on the hill in the center of Arilje, dominates the view and it is obvious that its attraction created the city and surrounding villages, farms, and orchards. The holy place is surrounded by a deep green lawn and the final resting places of many well-known individuals from Serbian history.

The surroundings, untouched for centuries, is a constant reminder and incentive that the work of BLAGO has meaning and records and promotes some of the most precious treasures of Serbian culture and heritage. "Com-

ing here we brought in all our previous experience and knowledge, but we are aware that coming out of this trip we will be enriched with new ones," said one participant.

After the work day, the evening goes well as we spent most of the time chatting with the clergy taking care of the church and the people of Arilje. As a rule, every day of our trip had a morning coffee break with Father Dragan, the main priest of the church in Arilje, and his colleagues. Participants expressed gratitude for all the time and support the clergy offered during.

Work included mounting scaffolding in the church altar area for the purpose of taking high-resolution pictures of the fresco paintings. One of the workers said, "As many times before, everybody is involved, and each piece of the equipment passes through many hands before reaches Meda, our technical lead, for its final place in the tall, six levels scaffolding. We are joined by a friend living in Germany, Mihajlo, who was staying in the same house we rented during the stay in Arilje...After our work is done in the altar area, scaffolding is brought down, and piece by piece taken to the nave under the main dome of the church. This time, the scaffolding is extended to the full height (45 feet) as we need to reach the dome of the church. Photography is an art, but photography at the top of the shaking and moving scaffolding is almost acrobatic."

Since 1998, BLAGO Fund has been collecting and promoting Serbian heritage and cultural/spiritual treasures. To help them continue their work donations may be made to BLAGO Fund, a non-profit USA and Serbia based organization. Our Relationship with Jesus Christ

This is the time to consider Jesus Christ and our relationship with Him. Jesus Christ is ever present with us. At times we will clearly sense His presence. At other times, we will feel distant and have thoughts dwelling other than on Christ. It is important that we always repent and return to Jesus Christ.

Our relationship with Jesus Christ is more than intellectual. It is intensely and uniquely personal. Though all Christians are united with and identify with Christ, each person feels a special relationship with Christ, a one to One relationship.

A special bond exists among Christians which they share with each other and with Christ. This bond transcends language and territory to link together in spirit and love, people who have never met personally.

The physical birth of Jesus Christ took place centuries ago. As Orthodox Christians, we celebrate Christ's nativity each year as a present day reality. We proclaim with joy each year that "God is with us!"

It is likely that we do not spend sufficient time being amazed at the passage of centuries and the enduring presence of Christ. Each year at the Divine Liturgy on Pascha we read from the Gospel of St. John that Jesus existed at what is referred to as "the beginning." (Jn.1:2). St. John states that all things were made through Him, and without Him nothing was made that was made." (Jn. 1:3).

Jesus Christ is central to our Faith. We take our identity from Him. We place our hope in Him. He is our salvation, the source for the remission of sins.

As Christians, we live in a busy and diverse world. There are many distract-

tions. Many individuals in the world blaspheme and do not proclaim Jesus Christ with great glory. At times, the conclusion can be drawn a war is being waged to denounce and subdue any references to Jesus Christ in public places.

We must be certain of our faith. Our perspective must be clear. Through prayer, continual prayer without ceasing, we can come to know Christ as we have never known Him. The barriers to our relationship with Jesus Christ exist within us.

Each of us exerts control over our personal prayer life. Each of us exerts control over our use of time. Our thoughts are subject to personal control. We must be sensitive to the word "discipline" and how it emanates from the word "disciple". To be disciples of Christ, He must ever be present in our prayers, thoughts and mind. Jesus Christ must be our consuming interest.

The Orthodox Church is a Trinitarian Church. In the Creed, we proclaim our belief in One God, the Father Almighty, maker of heaven and earth. We proclaim our belief in the Son of God, of one essence with the Father. In the Creed, we assert our belief in the Holy Spirit, the giver of life, who with the Father and Son is worshipped and glorified. Our beliefs give rise to our actions and they define us as human beings.

We are members of the Holy Orthodox Church. Our religious teachings and services proclaim Christ as God and enable us to learn more about Him. Through the Holy Mysteries, we experience Christ in diverse ways in which He wonderfully impacts our lives.

The Holy Mysteries are turning points in human lives. We meet Christ in the

Holy Mysteries, in Baptism, Chrismation, Confession and Communion, Marriage and Ordination, in Holy Unction...these are times when changes noticeably occur in human beings. Participation in the Holy Mysteries is a turning point of life.

There is a subtlety to Jesus Christ. He acts in ways which defy total comprehension and challenges the best of minds. Jesus Christ became man without giving up His divinity. He entered the world through humble surroundings. We have no record of His being educated in institutions of higher learning but His teachings interest the world's best scholars.

Records exist of healing by Jesus Christ. These miracles are sources of hope and inspiration for the sick and suffering of the world. They are objects of scholarly research and close scrutiny. More importantly, the miracles of Christ serve to manifest the faith of Christians everywhere. Christ offers hope!

People of all ages have relationships with Jesus Christ. We know from the Gospel of St. Matthew that Jesus wanted the little children to come to Him. (MT.19:14). From personal observation, we can attest that men and women of all ages find a bond with Jesus Christ.

For many, the relationship with Jesus Christ begins at infant Baptism and grows throughout life. Other individuals may experience unity with Christ at later stages in life. The relationships may mature at different rates and in different ways. With certainty, we know the relationships with Christ are not limited by age, sex, race or national origin.

Jesus Christ is identified with the Kingdom of God. In the Creed, we refer to His Second Coming. In the Lord's Prayer, we pray, "Thy Kingdom come..." The Creed,

The Lord's Prayer and our thoughts regarding Jesus Christ, all deserve careful attention.

In the Creed, we refer to the judgment that will take place when Christ returns. The Gospel of St. Matthew in the Twenty Fifth Chapter is an additional point of reference to the Last Judgment.

Our relationship to Jesus Christ is not to be stagnant. We should look to St. Apostle Paul who said Jesus Christ would be magnified in his body whether by life or by death. For St. Paul, to live is Christ and to die is gain. (Phil. 1:26-27).

Everyday is a new opportunity to renew our relationship with Jesus Christ. Every moment is an opportunity to say: "Lord Jesus Christ, Son of God, have mercy on me a sinner."

Throughout our lives, Jesus Christ is ever-present. He is wherever we may go. If we travel to another country, He is there. If we work in a factory or hospital or office, Jesus Christ is present. Airplanes and rockets do not reach heights which exceed the grasp and presence of Christ.

We do not have to search to find Christ. We do not have to travel far. Our challenge is to open our hearts to Him and to keep them open. Our challenge is to keep our minds on Christ. We must open our eyes and be sensitive to Christ's presence wherever we are.

Now is the time to consider our relationship with Jesus Christ. It is always time to consider our relationship with Him. Time is measured according to Christ's birth. It behooves us to measure each moment of time as a golden opportunity to be with Jesus Christ.

U.S. GRANTS AID SERBIA

BELGRADE - Earlier this year the United States Government and the Government of Serbia signed agreements under which the United States will provide \$22 million in assistance to Serbia. These funds will be used to help make Serbia's economy more competitive, strengthen the rule of law, bolster government operations, improve the media regulatory environment, and combat corruption.

"Since 2001, the United States has provided nearly \$1 billion in assistance to Serbia," said United States Ambassador Kyle Scott. "I want to stress that our assistance is a partnership. We work directly with the government of Serbia, the Serbian private sector, and civil society to identify the challenges facing Serbia. More importantly we turn to Serbians to identify the solutions."

Minister for EU Integration Jadranka Jok-

simovic said that Serbia has been engaged in EU accession negotiations and that "to reach its strategic goal, Serbia will focus all of its available resources toward adopting and implementing the EU aquis and attaining standards that will make it an equal member state. On this path, financial support and future collaboration with the United States as a partner in development, is of utmost importance to Serbia."

United States Government support to Serbia has made obtaining construction permits and complying with business inspections easier and more transparent—increasing construction activity and moving companies out of the shadow economy; helped communities affected by the migrant crisis repair and improve infrastructure; renovated misdemeanor courts throughout Serbia and improved court

operations through case management systems and electronic registries—generating more than 100 million euros for Serbia's budget and reducing case backlogs by up to 80 percent in some courts; introduced e-governance solutions in 83 municipalities – making it easier for Ser-


bians to change their official residences and to register marriages and births; and helped Serbia draft and implement its first whistle-blower protection law – making it easier and safer to report corruption and fraud.


