4. Na pagina 16, bao di e punto “Aandachtspunten en Wenselijkheid” Marisol ta bisa: Diversificacion di e economia Arubano ta bon, solamente si inversionan por wordo haci. E ta bay akinan pa cientos di miyones di florin cu gobierno di Aruba ta bay tin mester. Metanan di presupuesto por stroba e inversionnan ki. Ni den e ley, ni den e splicacion ta wordo informa con Hulanda ta pensa riba e aspecto aki. E pregunta ta, con e RAft lo haci cu metanan di presupuesto, pa esakinan no bay stroba e inversionnan internacional yega Aruba.

Government Receives Manifesto from TOPA Union Regarding Performance Management System

ON Wednesday morning, the TOPA Union approached the Aruban Government at the Government Office with a manifesto regarding the Performance Management System. Prime Minister Evelyn Wever-Croes, Minister Geoffrey Wever, and Minister Rocco Tjon received the union delegation.

The Prime Minister emphasized that the Performance Management System is a system that undoubtedly convinces everyone of its importance for the public sector. It is a uniform system for evaluating the performance of all public employees. This system allows for the assessment of how work is progressing and whether a public employee deserves a promotion.

The reason the Aruban Government introduced this system is that, before its implementation, there was no uniform system for evaluation in the public sector. Some government departments had their own systems, while others lacked such a structured approach. Public employees have raised concerns, stating that in some departments, promotions are easily obtained, while in others, it is quite challenging. They also voiced concerns about not knowing the criteria by which they are evaluated and having to wait until the end of the year to receive evaluation results. These are issues that have been occurring within government departments for some time.

With the Performance Management System, each employee knows in advance what they will be evaluated on, and the employee also sets their tasks and goals. Throughout the year, department heads will evaluate each employee. "This is a system that I am sure will benefit everyone," stated the Prime Minister.

The Performance Management System law was introduced last year and came into effect in January of this year. However, unions approached the Government to suggest some changes. The Government invited all unions, but the TOPA Union was the only one that engaged in dialogue with the Government and brought their concerns to the attention of the Government.

Together with their manifesto, the TOPA Union presented a rather extensive report, which they had already submitted to the Government's appointed committee. However, they did not receive a response to this report, which is why they also handed over their manifesto, requesting a response from the Government within two weeks.



"I thanked the TOPA Union for always engaging with the Government and for always maintaining a constructive attitude to find a solution. The Government will certainly consider their concerns in order to conclude this year, which is considered a pilot year for the Performance Management System. In 2024, we will begin full implementation, taking into account the proposals brought forward by the unions. Although not all unions participated in the discussions with the Government's committee, we have considered all concerns to make the Performance Management System a better product that, in the end, Aruba can benefit from, as it is something that we all believe in and can be applied uniformly in all government departments and the public sector," Prime Minister Evelyn Wever-Croes stated.

Project Announcement:

Water Cooler in Schools Initiative in Aruba

THE Water Cooler Project, overseen by The Rotary Club of Aruba, drew inspiration from the pioneering efforts of The Interact Club of Colegio Arubano. The Interact Club took the lead by initiating the Water Cooler in Schools project, on March 22, 2021, World Water Day, with the installation and inauguration of the FIRST water cooler at Colegio Arubano. This innovative project is designed to benefit students aged 4-18 years across Aruba, with the overarching goal of providing access to clean and revitalizing drinking water in all 75 schools, thereby fostering a healthier and more sustainable community.

To date, 19 water coolers have been installed in various schools across Aruba. Currently, many schools are buying bags of ice several times a week and storing these in freezers to cool water. , With the Water Cooler Project, this practice is slowly but surely being eliminated significantly enhancing the efficiency of distributing clean, chilled water.

An important advantage of this initiative lies in its objective to combat obesity within the community. By encouraging the consumption of clean, cool water as a much healthier alternative to sugary beverages, the project aligns with broader health objectives. It also plays a crucial role in the areas of disease prevention and treatment, especially in reducing the risk of transmitting bacteria (such as COVID-19). Additionally, the project promotes child health, and enhances environmental sustainability by reducing the use of (disposable) plastic water bottles.

Despite the continued success of this project, our primary ongoing challenge revolves around sourcing these units locally at favorable prices. However, the realization of this initiative has been made possible through the generous sponsorship and steadfast support of our sister clubs, including the Rotary Club of Curacao, Rotary Club of Willemstad, Rotary Club of Bonaire, Rotary Club of Kentville (Canada), Rotary Club of Moncton West and Riverview (Canada), and District 7030. Former President Donald Trump Liable for Business Fraud, New York

IN a significant legal development, a New York judge has ruled that former President Donald Trump engaged in fraudulent activities by consistently misrepresenting his wealth by hundreds of millions of dollars. This ruling is part of a civil case brought against the former president and his family business, alleging that they defrauded banks and insurance companies over an extended period.

The judgment represents a notable setback for Mr. Trump and could potentially impede his business activities within the state of New York. Notably, Mr. Trump, along with the other defendants in the case, has consistently maintained their innocence, asserting that they never committed fraud.

New York Attorney General Letitia James led the accusations against Donald Trump, his two adult sons, and the Trump Organization. The allegations centered on inflating the value of their properties by over \$2 billion (£1.65 billion) to align with their business interests. It was claimed that the defendants provided false records and financial statements to secure advantageous loan terms, insurance arrangements, and reduced tax obligations.

Judge Arthur Engoron, presiding in the New York state court, issued this scathing decision after Attorney General James requested a summary ruling to expedite the trial. The judge's ruling includes determinations that Mr. Trump significantly overvalued Mar-a-Lago by an astonishing 2,300% in one financial statement and that he exaggerated the size of his Trump Tower penthouse in New York threefold. He notably characterized Mr. Trump's argument regarding the penthouse's



area calculation as “absurd.”

This ruling addresses the pivotal fraud claim made in the lawsuit, with the trial now expected to focus on a narrower set of six remaining claims and the potential penalty size. The trial is scheduled to commence on October 2nd, with the Attorney General seeking penalties of \$250 million and a prohibition on Mr. Trump conducting business in his home state.

Judge Engoron's ruling categorically states that the documents in question contained fraudulent valuations, emphasizing that they were utilized in business matters. He described the valuations as belonging to a “fantasy world” rather than reflecting reality.

In addition to his judgment, Judge Engoron ordered the revocation of business certificates allowing certain entities, including the Trump Organization, to operate in New York. While this action does not dissolve Mr. Trump's company, it could significantly impact his control over prominent New York properties like the Trump Tower and the Trump Building at 40 Wall Street.

The Trump legal team's request to dismiss the case was denied by the judge, who also imposed fines of \$7,500 each on five Trump attorneys for making arguments that had previously been rejected by the court. Judge Engoron characterized these arguments as “preposterous” and cited their contribution to their clients' “obstreperous” conduct.

Legal representatives for Mr. Trump have denounced this ruling as “a miscarriage of justice” and have indicated their intention to file an appeal. Donald Trump himself has consistently denied any wrongdoing, characterizing the case as another instance of political bias against him.

As the legal proceedings continue, the former president remains embroiled in multiple legal battles, including 91 felony charges across four criminal cases. Despite these challenges, Mr. Trump is actively campaigning for a potential rematch with President Joe Biden in the upcoming election year, with aspirations of returning to the White House.

Republicans Enter Critical Phase in Presidential Campaign as Trump Dominates Second Debate



In a pivotal moment in the Republican presidential campaign, seven GOP candidates gathered for their second debate at the Ronald Reagan Presidential Library in California. The backdrop of this event is marked by the growing momentum of former President Donald Trump, who currently holds a dominant position in the race and has opted not to share the debate stage with his rivals.

The debate, hosted by Fox Business Network, comes with less than four months remaining before the Iowa caucuses officially kick off the presidential nomination process. The significance of this moment cannot be overstated, as it provides Trump's competitors with a shrinking window of opportunity to challenge his lead.

Donald Trump, confident in his position, chose to be in Michigan during the debate, where he delivered a prime-time speech. His focus was on capitalizing on the ongoing Auto Workers Union strike and appealing to rank-and-file union members in a pivotal state for the general election.

However, despite his frontrunner status, Trump is not without vulnerabilities. He faces four criminal indictments that carry the potential of decades in prison, adding a layer

of complexity to the race. This situation has created a sense of urgency among some candidates, prompting them to consider a more direct confrontation with the former president, especially when addressing a national audience in the millions.

Republican strategist Kevin Madden, who has played key roles in Mitt Romney's presidential campaigns in 2008 and 2012, emphasized the need for candidates to recognize the competitive nature of the nomination process. Madden stated, "This is not a nomination that's going to fall in your lap. You have to go and beat the other candidates, and one of those happens to be Donald Trump. This debate will reveal whether participants grasp the dwindling time left in the hourglass."

As the Republican candidates seek to distinguish themselves and alter the trajectory of the campaign, the second debate unfolds against a backdrop of uncertainty, with Trump's formidable presence casting a long shadow over the field. With the Iowa caucuses drawing nearer, the race remains dynamic and unpredictable, with the future of the Republican Party hanging in the balance.

Spain Imposes Fines on ‘Big Four’ Consulting Firms Over Marathon Workdays

THE Spanish Labour Ministry has taken a decisive step by imposing fines amounting to at least €1.4 million on the ‘Big Four’ consulting firms – Deloitte, PwC, EY, and KPMG – a year after launching an investigation into their working practices and conditions. This investigation was initiated amid concerns that employees might be working longer hours than officially recorded.

Some employees at these consulting giants reportedly endured grueling workdays of up to 16 hours, sparking concerns about their well-being and labor rights. The lack of an hourly register, required for all companies since a change in Spanish law in 2019, contributed to this issue.

The absence of proper accountability allowed what were referred to as “marathon working days” to become commonplace. A former employee at PwC in Madrid, Sergio Padilla, shared his experience of working 12-hour days from 9 am to 9 pm. This demanding schedule left him with minimal free time, leading to a diet of fast food due to his inability to buy groceries.

The ‘Big Four’ consulting firms faced scrutiny when their offices were raided in November 2022 after the Spanish Ministry of Labour initiated an investigation without receiving any formal complaints. Inspectors examined whether these companies adhered to labor laws regarding working hours and compensation for overtime.

Raúl de la Torre from Comisiones Obreras, a Spanish trade union, highlighted that Spain’s consulting sector has experienced significant workforce fatigue. He mentioned that there were attempts to include a clause in employment agreements requiring employees to work up to 12 hours a day, six days a week, without additional compensation. This sparked the sector’s first strike, drawing attention to deteriorating working conditions despite these companies reporting record profits.

In 2021, the ‘Big Four’ collectively generated €2.5 billion in revenue, according to Expansión newspaper.

De la Torre argued that working conditions had deteriorated since 2008, with many employees earning as little as €14,000 per year in Madrid.

After extensive negotiations and strikes, an agreement was reached to increase the salaries of graduate workers from €14,100 to €15,300 and ensure that workers with three years’ experience would not earn less than €17,100.

Despite changing expectations about benefits and working conditions, marathon workdays have persisted in the ‘Big



Four’ firms. The recession of 2008 and the subsequent competitive labor market contributed to a mindset that values job security over working conditions.

Furthermore, a significant portion of new hires at these consulting firms consists of recent graduates with no prior work experience. A report by the Spanish Association of Consulting Companies revealed that 29% of new contracts in 2021 were awarded to fresh graduates.

For many young professionals, enduring these demanding work conditions is perceived as a means to advance their careers in a highly competitive job market.

The fines imposed on the ‘Big Four’ consulting firms underscore the need for improved working conditions and adherence to labor laws within the consulting sector in Spain.

Chemours Held Partially Liable for PFAS-Related Environmental Damage, Rules Court

IN a significant legal development, the chemical factory Chemours, located in Dordrecht, has been deemed partially responsible for the environmental damage incurred by neighboring municipalities due to PFAS contamination. This judgment has been delivered in an interim verdict by the Rotterdam District Court in a civil case.

The court's ruling points to omissions by Chemours and its predecessor, DuPont, in withholding crucial information about the harmful emissions when applying for permits. This legal action was initiated by the municipalities of Dordrecht, Papendrecht, Sliedrecht, and Molenlanden. With the court's key findings favoring the municipalities, the path towards a compensation procedure is now open. The municipalities aim to recover the expenses arising from the contamination, which encompass soil and health investigations, as well as financial losses due to soil pollution. While this case is essentially separate from legal proceedings initiated by residents in the vicinity, it may intersect with them in due course.

Between 1984 and 1998, the court concluded that the emission of the PFAS variant PFOA through the air constituted an unlawful act. DuPont, which Chemours separated from in 2015, was aware of the hazards but failed to adequately inform the authorities responsible for granting permits, as stated in the verdict. The court cannot yet determine whether emissions from 1998 to 2012 were also unlawful; this aspect will be addressed in a subsequent ruling.

In contrast, the court found that the emission of another substance, GenX, was not unlawful. The municipalities failed to sufficiently establish the risks associated with the relatively small quantities emitted since 2012. Nevertheless, Chemours may still bear the costs of GenX removal if the quantities emitted prove to be greater than currently known.

The final verdict in this case is yet to be scheduled, but the court does not anticipate it will be delivered this year.

Background

This legal dispute has been ongoing since 2018. The municipalities assert that their residents and others should not be exposed to the consequences of PFAS emissions without consent, emphasizing that these substances have no place in the environment, water, soil, or food. The municipalities argue that Chemours should have shared information about the environmental and health risks when applying for the necessary permits and should have taken more effective measures to mitigate emissions' consequences.

In response, Chemours stated that it possessed permits to emit the relevant substances and highlighted its efforts in recent years to reduce emissions. Earlier this month, it was revealed that Chemours had attempted to reach a settlement in the case, which the municipalities declined. Chemours has expressed its intention to carefully examine the verdict and refrain from substantive commentary at this time. The company underscores its commitment to addressing the concerns of residents in the vicinity of its Dordrecht facility.

Zembla Investigation

In June, a broadcast of the BNNVARA program Zembla made it evident that Chemours predecessor DuPont had been aware for decades of the risks associated with PFAS production for both its employees and the surrounding environment. As early as the 1990s, a PFAS coordinator was appointed, who identified substantial PFAS leakage. He warned that managing the contamination was exceedingly challenging and could lead to liability claims.

Understanding PFAS

PFAS represents a group of thousands of synthetic chemicals not naturally found



in the environment. The acronym stands for poly- and perfluoroalkyl substances, including notable types like GenX, PFOA, and PFOS. These substances are heat-resistant and exhibit water, grease, and dirt-repelling properties. They are utilized as non-stick coatings in cookware, in water-resistant clothing, firefighting foam, and cosmetics. PFAS is environmentally detrimental, hardly degradable, and poses risks to the immune system. Some PFAS types have been classified as potentially carcinogenic upon prolonged exposure.

Ongoing Legal Proceedings

Chemours is the subject of additional legal actions. In a recent development, lawyer Bénédicte Ficq, on behalf of over 3,000 residents in the vicinity, filed a criminal complaint against Chemours' management for alleged unlawful conduct that endangered the health and lives of nearby residents, despite the company's knowledge of the risks.

Furthermore, a former employee suffering from serious health issues has individually summoned Chemours, holding the company liable for his deteriorating health. Earlier this year, the province of South Holland lost a case against Chemours, which centered on whether emissions of potentially harmful substances could be limited. However, the province is pursuing an appeal.

Additionally, South Holland has filed a complaint regarding the illegal discharge of the PFAS variant trifluoroacetic acid (TFA) by Chemours. The company has previously been subject to a fine of €125,000, payable if it discharges TFA into the sewer system again.

While legal battles continue, the ramifications of PFAS contamination persist as a pressing concern for both affected communities and environmental regulators.

Google Celebrates 25th Anniversary:

From a Dorm Room Project to Tech Giant

ON September 27, 2023, Google, the American multinational technology behemoth, marks its 25th birthday, tracing its extraordinary journey from modest origins to global dominance. In the mid-'90s, the fateful meeting of two brilliant minds, Larry Page and Sergey Brin, took place within the hallowed halls of Stanford University's computer science program. Little did they know that their collaboration would forever alter the digital landscape. Their research project, initially named "BackRub," would evolve into the world-transforming search engine known today as Google.

Larry Page delved into the intricate mathematics of the World Wide Web's link structure, laying the foundation for a revolutionary search algorithm that propelled Google to its current status as a search giant. By 1998, their research project had metamorphosed into Google, a name inspired by 'Googol,' a mathematical term signifying an enormous number.

In August 1998, Google Inc. received its official birth certificate in the form of a \$100,000 check from Andy Bechtolsheim, co-founder of Sun Microsystems. From their Stanford dorm room, Page and Brin transitioned to their first "office" – a rented garage in Menlo Park, California. This garage, adorned with both computers and a ping pong table, became their sanctuary as they tirelessly worked to manifest their vision of an organized internet.

Today, Google's influence transcends its foundational search engine. With products such as YouTube, Android, Gmail, and Google Maps, Google has become an integral part of billions of lives across the globe.



Google's ascendancy in the tech sphere surged when it became the default search engine for Yahoo in 2000. In October of the same year, the company introduced AdWords, a move that laid the groundwork for Google's dominance in online advertising.

Another pivotal moment arrived in 2004 when Google unveiled Gmail, offering a groundbreaking 1GB of storage capacity. This move not only made Gmail an essential part of daily life but also solidified its position against competitors like YahooMail and Microsoft's Hotmail. The company went public in August of the same year. Google's foray into mobile began with the acquisition of Android in 2005 and the launch of Google Talk. In 2006, the acquisition of YouTube marked Google's entry into the online video arena.

The company's acquisition spree continued in 2007 with the addition of DoubleClick, further expanding its influence in online advertising. The introduction of universal search in 2007 empowered users to access a diverse range of content types within a single search.

In 2008, Google unveiled its inaugural

Android phone, the T-Mobile G1, and introduced the world to the Chrome web browser. Subsequent years witnessed milestones such as the introduction of Google Glass, the acquisition of mapping startup Waze, and the establishment of Alphabet, Google's parent company, with Sundar Pichai assuming the role of Google's CEO.

As Google embarks on its next quarter-century, CEO Sundar Pichai emphasized the company's commitment to harnessing the potential of artificial intelligence (AI) in a recent blog post. Google's pursuit of AI excellence positions it as a major player in this burgeoning field. The forthcoming 25 years will likely demand even greater innovation and impact from Google as it strives to maintain its preeminent position in the ever-evolving tech landscape.



Anchorage Joins Coalition Urging Supreme Court Review of Homeless Camping Decision

THE Municipality of Anchorage has aligned itself with a coalition of over a dozen cities and jurisdictions, making a collective plea to the U.S. Supreme Court for a review of a pivotal federal court ruling. This decision has reshaped the response to homelessness in several Western states in recent years, and Anchorage, under the leadership of Mayor Dave Bronson, is seeking greater flexibility in enforcing regulations pertaining to homeless camping on public lands.

At a news conference, Mayor Bronson underscored the complexity of the homelessness crisis and expressed concerns about the profound impact of two rulings issued by the U.S. Court of Appeals for the 9th Circuit, which has jurisdiction over Alaska and eight other Western states. The cases in question, *Martin v. Boise* and *Grants Pass v. Johnson*, have centered on the rights of homeless individuals to camp on municipal property when no alternative indoor shelter is available to them.

The heart of the matter lies in whether local governments have the latitude to implement bans on homeless camping in public spaces. The 9th Circuit’s rulings have, to a significant extent, shielded homeless individuals from punitive measures, such as jail time or fines, for sleeping outdoors when homeless shelters are at capacity. This interpretation is based on the Eighth Amendment of the Constitution, which protects individuals from cruel and unusual punishment.



Notably, the Supreme Court declined to take up the *Martin v. Boise* case in 2019, thereby upholding the 9th Circuit’s conclusion. This decision has since come under mounting criticism from various quarters, with concerns spanning the ideological spectrum. Local governments, regardless of their political leanings, have grappled with the threat of legal action or injunctions when trying to enact policies addressing homelessness.

The other case, *Grants Pass v. Johnson*, revolves around the definition of “camping” on public lands. The 9th Circuit’s ruling in favor of homeless residents left a critical question unanswered—what constitutes a reasonable right for individuals to protect themselves from the elements when sleeping outdoors? This ambiguity has left municipalities and law enforcement agencies uncertain about whether they can regulate elaborate outdoor camp setups on sidewalks and in public parks.

The decision to join this coalition reflects Anchorage’s determination to navigate the complex issue of homelessness while also addressing the legal challenges posed by the 9th Circuit’s rulings.

As cities grapple with the practical implications of these decisions, the Supreme Court’s review could offer much-needed clarity on how local governments can balance compassion for the homeless with the broader interests of public safety and land use regulations. The outcome of this legal battle may have far-reaching consequences for municipalities across the Western United States.

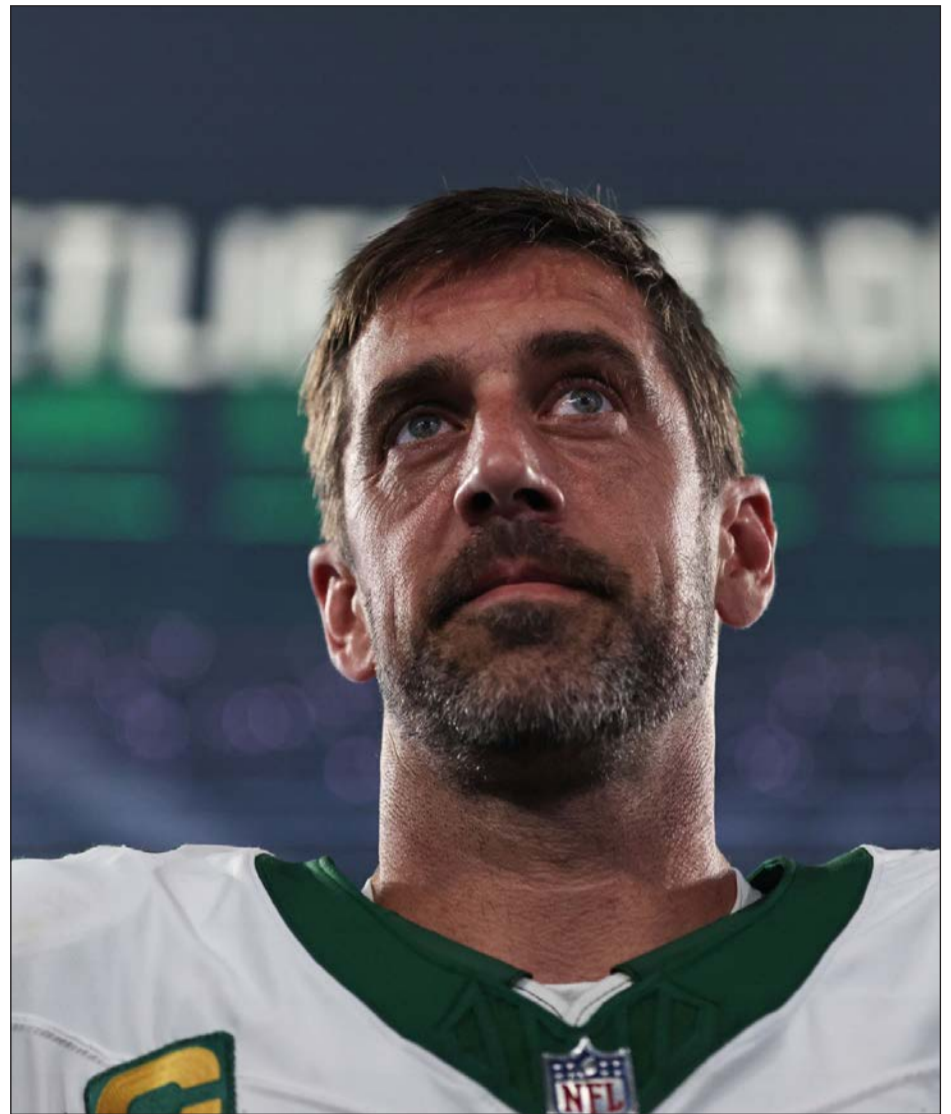

Low-Carbon Hydrogen Faces Cost Challenges, Calls for Support Grow

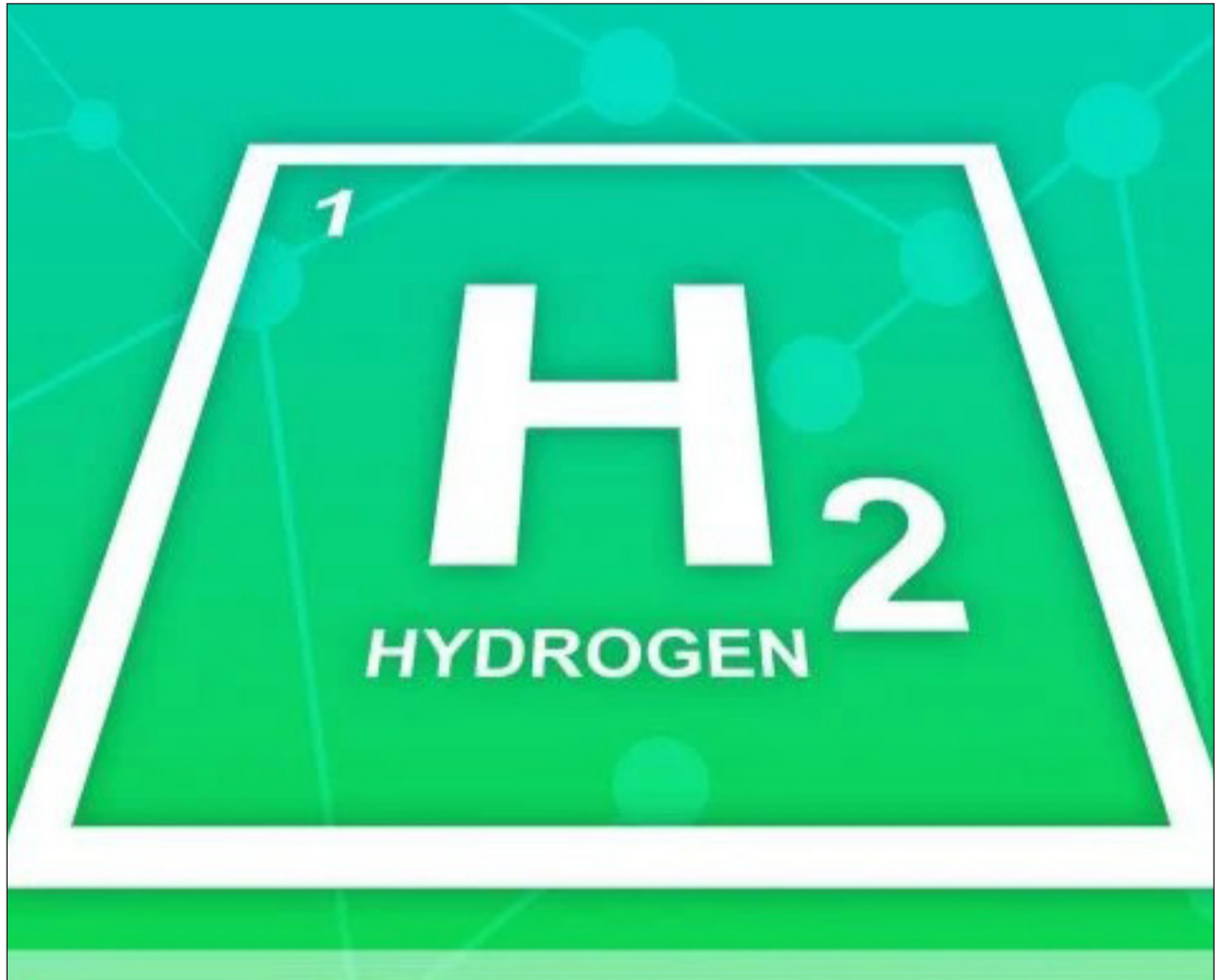

Hydrogen, known as a versatile energy carrier, finds applications in various sectors, including industry and transport.

Green hydrogen, produced via methods like electrolysis using renewable energy sources, is considered a cornerstone for achieving carbon neutrality. However, its current cost structure presents a significant challenge. Most hydrogen production still relies on fossil fuels, and green hydrogen production remains expensive.

The U.S. Department of Energy has embarked on the Energy Earthshots Initiative, with the initial goal of reducing the cost of clean hydrogen to \$1 per kilogram within a decade. Presently, green hydrogen costs hover around \$5 per kilogram, demonstrating the magnitude of the cost reduction required to make it a competitive



energy source.

Several countries are actively fostering bilateral partnerships to establish global hydrogen supply chains, ensuring a clean and secure hydrogen supply. With the right policies and technological advancements, some projections suggest that green hydrogen could become cost-competitive with other energy solutions as early as 2030.

However, the hydrogen economy faces what the WEC report terms a “chicken and egg problem” in terms of supply and demand. To establish a sustainable value chain, secure volumes of supply and demand must complement each other effectively.

Additionally, there is a growing debate surrounding the use of colors, such as brown, blue, gray, and pink, to classify hydrogen production methods based on their carbon footprint. Clear and

universally accepted color codes for specific technologies are needed to avoid prematurely dismissing potentially cost-effective solutions.

Despite these challenges, various firms are entering the green hydrogen sector. SSE Renewables and Siemens Gamesa Renewable Energy, for example, recently announced a partnership to explore opportunities related to green hydrogen production at selected wind farms in Scotland and Ireland.
