For top U.S. virus experts, faith and science work together

NEW YORK (AP) — The relationship between faith and science has faced its share of strain during the coronavirus pandemic — but for some scientists leading the nation's response, the two have worked in concert. National Institutes of Health Director Francis Collins founded a non-profit focused on "the harmony between science and biblical faith."

Anthony Fauci, NIH's senior infectious disease specialist, has said he isn't active in organized religion but credited his Jesuit schooling with burnishing the values that drive his public service. And Robert Redfield, director of the Centers for Disease Control and Prevention, describes his faith and his public health work as mutually reinforcing. "One of the great things about faith is, you can approach life with a sense of hope — no matter what the challenges you're dealing with, that there's a path forward," Redfield told The Associated Press.

The influence of faith on some of the government's top coronavirus fighters illustrates its complicated connection to science.

Tambe nan ta mira un 14% relaciona cu proyecto turistico. Despues cu nos pais a cay den un total recesion debi na e crisis di Coronavirus/Covid-19, e meta ta cu e proyectonan fast track lo yuda reactiva nos economia mas lihe posibel. Croes a bisa cu e balor total di e inversion ta casi 1 mion florin.

Tin 18 proyecto totalmente nobo riba seis sector cu Aruba ta cuminsa explora. Nan a bira un posibilidad pa trece diversidad den nos actividad economico cu pa basta aña a cay riba e pilar economico di turismo.

"Nan ta proyectonan hopi ambicioso y moderno," el a bisa. E ta haya cu e proyectonan aki mester bira e curason di nos economia pa futuro.

Nan ta proyectonan na balor di 47 mion. Un 27% ta relata na agricultura y tambe loke ta wordo yama economia nobo relaciona cu cannabis. Nan ta proyectonan cu a cuminsa cana nan caminda hayando financiamiento.

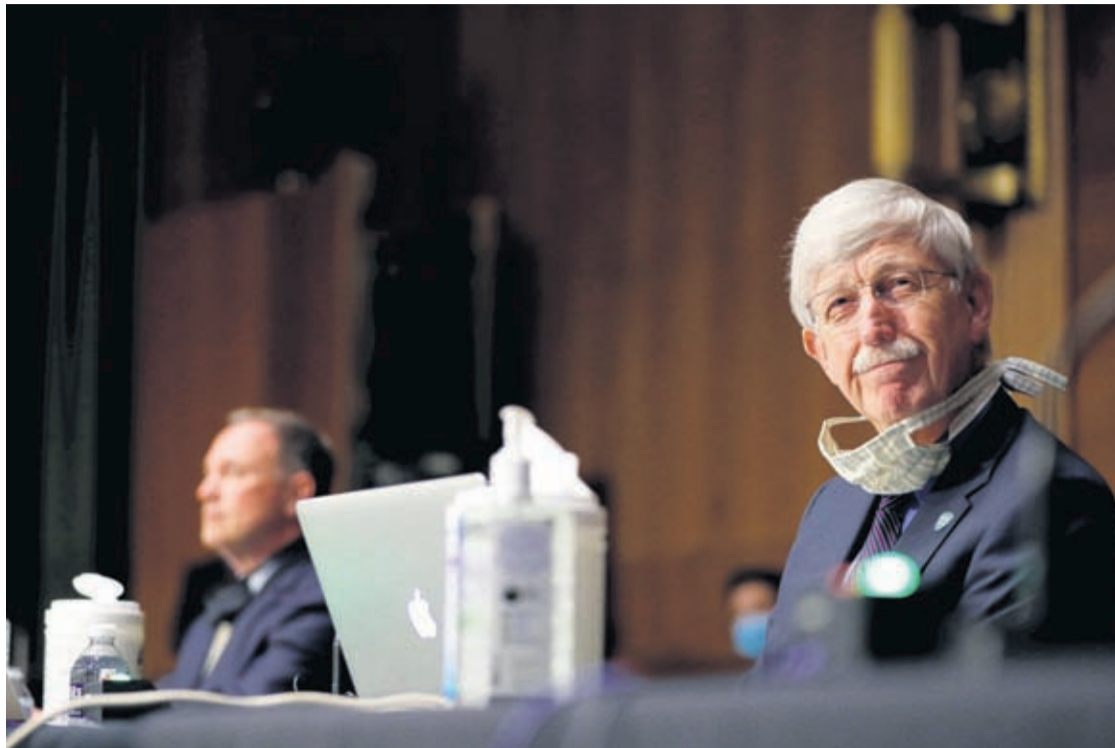
For top U.S. virus experts, faith and science work together

While tensions over public worship's effect on public health amid the pandemic – with President Donald Trump declaring religious services “essential” – personal spirituality, in all of its forms, remains an unquestioned guidepost for some scientists guiding the U.S. response.

Redfield said that during major crises he's faced, such as his role responding to 2010's Haiti earthquake and the death of his son, his faith had helped orient him toward the potential for “greater good” to arise from tragedy. Faith and science have not been in tension for him, Redfield said.

During the early weeks of the pandemic, the 68-year-old virologist was not as much of a fixture at the televised White House briefings as Fauci, his fellow Catholic. But Redfield's modesty is itself a facet of how his faith plays out in his public persona, as his longtime friend William Blattner put it. Redfield sees people of faith as “not holier than anybody – we're just who we are,” said Blattner, who co-founded University of Maryland's Institute of Human Virology alongside Redfield and a third prominent AIDS researcher, Robert Gallo, in the mid-1990s. “You don't see him jumping up to the microphone. You see him speaking as he's required,” Blattner said of his friend. Faith helps

Redfield “filter out the noise and distraction” of the push to contain the virus, Blattner added, affording “him, and us, the ability to see more clearly.”

Redfield was tapped by Trump, while Collins and Fauci's stints as government scientists predate 2016. Collins, for his part, was already a vocal advocate for communicating what he sees as the consistency between religious belief and evidence-based science before he was named to lead NIH.

After writing a 2006 book about his journey from youthful atheism to belief in God, the 70-year-old Collins founded the Bio-

Logos Foundation to help further a dialogue about religion's relationship to science. Since the pandemic began, he has received a major religion prize for his work.

“I see science as the most reliable way to study nature – and that includes this virus,” Collins said by email. “But science doesn't help me with deeper questions like why suffering exists, what we are supposed to learn from it, what is the meaning of life, and whether there is a loving God who grieves with us at a time like this,” he added. “For that, I rely on what I have learned as a person of faith.”

Collins lauded the majority

of American faith communities for treating the pandemic as an opportunity to live out their values by helping the vulnerable, adding that “most of that loving and altruistic behavior doesn't get much attention.” He also offered careful criticism for the “occasional examples of churches who reject the scientific conclusions and demand the right to continue to assemble freely, even in the face of evidence that this endangers their whole community.”

Trump on Friday called for governors to allow in-person worship, vowing that “faith leaders will make sure that their congregati-

ons are safe as they gather and pray.” The president spoke as the CDC released recommendations for safe reopening of physical religious services, and faith gatherings that occurred this week largely operated with safeguards in place to help prevent the virus' spread. Fauci's faith has shifted from the path of his Catholic upbringing to what he has described as a humanist belief system. The 36-year veteran chief of the National Institute of Allergy and Infectious Diseases told C-SPAN in 2015 that “I'm less enamored of organized religion than I am with the principles of humanity and goodness to mankind and doing the best that you can.”

While Fauci distanced himself from organized religion in that 2015 interview, he has described himself as Catholic and told C-SPAN his Jesuit education had helped develop the “principles that I run my life by.” Those principles came into sharper view this month when Fauci recorded a video for graduates of high schools affiliated with the Jesuits, a Catholic order that focuses on service.

After citing “precision of thought and economy of expression” as two watchwords, he invoked “social justice” as another value instilled by his Jesuit education. Fauci graduated in 1958 from New York's Regis High School, a Jesuit institution. □

Court denies request to revive U.S. pipeline permit program

BILLINGS, Mont. (AP) — A U.S. appeals court on Thursday turned down a request by the Trump administration and energy industry groups to revive a permit program for new oil and gas pipelines that had been canceled by a lower court. The case originated with a challenge to the Keystone XL oil pipeline from Canada to the U.S. but has affected oil and gas pipeline proposals across the nation. The U.S. Army Corps of Engineers permitting program allows construction of pipe-

lines across wetlands and other water bodies with minimal review if they meet certain criteria.

Backed by numerous states and industry groups, attorneys for the government argued the cancellation would delay construction of pipelines needed to deliver fuel to power plants and other destinations.

U.S. District Judge Brian Morris in Montana said May 11 that officials had failed to adequately consult with wildlife agencies before reauthorizing the permit-

ting program in 2017. Its continued use could cause serious harm to protected species and critical wildlife habitat, he said.

A two-judge panel of the 9th U.S. Circuit Court of Appeals denied an emergency request to block Morris' ruling.

They said in a one-page decision that the government, states and industry groups had not demonstrated sufficient harm to their interests to justify reviving the program while the case is still pending. □

Violent protests rock Minneapolis for 2nd straight night

MINNEAPOLIS (AP) — Violent protests over the death of a black man in police custody rocked a Minneapolis neighborhood for a second straight night as angry crowds looted stores, set fires and left a path of damage that stretched for miles. The mayor asked the governor to activate the National Guard.

The protests that began late Wednesday and stretched into Thursday morning were the most destructive yet since the death of George Floyd, who was seen on video gasping for breath during an arrest in which an officer knelt on his neck for almost eight minutes. In the footage, Floyd pleads that he cannot breathe and slowly stops talking and moving.

Mayor Jacob Frey sought calm. "Please, Minneapolis, we cannot let tragedy beget more tragedy," he said on Twitter.

Protests also spread to other U.S. cities. In California, hundreds of people

protesting Floyd's death blocked a Los Angeles freeway and shattered windows of California Highway Patrol cruisers. Memphis police blocked a main thoroughfare after a racially mixed group of protesters gathered outside a police precinct. The situation intensified later in the night, with police donning riot gear and protesters standing shoulder-to-shoulder in front of officers stationed behind a barricade.

Minneapolis police said the violence contrasted sharply with a mostly peaceful demonstration Tuesday afternoon at the street corner where Floyd died.

"They were chanting for things to remain peaceful," police spokesman John Elder said. "Tonight didn't have the same feel. And that's sad."

Pockets of looting continued Thursday. A liquor store employee displayed a gun as he stood among the debris of broken bottles and beer cans inside the business.

Amid the violence, a man

was found fatally shot Wednesday night near a pawn shop, possibly by the owner, authorities said.

Fire crews responded to about 30 intentionally set blazes during the protests, including at least 16 structure fires, and multiple fire trucks were damaged by rocks and other projectiles, the fire department said. No one was hurt by the blazes.

Firefighters were still spraying water onto hot buildings Thursday morning, and some buildings still smoldered, sending a bitter smell into the smoke-filled air.

Windows were smashed out of several businesses in a strip mall, including a department store, a charter school and other businesses, and the destruction was visible for blocks. A Wendy's restaurant was damaged beyond recognition.

Inside some of the stores, shelves were toppled and debris strewn about. Video taken inside a damaged Target that had been looted showed empty cloth-

ing racks. Obscenities were spray-painted on the outside of the store. Streets and parking lots were also covered in debris, and many businesses had been spray-painted.

There was no sign of a police presence, except around the precinct building, where officers were in riot gear. One man standing outside the building was using a bullhorn to shout. "I can't breathe, I can't breathe. Mama, I can't breathe," repeating some of Floyd's pleas for relief.

Across from the precinct, someone had spray-painted the sidewalk in red: "Where's humanity?"

Protesters began gathering Wednesday afternoon near the city's 3rd Precinct station, in the southern part of the city, where the 46-year-old Floyd died on Memorial Day as police arrested him outside a convenience store on a report of a counterfeit bill being passed. Demonstrators also skirmished with officers, who fired rubber bullets and tear gas in a repeat of

Tuesday night's confrontation.

The U.S. Attorney's Office and the FBI in Minneapolis said Thursday they were conducting "a robust criminal investigation" into Floyd's death and making the case a priority. The announcement came a day after President Donald Trump tweeted that he had asked an investigation to be expedited.

The FBI had already announced that it would investigate whether Floyd's civil rights were violated.

The officer who knelt on Floyd and three others were fired Tuesday. On Wednesday, the mayor called for him to be criminally charged.

Frey appealed to Gov. Tim Walz to activate the National Guard, a spokesman confirmed Thursday. The governor's office did not immediately respond to a request for comment. Walz tweeted for calm Wednesday night, calling the violence "an extremely dangerous situation" and urging people to leave the scene.

The last time the Minnesota National Guard was called out to deal with civil unrest was in a backup role during the 2008 Republican National Convention in St. Paul. The most comparable situation to the current disturbances happened when the Guard was called up to deal with the riots in Minneapolis in 1967, a summer when anger over racial inequalities came to a boil in many cities across the country.

The Minnesota National Guard was also called out during protests against the Vietnam War in the 1960s and early 1970s and during a 1986 strike by Hormel meatpackers in Austin. □



Chinese lawmakers endorse Hong Kong national security law

BEIJING (AP) — China's legislature endorsed a national security law for Hong Kong on Thursday that has strained relations with the United States and Britain and prompted new protests in the territory.

The National People's Congress approved the bill as it wrapped up an annual session that was held under intensive anti-coronavirus controls. The vote was 2,878-1 with six abstentions, in line with the high-profile but largely ceremonial body's custom of near-unanimous support for all legal changes decided by the ruling Communist Party. The law will alter Hong Kong's mini-constitution, or Basic Law, to require the territory to enforce measures to be decided by the NPC's standing committee, a small body controlled by the ruling party that handles most lawmaking work. The law reflects the determination of President Xi Jinping's government to tighten control over Hong Kong following 11 months of anti-government protests. Activists in Hong Kong say the law will undermine the "high degree of autonomy" promised to the former British colony when it was handed back to China in 1997 under a "one coun-

try, two systems" framework and might be used to suppress political activity. Premier Li Keqiang, the country's No. 2 leader, defended the law as consistent with Beijing's promises. "The decision adopted by the NPC session is designed for steady implementation of 'one country, two systems' and Hong Kong's long-term prosperity and stability," Li said at a news conference.

The law and the way it is being enacted prompted U.S. Secretary of State Mike Pompeo on Wednesday

to announce Washington will no longer treat Hong Kong as autonomous from Beijing. That could hurt the territory's attractiveness as a business center.

Pompeo's notice adds Hong Kong to the Trump administration's conflicts with China over trade, technology, religious freedom, Chinese handling of the coronavirus pandemic and the status of Taiwan, the self-ruled island Beijing claims as its own territory.

Li called for mutual respect and Sino-U.S. cooperation to promote "extensive

common interests" in resolving global problems and promoting trade, science and other fields.

"Both countries stand to gain from cooperation and lose from confrontation," Li said. On Thursday, three pro-democracy lawmakers were ejected from Hong Kong's legislative chamber during a debate over a bill that would criminalize insulting or abusing the Chinese national anthem.

Also Thursday, the NPC approved a government budget that will increase spending to generate jobs

to try to reverse an economic slump after Chinese industries were shut down to fight the coronavirus pandemic.

Private sector analysts say as much as 30% of the urban workforce, or as many as 130 million people, lost their jobs at least temporarily during the shutdown. They say as many as 25 million jobs might be lost for good this year.

The budget calls for giving local governments 2 trillion yuan (\$280 billion) to spend on meeting goals including creating 9 million new jobs. That is in line with expectations of higher spending but a fraction of the \$1 trillion-plus stimulus packages launched or discussed by the United States, Japan and Europe.

Li, the premier, said Beijing is in a "strong position to introduce new measures" if necessary but wants to avoid flooding the economy with too much money. He said 70% of planned spending is aimed at putting wages in workers' pockets in order to support consumer spending, the biggest driver of the economy.

"We will do our utmost to keep China's economic growth stable," Li said. "At the same time, we must make sure that all measures taken are well calibrated." □

Kosovo's caretaker governing party holds peaceful rally

PRISTINA, Kosovo (AP) — A few thousand supporters of Kosovo's left-wing governing party surrounded government buildings Thursday to oppose the nomination of a new prime minister by the small Balkan country's president. The participants maintained social distancing and wore masks and gloves during the demonstration around the parliament, main government and presidential buildings in Pristina. A big poster at the rally read, "We want elections."

A spokesman for the Self-Determination Movement, or Vetevendosje!, Arlind

Manxhuka, said the rally was intended to illustrate the party's ability to assemble a protest crowd while respecting the conditions during the coronavirus pandemic.

Kurti has led a caretaker government since he lost a no-confidence vote in late March initiated by the LDK, which at the time was the junior partner in a coalition government with Vetevendosje!

Vetevendosje! argues that the presidential decree nominating Avdullah Hoti to become prime minister is unconstitutional, claiming it is the only party entitled to form a new

Cabinet because it won the most seats in Kosovo's parliamentary election in October.

The party argues that if it is unable to put together a government, the country should have another election. Hoti's LDK says it has the required number of votes, at least 61 in the 120-seat parliament, for his confirmation.

Kosovo's Constitutional Court has suspended the nomination decree until May 29.

Kosovo was part of Serbia until an armed separatist uprising in 1998-1999 triggered a bloody Serb crackdown. A NATO

bombing campaign its troops and ended the forced Serbia to withdraw war. □

EU pledges to stay green in recovery from coronavirus

BRUSSELS (AP) — The European Commission pledged Thursday to stay away from fossil-fueled projects in its coronavirus recovery strategy, and to stick to its target of making Europe the first climate neutral continent by the mid-century, but environmental groups said they were unimpressed.

To weather the deep recession triggered by the pandemic, Commission President Ursula von der Leyen has proposed a €1.85 trillion (\$2 trillion) package consisting of a revised long-term budget and a recovery fund, with 25% of the funding set aside for climate action.

To help economies from the 27-nation bloc bounce back as quick as possible, the EU's executive arm wants to massively increase a 7.5-billion euro (\$8.25 billion) fund presented earlier this year that was part of an investment plan aiming at making the continent more environmentally friendly.

Under the commission's new plan, which requires the approval of member states, the mechanism will be expanded to 40 billion euros (\$44 billion) and is expected to generate another 150 billion euros in public

and private investment. The money is designed to help coal-dependent countries weather the costs of moving away from fossil fuels.

Environmental group WWF acknowledged the commission's efforts but expressed fears the money could go to "harmful activities such as fossil fuels or building new airports and motorways."

"It can't be used to move from coal to coal," Frans Timmermans, the commis-

sion executive vice president in charge the European Green Deal, responded on Thursday. "It is unthinkable that support will be given to go from coal to coal. That is how we are going to approach the issue. That's the only way you can ensure you actually do not harm."

Timmermans conceded, however, that projects involving fossil fuels could sometimes be necessary, especially the use of natu-

ral gas to help move away from coal.

The commission also wants to dedicate an extra 15 billion euros (\$16.5 billion) to an agricultural fund supporting rural areas in their transition toward a greener model.

Von der Leyen, who took office last year, has made the fight against climate change the priority of her term. Timmermans insisted that her goal to make Europe the world's first

carbon-neutral continent by 2050 remained unchanged, confirming that upgraded targets for the 2030 horizon would be presented by September.

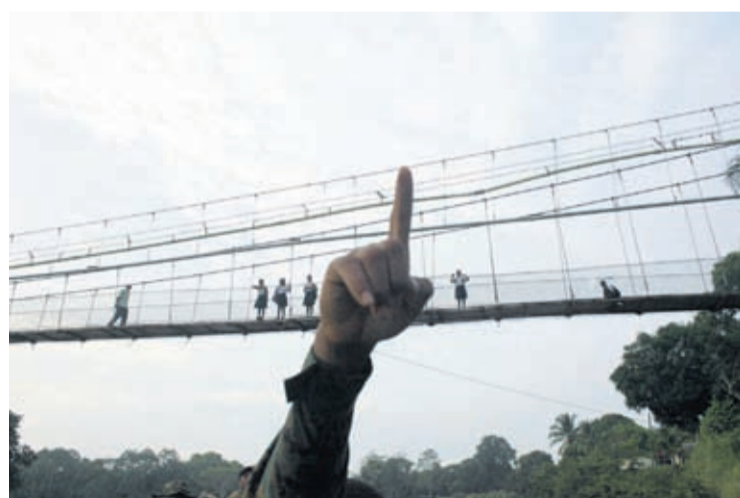
Reacting to the executive arm's recovery plans, Greenpeace lashed out at a project it described as "contradictory at best and damaging at worst," accusing the commission of sticking to a growth-driven mentality detrimental to the environment.

"The plan includes several eye-catching green 'options,' including home renovation schemes, taxes on single-use plastic waste and the revenues of digital giants like Google and Facebook. But it does not solve the problem of existing support for gas, oil, coal, and industrial farming — some of the main drivers of a mounting climate and environmental emergency," Greenpeace said.

"The plan also fails to set strict social or green conditions on access to funding for polluters like airlines or carmakers."

Timmermans said the EU will keep investing in the development of emission-free public transportation systems, and promoting clean private transport through the EU budget. □

Regional court orders Panama to protect migrants' health

PANAMA CITY (AP) — A regional human rights court has ordered Panama's government to immediately

provide medical care and more sanitary conditions for some 2,000 migrants detained near the Colombian border.

Prior to the novel corona-

virus pandemic, Panama had practiced what it called a "controlled flow," which allowed migrants emerging from the dangerous Darien jungle to rest at camps before boarding buses and continuing their journey up through Central America.

Now border police are holding migrants in those same centers as COVID-19 infections build.

Panama's government and the International Organization for Migration, which aids Panama in the area, did not immediately respond to requests for comment Thursday.

This week the Inter-American Court of Human Rights ordered the government to safeguard the welfare of

the migrants held in Peñitas and Lajas Blancas.

The migrants come from Haiti and Cuba, as well as African and Asian nations. About 80 infected with the virus were moved to Lajas Blancas, the second camp along the route. Dozens of others with symptoms or who had contact with the infected have been sent there as well.

The court said the Peñitas shelter was still far beyond its capacity with nearly 1,700 people there including more than 400 children. It ordered immediate "access to essential health services without discrimination to all of the people" in the camps. Vice-Minister of Foreign Affairs Federico Alfaro Boyd noted earlier this

week that Costa Rica and Nicaragua had closed their borders as well, making it impossible for the migrants to advance.

He said a strong effort was being made to provide the migrants with the medical care, as well as basics such as cots to sleep on and water.

The court has watched Panama closely since a 2002 case about human rights violations of an Ecuadorean migrant in Darien. The non-governmental Center for Justice and International Law monitors Panama's compliance. The center says that migrants crossing the Darien face a policy of automatic and arbitrary detention and overcrowded conditions. □

Too much TV? Enter HBO Max, the latest streaming wannabe

Is a pandemic the perfect time to launch a new and relatively expensive streaming service? AT&T sure hopes so.

The phone company is investing billions in HBO Max, its first big entertainment venture since it spent \$85 billion for Time Warner in 2018. The good news for its timing: millions are stuck at home, watching more video than ever. The bad news: many of them also out of work and carefully watching their incomes. The service launches Wednesday in the U.S.

"People are going to look at the price point first," said Steve Nason, research director at Parks Associates. HBO Max costs \$15, same as the HBO Now streaming service it's supposed to replace, with discounts after the launch limited to some AT&T customers as well as a one-week free trial. Other new streaming services such as Disney Plus and Quibi launched with cheaper prices and bigger discounts.

Entertainment companies like AT&T's WarnerMedia are broadly shifting to streaming video, following in Netflix' wake, as more people drop their traditional cable bundles. Disney launched Disney Plus and the sports-focused ESPN Plus and took control of Hulu from an industry joint venture. Comcast's NBCUniversal is launching Peacock widely this summer. ViacomCBS is redoing CBS All Access, pumping it up with more programming. Even Fox Corp. has its Fox Nation app. Apple, a tech company, started a small service of its own. A short-video service targeted to cellphones, Quibi, also hopes to get in on the streaming pie; it hasn't had much success yet.

HBO Max comes stacked with goodies, like browsing a particularly pleasing Blockbuster store — classic quality-TV series from HBO like "The Sopranos," "The Wire" and "Sex and the City;" comfort-food network TV in "Friends" and "The Big Bang Theory;" Superman and Bat-

man movies from DC. The Warner Bros. film library stretches back decades to Hollywood's golden age. There's even a reboot of Looney Tunes.

"Maybe timing is actually good," said Wells Fargo analyst Jennifer Fritzsche. "There might be a Netflix exhaustion factor." Netflix has predicted extremely strong subscriber gains for this quarter.

But people will have to decide if it's worth paying up for a new video service on top of the "foundational" services many already have: Netflix, the heaps of video that come with an Amazon Prime membership, Hulu and, increasingly, Disney Plus, Nason said. The company has predicted 50 million U.S. subscribers by 2025, building on a base of 36 million current HBO customers, per research firm S&P Global. That number includes people who pay their cable company for the channel and the HBO Go app as well as those who subscribe to the HBO Now standalone streaming service.

WarnerMedia would like to convert those users to HBO Max, but there are contract issues that muck it up and could potentially antagonize customers.

"The confusion point is one we've obsessed over for a year," said Andy Forsell, the general manager of WarnerMedia's direct-to-consumer arm.

It's easy to prompt HBO Now users to switch to Max if they signed up directly through HBO, and many big cable companies have agreed to promote HBO Max to their existing HBO customers. But there's no deal yet with Roku and Amazon, so people who signed up for HBO through them won't easily have access to Max on a TV. That's likely to be resolved, Nason predicted.

Another weak point for WarnerMedia is that the coronavirus pandemic has shut down Hollywood productions, and that's expected to slow down the rollout of HBO Max's original productions, such as a highly anticipated "Friends" reunion special that was supposed

to be ready for launch. But that impact will be felt more in 2021 than this year, Forsell said. Originals are important because they help bring on subscribers and get them to keep paying, month after month. For AT&T, getting HBO Max right is critical. Its DirecTV satellite service is bleeding customers, and the traditional TV model is under threat from industry-wide cord-cutting and, recently, a coronavirus-related advertiser retreat. (AT&T owns TBS, TNT, CNN and other networks.) □

'The Vast of Night' is a cunning lo-fi sci-fi noir

"The Vast of Night," a micro-budget noir set in 1950s New Mexico, crackles with B-movie electricity.

The film is one of those little miracles: a directorial debut, made for nothing, that establishes a young filmmaker of self-evident command. With atmosphere and cunning, director Andrew Patterson steers "The Vast of Night" through the soft, shadowy night air of a small and quaint borderland town where unseen mysteries lurk.

The set-up may sound

vaguely familiar, and it is. "The Vast of Night" is framed as an episode of "Paradox Theater," a "Twilight Zone" knockoff that opens by warning the TV viewer: "You are entering the realm between the clandestine and the forgotten."

But "The Vast of Night" is more than the pastiche it pretends to be, and it shows plenty of B-movie moves of its own. That made "The Vast of Night" a festival hit last year after it premiered at the Slamdance Film Festival. Amazon subsequently picked it up and will begin streaming the film Friday.

"The Vast of Night" has also already been playing at a handful of drive-ins, where its period setting and old-fashioned sci-fi intrigue make it very possibly the most drive-in-ready movie of the pandemic.

It also works just fine at home. The film takes place during the first high school basketball game of the season in Cayuga, New Mexico. The game has drawn most of the town's 492 population to the gym, where the camera trails Everett (Jake Horowitz), a fast-talking student and radio DJ who already looks

and sounds ready to join Edward R. Murrow at CBS.

He's showing Fay (Sierra McCormick), a 16-year-old switchboard operator with a new audio recorder, some of the basics of reporting as they circle the gym and the already-bustling parking lot.

They're both bright, ambitious teenagers in dark-framed glasses. Fay excitedly recounts the future predictions of a magazine article that forecast "vacuum-tube transportation" and telephone numbers assigned at birth. While strolling on a quiet, dark

lane beneath leafy trees and talking of a semi-true future, they seem momentarily out of time.

Science and technology hover around "The Vast of Night"; power outages at the school are rumored to be caused by squirrels eating the wires. And once Everett is at the radio station and Fay is plugged in at the switchboard, they hear a strange sound interrupting the transmission. Something, people are saying, is in the sky.

Working from Fay's recording, they quickly investigate with the guidance of an ominous caller. The secret seems to have only been glimpsed by witnesses that others have ignored — a black man, an old woman. "The Vast of Night" is, in a slinky way, about escaping small-town small-mindedness.

Patterson, who came up with the concept for James Montague and Craig W. Sanger's script, occasionally lets his camera prowl the Cayuga streets. He and the cinematographer M.I. Littin-Menz conjure the feeling that something is indeed in the air — something that momentarily crosses with the frequency of Orson Welles' "War of the Worlds" broadcast, before the signal cuts out. □

Leatherback Turtle hatching on Eagle Beach



EAGLE BEACH — Last Wednesday, May 27, a Leatherback Turtle hatching took place on Eagle Beach, just in front of the Bucuti & Tara Beach Resort. Saturday May 23 World Turtle Day was celebrated to bring attention to, and increase knowledge of turtles and tortoises.

On Aruba the foundation Tortugaruba undertakes action to make the turtles survive and thrive. Four species of sea turtles are found nesting on Aruba: The Leatherback, the Loggerhead, the Green and the Hawksbill.

82 eggs hatched and these newborn baby turtles came up from below the sand from a hole that the mother had dug and filled with eggs about 60 days ago. The pictures, made by Ken Grille, feature multiple baby turtles hatching out of their eggs in the sand at the same time. Tortugaruba Foundation monitor every nest, block it off, and educate people on how to keep the turtles safe as they hatch.

- Sea Turtles do not nest every year, but rather every 2-5 years.
- The Leatherback Sea Turtles of Aruba lay about 115 eggs a clutch.
- The Leatherback female will nest 6 – 8 times a season.
- It is estimated that only 1 in 1000 hatchlings survives to maturity.
- All species of sea turtles are endangered and need our protection.
