## 4 Minneapolis cops now charged in George Floyd's death

**MINNEAPOLIS (AP)** — Prosecutors charged a Minneapolis police officer accused of pressing his knee against George Floyd's neck with second-degree murder on Wednesday, and for the first time leveled charges against three other officers at the scene, according to criminal complaints.

The updated criminal complaint against Derek Chauvin says the officer's actions were a "substantial causal factor" in Floyd's death.

"Officer Chauvin's restraint of Mr. Floyd in this manner for a prolonged period was a substantial causal factor in Mr. Floyd losing consciousness, constituting substantial bodily harm, and Mr. Floyd's death as well," the criminal complaint said.

The complaints against the other officers allege they aided and abetted in Chauvin's actions.

Widely seen bystander video showing Floyd's May 25 death has sparked protests nationwide and around the world against police brutality and discrimination.

“E maestronan di Colegio Arubano no tin confiansa den dicho directiva cu ta na mando desde 3 aña caba”, Lardey a expresa.

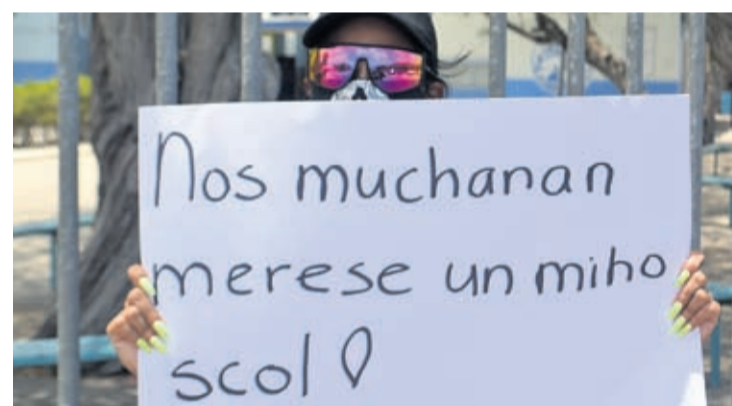

Tocante esaki, Vargas a splica cu hende por haci un actividad fisico aerobico, como canamento cu ta fortifica e sistema inmunologico desde e punto di bista deportivo. Landamento ta otro actividad cu ta bon pa hende por haci, asina como tambe compana ehercicio cu un bida mas saludabel.

Vargas a comenta cu ta existi hopi hende cu a haya falta di bay gym y entrena duro. Pa deporte di halto rendimiento tin un momento na unda e sistema inmunologico di e persona ta baha y por haya grip of algun tipo di malesa. "Si e persona ta entrena hopi duro, e sistema inmunologico ta baha pasobra e curpa tin stress y e celula cytokine, cu ta protege e curpa, ta subi."

Asina mes, el a sigura cu e parti psicologico ta haya un mehoracion cu actividad fisico, ta haci e persona mas relax. 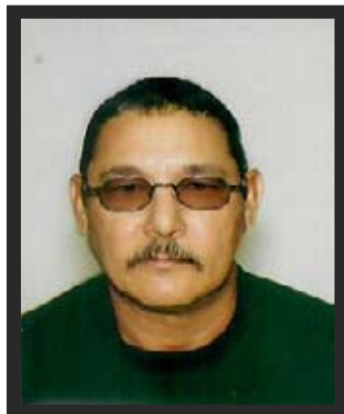

Chauvin was fired May 26 and initially charged with third-degree murder and second-degree manslaughter. The three other officers involved were also fired but were not immediately charged.

Minnesota Attorney General Keith Ellison updated the complaint against Chauvin to add a charge of unintentional second-degree murder, in addition to the earlier charges. He also charged Thomas Lane, J. Kueng and Tou Thao with aiding and abetting second-degree murder and second-degree manslaughter.

The unintentional second-degree murder charge alleges that Chauvin caused Floyd's death without intent while committing another felony offense, namely third-degree assault. It carries a maximum penalty of 40 years in prison, compared with a maximum of 25 years for third-degree murder.

The other officers face the same maximum penalties for aiding and abetting, if convicted.

Ellison was expected to talk about the new charges on Wednesday afternoon.

Attorney Earl Gray, who represents Lane, told The Associated Press that he hadn't seen the complaint or talked with his client. He said Lane was not in custody. Before news of the upgraded charges, an attorney for Chauvin said he was not making any statements at this time. Attor-

neys for Thao and Kueng did not return messages seeking comment on the charges.

Attorney Ben Crump tweeted that the Floyd family was "deeply gratified" by Ellison's action and called it "a source of peace for George's family in this difficult time." He said Ellison had told the family his office will continue to investigate and upgrade charges against Chauvin to first-degree murder if warranted. Reached by phone, Crump declined to speak beyond the statement or make clear when Ellison had spoken with the family and whether he had been informed directly that additional charges had been filed.

Floyd's family and protesters have repeatedly called for criminal charges against all four officers as well as more serious charges for Chauvin, who held his knee to Floyd's neck, despite his protests that he couldn't breathe, and stayed there even after Floyd stopped moving. Floyd, a black man, was in handcuffs when he died with his face pressed to the street.

"He died because he was starving for air," Crump said at a news conference earlier Wednesday. "He needed a breath. So we are demanding justice. We expect all of the police officers to be arrested before we have the memorial here in Minneapolis, Minnesota, tomorrow."

Crump said the other officers failed to protect a

man who was pleading for help and said he couldn't breathe.

Personnel records released by the city show Chauvin served as a military policeman in the U.S. Army in the late 1990s. Since being hired as a police officer in 2001, he has been awarded two medals of valor: One for being part of a group of officers who opened fire on a stabbing suspect after the man pointed a shotgun at them in 2006, and one for apprehending another man in a domestic incident in 2008. In the latter incident, Chauvin broke down a bathroom door and shot the man in the stomach.

Chauvin was reprimanded in 2008 for pulling a woman

out of her car in 2007, frisking her and placing her in his squad car after he stopped her for speeding 10 miles per hour over the limit. His dashboard camera was not activated and a report said he could have interviewed the woman while standing outside her car.

Lane, 37, and Kueng both joined the department in February 2019 and neither have any complaints on their files.

Lane previously worked as a correctional officer at the Hennepin County juvenile jail and as a probation officer at a residential treatment facility for adolescent boys. Kueng was a 2018 graduate of the Univer-

sity of Minnesota where he worked part-time on campus security. He also worked as a theft-prevention officer at Macy's in downtown Minneapolis while he was in college. Tou Thao, a native Hmong speaker, joined the police force as a part-time community service officer in 2008 and was promoted to police officer in 2009. He was laid off later that year due to budget cuts and rehired in 2012.

Gov. Tim Walz and the Minnesota Department of Human Rights on Tuesday launched a civil rights investigation of the Minneapolis Police Department and its history of racial discrimination, in hopes of forcing widespread change. □

## Safety board asks helicopter makers to install 'black boxes'

Federal safety investigators bypassed aviation regulators on Tuesday and urged leading helicopter manufacturers to install so-called black boxes that would help determine the cause of crashes such as the one that killed former NBA star Kobe Bryant.

The National Transportation Safety Board appealed directly to six manufacturers after the Federal Aviation Administration failed to act on the board's recommendations to require the devices on most helicopters.

The safety board said turbine-powered helicopters should record data, audio and images during flight.

The NTSB identified seven crash investigations between 2011 and 2017 in which it said the lack of recorder information slowed its ability to find potential safety issues.

"The more information we have, the better we can understand not only the circumstances of a crash, but what can be done to prevent future accidents," said Dana Schulze, director of aviation safety for the NTSB. The NTSB's move is highly

unusual. The board investigates accidents but has no authority to make regulations; that falls to the FAA. The board said it recommended flight-data and cockpit-voice recorders in 2013 and 2015, but the FAA did not act. The request for image-recording capability is new.

The FAA has required flight-data recorders on helicopter ambulances since 2018. In a statement Tuesday, the FAA said it encourages other helicopter operators to use data-gathering systems and analyze the information to improve safety. □



# Malaria drug fails to prevent COVID-19 in a rigorous study

A malaria drug President Donald Trump took to try to prevent COVID-19 proved ineffective for that in the first large, high-quality study to test it in health workers and others closely exposed to people with the disease. Results published Wednesday by the New England Journal of Medicine show that hydroxychloroquine was no better than placebo pills at preventing illness from the coronavirus. The drug did not seem to cause serious harm, though -- about 40% on it had side effects, mostly mild stomach problems.

"We were disappointed. We would have liked for this to work," said the study leader, Dr. David Boulware, an infectious disease specialist at the University of Minnesota. "But our objective was to answer the question and to conduct a high-quality study," because the evidence on the drug so far has been inconclusive, he said.

Hydroxychloroquine and a similar drug, chloroquine, have been the subject of much debate since Trump started promoting them in March. Hydroxychloroquine has long been used for malaria, lupus and rheumatoid arthritis, but no large studies have shown it or chloroquine to be safe

or effective for much sicker patients with coronavirus, and some studies have suggested the drugs may do harm.

Trump took a two-week course of hydroxychloroquine, along with zinc and Vitamin D, after two staffers tested positive for COVID-19, and had no ill effects, according to results of his latest physical released by his doctor Wednesday. Federal regulators have warned against their use except in hospitals and formal studies because of the risk of side effects, especially heart rhythm problems.

Boulware's study involved 821 people in the United States and Canada living with someone diagnosed with COVID-19 or at high risk of getting it because of their job -- doctors, nurses, ambulance workers who had significant exposure to a sick patient while not wearing full protective gear.

They were randomly assigned to get either placebo pills or hydroxychloroquine for five days, starting within four days of their exposure.

Neither they nor their doctors knew who who was

getting what.

After 14 days in the study, 12% on the drug developed COVID-19 symptoms versus 14% in the placebo group, but the difference is so small it could have occurred by chance, Boulware said.

"There's basically no effect. It does not prevent infection," he said of the drug. Even if it were to give some slim advantage, "we'd want a much larger effect" to justify its use and risk of side effects for preventing illness, he said.

Results were no different among a subgroup of par-

ticipants who were taking zinc or vitamin C, which some people believe might help make hydroxychloroquine more effective.

"This fits with everything else we've seen so far which suggests that it's not beneficial," said Dr. Peter Bach, director of a health policy center at Memorial Sloan Kettering Cancer Center in New York.

This study was in younger relatively healthy people, but the results "would make me very discouraged about trying to use this in older people" who are most vulnerable to serious illness from the coronavirus, Bach said. "If it does work, it doesn't work very well."

Dr. Dan Culver, a lung specialist at the Cleveland Clinic, said there's still a chance that giving the drug sooner than four days after someone's exposure to the virus may help prevent illness.

But the study "takes 'home run' off the table" as far as hopes for the drug, he said. The study was mostly funded by David Baszucki, founder of Roblox, a California-based game software company, and other private donors and the Minnesota university.

Boulware also is leading a study testing hydroxychloroquine for treating COVID-19. The study is finished and results are being analyzed now. □

# Cinema chain AMC warns it may not survive the pandemic

Movie theater chain AMC warned Wednesday that it may not survive the coro-

navirus pandemic, which has shuttered its theaters and led film studios to explore releasing more movies directly to viewers over

the internet.

All of AMC's theaters are shut down through June, which means the company isn't generating any revenue. AMC said it had enough cash to reopen its theaters this summer, as it plans to do. But if it's not allowed to reopen, it will need more money, which it may not be able to borrow. The company said that even when local governments allow theaters to reopen, AMC may still have problems if entertainment companies delay releasing new films.

"Due to these factors, substantial doubt exists about our ability to continue as

a going concern for a reasonable period of time," AMC wrote in a regulatory filing. And people may not want to go sit in crowded spaces because they fear the virus. AMC believes that desire for social distancing is temporary and that people will want to go to the movies again.

Apart from the pandemic and its economic aftershocks, the movie business in the U.S. and Canada has benefited from rising ticket prices, but admissions have been gradually declining since 2005. Sequels, remakes and superhero movies dominate the box office. Meanwhile, the

rise of streaming services — Netflix and a growing stable of rivals — is providing new competition. Theater chains are also concerned that film studios could push more movies straight to the streaming services that they own. Since the pandemic shut down theaters, entertainment companies have delayed most movies. But Comcast's NBCUniversal released "Trolls World Tour" on video on demand in April, triggering an angry response from the theater industry, and Disney will release "Artemis Fowl" to its streaming service, Disney Plus, in June, rather than in theaters. □



# Scientist defends Sweden's hotly debated virus strategy

**STOCKHOLM (AP)** — Sweden's chief epidemiologist on Wednesday defended his country's controversial coronavirus strategy, which avoided a lockdown but resulted in one of the highest per capita COVID-19 death rates in the world. Anders Tegnell of the Public Health Agency denied that "the Swedish strategy was wrong and should be changed. That's not the case."

"We still believe that our strategy is good, but there is always room for improvement. ... You can always get better at this job," Tegnell told a news conference in Stockholm.

Sweden has stood out among European nations and the world for the way it has handled the pandemic, not shutting down the country or the economy like other nations but relying on citizens' sense of civic duty. Swedish authorities have advised people to practice social distancing, but schools, bars and restaurants have been kept open the entire time. Only gatherings of more than 50 people have been banned.

Tegnell's statement to reporters came after more contrite comments earlier in the day to Swedish radio in which he said "I think there is potential for improvement in what we have done in Sweden, quite clearly."

Asked if the country's high death toll has made him reconsider his unique approach to the pandemic, Tegnell told Swedish radio "yes, absolutely."

According to the national health agency, Sweden, a nation of 10.2 million people, has seen 4,542 deaths linked to COVID-19, which is far more than its Nordic neighbors and one of the highest per capita death rates in the world. Denmark has had 580 coronavirus deaths, Finland has seen 320 and Norway has had 237, according to a tally by Johns Hopkins University.

"If we were to encounter the same disease again, knowing precisely what we know about it today, I think we would settle on doing something in between what Sweden did and what the rest of the world has done," Tegnell, considered the architect of the unique Swedish pandemic approach, told SR.

Still, authorities in Sweden, including Tegnell, have

been criticized — and some have apologized — for failing to protect the country's elderly and nursing home residents.

But Tegnell said Wednesday it was still unclear what the country should have done differently. He also said other nations are unable to tell exactly what measures affected the outcomes of their outbreaks because they threw everything at the crisis at once.

"Maybe we know that now, when you start easing the measures, we could get some kind of lesson about what else, besides what we did, you could do without a total shutdown," Tegnell said in the radio interview.

At the news conference, Tegnell made it clear that his previous statement "was an admission that we always can become better.

I'm sure my colleagues all over the world would say the same thing. There are always aspects which we could have handled this situation even better than we do today, now, as we learn more and more things," he told The Associated Press.

"Sometimes I feel like a personal punchbag, but that's OK. I can live with that," Tegnell added.

Sweden's COVID-19 infection rate of 43.2 deaths per 100,000 inhabitants is lower than Spain's (58.1) and Italy's (55.4), but is higher than reported rates in the United States (32.1) and Brazil (14.3), according to Johns Hopkins University.

Last week, the country's former state epidemiologist, Annika Linde, said in retrospect she believes an early lockdown could have saved lives in Sweden. Po-

litical pressure has also forced the Swedish government to speed up an investigation into the handling of the pandemic.

Ordinary Swedes are not sure what to think.

"I'm not walking around thinking that we have a real disaster here in Sweden," Jan Arpi, a 58-year-old sales executive, told The Associated Press. "I think we have it more or less under control, but we have to be even more careful now after we learned how the virus is spread, especially among elderly people."

Tegnell's pandemic tactics made Sweden a bit of a local pariah in the Nordics and didn't spare the Swedish economy.

Sweden's economy, which relies heavily on exports, is expected to shrink 7% in 2020 and the finance minister says the Scandinavian country is headed for "a very deep economic crisis." More than 76,000 people have been made redundant since the outbreak began and unemployment, which now stands at 7.9%, is expected to climb higher.

On the travel front, neighboring Norway and Denmark said they were dropping mutual border controls but would keep Sweden out of a Nordic "travel bubble."

The Danes said they will reopen the border next month to residents of Germany, Norway and Iceland as the country eased its coronavirus lockdown. But Denmark, which has a bridge that goes directly into Sweden, has postponed a decision reopening to Swedish visitors until after the summer. □

# Syria says new wave of U.S. sanctions is 'economic terrorism'

**DAMASCUS, Syria (AP)** — The Syrian government condemned Wednesday a new wave of U.S. sanctions against the country, calling the measures "economic terrorism" that will increase the suffering of the Syrian people.

A Foreign Ministry statement said Washington's

so-called Caesar Syria Civilian Protection Act, which goes into effect this month, is based on "lies and fabricated claims by enemies of the Syrian people."

The act, which gained bipartisan support in Congress in December, envisages sanctions on Syrian troops and others respon-

sible for atrocities committed during Syria's civil war and funding for war crimes investigations and prosecutions. President Donald Trump later signed the National Defense Authorization Act, which includes the Caesar act, into law.

Caesar is a code name for a Syrian forensic photogra-

pher who took thousands of photographs of victims of torture and other abuses and smuggled them out of the country. The images, taken between 2011 and 2013, were turned over to human rights advocates, graphically exposing the scale of the Syrian government's brutal crackdown.

The bill applies sanctions to those who lend support to "the Assad regime's military efforts" in the war, and grants authorities to the U.S. secretary of state to support entities collecting evidence and pursuing prosecutions against those who have committed war crimes in Syria. □

## Germany wants to kick extremists out of military faster

**BERLIN (AP)** — The German government has agreed on a bill that would speed up the dismissal of soldiers involved in extremism or serious crimes.

Current military rules mean that soldiers who have served for more than four years can only be kicked out after they have been convicted of a crime or removed as part of a court-ordered disciplinary procedure. In practice, this can mean soldiers remain in the military for years until they are removed. The bill proposed Wednesday by Defense Minister Annegret Kramp-Karrenbauer allows the military to swiftly expel soldiers

if their continued presence would "seriously threaten the military order or the reputation of the Bundeswehr" and they have served fewer than eight years.

German officials have expressed alarm over the recent discovery of several far-right extremists in the military, including a member of the special forces unit KSK who had hoarded weapons, ammunition and explosives at home. Last month, the head of the unit, Brig. Gen. Markus Kreitmayer, told soldiers that he wouldn't tolerate extremism in the ranks.

The bill still needs to be passed by parliament. □

## EU, China postpone September summit due to pandemic

**BERLIN (AP)** — The European Union and China have agreed to postpone a summit planned for this fall because of the coronavirus pandemic, German officials said Wednesday.

Germany's Chancellor Angela Merkel spoke by phone with Chinese President Xi Jinping and later with European Council President Charles Michel to discuss the Sept. 14 meeting, due to be held in the German city of Leipzig and

seen as a key moment in EU relations with China.

In a statement, Merkel's office said the three sides agreed that "the meeting can't take place at the envisaged time due to the overall pandemic situation." They also agreed to hold it at a later date and to discuss further details soon.

The European Union has tried to position itself as a mediator between China and the United States. □

## Australia police reject comparison to U.S. over teen's arrest

**CANBERRA, Australia (AP)**

— Australian police on Wednesday rejected comparisons to the U.S. after an indigenous teenager was injured while being arrested in Sydney, though a government leader said it raised questions about race relations and the teen's family called for the officer involved to be charged.

A New South Wales state police constable is under internal investigation after he pinned the 16-year-old's arms behind his back then kicked his legs out from under him on Monday. A video had circulated on social media of the teen falling face-first to the ground.

Police have said the officer was in the inner-suburb of Surry Hills for an unrelated reason when he struck up a conversation with the teenager and his four companions. The video showed the teen threatened to break the police officer's jaw, and the officer's response was to arrest him.

"We have probably the best relationship between the community and the police of any jurisdiction around the world," Police Minister David Elliott told reporters.

He said the police response

"was not unprovoked."

"The important message here is that Sydney is not Minnesota," Elliott said, referring to the death of George Floyd. "What happened in the United States is not what happens here." He said he rejects claims that Australian police "have similar problems that exist in the United States."

But New South Wales Premier Gladys Berejiklian said the teen's arrest raised questions about race relations in Australia.

"I thought what most Australians thought and that is we still have a long way to go in our country," Berejiklian said of the video.

"I think what's happened in the U.S. is a good wake-up call for all of us and I think all of our hearts are breaking as to what's happening in the United States and we certainly have to ensure that we do what we can in our own country to protect all of our citizens," she added.

Indigenous Australians are 2% of the Australian adult population but 27% of the prison population. A total of 432 indigenous Australians have died in police detention and prison since 1991, according to a running analysis by The Guardian newspaper.

Australia's indigenous people also have higher-than-average rates of infant mortality and poor health, as well as shorter life expectancy and lower levels of education and employment than other Australians.

The police officer involved in the Sydney arrest has been restricted on what duties he can perform while his use of force is investigated. The teen, who cannot be identified, was not charged and was taken to a hospital for a medical examination. He suffered grazes to his face and a chipped tooth.

The teen's father, mother and sister held a news conference flanked by lawyers in which the family called for the officer to be charged and the incident to be investigated independent of police.

The family cannot be identified under state law to conceal the teen's identity. The family took a knee during the news conference in respect for Floyd.

The teen's father said what happened to his son echoed experiences he had when he was young, but back then people didn't have smartphones and social media to draw attention to it. □



# Zoom booms as pandemic drives millions to its video service

**SAN RAMON, Calif. (AP)** — Zoom Video Communications is rapidly emerging as the latest internet gold mine as millions of people flock to its conferencing service to see colleagues, friends and family while tethered to their homes during the pandemic. Tuesday's release of the once-obscure company's financial results for the February-April period provided a window into the astronomical growth that has turned it into a Wall Street star.

Zoom's revenue for its fiscal first-quarter more than doubled from the same time last year to \$328 million, resulting a profit of \$27 million — up from just \$198,000 a year ago.

The numbers exceeded analysts' already heightened expectations, providing another lift to a rocketing stock that has more than tripled in price so far this year while the benchmark Standard & Poor's 500 index has fallen 5%.

After a big run-up leading up to Tuesday's highly anticipated announcement, Zoom's stock initially rose even higher in extended trading. But it abruptly reversed course and fell more than 3% after company executives acknowledged during a video discussion that some of its newfound users might depart during the second half of the year if health worries caused by the novel coronavirus dissipate.

Even if the shares trade in similar fashion during Wednesday's regular session, the stock will still be hovering around \$200 — more than five times the company's initial public offering price of \$36 less than 14 months ago.

The surge left Zoom with a market value of about \$59 billion through Tuesday — greater than the combined market values of the four largest U.S. airlines, which have seen their businesses hammered by the coronavirus outbreak that has dramatically curtailed travel. "Videoconferencing is going to become a mainstream service," predicted

Zoom CEO Eric Yuan, who co-founded the company nine years ago. He made the remarks during the video conference that at one point attracted more than 3,000 participants, a reflection of the intense interest in the company and its hot stock.

In a sign that the company still expects phenomenal growth in the months ahead, Zoom forecast revenue of roughly \$500 million for its current quarter ending in July, more than quadrupling from the same time last year. For its full fiscal year, Zoom now expects revenue of about \$1.8 billion, nearly tripling in a year.

Zoom's boom has come despite privacy and security problems that enabled outsiders to make uninvited — and sometimes crude — appearances during other people's video conferences.

The concerns prompted some schools to stop using Zoom for online classes that have become widespread since February, although the company's efforts to introduce more security protection has brought some back to the service. More than 100,000 schools worldwide are now using Zoom for online classes, according to the company.

Overall, Zoom now has more than 300 million daily

participants attending a meeting held on its service, up from 10 million five months ago. Those numbers include people who join multiple Zoom meetings during the same day, something that has been happening more recently in recent months.

But the once-weak privacy controls also helped make Zoom extremely easy to use, one of the reasons it became such a popular way to hold online classes, business meetings and virtual cocktail hours after most of the U.S. began ordering people to stay at home in effort to reduce the spread of the coronavirus that causes COVID-19. Zoom also offers a free version of its service, another factor in its popularity at a

time when about 40 million people in the U.S. have lost their jobs since mid-March, raising the specter of the worst economic downturn since the Great Depression of the 1930s.

The San Jose, California, company has always made most of its money from companies that subscribe to a more sophisticated version of its service that traditionally has been used for business meetings among employees working in offices far apart from each other.

But the pandemic-driven shutdown turned Zoom into a tool for employees who once worked alongside each other, but have been doing their jobs from home during the past few months.

Zoom ended April with 265,400 corporate customers with at least 10 employees, more than quadrupling from the same time last year. About 30% of the company's revenue in the most recent quarter came from users with fewer than 10 employees, up from 20% in the November-January period.

Although Zoom remains focused on servicing its corporate customers, Yuan is hoping to figure out ways to make money from the all the socializing and learning that is happening on the service, too. Some analysts have speculated that eventually may involve showing ads on the free version of Zoom, although the company hasn't given any indication it will do that. "There are a lot of opportunities ahead of us," Yuan said in Tuesday's video conference without elaborating.

If it hopes to continue to expand, Zoom also will likely have to do a better job of protecting the privacy of its video conferences. To help achieve that goal, Yuan has been consulting since April with Alex Stamos, a highly respected online security expert who previously worked at Yahoo and Facebook. Both those companies encountered their only security and privacy problems, too.

Zoom's success is also drawing stiffer competition from much larger companies, including Microsoft, Google and Facebook. □

# Eagles' Don Henley asks Congress to change copyright law

**WASHINGTON (AP)** — Eagles songwriter Don Henley urged Congress on Tuesday to "Take It to the Limit" to protect artists against online pirating, wading into a copyright fight pitting Hollywood and the recording industry against big tech platforms like Google's YouTube.

The blockbuster hitmaker of the 1970s testified online from his home before a Senate Judiciary subcommittee weighing possible changes to a 1998 copyright law. The law al-

lows holders of copyrighted material to formally ask parties they believe have taken their content without permission to remove it. The parties can dispute the claim. If they comply promptly with the request, there are no legal consequences. Otherwise, they may be subject to criminal penalties.

Henley said the law is weak and needs to be changed to make it more effective in stopping online piracy. The so-called "notice and takedown" system under the copyright law is used by the movie and recording software makers and book authors to pursue tech platforms, universities and other facilitators of file-sharing. Henley called the copyright law "a relic of a MySpace era in a TikTok world." With hundreds of millions of

takedown notices sent, for every link taken down, "a dozen more pop up in its place," he said. The system "still allows Big Tech to rake in revenue" after repeated copyright infringements, Henley said.

The copyright battle is being spotlighted in Congress at a time when U.S. tech giants are in an escalating feud with President Donald Trump and Republican lawmakers, who accuse platforms such as Twitter, Google and Facebook of suppressing conservative viewpoints. The dispute boiled over last week when Twitter attached warnings to some of Trump's tweets, on mail-in voting and the use of force against people protesting the police killing of George Floyd. Trump, who is Twitter's most prominent user, responded by issuing an executive order

intended to chip away at the tech platforms' legal shield for speech content they carry.

In the debate over online pirating, the subcommittee chairman, Sen. Thom Tillis, R-N.C., made his leanings clear. He said creative industries have been "absolutely decimated" by the economic fallout of the pandemic as well as online pirating of copyrighted material that hasn't slowed down.

"Piracy has become easier and faster and much, much more common," Tillis said. "The current system is failing and it's failing badly." He confided that the first live music performance he saw, when he lived in Nashville, was the Eagles. The rock group, with Henley as singer, drummer and songwriter, produced some of the best-selling albums of

all time in the 1970s.

The other senators who attended the hearing, Democrats Chris Coons of Delaware and Richard Blumenthal of Connecticut, expressed support for changes to update the copyright law.

Copyright holders maintain that some network operators have manipulated internet-provider addresses in a way to make other networks appear responsible for the file-sharing. Entertainment industries have been pushing tech platforms to do more themselves to police content that violates copyright.

On the other side, users of the content have accused copyright holders of alleging infringement where it doesn't exist. Internet companies say they have worked actively with the creative industries to block access to illegal content and protect the copyrights. Jonathan Berroya, interim president and CEO of the major trade group Internet Association, testified that the "overwhelming majority" of copyright infringement takes place on foreign tech platforms outside the reach of U.S. law and is not conducted by U.S. companies.

Tech companies themselves are in a golden age of creating content and investing in others' projects, Berroya said.

They do not want to profit from illegally taken content, he said. Given the huge scale of piracy, tech platforms and the entertainment industries need to pool their resources and use new technology to identify violations. □

# Whirling Rooms

**ST. CRUZ — With my eyes closed my airplane instructor twists and turns the plane so that it is not flying level. This is a classic “unusual attitude” training every pilot needs to repeat to stay a safe pilot. I groan as I fight to keep from vomiting my breakfast. “OK, open your eyes and straighten the aircraft”, orders my instructor.**

I open my eyes to find my instructor has covered my airplane instruments. Not good my instincts scream. Facing out to sea I cannot tell the difference between sky and ocean and my brain is telling me we are turning left. The seconds tick off as I try to adjust the aircraft to what I feel is going on. “Now”, I say implying that I think I have control of the airplane to my instructor as he uncovers my airplane instruments. As I look at my instruments. I am headed into the ground turning slowly in a classic flying problem, called the “graveyard spiral”.

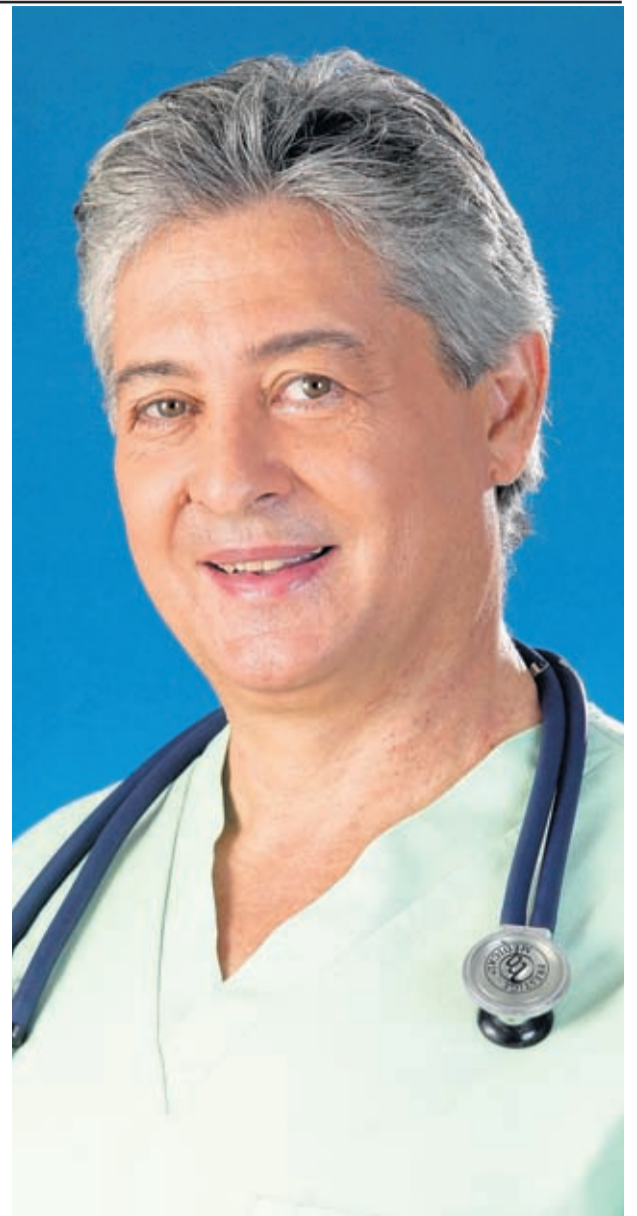
I have done this maneuver before and I know that in a spinning cockpit I have to trust my instruments even though my sense of balance, coming from my middle ear is telling me different. I line up the plane according to my instruments and start feeling a sensation of whirling or tilting that causes a loss of balance, a dizziness that puts my stomach wanting to give up breakfast. “Vertigo”, I complain as my instructor intently watches to make sure I have regained composure of both the plane and myself. Vertigo from Latin that means “whirling about” describes a medical condition in which somebody feels the sensation of dizziness with the room spinning. Dizziness is an indistinct term which describes a variety of conditions ranging from lightheadedness, unsteadiness to vertigo and spans a large range of symptoms. These symptoms range from the most dramatic, vertigo, to the least severe, imbalance. Included in these feelings is fainting, which results in a loss of consciousness.

As a private pilot I know it is the sensory system located in the inner ear that helps the body to maintain balance. Balance in the human body is coordinated by the brainstem, which collects information from other parts of the brain and sensory organs throughout the body. The sensory organs that play critical roles relaying infor-

mation to the brain-stem include the skin, eyes, muscles and joints, and the vestibular system in the inner ear. Dizziness may result with dysfunction in any of these components or in the nerves that connect them. French physician Prosper Mènière described Mènière's disease as having four particular symptoms: vertigo lasting for an hour or more, but less than 24 hours; ringing or buzzing sounds in the ear; feeling of pressure or fullness in the ear; and some hearing loss. Some people are affected in both ears; others just one ear. Onset of Mènière's is sometimes related to stress. Regular medicine usually looks for problems with the inner ear for dizzy symptoms. However, most people that we see have been dizzy for more than a couple of days.


