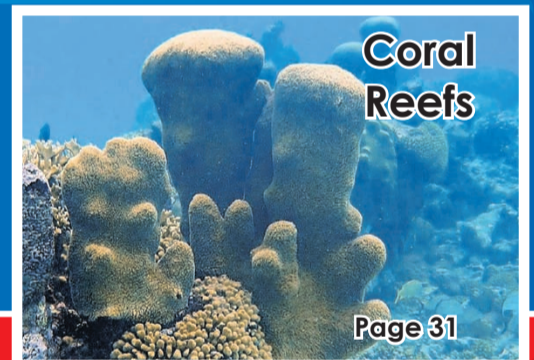

Democrats propose sweeping police overhaul; Trump opposes

WASHINGTON (AP) — Democrats proposed a far-reaching overhaul of police procedures and accountability Monday, a sweeping legislative response to the mass protests denouncing the deaths of black Americans in the hands of law enforcement. The political outlook is deeply uncertain for the legislation in a polarized election year. President Donald Trump is staking out a tough "law and order" approach in the face of the outpouring of demonstrations and demands to re-imagine policing in America. "We cannot settle for anything less than transformative structural change," said House Speaker Nancy Pelosi, drawing on the nation's history of slavery. Before unveiling the package, House and Senate Democrats held a moment of silence at the Capitol's Emancipation Hall, reading the names of George Floyd and many others killed during police interactions. They knelt for 8 minutes and 46 seconds — now a symbol of police brutality and violence — the length of time prosecutors say Floyd was pinned under a white police officer's knee before he died.

Contribucion na pension di politiconan no ta cubri ni un año

ORANJESTAD – Nos a haci pregunta na Promer Ministro siman pasa durante rueda di prensa, si e parti cu mester reserva pa por paga e pension di un mandatario despues, calcula na 200.000 florin pa año, ta parti di e 'Wever-Croes norm' tambe. Cu esey e suma total lo ta Afl. 380.000,- pa año, loke aparentemente e NVnan di gobierno ta usa como base. E contesta tabata negativo, e ta bisa cu ta solamente e salario y otro beneficio ta parti di e norma.

Sin embargo segun fuente bon informa gobierno semper lo ta haciendo reservacion pa por paga e pensionnan aki ora yega e momento, y e empresanan estatal tambe. Bon Dia Aruba a laga un experto financiero calcula kico ta e efecto financiero berdadero di e pension cu un funcionario politico a base di su salario como ministro. Esaki a base di e stipulacionnan di 'Landsverordening Voorzieningen gewezen politieke ambtsdragers en hun nabestaanden' (AB 2010 no. 91).

E pension ta ser paga parcialmente di e suma di 8% di e salario di e ministro (Afl. 15.010 pa luna) cu ta retene durante su funcionamiento. Pa bin na remarke pa esaki e ministro mester a funciona por lo menos 'en total' pa un periodo di ocho luna, pues cu no mester ta un solo periodo continuo. Ademas e lo mester a yega na e edad di pension di awor 65 año. Sin embargo, pa haya e pension completo di 70% di e salario promedio durante cu e tabata funciona como tal, o di e promedio di ultimo 8 año si el a sirbi mas tempo como politico/ministro. Despues di ocho año completa e ministro/politico no mester contribui mas.

E calculacion cu e experto a haci, ta muestra cu e gastonan di un año relaciona cu e pagonan cu mester haci pa e 'uitkering bij wijze van pensioen' na e ex-mandatario (y na su herederonan), cu mester financia a base di ocho año completo (96 luna) ta mas cu 100% di e suma na salario anual (12 x Afl. 15.010,- = Afl. 180.120,-). Nos ta duna

un resumen mas detaya pa nos por mira cuanto placa ta involvi cu e pension di ministro/mandatario.

E ministro cu sinta en total por lo menos 8 año completo, na e salario actual, lo a contribui na e fondonan 8x8% di Afl. 15.010,- = Afl. 115.276,80. Pa mas facilidad nos no ta conta e otro beneficio manera vakante-uitkering den e calculo aki. Si e haya un pension a base di ocho año cu el a cobra Afl.15.010 como salario mensual, e ta haya e maximo di Afl. 10.507,- pa luna como pension, cu ta 70% di e salario di Afl. 15.010,- pa luna.

Pa año e ta haya Afl. 126.810,- loke ta mas cu el a paga den su vida. E resto di añanan cu e pensionado ex-mandatario ta biba, cu por ta mas di 20 año, nos ta paga, sin cu e mes ta contribui un cent preto mas. Ademas, e mandatario ta haya un 'overbruggingstoelage' ora e baha, cu ta practicamente e suma anual cu a reserva den 8 año. Pues por bisa tambe cu e pension ta completamente gratis.

Asina por bisa cu e Afl. 2.305.536,- cu e ta costa comunidad ta bin directamente di caha di gobierno. Si nos tin, teoricamente, ocho ministro cu bay 8 año y bay cu pension, nan ta costa nos den 20 año 8x Afl. 2.305.536 = Afl. 18.444.288, casi 18 milyon y mey. Nos no ta papiando ainda di e 21 parlamentarianan, cu ta gana menos, pero tin (casi) e mesun areglo pa loke ta e pension.

Naturalmente tin cu bisa cu en general ningun funcionario publico ta paga su so pa su pension. Un parti grandi ta bin tambe di e mesun caha di gobierno. Loke si ta berdad ta cu e ambtenaar comun y coriente ta paga hopi mas durante 35 año pa e yega na un pension di 70% di su salario promedio.

En vista di e privilegianan grandi cu e politiconan ta acumula den poco tempo, no ta nada straño cu Hulanda no a pone como exigencia corta 20% di salario y beneficio so, sino tambe a stipula cu esey ta 'te proximo aviso' y no te fin di e año aki.

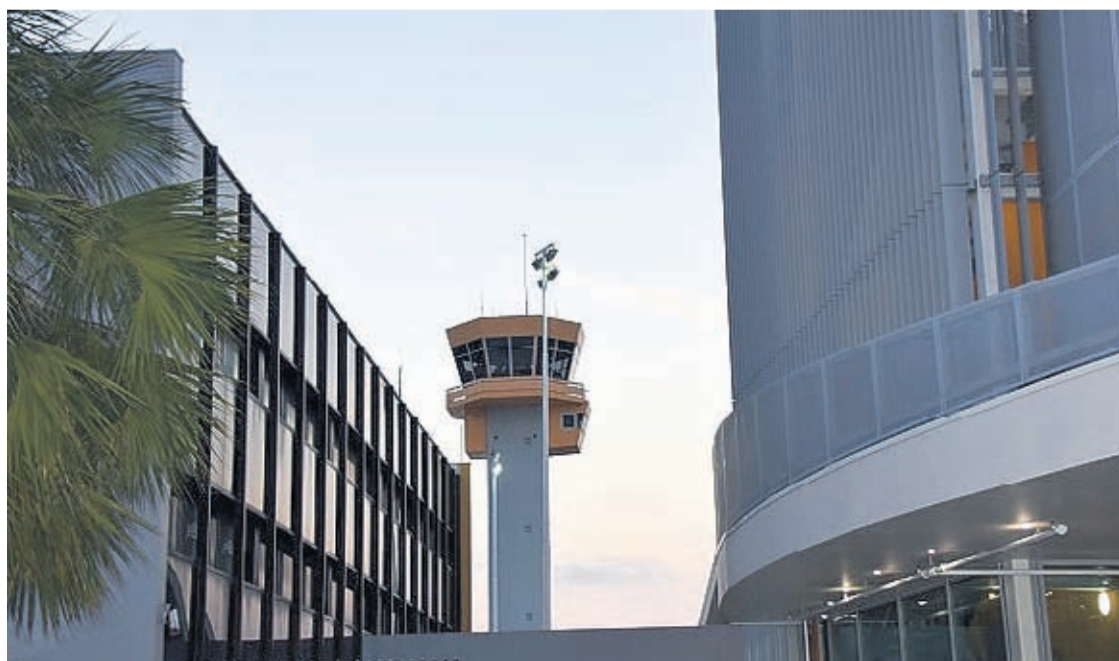

Democrats propose sweeping police overhaul; Trump opposes

Trump, who met with law enforcement officials at the White House, characterized the Democrats as having “gone CRAZY!”

As activists call for restructuring police departments and even to “defund the police,” the president tweeted, “LAW & ORDER, NOT DEFUND AND ABOLISH THE POLICE.”

Democratic leaders pushed back, saying their proposal would not eliminate police departments — a decision for cities and states — but establish new oversight.

Joe Biden, the presumed Democratic presidential nominee, “does not believe that police should be defunded,” said spokesman Andrew Bates.

The Justice in Policing Act would limit legal protections for police, create a national database of excessive-force incidents and ban police choke holds, among other changes, the most ambitious law enforcement reforms sought by Congress in years.

The legislation would revise the federal criminal police misconduct statute to make it easier to prosecute officers who are involved in misconduct “knowingly or with reckless disregard.”

The package would also change “qualified immunity” protections for police

to more broadly enable damage claims in lawsuits. The legislation would seek to provide greater transparency of police behavior in several ways. For one, it would grant subpoena power to the Justice Department to conduct “pattern and practice” investigations of potential misconduct and help states conduct independent investigations. It would ban racial profiling, boost requirements for police body cameras and limit the transfer of military equipment to local jurisdictions.

And it would create a “National Police Misconduct

Registry,” a database to try to prevent officers from transferring from one department to another with past misconduct undetected, the draft says.

A long-sought federal anti-lynching bill that has stalled in Congress is included in the package.

House Judiciary Committee Chairman Jerrold Nadler, D-N.Y., a co-author with Rep. Karen Bass, D-Calif., and Democratic senators, will convene a hearing on the legislation Wednesday. The legislation confronts several aspects of policing that have come under strong criticism, especially

as more and more police violence is captured on cellphone video and shared widely across the nation and the world.

“The world is witnessing the birth of a new movement in this country,” said Rep. Bass, chairwoman of the Congressional Black Caucus, which is leading the House effort. She called the proposal “bold” and “transformative.”

While Democrats are expected to swiftly approve the legislation this month, it does not go as far as some activists want. The outlook for passage in the Republican-held Senate is slim.

Republican campaign officials followed Trump’s lead in bashing the effort as extreme.

“No industry is safe from the Democrats’ abolish culture,” said Michael McDams, a spokesman for the House Republican campaign committee, in an email blast. “First they wanted to abolish private health insurance, then it was capitalism and now it’s the police.”

Democrats fought back. “This isn’t about that,” Pelosi said. Congress is not calling for any wholesale defunding of law enforcement, leaving those decisions to local cities and states, Democrats noted.

It is unclear if law enforcement and the powerful police unions will back any of the proposed changes or if congressional Republicans will join the effort.

Senate Majority Leader Mitch McConnell, whose Louisville hometown faces unrest after the police shooting of Breonna Taylor in her home, said he would take a look at potential legislation.

Republicans are likely to stick with Trump, although McConnell was central to passage of a criminal justice sentencing overhaul and some key GOP senators have similarly expressed interest in changes to policing practices and accountability. □

Report: NYC police misconduct often involves minority youths

NEW YORK (AP) — The vast majority of complaints about New York City police officers’ mistreatment of youths stemmed from encounters with black and Hispanic children, according to a new study by the city’s police watchdog agency.

Nearly two-thirds of youth complaints to the Civilian Complaint Review Board involved young boys of color, the report says, including some “stopped for seemingly innocuous activities such as playing,

high-fiving, running, carrying backpacks, and jaywalking.” The report, based on a review of more than 100 complaints, highlights several instances of racial profiling and comes amid mounting calls for police reforms in the wake of the May 25 death of George Floyd at the hands of Minneapolis police. Thousands of New Yorkers have taken to the streets to protest Floyd’s death and call for greater accountability. “It’s time for the NYPD to re-consider how officers police our youth, address disparities in law enforce-

ment, and commit to swift discipline when officers engage in misconduct,” Fred Davie, chair of the Civilian Complaint Review Board, said in a statement. The watchdog agency recommended New York City police take steps to prevent the “over-policing” of minority youths and break out its use of force data by age and race.

The NYPD said even one case of police misconduct is unacceptable.

“After careful review, we accept each of the CCRB’s thoughtful and constructive recommen-

dations — some of which are already in the process of being implemented and all of which will strengthen our new Youth Strategy.” □

Poll: Pandemic does little to alter U.S. views on health care

WASHINGTON (AP) — The coronavirus pushed hospitals to the edge, and millions of workers lost job-based coverage in the economic shutdown to slow the spread, but a new poll suggests Americans have remarkably little interest in big changes to health care as a result of the pandemic. People are still more likely to prefer the private sector than the government on driving innovation in health care, improving quality and, by a narrower margin, providing coverage, according to the survey by the University of Chicago Harris School of Public Policy and The Associated Press-NORC Center for Public Affairs Research. Those views are basically unchanged since February, when an earlier edition of the AP-NORC poll asked the same questions at a time that the coronavirus was still largely seen as a problem in other countries, not the United States.

"It does strike me as odd," said Gaye Cocoman, a retired data processing administrator from small-town Macedonia, Ohio, who has Medicare. "I'm covered, but I look at the millions of people who aren't and wonder what in the world they're going to do if they get sick. There seems to be

no appetite for change." The poll found that people are more likely to trust private entities over government at driving innovation in health care (70% to 28%), improving quality (62% to 36%) and providing insurance coverage (53% to 44%). Americans had more confidence in government's ability to reduce costs, preferring it over the private sector 54% to 44%. All of those preferences are unchanged since before COVID-19 arrived.

Not that long ago Vermont Sen. Bernie Sanders' "Medicare for All" plan was at the center of the Demo-

cratic presidential debate. But even with an estimated 27 million people losing employer coverage in the economic shutdown, there's been no groundswell of support for the Sanders plan, which calls for replacing the nation's hybrid system of private and government coverage with a single government plan for all. House Speaker Nancy Pelosi, asked last month whether waves of layoffs were prompting her Democratic caucus members to reconsider the employer-based system that covers most working families, responded: "That's not

our conversation." Pelosi said Democrats are backing measures to tide over workers who have lost coverage — such as expansions of the Affordable Care Act — but "rather than saying let's take that (employer coverage) away from them, we should say let's get them their jobs back." It could simply be a reflection of human nature to shelve ambitious schemes during a crisis, said health economist Katherine Baicker, dean of the University of Chicago Harris School of Public Policy. There's only so much available band-

width. "I wonder if the short-term crisis dampens people's appetite for health system reform," Baicker said. "The idea of upending the health system at this moment ... it may be that people think, 'No — let's get a vaccine.'"

After the spectacle of coronavirus-related shortages of everything from cotton swabs, to protective gear for nurses and doctors, to breathing machines for desperately ill patients, the poll did find 56% saying the U.S. is spending too little on improving and protecting the nation's health.

That is a significantly bigger share than the 42% who think the government is spending too little in general. Still, views on the need for more health care spending were unchanged since before the pandemic. Christina Rush, a middle school counselor from Raleigh, North Carolina, is among those who think the U.S. should spend more on health care and cites the virus as a reason.

"Looking at COVID, I didn't realize the huge shortages of material that would be needed," Rush said. "I would have thought we had what we needed in terms of the medical system, but it seems we were so far behind some of these other countries, like South Korea. We could be spending more." □

Suspect in police killing was member of elite military team

SANTA CRUZ, Calif. (AP)

— An active-duty U.S. Air Force sergeant accused of killing a Northern California sheriff's deputy in an ambush-style attack was a leader for a military base's elite security force, officials said Monday.

Staff Sgt. Steven Carrillo has been arrested on suspicion of fatally shooting Santa Cruz County sheriff's Sgt. Damon Gutzwiller and wounding two other officers Saturday. He is expected to be charged with first-degree murder.

The FBI also is investigating if Carrillo has any links to the killing of a federal officer who was shot outside the U.S. courthouse in Oakland more than a week ago. Both killings involved shooters in a van. Carrillo, 32, was a team leader for the Phoenix Ravens at Travis Air Force Base, 50 miles (81 kilometers) northeast of San Francisco, as part of the 60th Security Forces Squadron. The Phoenix Ravens are tasked with protecting aircraft and crews from assaults on airfields "where security is unknown or additional

security is needed to counter local threats," according to the Air Force. Carrillo's wife, Monika Leigh Scott Carrillo, who was also in the Air Force, was found dead in an off-base hotel in May 2018 while she was stationed in South Carolina. She was 30. Her death was ruled a suicide, according to the Air Force. Carrillo arrived at Travis Air Force Base the month after her death.

On Saturday, deputies responded to a 911 call about a suspicious van in Ben Lomond, an unincorporated area near Santa Cruz. The caller said

guns and bomb-making devices were inside, Sheriff Jim Hart said.

When deputies arrived, the van pulled away and the deputies followed. The van went down a driveway at a home, and the deputies were ambushed by gunfire and explosives after getting out of their vehicle. Gutzwiller was wounded and later died at a hospital. Another deputy was wounded by gunfire or shrapnel and struck by the van as the suspect fled, authorities said. A third officer from the California Highway Patrol was shot in the hand, Hart said. □

Germany: U.S. troop reduction could harm NATO security

BERLIN (AP) — Germany's defense minister suggested Monday that U.S. President Donald Trump's reported plans to withdraw more than a quarter of American troops out of Germany could weaken not only the NATO alliance but the U.S. itself. Trump is said to have signed off on a plan to reduce the total of troops stationed in Germany from 34,500 to no more than 25,000, according to reports by The Washington Post and The Wall Street Journal, but German Defense Minister Annegret Kramp-Karrenbauer told reporters that Berlin hasn't yet been informed of any such move.

A White House official, speaking on condition of anonymity to discuss internal matters, confirmed to The Associated Press that there are plans to move troops, saying some could go to Poland while others could go elsewhere. The decision is part of the president's and Department of Defense efforts to review combatant commands around the globe, the official said.

If the U.S. goes ahead, Kramp-Karrenbauer suggested the move would do more harm to NATO as

a whole than to Germany's own defense.

In Brussels, NATO Secretary-General Jens Stoltenberg sidestepped a question on the decision, saying that in general "over the last few years we have actually seen an increase in the U.S. presence" in Europe.

"What I can say is that we are constantly consulting with the United States, with other NATO allies on the military posture and presence in Europe," he said.

The Trump administration has been urging Germany to spend more on its de-

fense to meet the NATO goal of spending 2% of gross domestic product on defense, and American officials in the past had raised the possibility of moving troops out as a veiled threat. As such, the government's coordinator for trans-Atlantic relations, Peter Beyer, said if the plan is confirmed it wouldn't be a surprise, but that it was irritating to first learn of the possibility through media reports. "The German-American relationship could be severely affected by such a decision of the

U.S. president," Beyer told the dpa news agency.

"It's not just about 9,500 soldiers, but also about their families, so about 20,000 Americans. This would break down trans-Atlantic bridges."

The days are long gone when hundreds of thousands of American troops were stationed in Germany as a bulwark against the possibility of a Soviet invasion. Today, the country is much more a hub for wider American military operations. Facilities include Ramstein Air Base, critical

for operations in the Middle East and Africa and headquarters to the U.S. Air Forces in Europe and Africa; the Landstuhl Regional Medical Center, which has saved the lives of countless Americans wounded in Iraq and Afghanistan; and the headquarters of both U.S. European Command and U.S. Africa Command in Stuttgart.

Germany is also home to the headquarters of U.S. Army Europe in Wiesbaden, an F-16 fighter base in Spangdahlem, and the Grafenwoehr Training Area, the largest NATO training facility in Europe.

"If this is confirmed, you have to ask yourself what impact this will have on NATO and the security architecture in Europe," Beyer said. Germany has been increasing its defense spending and the issue of troops had lain dormant for many months.

It wasn't immediately clear why it was being brought up again, but Trump's decision came shortly after Chancellor Angela Merkel said that she wouldn't attend a Group of Seven summit in person in the U.S. if the president decided to go ahead with it. Shortly after the chancellor's announcement, Trump said he was postponing the summit. □

Lawyers: U.S. not investigating Prince Andrew in Epstein probe

LONDON (AP) — Attorneys representing Britain's Prince Andrew say they've been assured by the U.S. Department of Justice that he is not a target in the investigation of the late sex offender Jeffrey Epstein.

The firm, Blackfords LLP, said U.S. authorities requested the help of the son of Queen Elizabeth II for the first time in January after having investigated Epstein for 16 years. He has offered three times to do so — contrary to the statements of U.S. Attorney Geoffrey Berman, the firm said.

"Importantly, the DOJ advised us that the Duke is not

and has never been a 'target' of their criminal investigations into Epstein and that they sought his confidential, voluntary co-operation," the attorneys said.

The firm issued the unusual statement after reports in Britain's Sun newspaper and on NBC that American authorities had formally requested that Andrew answer questions on the matter. He categorically denies wrongdoing and has repeatedly insisted that he was willing to cooperate with U.S. authorities.

Berman has instead said that Andrew has provided "zero cooperation" to the American investigators who want to interview him

as part of their sex trafficking probe.

The contrasting views of what is going on behind the scenes came after The Sun newspaper reported that the DOJ submitted a mutual legal assistance request to Britain's Home Office. Such requests are used in criminal cases under a treaty and are generally used when material can't be obtained on a police cooperation basis.

As Blackfords insists Andrew is trying to cooperate, it pushed back Monday. It said it was a "matter of regret" that the department would "breach its own rules of confidentiality, not least as they are designed to en-

Settler leader: Netanyahu moving ahead with annexation plans

JERUSALEM (AP) — Prime Minister Benjamin Netanyahu has assured Jewish settlers that he is going ahead with plans to begin annexing parts of the occupied West Bank next month, a settler representative said Monday.

Netanyahu told a group of settler leaders late Sunday that President Donald Trump's Mideast plan allowing the annexation has not been finalized, Oded Revivi, mayor of the Efrat settlement, told The Associated Press. But Netanyahu said that once a final map is agreed upon with the Americans, he will present it to settler leaders individually, Revivi said.

Revivi was one of a dozen settler leaders who attended Sunday's meeting to support the annexation effort and offer a counterbalance to growing criticism of the plan among the prime minister's nationalist base. Annexation of West Bank land has long been a dream of the Israeli settler movement.

Despite what is widely viewed as a pro-Israel plan, some settlers have voiced concern that Trump's initiative does not go far enough. They note that many settlements would be turned into isolated

enclaves surrounded by Palestinian territory. They also reject the U.S. offer to recognize Palestinian statehood, albeit with far less land and far less authority than the Palestinians seek. "This doesn't answer all our dreams but you have to keep it in perspective and see what the alternative is," Revivi said. "We have an opportunity with this president, this prime minister and this international climate and we have to seize it."

The schism in the settlement leadership burst into the

open last week when David Elhayani, chairman of the Yesha Council, an umbrella settlers' group, told an Israeli newspaper that the plan was inadequate and proved Trump was "not a friend of Israel." Netanyahu, fearful of upsetting his close ally in the White House, responded harshly, lauding Trump's friendship and accusing the settler leadership of being ungrateful.

Revivi, a senior figure in Yesha, said the majority of settlers supported the plan, even if they harbored some

concerns, and were solidly behind Netanyahu.

Netanyahu and much of his nationalist base are eager to move ahead with annexation, especially with Trump facing shaky re-election prospects in November.

The proposal also faces opposition in Israel, where many fear that annexation is a step that could lead to the creation of a single binational state with the Palestinians.

Channel 13 TV reported Monday night that Netanyahu's main coalition

partner, Defense Minister Benny Gantz, has reservations about the plan. The report said that U.S. Ambassador David Friedman met with the two men in an attempt to bridge their differences. Netanyahu has said he wants to annex parts of the West Bank, including the strategic Jordan Valley and dozens of Jewish settlements, in line with Trump's Mideast plan. He's lauded the move as a historic opportunity to establish Israel's permanent borders, without having to evacuate a single settler. Previous peace plans have all included far greater Israeli concessions.

A U.S. Embassy official, said the "the work of the mapping committee is ongoing." The official was not authorized to speak to the media on the record and requested anonymity.

Netanyahu's office declined to comment.

The U.S. plan envisions leaving about one third of the West Bank, which Israel captured in 1967, under permanent Israeli control, while granting the Palestinians expanded autonomy in the remainder of the territory. The Palestinians, who seek all of the West Bank as part of an independent state, have rejected the plan, saying it unfairly favors Israel. □

With recovery of last case, New Zealand has eradicated virus

land (AP) — New Zealand appears to have completely eradicated the

coronavirus — at least for now — after health officials said Monday the last known infected person had recovered.

The announcement was greeted with joy around the country and means the nation of 5 million people will be among the first to welcome throngs of fans back into sports stadiums, embrace crowded concerts and remove seating restrictions from flights.

It has been 17 days since the last new case was reported, during which time an additional 40,000 people have been tested, bringing the total number tested to about 300,000. Monday marked the first

time since late February there have been no active cases. Prime Minister Jacinda Ardern said she was confident New Zealand had halted the spread of the virus but it still must be prepared for more.

"We are confident we have eliminated transmission of the virus in New Zealand for now, but elimination is not a point in time, it is a sustained effort," she said at a news conference. "We almost certainly will see cases here again, and I do want to say that again, we will almost certainly see cases here again, and that is not a sign that we have failed, it is a reality of this virus. But if and when that

occurs we have to make sure — and we are — that we are prepared."

More cases are likely to be imported as people enter the country. For now, the border remains shut to all but citizens and residents, with some limited exceptions. Everybody who does enter has to go into quarantine.

"We can hold public events without limitations. Private events such as weddings, functions and funerals without limitations," Ardern said. "Retail is back without limitations. Hospitality is back without limitations. Public transport and travel across the country is fully opened." □

How messaging technology is helping fuel global protests

When a friend shared a Facebook post with Michelle Burris inviting her to protest in downtown Washington, D.C., last Saturday, she knew she had to go. So she bought a Black Lives Matter mask from a street vendor before marching the streets of the district with a "No Justice, No Peace" sign.

After that march ended, she pulled up details on Instagram for a car caravan demonstration just a few blocks away. "It was extremely powerful, not only Facebook but Instagram," Burris said. "It was very easy to mobilize."

Protesters are using a variety of technology tools to organize rallies, record police violence and communicate during the marches sweeping the U.S. and other countries following the death of George Floyd. Some of that involves secure messaging services like WhatsApp, Signal and Telegram, which can encrypt messages to thwart spies. Those apps, along with others for listening to police scanners and recording video, are enjoying an uptick in popularity. But experts say convenience and reach are key. "Reaching as many people as possible is the number one criterion for which platform someone is going to use," said Steve Jones, a University of Illinois at Chicago media researcher who studies communication technology.

That means Twitter, Facebook and Facebook-owned Instagram remain the easiest ways for people to organize and document the mass protests. Facebook's tools remain popular despite a barrage of criticism over the platform's inaction after President Donald Trump posted a message that suggested protesters in Minneapolis could be shot.

"I don't want to support or be a part of something that is possibly supporting Trump and his racist, hate filled spew," said Sarah Wild-

man, who's been to three protests in Atlanta and has used Instagram exclusively to locate and to document the demonstrations she attended. But she said she feels that, at this point, "the benefits of Instagram outweigh not using it."

Half a century ago during the civil rights protests, Jones said, it was almost impossible to know what was going on during a protest. "There was a lot of rumor, a lot of hearsay," he said. "Now you can reach everyone almost instantaneously."

Wildman said she uses Instagram's "live" function to find out what is happening during protests, especially when protesters in the back might not know what's happening at the front. At one, she said, people started yelling that police were using tear gas — but it wasn't true, which she learned by checking Instagram.

Organizers are also using Telegram, an app that allows private messages to be sent to thousands of people at once, creating channels for specific cities to give updates on protest times and locations, as well as updates on where police are making arrests or staging. One New York City Telegram channel for

the protests grew from just under 300 subscribers on Monday to nearly 2,500 by Friday. During a peaceful rally in Providence, Rhode Island, on Friday, Anjel Newmann, 32, said that while she's mostly using Instagram and Facebook to organize, younger people are using Snapchat. The main problem: It's hard to tell which online flyers are legitimate. "That's one of the things we haven't figured out yet," she said. "There was a flyer going around saying this was canceled today."

The simplicity of shooting and sharing video has also made possible recordings of violence that can spread to millions within moments. A smartphone video of Floyd's death helped spark the broad outrage that led to the protests.

Apps like Signal are seeing an uptick in downloads according to Apptopia, which tracks such data. Signal was downloaded 37,000 times over the weekend in the U.S., it said, more than at any other point since it launched in 2014. Other private messaging apps, such as Telegram and Wickr, have not seen a similar uptick.

One new user is Toby Anderson, 30, who also attended the Providence rally on Fri-

day. Anderson, who is biracial, said he downloaded the encrypted Signal app several days earlier at the request of his mom. "She's a black woman in America," he said, worried about his safety and eager to grasp any additional measure of security she could.

Meanwhile, apps like Police Scanner and 5-0 Police Scanner, which allow anyone to listen to live police dispatch chatter — and may be illegal in some states — racked up 213,000 downloads over the weekend, Apptopia said. That is 125% more than the weekend before and a record for the category. Citizen, which sends real-time alerts and lets users post live video of protests and crime scenes, was downloaded 49,000 times.

On the down side, the Anti-Defamation League's Center on Extremism said in a blog post this week that it has found white nationalists using Telegram to try to wreak havoc during the protests.

"Some, especially those in the accelerationist camp, are celebrating the prospect of increased violence, which they hope will lead to a long-promised 'race war,'" the ADL said Monday. "They are extremely

active online, urging other white supremacists to take full advantage of the moment." In one Telegram channel, the ADL found, participants suggested murdering protesters, then spreading rumors to blame the deaths on police snipers. Others want to further exacerbate racial tensions. "Good time to stroke race relations" and "post black live's don't matter stickers," a user posted — with misspellings — to the Reformthstates Telegram channel, according to the ADL. □

The 10 best movies released since theaters were shuttered

Believe it or not, a lot of new films have been released since movie theaters were shuttered by the coronavirus pandemic — and a lot of good films.

They have arrived by streaming service, cable television, on-demand, drive-in and even Instagram. But the movies have kept coming. Here are 10 favorites of AP Film Writers Jake Coyle and Lindsey Bahr:

— "Driveways": A gracefully understated film about next-door neighbors — one an eight-year-old boy (Lucas Jaye), the other a retired Korean veteran (Brian Dennehy, in one of his last performances) — who become unlikely friends, Andrew Ahn's exquisitely gentle little movie has felt blessedly nourishing this spring. The tale might

be sentimental, but Ahn's touch is true, and the performances of the three leads (including Hong Chau, as the boy's mother)

are all tenderly human. The beautiful final shot is achingly sweet. (Available for digital rental.) — Coyle

— "Never Rarely Sometimes Always": Eliza Hittman's "Never Rarely Sometimes Always" will break your heart, and you'll be glad it did. This quiet, sharp and deeply felt drama about a teenage girl in rural Pennsylvania who must travel to New York to get an abortion is the kind of film that burrows deep into your being and stays with you long after. Newcomers Sidney Flanigan and Talia Ryder capture the unease of simply existing in their teenage girl bodies when the world sees them only as objects to be possessed and controlled. (Available for digital rental) — Bahr

— "New York, New York": Spike Lee has an ambitious Vietnam War veteran film, "Da 5 Bloods," coming to Netflix, but he's already made possibly the most indelible and moving film of the pandemic. Set to Frank Sinatra, the three-minute short "New York, New York" simply and straightforwardly captures lockdown in Lee's home city. A galvanizing tribute to New York when it needed it most. — Coyle

— "The Half of It": This Netflix sleeper is smarter than your average Cyrano-inspired high school dramedy. From

writer-director Alice Wu ("Saving Face") in her first film in 15 years, "The Half of It" follows a whip-smart Chinese-American student Elsie (played by the wonderful Leah Lewis) who reluctantly helps a romantically challenged football player woo the beautiful and soulful Aster (the girl of both of their dreams). It's an original gem that didn't get half the buzz it would have had the Tribeca Film Festival not been canceled because of the pandemic. — Bahr

— "The Vast of Night": Andrew Patterson's stunning directorial debut (streaming on Amazon) is a low-budget sci-fi thriller set in a small town in 1950s New Mexico. With sound and shadow it summons a fully realized vision of mid-century paranoia with more contemporary filmmaking flare, including a memorable long-take prow through town. Rarely do new directorial talents announce themselves this clearly. — Coyle

— "How to Build a Girl": A portrait of a writer as a young, talented and messy woman, "How to Build a Girl," based on Caitlin Moran's semi-autobiographical novel, is the fanciful, empowering and funny opposite side of the "Never Rarely Sometimes Always" coin, in which a teenage girl (a delightful Beanie

Feldstein) from a down-trodden U.K. town invents a larger-than-life persona to help get a foot in the door in the male-dominated world of music writing. (Available for digital rental) — Bahr

— "Crip Camp: A Disability Revolution": The decades-long struggle for the equity of people with disabilities is the central and most important part of Nicole Newnham and Jim LeBrecht's Netflix documentary. But for a film that tells a vital and under-told history, it's also uncommonly loving, celebratory and spirited. In "Crip Camp" we see a social movement fueled by the passion of remarkable individuals. — Coyle

— "The Trip to Greece": There is a poignant melancholy to "The Trip to Greece." It's partly because it might just be the last time Steve Coogan and Rob Brydon take their semi-fictionalized versions of themselves out for an impression-soaked spin around a picturesque locale. But it's also a beautiful reminder of everything that we're missing, and the little and big luxuries that we can't even afford to dream about right now: Travel, food, wine, friends. (Available for digital rental.) — Bahr

— "Bad Education": This true-life suburban crime drama, which premiered last fall at the Toronto International Film Festival, might very well have been destined for Oscar buzz. Instead, it went straight to HBO and very likely the Emmys, should they happen. In Cory Finley's film, a Long Island school district becomes enmeshed in an embezzlement scandal that has its prim superintendent (Hugh Jackman) and assistant superintendent (Allison Janney) fighting for their jobs. Jackman and Janney, both, make grand bamboozlers. — Coyle

— "Shirley": Josephine Decker's prickly, unnerving "Shirley," about the reclusive author Shirley Jackson, is set a '50s Vermont college town but also takes place in the gothic realm of one of Jackson's own stories. □

Review: Identical twins veer apart in moving 'Thin Girls'

Dark, poignant and gripping, Diana Clarke's "Thin Girls" is sure to be unlike anything else you've read. Identical twins Rose and Lily Winters are deeply connected, but in high school their relationship begins to grow complicated. Rose's desperation to be cool leads her down a dan-

gerous path of extreme dieting. Meanwhile, as if to compensate for Rose's weight loss, Lily begins eating and eating and eating. Both girls struggle with body and mental health issues well into adulthood. When we meet them, Rose is living in an anorexia rehabilitation facility and Lily has found herself in an abusive relationship, addicted to a new and dangerous fad diet, and in complete denial that anything in her life needs to change.

Alternating between flashbacks and the present day, "Thin Girls" is a captivating story of the Winters twins' road to recovery as they work to help each other through issues of body image, love, identity and sexuality. Clarke succeeds at creating a story that feels wholly unique while at the same time wholly relatable for young women who endure so many of the challenges Rose and Lily face. □

The importance of the coral reef

ORANJESTAD — World Ocean Day is on June 8 and this year the focus is on growing the global movement to call on world leaders to protect 30% of our blue planet by 2030. Coral reefs are extremely important to the overall health of planet Earth and its human inhabitants: Coral reefs provide protection and shelter for many species of fish and sea life. From the smallest shrimp to the largest predator, sea creatures find both food and protection on coral reefs.

The Dutch Caribbean Nature Alliance (DCNA) is regional network of protected areas set up to help and assist the park management and conservation organizations on the islands of Aruba, Bonaire, Curaçao, Saba, St. Eustatius and St. Maarten. Together they are working to safeguard our unique natural world. On their website you can find valuable information about the islands nature, among others about the coral reef.

Coral reefs

For someone who has never been snorkeling or diving over a tropical coral reef it is almost impossible to imagine the sheer restless energy, the breathtaking color and beauty of a reef. Waves crash, currents drift, tides ebb and flow drawing a ceaseless rain of food and fresh seawater across the reef. There are fantastically shaped corals from dome like brain corals to mountainous pagodas, prickly tables and perfect spheres. Flitting and darting amongst the corals are numberless vividly colored reef fish.

Reefs which form close to land, following the contours of the coastline are called fringing reefs. Where the reef is separated from land by a lagoon or open water it is called a barrier reef. Coral reef atolls are almost exclusively a feature of the Pacific where they form rings of coral up to several kilometers in diameter around open sea

or sandy islands.

The coral reefs of the Dutch Caribbean are very diverse. Bonaire and Curaçao have fringing coral reefs which encircle their islands. Starting in very shallow water the reefs slope gently seaward to around 30 feet (10m) before dropping down to depths in excess of 200 feet (60m). St Maarten has patch/barrier reef whilst the reefs on Saba are found on the top of underwater seamounts or pinnacles which make for spectacular diving. St Eustatius by contrast has very well developed patch reefs.

Despite enormous differences between coral reefs, they all have the same basic needs: warm, clear, sunlit water with an absence of sediment, which could choke and kill them and a hard substrate on which to grow. They are only found in tropical seas where the year round water temperature is between 18–30°C, or broadly speaking between 30' north and 30' south of the equator.

Building a coral reef

Coral reefs are painstakingly constructed by a humble group of invertebrate animals belonging to the cnidarian family. Scleractinian (stoney) corals are closely related to anemones but different from them in that they form huge interlinked colonies consisting of hundreds and thousands of individual coral polyps. Coral

polyps are incredibly delicate and very slow growing. The fastest species of branching coral only grows at 10cm a year, other corals take years to grow a few millimeters. Coral colonies can reach immense sizes and are tremendously long lived. There are colonies alive today which are believed to be over 700 years old.

Stoney corals have developed the remarkable ability to extract calcium carbonate from sea water. This they use to build complex limestone homes which form the solid framework, or matrix, of the reef.

Around this framework there co-exists a complex web of life. Calcareous algae help to build the reef up whilst animals like boring sponges, worms, grazing fish and urchins work to erode it away. In their eagerness to graze on algal (plant) turf parrotfish recycle huge amounts of reef: up to 75% of their stomach content is ground up coral reef. Still other creatures find shelter on the reef and for them it is their home. This multitude of life is what we know of as the coral reef.

But what has long fascinated scientists is how corals could build such immense cities of life in the aquatic equivalent of a desert. Oceanic water is remarkably low in food (plankton) and nutrients.

Seawater is rich in dissolved calcium carbonate. Coral polyps are able to take this



up and secrete it beneath themselves as microscopic crystals. The polyps of each type of coral build according to their own innate plan. And even though coral heads are incredibly plastic, forming radically different shaped colonies according to the amount of wave action, current and light, their polyps always build identical limestone homes.

The value of reefs

In part coral reefs are valuable because they protect tropical shorelines from damage by storm waves. A recent World Bank study suggests that each square meter of coral reef in the Caribbean protects \$

47,000 in property. They provide hundreds of thousands of people with income and food from fishing. A coral reef in prime condition can produce over 20 tons of protein per square kilometer a year. And tourism is a major source of income for many tropical island nations. Caribbean reefs alone are worth around \$ 140 billion per year in tourism dollars.

At the global level scientists believe that by taking up calcium carbonate from seawater, corals create carbon sinks which lessen the impact of the green house gasses involved in global warming. Coral reefs are home to such a vast array of animals and plants that only a small fraction of them have so far been described. More and more medical compounds are being isolated from coral reef creatures which can be used to combat HIV, cancer and other diseases whilst sterilized coral skeleton is already being used as a bone substitute for implants.

But most of all coral reefs give us an unparalleled opportunity to marvel at the wonder of life and the beauty and complexity of the world we live in. Source: DCNA. □



Central bank of Aruba: Lackluster consumption weighs down good performance in tourism and investment during 2019

ORANJESTAD — Today the Centrale Bank van Aruba (CBA) published the State of the Economy of 2019. This publication provides a synopsis of the local and international economic developments of this period. The domestic highlights are presented below, including a summary of main economic indicators.

Economic contraction in 2019

Aruba's economy is estimated to have contracted by 0.7 percent in real terms in 2019, according to the latest Economic Outlook publication of the CBA. The slow-down in the economy was mostly driven by a further slack in the consumption component. Consumption indicators such as banking credit and car sales pointed towards a decline. Available data indicated positive results in the tourism sector for the year, while investment data showed a pick-up in investment activities. Tourism related activities remained strong, as available data on stay-over visitors (both including and excluding Venezuela) showed further gains, with the average length of stay remaining relatively unchanged.

Increase in consumer price inflation and trade deficit

The 12-month average CPI inflation accelerated from 3.6 percent at end-December 2018 to 4.3 percent in December 2019, caused primarily by rising food- and communication prices. The real exchange rate of the florin vis-à-vis the U.S. dollar increased steadily since the first quarter of 2018.

Aruba's trade deficit, as reported by the CBS reached Afl. 2,199.1 million in December 2019, i.e., a widening of Afl. 72.4 million (+3.4 percent) compared to December 2018. The attributing factors are increased imports of construction related materials.

Surplus on the balance of payments

The current account of the balance of pay-



ments recorded an Afl. 115.4 million surplus during 2019. This surplus was a substantial turnaround compared to 2018, when an Afl. 38.9 million deficit was recorded. This positive development was mainly related to the strong performance in the tourist sector that pushed up the surplus on the services account by 3.9 percent, combined with a smaller deficit on the income account.

The financial account resulted in a net lending abroad of Afl. 104.8 million in 2019, compared to a net borrowing of Afl. 44.2 million in the previous year.

Total money supply stood at Afl. 4,569.4 million at year-end 2019, a growth of Afl. 191.8 million compared to December 2018. The expansion in money supply was the result of an Afl. 255.4 million increase in net domestic assets, which

was partially offset by an Afl. 63.7 million drop in net foreign assets. The contraction in net foreign assets was mainly related to domestically financed repayments of foreign private loans and the repurchases of equity from nonresidents.

Improvement in the fiscal deficit

The government of Aruba recorded a fiscal deficit (on a cash basis) of Afl. 3.1 million or 0.1 percent of GDP in 2019, reflecting an improvement of Afl. 42.1 million compared to a year earlier. The narrowing of the fiscal deficit was due to a 7.9 percent increase of in government revenue, pushed up by gains in both tax and non-tax revenue. The higher government revenue was partially offset by a 4.8 percent uptick in government expenditure. The latter was mainly caused by higher outlays on goods and services. Consequently, government debt reached Afl. 4,318.3 million at the end of 2019, up Afl. 19.2 million from 2018. Meanwhile, the estimated year-end debt-to-GDP ratio fell from 75.0 percent at end-2018 to 72.9 percent at end-2019.
