Decline in new U.S. virus deaths may be temporary reprieve

The number of deaths per day from the coronavirus in the U.S. has fallen in recent weeks to the lowest level since late March, even as states increasingly reopen for business. But scientists are deeply afraid the trend may be about to reverse itself.

"For now, it's too soon to be reassured that deaths are going down and everything's OK," said Dr. Cyrus Shahpar of Resolve to Save Lives, a nonprofit organization that works to prevent epidemics.

Deaths from COVID-19

across the country are down to about 680 a day, compared with around 960 two weeks ago, according to an Associated Press analysis of data compiled by Johns Hopkins University. The analysis looked at a seven-day rolling average of deaths through Wednesday.

A multitude of reasons are believed to be at play, including the advent of effective treatments and improved efforts at hospitals and nursing homes to prevent infections and save lives.

But already there are warning signs.





For one thing, the number of newly confirmed cases per day has risen from about 21,400 two weeks ago to 23,200, the AP analysis found.

And in Florida, Georgia, Texas and Arizona — states that loosened their stay-at-home restrictions early — daily deaths have been quietly rising since early June, said Ali Mokdad, professor of health metrics sciences at the University of Washington in Seattle.

"These are not numbers. These are human beings," Mokdad said. "We're going to see a rise in deaths in many places in the United States."

The outbreak has killed about 118,000 people in the U.S. and nearly a half-million worldwide, according to Johns Hopkins' count, though the real numbers are believed to be higher. Potential vaccines are in early stages of testing, and it is unlikely any will be ready before early next year.

Experts note that a rise in deaths could take awhile to show up in the U.S. statistics. Stay-at-home orders imposed in March, combined with the use of face masks and other social-distancing measures,

have been bringing down the daily death toll since mid-April, and the U.S. as a whole is still seeing the positive effects, even though people are starting to work, shop and eat out again.

Doctors watching for an uptick in deaths will be on the alert for certain signals to emerge in a specific order, Shahpar said.

First, cellphone data will show people moving around more. Next, doctors will report more flu-like illnesses, and the proportion of people testing positive

for the virus will rise. Hospitalizations will then go up and, finally, so will deaths. Several factors are believed to be pushing the curves for deaths and cases in opposite directions. Rising case numbers can partially be explained by the wider availability of testing. Mild cases, previously undetected because of limits on who could be tested, are now showing up in the numbers. As for the drop in deaths, "it is probably several things happening at once," said

Dr. Shmuel Shoham, a professor of medicine at Johns Hopkins University School of Medicine. Lessons learned from the "awful early days" are now benefiting the severely sick and people in nursing homes, Shoham said.

It looks that way in Washington state's King County, where the first nursing home outbreak in the U.S. killed 45 people at the Life Care Center in suburban Seattle. County data shows deaths in similar facilities declining over the past two months.

And no single facility in the county has come close to the death toll at Life Care, which was struck unaware. While it is unclear how much specific treatments may have contributed to the decline in deaths, doctors are trying antivirals such as remdesivir, plasma donated from people who have recovered from the virus and steroids such as dexamethasone, which grabbed attention this week with reports confirming it can save the lives of many of the sickest patients. While all viruses mutate, scientists say the coronavirus so far is not changing in a way that has made it less deadly.

The decline in deaths this spring might well be tied in part to warmer weather as people spend more time outdoors where circulating air disperses the virus. But that does not bode well for the U.S. come this fall and winter. Mokdad noted that deaths are on the rise in the Southern Hemisphere, where it's now winter.

"This virus is going to have a second wave. It's going to follow the pattern of pneumonia," he said. "What we're seeing in the Southern Hemisphere will be happening here." □

Cream of Wheat, Mrs. Butterworth confront race in packaging

Colgate, Cream of Wheat and Mrs. Butterworth are the latest brands reckoning with racially charged logos.

The soul-searching comes in the wake of PepsiCo's announcement Wednesday that it's renaming its Aunt Jemima syrup brand. Mars Inc. says it's also reviewing its Uncle Ben's rice brand.

New York-based Colgate-Palmolive Co. said Thursday it is working with its Chinese partner, Hawley & Hazel Chemical Co., on changes to its Darlie brand toothpaste.

The toothpaste, which is popular in Asia, was called Darkie when it was first introduced in the 1930s. Packages featured a drawing of a minstrel singer in blackface with

a wide smile; a Hawley & Hazel executive came up with the logo after visiting the United States and seeing Al Jolson perform. The Chinese name on the box translated to "black man toothpaste."

Colgate-Palmolive acquired a 50% stake in Hawley in 1985. In 1989, the

name of the toothpaste was changed to Darlie and the logo was changed to a racially ambiguous figure in a top hat. But Colgate said the product is under further review.

"We are currently working with our partner to review and further evolve all aspects of the brand, includ-

ing the brand name," the company said in a statement.

B&G Foods Inc., which makes Cream of Wheat hot cereal, said Wednesday it is initiating "an immediate review" of its packaging. A smiling black chef holding a bowl of cereal has appeared on Cream of Wheat packaging and in ads since at least 1918, according to the company's web site.

"We understand there are concerns regarding the Chef image, and we are committed to evaluating our packaging and will proactively take steps to ensure that we and our brands do not inadvertently contribute to systemic racism," Parsippany, New Jersey-based B&G said in a statement.

Chicago-based Conagra Brands, which makes Mrs.

Butterworth's syrup, said its bottles — which are shaped like a matronly woman — are intended to evoke a "loving grandmother." But the company said it can understand that the packaging could be misinterpreted. Critics have long claimed that the bottle's design is rooted in the "mammy" stereotype.

"We understand that our actions help play an important role in eliminating racial bias and as a result, we have begun a complete brand and packaging review on Mrs. Butterworth's," Conagra said in a statement. The changes are the latest signal of the powerful cultural moment unleashed by the Black Lives Matter protests, which have spread around the world and prompted companies to rethink their policies and products. □

Facebook removes Trump ads with symbols once used by Nazis

WASHINGTON (AP) —

Facebook has removed a campaign ad by President Donald Trump and Vice President Mike Pence that featured an upside-down red triangle, a symbol once used by Nazis to designate political prisoners, communists and others in concentration camps.

The company said in a statement Thursday that the ads violated "our policy against organized hate." A Facebook executive who testified at a House Intelligence Committee hearing on Thursday said the company does not permit symbols of hateful ideology "unless they're put up with context or condemnation."

"In a situation where we don't see either of those, we don't allow it on the platform and we remove it. That's what we saw in this case with this ad, and anywhere that that symbol is used, we would take the same action," said Nathaniel Gleicher, the company's head of security policy.

The Trump campaign spent more than \$17,000 on the ads for Trump and Pence combined.

In a statement, Trump campaign communications director Tim Murtaugh said the inverted red triangle was a symbol used by antifa so it was included in an

ad about antifa. He said the symbol is not in the Anti-Defamation League's database of symbols of hate. The Trump campaign also argued that the symbol is an emoji.

"But it is ironic that it took a Trump ad to force the media to implicitly concede that Antifa is a hate group," he added.

Antifa is an umbrella term for leftist militants bound more by belief than organizational structure. Trump has blamed antifa for the violence that erupted during some of the recent protests, but federal law en-

forcement officials have offered little evidence of this. But some experts disputed that the red triangle was commonly used as an antifa symbol.

European anti-fascist groups initially used the red triangle as a symbol, hoping to reclaim its meaning after World War II, but it is no longer widely used by the movement and has never been used by U.S. antifa groups, said Mark Bray, a Rutgers University historian and author of "Antifa: The Anti-Fascist Handbook." Anti-fascist groups typically use flags or arrows

as their symbol.

The ADL said the triangle was not in its database because it is a historical symbol and the database includes only those symbols used by modern-day extremists and white supremacists.

"Whether aware of the history or meaning, for the Trump campaign to use a symbol — one which is practically identical to that used by the Nazi regime to classify political prisoners in concentration camps — to attack his opponents is offensive and deeply troubling," ADL chief executive officer Jonathan Green-

latt said in a statement. Even with the ads removed, Facebook and CEO Mark Zuckerberg, still face criticism for not removing or labeling earlier posts by Trump that spread misinformation about voting by mail and, many said, encouraged violence against protesters.

Those questions arose during Thursday's hearing as Democrats pressed the executives about what moral obligations they felt they had when it came to content and about decisions they've made to remove, label or leave up false or incendiary posts.

Facebook, for instance, was asked why it did not remove a doctored video of House Speaker Nancy Pelosi, D-Calif., last year that appeared to show her slurring her words.

"If we simply take a piece of content like this down, it doesn't go away," Gleicher said. "It will exist elsewhere on the internet. People who are looking for it will still find it."

With Thursday's hearing focused on the spread of disinformation tied to the 2020 election, the companies said they had not yet seen the same sort of concerted foreign influence campaigns like the one four years ago, when a Russian troll farm sowed discord online by playing up divisive social issues. □

Netflix CEO to donate \$120M to historically black colleges

Netflix CEO Reed Hastings and his wife, Patty Quillin, are donating \$120 million

toward student scholarships at historically black colleges and universities. The couple is giving \$40

million to each of three institutions: the United Negro College Fund, Spelman College and Morehouse College. The organizations said it is the largest individual gift in support of student scholarships at HBCUs.

Hastings has a history of supporting educational causes, including charter schools. He launched a \$100 million education fund in 2016, beginning with money toward college scholarships for black and Latino students.

Hastings said now is the time when "everyone needs to figure out" how to contribute to solving rac-

ism. He said HBCUs have been resilient "little-known gems" for black education. Amid protests over police brutality that began three weeks ago, companies and business leaders have been pledging solidarity with their black employees and the black community. But tech companies — including Netflix — have fallen short in hiring, retaining and promoting underrepresented minorities within their own ranks.

Other tech industry donations in the wake of the Black Lives Matter protests have largely been on the company level. On

Wednesday, Google CEO Sundar Pichai outlined plans toward racial equity at the company that includes increasing the number of black and other underrepresented minority executives and creating a \$175 million "economic opportunity package" that includes \$100 million in funding for black-led venture capital firms and startups.

Last week, Apple CEO Tim Cook announced that the company will spend \$100 million on a new Racial Equity and Justice Initiative, investing in education and criminal justice reform among other things. □

Official: German slaughterhouse virus outbreak untenable

BERLIN (AP) — Germany's agriculture minister said Thursday that conditions at a slaughterhouse where hundreds of workers tested positive for COVID-19 were untenable and backed an official investigation into the outbreak.

Authorities in the western region of Guetersloh said that 730 people at the Toennies Group meatpacking plant in Rheda-Wiedenbrueck had tested positive for the new coronavirus, an increase of 73 since Wednesday.

"Hundreds of infections in one plant. These conditions aren't tenable," Agriculture Minister Julia Kloeckner said in a statement. She added it was right for officials in North Rhine-Westphalia state, where the plant is located, to have launched a probe into the source of the infections.

Following a series of earlier coronavirus clusters at abattoirs, the German government pledged to crack down on the practice of using subcontractors, who often hire migrant workers and house them in cramped accommodation. But some lawmakers have warned of the risk that jobs might move abroad. Coronavirus outbreaks have also affected meatpacking plants in other countries, including in the

United States. The United Food and Commercial Workers union said recently that at least 44 slaughterhouse workers in the U.S. have died from the virus and another 3,000 have tested positive.

Labor campaigners said the outbreak at one of Germany's biggest slaughterhouses, which employs about 7,000 people, showed the need for change.

"It's no coincidence that the Toennies slaughterhouse has become the next hot spot of coronavirus infections," said Freddy Adjan, the deputy chairman of the NGG union that represents workers in the food and drinks industry.

Adjan said workers employed by subcontractors

face "catastrophic working and living conditions."

"This sick system needs to finally end," Adjan said. "The government's decision that includes a ban on contract work needs to be fully implemented in the legislative process."

Toennies has said the outbreak could be linked to recent travel by workers, especially from Eastern Europe, after borders started to reopen.

But experts questioned whether such a large outbreak — resulting in more cases than the entire country normally reports in a day — could have been caused by travel alone.

"The working conditions in slaughterhouses don't seem to be very compatible with

the currently required hygiene measures," said Isabella Eckerle, who heads the center for emerging viral diseases at the University of Geneva.

"In my view the large number of (infected) employees indicates an undetected 'super-spreading event' in the company that has been going on for some time," she said.

A spokesman for the company, Andre Vielstaedte, said conditions in the areas where carcasses are carved up could also have played a role, saying temperatures are "5 to 12 degrees Celsius (41 to 54 degrees Fahrenheit) in a humid atmosphere where aerosols are formed and the virus can then spread

through the air."

Karl-Josef Laumann, the health minister for North Rhine-Westphalia, said the scale the outbreak at Toennies was "intense," noting that about two-thirds of all tests had come back positive so far.

"Of course I'm a bit worried about what will turn up when we test the other 6,000 in the next days," he said.

Officials said a further 10 people from southeastern and Eastern Europe had also tested positive in Guetersloh county, though they didn't work at the meat plant.

The region has asked the German army to assist in the mass testing of further slaughterhouse workers.

Meanwhile, dozens of parents protested the decision to close schools and child care centers in the county because of the outbreak.

Germany's daily reported number of infections rose back above 500 for the first time in a week Thursday. While the figure didn't yet include the cases from Guetersloh, it did capture about 100 infections reported from an apartment building in the central German city of Goettingen.

Germany has recorded almost 190,000 cases of COVID-19 and 8,868 deaths since the outbreak began, according to a tally by Johns Hopkins University. □

Canada to introduce virus tracing app in July

TORONTO (AP) — Canada is introducing a contact tracing smartphone app that will notify Canadians of exposure to the new coronavirus.

Prime Minister Justin Trudeau said Thursday the app will be voluntary and that if someone tests positive, other users who have the app and have been in proximity will then be alerted they've been exposed to someone who has tested positive. Trudeau said privacy will be respected. "At no time will personal information be collected or shared, and no loca-

tion services will be used," Trudeau said.

Governments around the world have been turning to smartphone technology to help battle fresh virus flare-ups as they ease lockdown restrictions. But technical problems and privacy concerns have dogged the development of virus tracing apps.

Health authorities in Britain announced Thursday they are scrapping plans to launch their own coronavirus contact tracing smartphone app because of technical problems and will now work on building one

using technology supplied by Apple and Google.

Other European nations such as Switzerland, Germany and Italy, are using a "decentralized" approach based on the Apple-Google smartphone interface, which experts say is better for privacy because it keeps data on phones.

"We drew lessons from what other people did around the world," Trudeau said. "This type of simple and anonymous application, that is entirely voluntary, will be extremely powerful in terms of helping us to reopen the economy safely."

China passes draft of controversial Hong Kong security law

BEIJING (AP) — China's legislature on Thursday passed a draft of a national security bill for Hong Kong that has been strongly criticized as undermining the semi-autonomous territory's legal and political institutions.

The National People's Congress' Standing Committee reviewed the bill that covers four categories of crimes: succession, subversion of state power, local terrorist activities, and collaborating with foreign or external foreign forces to endanger national security. No details on the definitions of those crimes or the applicable punishments were given. It also wasn't clear when the law would be passed in its final version, although Beijing has repeatedly said it is determined to press ahead despite the criticism.

The congress moved to enact the legislation at the national level after Hong Kong's own Legislative Council was unable to do so because of strong local opposition. Critics say it could severely limit free speech and opposition political activity.

Legal experts say Beijing's justifications for the law are highly debatable.

China acted following widespread and sometimes violent anti-government protests in the territory last year that Beijing saw as a dangerous campaign to split Hong Kong from the rest of the country.

The U.S. has said that the

law if passed will revoke some of the special privileges it grants to Hong Kong after the former British colony was handed over to China in 1997. Britain has said it will offer passports and a path to citizenship to as many as 3 million Hong Kong residents. Beijing has denounced the moves as interference in its affairs. On Wednesday, the Group of Seven leading economies called on China to reconsider its plans in a joint statement voicing "grave concern regarding China's decision to impose a national security law on Hong Kong," adding that it would breach Beijing's international commitments as well

as the territory's constitution.

"It would jeopardize the system which has allowed Hong Kong to flourish and made it a success over many years," they said. "Open debate, consultation with stakeholders, and respect for protected rights and freedoms in Hong Kong are essential."

China's Foreign Ministry condemned the G-7 statement, accusing the group of "speaking and pointing fingers freely at Hong Kong affairs."

"We strongly deplore and firmly oppose the joint statement issued by the G-7 foreign ministers," the ministry spokesperson said

at a daily briefing. "China's determination in promoting the national security law in Hong Kong is unwavering."

In Berlin on Thursday, German Chancellor Angela Merkel called for an "open dialogue" between Europe and China on an investment agreement, climate change and Africa "but also on questions of the rule of law and human rights, and not least the future of Hong Kong, where we are concerned that the important principle of 'one country, two systems' is being hollowed out more and more."

The Asian financial hub's highly respected legal system already covers se-

curity issues from money laundering to terrorism and cybercrime. That leaves the proposed legislation to deal with vaguely defined crimes of a highly political nature along the lines found in mainland China's Communist Party-dominated system.

Earlier this month, Hong Kong's legislature approved a contentious bill making it illegal to insult the Chinese national anthem after pro-democracy lawmakers boycotted the vote out of protest.

Senior opposition figures have also been arrested for taking part in demonstrations and questions have arisen over whether the national security legislation will be used to disqualify pro-democracy candidates in September's elections for the Beijing-controlled Legislative Council.

Hong Kong activist Joshua Wong said he expected the law would bring negative repercussions for people like him who hold contrarian views.

Opposing the law "could be my last testimony (while) I am still free," Wong said Thursday during an online event to promote democracy and the market economy held in Copenhagen, Denmark. "Our long march to democracy will be forced into a prolonged period of crackdown," said Wong, who rose to prominence as a student leader during pro-democracy demonstrations in 2014. □

Japan's ex-justice minister arrested in vote-buying case

TOKYO (AP) — Japanese Prime Minister Shinzo Abe's former justice minister and the minister's lawmaker wife were arrested Thursday over allegations they engaged in vote buying during last year's election, officials and local media said.

The Tokyo Public Prosecutors Office said it arrested the former minister, Katsuyuki Kawai, and his wife, Anri Kawai, though it did not immediately give a

reason.

Local media including Kyodo News reported the arrest was over allegations that the couple offered millions of yen in cash to dozens of voters ahead of the 2019 upper house election in which Anri Kawai won a seat.

The couple has denied any wrongdoing.

Katsuyuki Kawai served as justice minister for only a month from last September, resigning when the allegations surfaced but has remained as lawmaker.

Their arrest came a day after the parliamentary session ended, when both no longer had immunity.

While the couple left Abe's ruling Liberal Democratic Party earlier this week, there are still questions about whether party election funds were used in the alleged vote-buying.

The couple's arrest comes as Abe's government is already facing public criticism over its handling of the coronavirus pandemic and its devastating economic impact. □

Wall Street eyes alternative data to track economy reopening

LOS ANGELES (AP) — The reopening of businesses shut due to the coronavirus pandemic is fueling optimism on Wall Street that the U.S. economy is on the path to recovering from a steep recession.

How quickly that recovery happens hinges on the outbreak subsiding and on Americans feeling confident and safe enough to return to their pre-lockdown habits.

For an up-to-the-minute read on consumer behavior, Wall Street is monitoring the number of people moving through airport security checkpoints, restaurant reservations and gasoline demand, among other data. This information is particularly valuable now because conventional economic reports on hiring, consumer confidence and spending can lag a month or more.

"We're looking at them as an indicator of consumer behavior, and really consumer trust in the health infrastructure," said Nela Richardson, investment

strategist at Edward Jones. "What this high frequency data is telling us is that behavior is starting to recover, and that's a good sign for the reopening, if it continues."

The Transportation Security Administration's daily tally of people moving through its checkpoints at airports indicates that more Americans are taking to the skies, though the tally remains far below where it was a year ago.

For example, 417,924 people moved through TSA airport checkpoints Tuesday. That's down 83% from the same day last year, when the TSA counted 2.47 million travelers.

Still, the steep drop-off marks an improvement from the same day in April, when passenger traffic sank 96.4%.

Government data also suggests more Americans are driving than just a couple of months ago. The four-week average of daily U.S. gasoline demand was 7.64 million barrels as of last week, according to the U.S. Energy Information Administration.

That's down about 21% from a year earlier.

But it's up sharply since April 24, when the four-week average of daily demand slumped to 5.33 million barrels.

Analysts are keeping an eye on restaurant reservation app OpenTable too, to gauge consumers' willingness to leave home and share space with other restaurant patrons.

The latest data, based on a sample of roughly 20,000 restaurants, show the number of seated diners from online, phone and walk-ins remains sharply lower from a year ago. The snapshot on Wednesday, for example, showed a 65.2% drop. But it's an improvement from the 100% decline through much of March and April.

"We're trying to measure the biggest thing coming into this pandemic: what's the appetite for people going outside their house?" said Megan Horneman, director of portfolio strategy at Verdence Capital Advisors.

"And what we're seeing right now is all those things

look positive."

Horneman also monitors data from Metropolitan Transit Authority subway turnstiles in New York for hints about Americans' willingness to be in close quarters with others, which bodes well for air travel, restaurants and shops. The turnstile "clicks" have climbed to the highest level since late March, but remain substantially lower than normal, she said.

The S&P 500 index has rebounded about 40% since late March. Initially, the Federal Reserve's vow to provide immense aid to keep markets running smoothly helped lift stocks. More recently, the gains have been driven by optimism among stock investors that the economy can climb out of its current hole faster than forecast as businesses reopen.

Signs of progress in reopening of the economy have to be balanced against the rate of new COVID-19 cases and hospitalizations, which have been rising, particularly in states like Florida and Texas that were among the first to reopen

their economies.

"It's discouraging to see that over half of states are experiencing rising case counts, but in a lot of those instances they were off of low levels, so the next few weeks are going to be important," said Brian Price, head of investments for Commonwealth Financial Network. "If we get to a point where ICU beds become stretched to capacity and hospitals start to become stressed, governors may not have a choice" in closing economies or imposing stricter social distancing, Price said. □

Denying marriage claim, justices OK James Brown's dying wish

COLUMBIA, S.C. (AP) — The Godfather of Soul's dying wish to help educate needy children is a big step closer to being fulfilled, now that South Carolina's Supreme Court — wading into a 14-year-old legal saga yet again — has ruled that James Brown's last partner was not legally married to him.

In an unanimous ruling on Wednesday, the state's justices wrote that Tomi Rae Hynie, a former partner of Brown's who claimed to be his wife, failed to annul a previous marriage, and therefore did not have a right to his multimillion-dollar estate.

Brown's union with Hynie has long been the center of the evolving legal troubles following his death at the age of 73 on Christmas Day 2006. The performer's death touched off years of bizarre headlines, beginning with Hynie being locked out of his 60-acre estate, while photographers captured her sobbing and shaking its iron gates, begging to be let in.

Brown was renowned for hundreds of iconic musical works including hits like "I Feel Good" and "A Man's World," and was known around the world for his flashy performances and dynamic stage presence. But years of drug problems and financial mismanagement caused his estate to dwindle.

More than a dozen law-

suits have been filed over the years by people trying to lay claim to what's left, which courts have estimated to be worth anything from \$5 million to more than \$100 million.

Wednesday's ruling dealt another blow to a deal brokered by Gov. Henry McMaster who, as South Carolina's attorney general, stepped in to facilitate

a 2009 settlement after Brown's estate had been floundering in court for years. In 2013, the state's high court overturned McMaster's settlement, which would have given nearly half the estate to a charitable trust, a quarter to Hynie, and the rest to be split among his adult children. At the time of that settlement, the exact value

of Brown's assets was not made public, and attorneys said his accounts had little money in them. In 2008, some of his possessions were auctioned for \$850,000, in part to pay down debt, and all agreed that future income from music and movie royalties and the use of Brown's highly marketable likeness was what remained at

stake.

In that 2013 ruling, justices wrote McMaster hadn't followed Brown's expressed wishes for most of his money to go to charity, having instead selected a professional manager who took control of Brown's assets from the estate's trustees to settle Brown's debts. Writing that McMaster's deal "destroys the estate plan Brown had established in favor of an arrangement overseen virtually exclusively by the AG," the court also ruled then that the Godfather of Soul was of sound mind when he made his will before his death.

The justices ruled again in the case two years later, ordering all estate proceedings halted pending further evaluation by a lower court.

Finally on Wednesday, the justices ruled that Hynie has no claims on the money, and ordered a circuit court to "promptly proceed with the probate of Brown's estate in accordance with his estate plan."

That plan, outlined in Brown's will, was to create an "I Feel Good" trust that would use his music royalties to fund educational expenses for children in South Carolina and Georgia.

"The ongoing litigation since Brown's passing has thwarted his expressed wish that his estate be used for educational purposes ... a point we find both extraordinary and lamentable," the court wrote. □

Memphis music festival, barbecue cooking contest canceled

MEMPHIS, Tenn. (AP) — The Beale Street Music Festival, the World Championship Barbecue Cooking Contest and other "Memphis in May" events were canceled Thursday due to the coronavirus outbreak in the Tennessee city.

Both the music festival and the barbecue cooking contest are the cornerstones of the city's month-long tourist event in May. They attract music fans and barbecue cooking

teams from around the world.

In March, Memphis in May events were pushed to late September and October in hopes that the virus outbreak would have slowed down.

But virus cases and hospitalizations in Memphis have risen in recent days, delaying a planned move to ease restrictions on businesses such as restaurants and retail stores this week. Memphis in May's board of directors met Thursday and decided to cancel

this year's events due to public safety concerns, a statement posted on its website said.

The Mississippi River city relies heavily on tourism revenue from Memphis in May. "The annual Memphis in May is an important part of the cultural fabric of our city, but this pandemic has impacted large scale public events worldwide and Memphis is no exception," said James L. Holt, president of the Memphis in May International Festival, in the statement.

Festivals can be places where COVID-19 can spread because they involve a large group of people who are standing close together and walking around for an extended period of time.

Shelby County Health Department Director Alisa Haushalter said it would not be prudent to have festivals in 2020 and into 2021.

She said the department has been reviewing proposals from organizers of several festivals.

"The festival holder has to make a decision if they can meet the requirements that we're going to set forth, and whether it's economically feasible for them to carry the event out," Haushalter said during an online news conference Thursday.

The Lumineers, Three 6 Mafia, The Avett Brothers, Lil Wayne and The Smashing Pumpkins were among the musical acts scheduled to perform at the music festival before the postponement. □

Conservative and gradual recovery expected

ORANJESTAD — The Aruba Hotel & Tourism Association has published the latest hotel performance data (last update May 19) showing the crisis' effect on 2020 tourism so far. April's 0 occupancy has affected the average for the first 4 months of the year as follows:

Occupancy: At 34.8 points lower than the same period in 2019, the 2020 year-to-date average occupancy rate is 53.6%.

ADR: The average daily rate (for occupied rooms) is 6.5% higher than the same period last year, at \$359.14.

RevPAR: The revenue per available room is \$192.38 year-to-date, a 35.4% reduction.

A month further into the COVID-19 crisis AHATA's projection for the rest of 2020 has become more conservative. The situation is still unprecedented with very little confirmed information to count on. However, considering the current view of the situation in the United States, the fact that fewer people will travel prior to introduction of a vaccine, immense financial effects on individuals, and the turmoil in the airline industry, AHATA has updated its forecast.

At this point, AHATA expects the following trajectory for Aruba's hotel oc-

cupancy recovery (if the border opens on June 15th):

During the recovery period most companies shall experience higher cost than income levels. The government's salary subsidy program offers relief as long as it is available. Reality remains that the crisis does not end when the lockdown ends. Many companies are not able to survive at the low levels of income that will be experienced for the months ahead. Some will need to restructure to survive and some will need to close their doors permanently.

For the reopening of Aruba's borders, AHATA has recommended strict entry requirements to help reduce the number of imported COVID-19 cases. It is impossible to escape importation of new cases; however, a substantial limitation would help minimize the size of a second wave and consequently its impact on our healthcare infrastructure. AHATA is of the opinion that Aruba must do its utmost to avoid a second lockdown, which would cause more economic damage than the first one. □

Sea turtle conservation by Turtugaruba Foundation



ORANJESTAD — Turtugaruba was founded on September 3rd, 2003 by a group of enthusiastic volunteers. Ten years earlier, in 1993, a Sea Turtle Recovery Action Plan (STRAP) was introduced in Aruba and the rest of the Caribbean as an initiative of the United Nations Environment Program (UNEP). Tom Barnes, who was working at DLVV (Department of Agriculture, Husbandry and Fishery) was one of the writers of the STRAP for Aruba, together with Karen Eckert, director of WIDECAST (Wider Caribbean Sea Turtle Conservation Network). This is how sea turtle conservation started on the island following a plan that is still complied with today.

Tom formed a group of volunteers around him, because nature does not know office hours, like an organization such as DLVV. This group of volunteers used the name Widecast Aruba and today there are still a few of them active. They first started protecting the Leatherback Sea Turtle nests on Palm Beach and Eagle Beach. This group also investigated which other species of sea turtles use Aruba as their nesting habitat and which beaches are used by them. For a period of 25 years a study has been conducted in which every early morning the beach was being monitored in which now there is a good overview of sea turtle nesting activities.

There are 4 different sea turtle species that visit Aruba to lay their eggs, each with their own specific season:

- Leatherback Sea Turtle - Lederschildpad - Driekiel (March – September)

Loggerhead Sea Turtle - Dikkopschildpad - Cawama (May – September)

Hawksbill Sea Turtle - Karetsschildpad - Caret (June – December)

Green Turtle - Soepschildpad - Turtuga Blanca (July-November)

There also came a better understanding and overview of the biggest threats to the sea turtles existence in Aruba and how these problems should be tackled. Despite hard work, all those years, most problems have not really gone away, but luckily and thanks to the enormous efforts from the volunteers, the sea turtles are still here. On Aruba the sea turtles are threatened with extinction by pollution, driving on dunes and beaches with quads and 4x4's and the loss of nesting beaches due to coastal development on behalf of tourism. Because coastal development comes with artificial light and artificial light is a major issue for sea turtles, mother turtle usually comes on shore at night looking for a dark beach to make her nest. However... a dark beach is hard to find here nowadays. Light causes stress and can result in her returning to the sea without laying her eggs. Artificial light causes disorientation for the baby sea turtles (hatchlings).

They crawl towards artificial light sources (like streetlights, hotel lights, etc.) and then they don't find the sea. In the 90's it was still a common occurrence to find a complete nest of

about 70 hatchlings on the streets, dead, as cars drove over them. Thanks to their protection methods and a lot of time and effort, the volunteers of Turtugaruba have managed to get this under control. But for a sustainable solution there must be less light visible on the beaches and a strict regulation of it. Sea turtles simply need dark nesting beaches for their survival. It is clear that even more coastal development would not make the situation better for the sea turtles. Again, more hotel rooms? And even busier beaches? These are choices Aruba has to make. Do we want to leave a place for the sea turtles? Not only Aruba, but the entire world needs sea turtles! Sea turtles play a vital role in keeping our oceans healthy.

The Green Turtle, for example, keeps the sea grasses on the bottom of the sea short and therefore a healthy place for many fish to deposit their eggs. The Leatherback, the largest turtle of the world, eats mainly jellyfish and helps maintain the balance between jellyfish and plankton. Despite the threats that exist on Aruba, the turtles still keep coming. That's why today Turtugaruba is especially proud of the volunteers and the many people and organizations of our community that carry a warm place in their hearts for the sea turtles. All four species are active now, which means all hands on deck in the field for us, the volunteers. We strive to keep the sea turtles, our oldest 'repeat guests', always coming back to Aruba and get the chance to reproduce here.□
