Barr says unrest not linked to Floyd, defends feds' response

WASHINGTON (AP) — Attorney General William Barr defended the aggressive federal law enforcement response to civil unrest in America, saying on Tuesday "violent rioters and anarchists have hijacked legitimate protests" sparked by George Floyd's death at the hands of Minneapolis police. Barr told members of the House Judiciary Committee at a much-anticipated election year hearing the violence taking place in Portland, Oregon, and other cities is disconnected from Floyd's killing, which he called a "horrible" event that prompted a necessary national reckoning on the relationship between the Black community and law enforcement. The hearing marks Barr's first appearance before the House Judiciary Committee after 18 months in office, bringing him face-to-face with a panel that voted last year to hold him in contempt and is holding hearings on what Democrats say is politicization of the Justice Department under his watch. It comes during tumultuous stretch in which Barr has taken actions cheered by President Donald Trump but condemned by Democrats and other critics.

E mandatario a declara cu berdad cu e asunto aki ta trata di un problema interno den POR. Pero e relación di trabao ta wordo afecta pasobra tin dos minister di POR den Conseho di Minister. El a bisa cu 'ami personalmente no tin niun issue cu minister Marisol Lopez-Tromp'.

Segun e mandatario, e no por bisa cu nan relacion di trabao cu minister Lopez-Tromp lo ta afecta. Sinembargo e ta haya cu e asunto aki ta un problema interno di POR. Pero tambe un problema entre dos minister di POR cu ta sinta den conseho di minister. Practicamente e problema interno di POR a wordo treći den reunion di Conseho

Prome cu e pandemia tabata premira cu e fondo te cu 2027 lo tabata stabiel y cu despues lo a mira e prome deficitnan aparece. Y ta pa e motibo ey a traha riba reservanan, pa absorba e deficit pa asina paga te memey di e siguiente decade.

"Pero cu e pandemia, e reserva cu tin ta desaparece. E añanan cu lo mester a uza pa sigui traha reserva awor mester ta dedica pa recuperacion economico, particularmente mirando cu e cantidad di hende cu ta califica pa pensioen di biehes ta aumenta. Pues Gobierno lo mester duna un man."

Jacobs a bisa cu ta proyecta cu ta na 2023 por cuminsa traha riba reserva atrope. Pero, na 2024 e edad di pensioen lo ta 65 y e siguiente aña ta proyecta aumento di gasto den e mesun velocidad cu 10 aña pasa, tempo cu e fondo a bay den crisis. Y p'eseys sa di awor caba cu ta bay tin deficit den e fondonan.

"Aruba tin un structura di AOV cu no ta adecuado pa un pais di migrante. Tin

hopi hende cu ta cobra pensioen, awor aki 21 mil, pero un grupo grandi no tin e AOV completo, pasobra nan a bin Aruba hopi despues. Si nan tabata cobra e AOV completo, anto e fondo lo tabatin mas problema. E diferencia cu Hulanda ta cu e gasto di AOW ta financia pa presupuesto di Gobierno Hulandes.

Y nos te awor aki, nos sistema ta completamente financia door di prima." Te ainda AOV nunca a haya un sosten financiero di Gobierno (aunque cu si no tin reserva, e lo mester bin despues di 2027). Pues e financiamiento di e pensioen ta diferente. Pero, e pregunta ta si pa Gobierno di Aruba e ta e miho sistema. Pasobra un persona grandi, cu no tin mucho famia aki, y no por traha mas y apenas ta cobra 400 florin di pensioen di biehes, dificil por sobrevivi. E por traha te cu 70, "pero nos como ciudadano ta bay permiti un hende asina biba cu 400 florin of nos ta bay agrega e fondo pa e por yega na 1000? For di unda ta saca e 600 florin? Ta gastonan pa futuro. Tin diferente aspecto cu mester tene na cuenta ora di papia di pensioen di biehes. Pasobra mester tene cuenta tambe kico e no tin, cu por tin impacto di bijstand."

Argumento pa hisa edad di pensioen

Ningun pais di mundo no a hisa edad di pensioen pasobra nan kier. Tur pais cu ta reforma sea pensioen of cuidado medico ta pasobra nan no por sigui paga e sistema. E financiamiento di un structura ta impulsa cambio. "SVB a restructura y a aplica un strategia di reserva di 2015 te cu 2027. Hulanda ta mira e cifranan di SVB, e jaarrekening ta publico. Y e calculacionnan ta basa riba edad di 65."

E tema ta uno di financiamiento y un decision politico. Jacobs a splica, cu na Hulanda a decidi cu ta saca 10 porciento di sistema nacional, esta presupuesto pa paga pa pensioen. P'eseys tambe tin belasting mas halto. "E ta un acercamiento holistico, pa decidi como sociedad te con leu bo gastonan colectivo mester ta y con bo kier pa destino e fondonan publico."

derecho, perdida di cumplimiento di ley, y esey ta haci cu ta perde tur posibilidad pa Venezuela haya un inversion cu ta facilita recuperacion”.

Encuento e situacion pa e año aki, e diputado opositor a bisa cu actividad economico a cay cu 25,38% den promer tres luna, compara cu e mesun periodo di 2019. 

Barr says unrest not linked to Floyd, defends feds' response

Among those actions is the Justice Department's decision to drop the prosecution of former Trump administration national security adviser Michael Flynn and Barr's urging for a more lenient sentence for Trump ally Roger Stone, a move that prompted the entire trial team's departure. Trump later commuted the sentence entirely.

Opening the hearing, committee Chairman Jerry Nadler said the Trump administration had "twisted the Department of Justice into a shadow of its former self," serving the powerful before average Americans. He said the committee has a responsibility to protect Americans "from that kind of corruption."

Nadler said Barr had "aided and abetted" Trump's worst impulses and excoriated him and the Justice Department for turning a blind eye to necessary reforms to police departments, for dismissing Black Lives Matter protests and for flooding streets with federal agents to stop protesters.

Republicans hit back hard in defense of Barr and Trump's administration. The top Republican on the panel, Ohio Rep. Jim Jordan, used his opening statement

to show an eight-minute video that spliced together images of violence by protesters around the country, showcasing law enforcement officers under attack in Chicago, Portland and New York. The images were cut from hundreds of hours of racial injustice footage of largely peaceful protests around the nation.

Under combative questioning, Barr acerbically defended himself but revealed little new information about his motivations or the Justice Department's

recent actions on policing or otherwise. Fuming Democrats often used their five minutes to lay out their frustrations and cut him off as he attempted to answer questions. "Many of the Democrats on this Committee have attempted to discredit me by conjuring up a narrative that I am simply the President's factotum who disposes of criminal cases according to his instructions," Barr said in his opening statement. "Judging from the letter inviting me to this hearing, that ap-

pears to be your agenda today." On policing, Barr's testimony underscores the Justice Department's ongoing effort to differentiate between increasing violence in some cities and Floyd's death, which has led to state charges against four officers and is under investigation by federal authorities. Massive but peaceful demonstrations followed Floyd's death in May. The attorney general, speaking as Congress and the public pay respects in the Capitol to the late civil

rights icon Rep. John Lewis, acknowledged to lawmakers Floyd's death struck a chord in the Black community because it reinforced concerns Black people are treated differently by police. But he condemned Americans who he says have responded inappropriately to Floyd's death through what he said was rioting and anarchy.

"As elected officials of the federal government, every member of this committee — regardless of your political views or your feelings about the Trump administration — should condemn violence against federal officers and destruction of federal property," Barr said. "So should state and local leaders who have a responsibility to keep their communities safe."

Civil unrest escalated in Portland after federal agents were accused of whisking people away in unmarked cars without probable cause; the people were detained and later released. And in Washington, D.C., peaceful protesters were violently cleared from the streets by federal officers using smoke bombs and pepper balls last month before a photo op by Trump in front of St. John's church, where Barr had accompanied him. □

California Indian tribe gets back Big Sur ancestral lands

BIG SUR, Calif. (AP) — A Native American tribe has reclaimed a small part of ancestral lands on California's scenic Big Sur coast that were lost to Spanish colonial settlement nearly 250 years ago.

The Esselen Tribe of Monterey County closed escrow on 1,199 acres (485 hectares) about 5 miles (8 kilometers) inland from the ocean that was part of a \$4.5 million deal involving the state and the Western Rivers Conservancy, The Mercury News reported Monday.

It marks the first restoration of any lands to the tribe, which lost 90% of its approximately 1,000 members to disease and other causes

by the early 1800s.

"It is beyond words for us, the highest honor," said Tom Little Bear Nason, chairman of the tribe. "The land is the most important thing to us. It is our homeland, the creation story of our lives. We are so elated and grateful." The land lies on the north side of the Little Sur River, where endangered steelhead fish spawn, and encompasses old-growth redwoods, oak woodlands and meadows.

"The property is spectacular, and on top of that it repatriates land to a tribe that has had a really hard go of it over the years," said Sue Doroff, president of the conservancy. Known as Rancho Aguila,

the property was put up for sale by the family of Axel Adler, a Swedish immigrant who bought it in the 1950s and died in 2004.

The Portland, Oregon-based Western Rivers Conservancy initially negotiated to purchase the property and transfer it to the U.S. Forest Service. But some area residents were concerned about potential increased use of the land by visitors and the agency's ability to care for the land. The conservancy then started working with the Esselen Tribe and received a \$4.5 million grant from the California Natural Resources Agency to cover the \$4.35 million purchase price and pay for land studies.

The money came from a 2018 voter-approved parks and water bond that included \$60 million for com-

petitive grants to acquire Native American natural, cultural and historic resources in California. □

Experts worry about errors if census schedule is sped up

ORLANDO, Fla. (AP) — After asking for coronavirus-related deadline extensions in April, the Trump administration now appears to be abandoning that request by asking Congress for extra funding to wrap up the 2020 census "as quickly, and safely as possible" in a move that could help ensure the number-crunching for redrawing congressional districts takes place on President Donald Trump's watch.

Census Bureau officials had warned as recently as early July that it was already too late to have the numbers ready without an extension. And outside experts predicted Tuesday that speeding up the timetable would lead to an inaccurate head count that misses people in hard-to-count minority communities.

"It would be like giving an expectant mother in the early stages of pregnancy a lot of money to have the baby in 4.5 months," said John Thompson, a former Census Bureau director in the Obama administration. The Census Bureau is in the middle of the 2020 census, and some of the bureau's 500,000 door-knockers started heading out this month to households that

haven't yet answered the questionnaire.

With the new coronavirus disrupting census operations in April, the Trump administration asked Congress to extend the deadlines required for the U.S. Census Bureau to turn in the head count data used for redrawing congressional district and legislative districts. The Census Bureau also postponed finishing field operations for the 2020 census from the end of July to the end of October.

The Democratic-controlled House agreed to the ex-

tensions as part of coronavirus-relief legislation, but the Republican-controlled Senate has yet to do so. Senate Republicans on Monday instead proposed an additional \$448 million in funding for the 2020 census in its coronavirus-relief bill. "This funding would allow for additional hiring, staffing resources, and replenished contingency funding to provide schedule flexibility as the Census Bureau conducts its largest field operation, nonresponse followup," the Census Bureau said Monday on its website.

"This flexibility is critical to helping the Census Bureau operate in the midst of unprecedented public health crisis, including trying to wrap up field data collection as quickly, and safely as possible, while ensuring a complete and accurate count."

Historically, the Census Bureau is required to turn over numbers for apportionment, the process of divvying up congressional seats, by Dec. 31, and the numbers used for redrawing legislative districts by March 30. The deadline extensions

would push back the apportionment deadline to April 30 and the redistricting deadline for state and local districts to July 31.

If the deadline extension for the apportionment numbers is granted by Congress, there's a chance the final months of the data-crunching would take place under a new administration if presumptive Democratic presidential nominee Joe Biden defeats Trump, a Republican, in the November election.

Wary of what they see as Trump's attempts to politicize the 2020 census, House Democrats say Senate Republicans should approve the request for deadline extensions.

"Otherwise, American taxpayers would be forced to pay for the most expensive and potentially least accurate census in our nation's history," said U.S. Rep. Carolyn Maloney, a Democrat from New York who chairs the House Committee on Oversight and Reform.

Earlier this month, House Democrats asked U.S. Commerce Secretary Wilbur Ross to withdraw two appointees from top positions at the U.S. Census Bureau, claiming they represented the latest effort by the Trump administration to politicize the 2020 census. □

Can you get the coronavirus twice?

Scientists don't know for sure yet, but they believe it's unlikely.

Health experts think people who had COVID-19 will have some immunity against a repeat infection. But they don't know how much protection or how long it would last.

There have been reports of people testing positive for the virus weeks after they were believed to have recovered, leading some to think they may have been reinfected. More likely, experts say people were suffering from the same illness or the tests detected

remnants of the original infection. There's also the chance tests could have been false positives.

Scientists say there has been no documented instance of a patient spreading the virus to others after retesting positive. With similar viruses, studies have shown that people could fall sick again three months to a year after their first infections. It's still too early to know whether that's also possible with the coronavirus.

"It's very much emerging science," said Dr. Philip Landrigan, director of the global public health program at Boston College.

A small U.S. study pub-

lished last week also found the antibodies that fight the coronavirus may only last a few months in people with mild illness, suggesting people could become susceptible again. But antibodies aren't the only defense against a virus, and the other parts of the immune system could also help provide protection.

Settling the question of whether reinfection is possible is important. If it can occur, that could undermine the idea of "immunity passports" for returning back to workplaces. And it would not bode well for hopes of getting a long-lasting vaccine. □

Returning UN envoy: Israel won't suffer for tight Trump ties

RAANANA, Israel (AP) — Israel's returning ambassador to the United Nations affirmed the country's bond with the Trump administration Tuesday, dismissing notions that Israel would pay a price for its tight ties to the divisive president should he be defeated in November. In his first comprehensive interview since returning from the diplomatic posting, Danny Danon said he was relieved that the more progressive forces in the Democratic Party failed to secure the party's nomination and claimed that Israel could prosper with either Trump or Joe Biden in the White House. When it comes to Israel, he says the country's supporters in the U.S. put their domestic politics aside.

"We have bipartisan support and we value and we cherish it," he said, at a temporary office near his home in central Israel. "I spoke publicly against Mr. Bernie Sanders. But he wasn't elected. Mr. Biden is a friend of Israel and he proved it over the years. So, yes, we hear those voices, the radical voices, but they're not the majority in the Democratic Party."

Dovish backers of Israel have accused Israeli Prime Minister Benjamin Netanyahu of undermining traditional bipartisan support over

the past decade. In 2012, he was seen as supporting Mitt Romney against then-President Barack Obama, and Netanyahu famously delivered a speech to Congress in 2015 railing against Obama's nuclear deal with Iran.

Jeremy Ben-Ami, president of J Street, a liberal pro-Israel lobbying group in Washington that has close ties to the Democratic Party, said it would be a "huge mistake" for Israeli officials to expect that all of the clashes with Obama and cozying up to Trump will be forgotten if Biden is elected president.

"The Netanyahu team chose a side in American partisan politics while pursuing policies that run counter to American values and interests," he said. "In doing so, the right wing has done significant damage to the relationship and should not expect that a new Democratic administration is going to act as if the past decade never happened."

In recent years, Netanyahu has emerged as one of Trump's strongest international allies, lavishing the American president with praise after openly clashing with Obama. He's been rewarded with what he

considers to be a slew of diplomatic achievements, most notably recognition of Jerusalem as Israel's capital and the moving of the American embassy there. But it has come at the cost of alienating some of Israel's more liberal American allies, who despise Trump, turning Israel into more of a wedge issue. Opinion polls show Republicans to be far more supportive of Netanyahu's policies than Democrats, especially among younger voters.

Influential American commentator Peter Beinart recently sent shock waves through the Jewish estab-

lishment by breaking a long-standing taboo and endorsing the idea of a single democratic entity of Jews and Palestinians living with equal rights between the Jordan River and the Mediterranean rather than the long-time goal of creating two states for two peoples.

The Democratic Party recently unveiled its Middle East platform, which largely adhered to its traditional approach of supporting Israeli security while calling for a two-state solution. But the party's progressive wing, led by Sanders, has urged a harder line by suggesting that American military aid be conditioned on changes in Israeli policy toward the Palestinians, such as its controversial settlement construction.

Prior to his posting, the 49-year-old Danon was known as an ideological firebrand in the ruling Likud Party who was not afraid to challenge Netanyahu from the right.

Danon's maverick ways pushed Netanyahu to fire him from his position as deputy defense minister in 2014. But the following year Netanyahu appointed him as a minister in his government before dispatching him as ambassador to the United Nations, a position that 30 years earlier launched Netanyahu's own political career. □

Germany: over a quarter of population has immigrant roots

BERLIN (AP) — More than a quarter of Germany's inhabitants are immigrants or have immigrant roots, according to official data for 2019 released Tuesday. Some 21.2 million, or 26% of the total population, have a "migrant background," according to figures from a 2019 microcensus, the Federal Statistical Office said. That is an increase of 2.1% compared to a year earlier — the smallest percentage increase since 2011, the office said. The largest single group, some 13% of all people who have a migrant background, are originally from Turkey or

with roots there, the office said. People with origins or roots from Poland and Russia followed. Overall, 65% of all immigrants have European roots. In Germany, somebody is considered to have a "migrant background" if they, or at least one of their parents, were born a non-German citizen. Some 11.1 million people, or 51% of the total with a migrant background, were born as German citizens. There is still a big difference between the numbers of immigrants living in western and eastern Germany. The northwestern city-state of Bremen has the highest

immigration-rooted population — 36.5% of the total population — while in the eastern state of Thuringia the figure is only 7.8%.

Following the division of Germany into east and west after World War II, West Germany invited millions of so-called guest workers to help rebuild the country, many of whom stayed for good.

Relatively few foreigners were allowed to live and work in communist East Germany. Thirty years after German unification in 1990, these differences are still visible. The new figures also show that people with im-

migrant roots are still overrepresented in low-paying jobs and underrepresented in professions that require an academic training. They

account for more than half, or 55%, of cleaning workers and 30% of geriatric care workers, but only 11% of teachers. □

South Korea to have solid fuel rockets in major deal with U.S.

SEOUL, South Korea (AP) —

South Korea said Tuesday it has won U.S. consent to use solid fuel for space launch vehicles, a move that is expected to enable Seoul to launch its first surveillance satellites and acquire technology to build more powerful missiles.

Solid fuel offers greater mobility for missiles and rockets, and reduces launch preparation time. But Washington had imposed strict restrictions on Seoul's use of solid propellant for space launch rockets out of concern that it could be used to produce big-

ger missiles and cause a regional arms race.

On Tuesday, the South Korean government said that Seoul and Washington have agreed to revise related bilateral missile guidelines to lift such restrictions. Kim Hyun-chong, deputy presidential national security adviser, told reporters that all South Korean research institutes, companies and individuals are now free to develop, produce and possess space launch rockets using solid fuel.

Kim said the revised agreement still bars South Korea from having a missile with a range of more than 800

kilometers (500 miles). But he said Seoul can discuss altering that restriction with Washington if it's needed for South Korean national security. A missile fired from South Korea with a maximum range of 800 kilometers is still enough to strike all of North Korea.

Kim said that South Korea's intelligence and reconnaissance capability would be significantly improved when it produces and launches solid-fuel rockets to put low-earth orbit spy satellites into space. He said it makes more sense to use solid fuel rockets for such satellite launches because the price of solid pro-

pellant is only about one tenth of the price of liquid propellant. "Theoretically, we can launch a low-earth orbit satellite via liquid-fuel rockets, but it's like delivering a dish of 'jjajangmyeon' by a 10-ton truck," he said, referring to a popular delivery food in South Korea.

Kim said South Korea has no military spy satellites while regional powers have dozens of them. He said the use of solid fuel rockets would help South Korea get an "unblinking eye" that monitors the Korean Peninsula around the clock.

Lee Choon Geun, a missile expert at South Korea's Science and Technology

Policy Institute, said South Korea could operate two or three low-earth orbit surveillance satellites to better monitor North Korea. He said solid propellants are easier to handle and require much less rocket launch times, though they have weaker thrust forces than high-quality liquid propellants. Lee said the latest deals with the U.S. would also allow South Korea to expand its space development infrastructure and accumulate know-how to manufacture missiles that can fly longer with bigger warheads. Experts say ballistic missiles and rockets in satellite launches share similar bodies, engines and other technology.

Jung Changwook, head of the the private Korea Defense Study Forum, agreed that technology to produce solid-fuel rockets can also be used to build longer-range missiles. He said the United States likely agreed on the deals' revision to strengthen its alliance with South Korea to better cope with China.

South Korea's missile capability is inferior to that of rival North Korea. In 2017, North Korea carried out three intercontinental ballistic missiles tests as part of its efforts to build a nuclear-tipped missile capable of reaching the U.S. mainland. In 2013, South Korea succeeded in thrusting an observational satellite into orbit aboard a rocket blasted from its soil for the first time, but parts of that rocket were built with Russian help. □

U.S. military says airstrike killed civilian in Somalia

JOHANNESBURG (AP) — The U.S. military on Tuesday acknowledged killing a civilian and wounding three others with an airstrike in Somalia earlier this year.

This is the second in a new series of quarterly reports the U.S. Africa Command issues on airstrikes in Somalia and allegations of civilian deaths after coming under pressure from Somalis and human rights groups.

The new report substantiates allegations around a Feb. 2. airstrike. At the time, the U.S. said one member of the al-Shabab extremist group

was killed in the vicinity of Jilib. "This admission is the third case they have substantiated in 13 years of airstrikes in the country," Brian Castner, Amnesty International's senior crisis adviser for arms and military operations, said in a statement. "Now that there has been an acknowledgment of their actions, there must be accountability and reparations for the victims and their families."

While the U.S. statement didn't give details about the civilian killed, the Amnesty statement said the airstrike killed a woman and wound-

ed three of her relatives. The human rights group last year released an investigation into U.S. airstrikes in Somalia that led to the U.S. acknowledging killing five civilians and wounding six others in three separate airstrikes.

The Trump administration has dramatically increased the number of airstrikes carried out in the Horn of Africa nation against the al-Qaida-linked al-Shabab extremist group and, to a lesser extent, a small number of fighters linked to the Islamic State group in northern Somalia. The U.S. carried out at least 63 air-

strikes in Somalia last year, most of them against al-Shabab, which often carries out deadly attacks in the capital, Mogadishu, and controls large parts of central and southern Somalia.

The new U.S. statement said it had received 12 new allegations this quarter around four incidents. It said four incidents remain under review, three of them from its previous report.

The U.S. Africa Command said those who wish to make allegations can submit them in their native language on its website. □

U.S. agency: Pandemic masks thwarting face recognition tech

Having a tough time recognizing your neighbors behind their pandemic masks? Computers are finding it more difficult, too. A preliminary study published by a U.S. agency on Monday found that even the best commercial facial recognition systems have error rates as high as 50% when trying to identify masked faces.

The mask problem is why Apple earlier this year made it easier for iPhone owners to unlock their phones without Face ID. It could also be thwarting attempts by authorities to identify individual people at Black Lives Matter protests and other gatherings. The National Institute of Standards and Technology says it is launching an investigation to better understand how facial recognition performs on covered faces. Its preliminary study examined only those algorithms created before the pandemic, but its next step is to look at how accuracy could improve as commercial providers adapt their

technology to an era when so many people are wearing masks.

Some companies, including those that work with law enforcement, have tried to tailor their face-scanning algorithms to focus on people's eyes and eyebrows. NIST, which is a part of the Commerce Department, is working with the U.S. Customs and Border Protection and the Department of Homeland Security's science office to study the problem.

It tested the software by

drawing digital masks onto the faces in a trove of border crossing photographs, and then compared those photos against another database of unmasked people seeking visas and other immigration benefits. The agency says it scanned 6.2 million images of about 1 million people using 89 algorithms supplied by tech firms and academic labs. Under ideal conditions, NIST says the failure rate for the best facial recognition systems is only about 0.3%, though research has found

significant disparities across race, gender and age.

Add masks and the failure rate rises to 5% or worse. When confronted with masks, the agency says, "many otherwise competent algorithms failed between 20% to 50% of the time."

Even before the coronavirus pandemic, some governments had sought technology to recognize people when they tried to conceal their faces.

Face masks had become a hallmark of protesters in Hong Kong, even at peaceful marches, to protect against tear gas and amid fears of retribution if they were publicly identified. The government banned face coverings at all public gatherings last year and warned of a potential six-month jail term for refusing a police officer's order to remove a mask.

Privacy activists, in turn, have looked for creative ways to camouflage themselves. In London, artists opposed to high-tech surveillance have painted their faces with geometric shapes in a way that's de-

signed to scramble face detection systems. Then came the coronavirus outbreak, when health experts around the world began strongly encouraging everyone to wear masks that cover the mouth and nose. NIST's preliminary study says what masks people wear, and how they wear them, makes a difference to facial recognition systems. The results are mostly unsurprising: The more facial features that are covered, the harder it is to recognize the person beneath the mask.□

Garmin acknowledges cyberattack, doesn't mention ransomware

BOSTON (AP) — The GPS device maker Garmin Ltd. acknowledged Monday being victimized by a cyberattack last week that encrypted some of its systems, knocking its fitness tracking and pilot navigation services offline. It said systems would be fully restored in the next few days. In an online statement, the company did not specify that it was the target of a ransomware attack, in which hackers infiltrate a company's network and use encryption to scramble data until payment is received. But a person familiar with the incident response told The Associated Press the attackers had turned over decryp-

tion keys that would allow Garmin to unlock the data scrambled in the attack. The person spoke on condition they not be further identified.

The attack crippled company services including Garmin Connect, which is popular with runners and cyclists for tracking workouts, and the FlyGarmin navigation service for pilots. A Garmin spokesperson said the company had no comment beyond its statement.

The online cybersecurity news site BleepingComputer identified the malware as WastedLocker, which various security firms have attributed to the Russian cybercriminal gang Evil Corp. The U.S. government announced in December

that it was freezing the assets of members of the group.

Olathe, Kansas-based Garmin said Monday that, in addition to GPS-based services, customer support and company communications were also interrupted by the July 23 attack.

"We have no indication that any customer data, including payment information from Garmin Pay, was accessed, lost or stolen," Garmin said in its statement. The attack also didn't

affect the functionality of any of its products, which include fitness watches, it added.

Ransomware is a growing threat and experts say it will only get worse if victims keep paying ransoms. In the U.S. last year, ransomware attacks on state and local governments, healthcare providers and educational institutions alone caused an estimated \$7.5 billion in damage, according to the cybersecurity firm Emsisoft.□

Ex-FBI agent Strzok due out with book about Trump, Russia


WASHINGTON (AP) — Former FBI counterintelligence agent Peter Strzok, who played a key role in the Russia investigation but whose pejorative text messages about Donald Trump during the 2016 campaign made him a target of the president's wrath, is releasing a book on his concerns the president could be compromised.

"Compromised: Counterintelligence and the Threat of Donald J. Trump" is due out Sept. 8, publisher Houghton Mifflin Harcourt Books & Media said in a statement to The Associated Press.

The book will offer an insider's view on some of the most sensational and politically freighted investigations in modern American history, including into whether the 2016 Trump campaign coordinated with Russia to sway the presidential election. Due out two months before the November election, the book adds to the list of first-person accounts from other senior FBI and Justice Department officials during the Trump era.

"Russia has long regarded the United States as its 'Main Enemy,' and I spent decades trying to protect our country from their efforts to weaken and undermine us," Strzok said Tuesday in a statement accompanying the book announcement. "In this book," he added, "I use that background to explain how the elevation by President Trump and his collaborators of Trump's own personal interests over the interests of the country allowed Putin to succeed beyond Stalin's wildest dreams, and how the national security implications of Putin's triumph will persist through our next election and beyond."

As a senior counterintelligence agent with more than 20 years at the FBI, Strzok helped lead the investigation into whether Democratic presidential candidate Hillary Clinton mishandled classified information on the private email server she relied on as secretary of state. The FBI ultimately recommended against criminal charges. He also played a pivotal role in the Russia investigation, including by interview-

ing former national security adviser Michael Flynn about his contacts with the Russian ambassador during the presidential transition period. Strzok briefly served on special counsel Robert Mueller's team but was removed from his role after the Justice Department inspector general flagged derogatory and pejorative text messages about Trump that Strzok sent and received during the 2016 campaign. Once the texts were made public, Strzok

became a regular Twitter target of the Republican president's attacks, with Trump alleging that Strzok and others in the FBI had plotted against his campaign and had even committed treason — an accusation that Strzok's lawyer rejected as "beyond reckless." The text messages were exchanged with an FBI lawyer, Lisa Page, and Trump routinely refers to the two of them together as "the lovers."

At a fiery, daylong congressional hearing in July 2018, Strzok insisted that he never allowed personal viewpoints to influence his work, though he did acknowledge being dismayed by Trump's behavior during the campaign.

The text messages featured prominently in the inspector general investigations into the Clinton and Russia probes, but the watchdog office said it did not find evidence in either case that the actions that Strzok and other FBI officials took were motivated by political bias. Strzok was fired from the FBI in August 2018, though he has since sued over the termination. He remains a

frequent target of Trump's scornful tweets. In a statement announcing the book, the publishing company said "the Trump administration used his private expression of political opinions to force him out."

"But by that time," the statement added, "Strzok had seen more than enough to convince him that the commander in chief had fallen under the sway of America's adversary in the Kremlin." Though Mueller did not allege a criminal conspiracy between Moscow and the Trump campaign, the publisher said that in the book, Strzok "grapples with a question that should concern every U.S. citizen: When a president appears to favor personal and Russian interests over those of our nation, has he become a national security threat?" Former FBI Director James Comey and former Deputy Director Andrew McCabe have each released books that describe aspects of the Trump investigation.

Andrew Weissmann, a former Justice Department prosecutor who served on Mueller's team, is due out with a book in September. □

Silkroad, the acclaimed international musical collective with a social conscience, has a new face — and a fresh sense of purpose. Grammy-winning folk singer and instrumentalist Rhiannon Giddens is Silkroad's new artistic director, taking the baton from renowned cellist Yo-Yo Ma, who founded the group two decades ago, Silkroad said Tuesday.

The 43-year-old North Carolina native is the first woman and first multiracial artist to lead Silkroad. The Boston-based organization is known not just for its touring ensemble comprised of world-class musicians from all over the globe, but also for its efforts to use the arts to bridge differences across races, countries and cultures.

"My keenest desire for Silkroad is a sharpening and reinterpretation of what it means for the 'right now,'" Giddens said in a statement, adding: "What is more American than the gathering of influences from disparate areas of the globe to create something unique and fantastic?"

She makes her debut Wednesday evening with "Recitals from the World Stage," a virtual presentation prerecorded for Tanglewood, the Boston Symphony Orchestra's summer home in the Berkshires of western Massachusetts. Ma, who launched Silkroad in 1998 and stepped down as artistic director in 2017, called Giddens "an extraordinary human being and musician."

"She lives Silkroad's values, at once rooted in history and its many musics, and is

an advocate for the contemporary voices that can move us to work together for a better world," Ma said. "In addition to her enormous musical talent, she fosters an immense social consciousness and creates unity through her art," said Kathy Fletcher, Silkroad's executive director.

Silkroad has recorded seven albums, including "Sing Me Home," which won a Grammy in 2016 for best world music. Founded to "seek and practice radical cultural collaboration in many forms," it holds training workshops and residency programs for music teachers and musicians around the globe.

The group takes its name from the ancient Silk Road trade route that linked China to the West, with the two hemispheres exchanging not only goods but ideas. □



Aruba National Park: Conservation work is a focal point during Conservation Week Aruba 2020


ORANJESTAD — From 26 July to 1 August, Fundación Parque Nacional Aruba (FPNA) celebrates its first ever Conservation Week, an awareness event that the nature conservation organization intends to repeat in the coming years.

Natasha Silva – Chief Conservation Officer – explains why such an event is important: "Well, at FPNA we are noticing an increase in public interest in nature and sustainability related topics, while at the same time we're witnessing an increase in threats to our island's biodiversity and the conservation of ecosystems and habitats." While her answer may surprise you, especially in the celebratory wake of recently acquiring 16 new nature reserves, Silva continues with: "Let me explain ..."

The current global and local environmental challenges have drastically changed the way we do nature conservation over the last decades. We have to deal with apocalyptic, global threats like climate change and ocean acidification. While at a local level our conservation work is challenged by an increase in the human population and tourism, overstressing the island's carrying capacity, land conversion, desertification and freshwater withdrawals, soil deterioration (erosion, salini-

zation, and soil fertility loss), pollution (air, water, land – including toxic substances), coastal development, deteriorating ecosystems health, (marine) overharvesting, introduction of invasive species such as tilapia, boa and cane toads, and biodiversity loss.

The Lora (yellow-shouldered parrot) and the Paloma Azul (scaly-naped pigeon) have already become extinct on Aruba, the charismatic Patrishi (crested bobwhite) and Coneo (cotton-tailed rabbit) have almost disappeared, and iconic endemic species such as Cascabel (Aruba island rattlesnake), Prikichi (Aruban brown-throated parakeet), Shoco (Aruban burrowing owl) and numerous species of flora are now endangered, some even critically. Silva exclaims: "We must prevent further extinction, as with the disappearance of species and habitats, we are also losing our Aruban identity." At the same time there's reason to celebrate. Only last week, 16 new nature reserves were brought under the management of FPNA. Together with the previously protected Arikok National Park and Ramsar area Spaans Lagoen, Aruba's protected areas contain important ecosystems and habitats – such as arid, xeric shrubland, vulnerable dune areas with characteristic vegetation,



hilly landscape, wetlands, watershed and drainage areas – which are home to many often vulnerable, endangered, and/or endemic species, including 10 species of terns, bats, frogs and numerous insects such as butterflies and other pollinators. Now more than 20% of the island is officially protected and the foundation also manages four Marine Protected Areas (MPAs) which collectively form the Parque Marino Aruba (6020 hectares). Although this may seem like a lot, the entire island and coastal seas are needed to prevent populations of flora and fauna from going extinct.

FPNA is already working on a Shoco recovery program together with Aruba Bird-life Conservation and the

Global Owl Project and will continue the coming years to further develop numerous other conservation programs together with local and international organizations. Partnership is key. However, working on biodiversity recovery and increasing ecosystem health alone is not enough.

Silva: "As a community, we need to change our way of thinking and develop sustainable behaviors. We need to start seeing the island as one big ecosystem and see us humans as part of this system. Nature is not something out there. Nature is all around us and humans are an integral part of nature. This way of thinking does not limit nature to protected areas only. After all, nature does not adhere to human induced boundaries: there are also Cascabel, Shoco and Prikichi living outside of our nature reserves in areas which under the national Spatial Development Plan (2019) are designated as 'Natuur en landschap', 'Landelijk gebied' and even in urban areas. All these spaces need to be connected by so-called 'green corridors', for wildlife to follow their natural rhythms and safely travel from one area to another. However, we can also go a step further and make our urban areas nature rich and nature friendly. This

would be truly working towards finding a balance by building and living with nature." "If we manage to achieve this then I believe that Aruba will be a wonderfully unique place and an example to the world!" Silva claims. "Moreover, safeguarding our natural resources will benefit our economy. Destroying them will negatively impact our economy, including our fisheries and tourism." FPNA's 2020 Conservation Week specifically celebrates Aruba's unique and protected nature with several conservation events, a webinar with FPNA's conservation experts, an online conservation quiz, and a rough hike in the national park.

FPNA will continue stimulating awareness and working hard the coming years towards contributing to a sustainable future for Aruba's people and a resilient, species-rich and diverse nature.

Silva ends: "Aruba's beautiful, unique and fragile nature is a common good. Tackling threats, forwarding nature conservation and working towards a sustainable future is by extension the responsibility of us all: nature NGOs, government, private sector and the community at large". (www.arubanationalpark.org/). □
