Pero di su banda, Prome Minister Evelyn Wever-Croes a sigura cu a logra bin cu cierto cambio substancial a base di negociacion riba e proposicion inicial cu a bin riba mesa.

“Mi ta kere cu nos rosea financiero ta yega pa e dia di rijksministerraad cu ta diabierna,” el a bisa. Nan ta calcula cu nos reserva financiero actual lo yega te mita di september.

Cambionan

E mandatario a señala algun cambio principal entre otro pa loke ta trata supervision financiero, Aruba lo haya otro cu e RST cu ta conta pa Corsou y St. Maarten, mirando cu nan situacion ta diferente cu esun di nos pais. Tambe riba tereno financiero, durante dos aña Hulanda lo tuma riba su encargo refinancia nos debe cu ta caduca pa



2021 y 2022. Kiermen cu e debenan aki cu ta bay caduca, Aruba no mester bay mercado internacional pa busca un fianza pa nan.

E ta considera esaki como un alivio, mirando cu actualmente nos rating duna pa instancianan di evaluacion manera Standard & Poor's no ta mucho di gaba cune. Esaki ta un punto cu e prome mandatario ta considera importante y cu nan a logr'e durante e negociacion cu Hulanda.

Pa loke ta landspakket, cu ta e

lista di tur e reforma cu Hulanda kier pa Aruba bin cune, nan a logra algun cambio. El a laga sa cu nan a logra un miho comprendemento di kico ta para eynan y kico ta intencion di cada un di nan. Entre nan, asunto di edad pension di 66 aña en bes di 67 aña, caminda a wordo haci un ahuste pa bin cu un estudio prome.

Tambe e asunto di benta di compania estatal caminda na principio a duna impresion cu e entidad lo dicidi cual di nan lo wordo bendi of no. E

asunto aki a wordo cambia caminda prome ta haci un sondeo di e situacion financiero di e compania estatal. Igualmente Parlamento ta keda cu e ultimo palabra, ya cu den nan statuut ta para esey.

E punto di entidad cu Hulanda kier bin cune pa ehecuta entre otro e reforma, practicamente nan no a logra mayor cambio cu Hulanda. E tarea di entidad – segun e prome mandatario – ta esun di atende unicamente cu e landspakket "cu gobierno di

Aruba ta duna aprobacion adelanta."

Segun e mandatario nan a purba di limita e autoridad hopi extenso cu e entidad tabatin. E mandatario a sigura cu awe den conseho di minister e lo bin cu un proposicion pa institui un organo propio di reactivacion economico cu lo atende cu nos master plan.

Igualmente e tabata muestra un organo pa Aruba so, ya cu St. Maarten y Corsou no kier a acepta e entidad aki. Pero e ultimo documento cu a drenta siman pasa ta indica cu e ta bira un entidad pa e tres paisnan Caribense. Den e punto aki, premier Wever-Croes a indica cu lo busca mas claridad y con e cambio aki lo por afecta loke ya caba nan a yega di palabra.

Pero di otro banda Hulanda no tabata kier cu e consulta aki ta wordo haci di acuerdo cu Aruba su deseo. Segun e mandatario, e acuerdo entre RdA y e compania cu lo lease e tankinan ta basta avansa caba, y seguramente pa e luna aki actividad ta cuminsa. Un biaha mas, Minister Presidente a sigura cu e no tin e nomber di e compania, pero el a keda di averigua cerca RdA pa asina haci publico. E compania estatal aki lo bini cu mas informacion pa prensa riba e topico aki.

Pero si el a sigura cu e acuerdo ta casi kedando cla, loke ta nifica entrada necesario pa RdA. Mientras cu tin otro tres tanki pendiente RdA por clean up y haci nan bashi pa por lease nan. El a sigura cu esaki ta totalmente otro procedura cu esun di e refinaria, ya cu esaki ta trata di huurmento di tankinan.

Nan ta solicita atencion di Directie Infrastructuur en Planning (DIP) y specialmente di minister di Infrastructura, Marisol Lopez-Tromp, pa motibo cu el a expresa cu nan ta pensa cu nan expresionnan no a yega na su oido, of no a yega cu e enfasis cu tabatin mester.

Di mesun manera, Guanipa a trece dilanti cu nan intento pa yega na acuerdonan cu DIP ta data for di mesun aña cu Welcome Plaza a habri na 2018. Nan a cuminsa manda cartanan no solamente como Asociacion di Comerciantenan di Welcome Plaza, pero tambe individualmente otro comerciantenan di e luga, pero ningun di e carta a haya un contesta, Guanipa a sigura.

Pa loke ta trata e crisis di Covid-19, Guanipa a expresa cu e situacion a yega na tal punto cu ta insostenibel pa e comerciantenan y artesanonan. Diabierna 13 di maart ultimo tabata e ultimo dia cu tabatin un barco na waf y tabata e ultimo dia cu Welcome Plaza a habri su portanan.

Pero, a pesar cu frontera a habri no tin fluho di turista



pa e area aki, cu ta hustifica pa e tiendanan por habri. Mesun situacion ta pasa na e mercado cu ta ubica na otro banda di e plasa. Guanipa a comenta cu expertonan local y den exterior ta pronostica cu industria crucero no lo ta back pa e aña aki mas y ora cuminsa, lo ta na un nivel hopi abou, manera a keda conoci den pasado.

“Nos ta e artesanonan cu tanto ta papia di dje di bay promove, empresarionan chikito cu tambe a scucha cu mester bay pusha pa nan bay dilanti. Nos kier, nos mester y nos ta desea di haya e ayudo aworaki, pasobra nos mester di dje”, Guanipa a bisa.

El a splica cu nan a aplica pa e ayudo Fase y tin algun cu a haya pa un luna of dos, pero

tambe otro cu no a haya e ayudo mes y cu aworaki cu ya tin seis luna cu e negoshinan ta cera. Tin aproximadamente 30 famia afecta pa e situacion aki.

Aparte di e preocupacion cu nan tin, tin tambe stress constante pa motibo cu nan no sa kico lo pasa cu nan inversion cu nan tin den e luga. El a expresa cu comerciantenan kier sinta cu DIP y traha cu nan pa yega na un solucion.

Lia Maldonado, un di e artesanonan di e plasa cu tin 44 aña den negoshi aki, na momento cu a cuminsa na Eagle cu artesanía Arubiano a presenta algun documentonan pa medianan di comunicacion presente, riba cual a pone e problemanan cu nan a

haya na e luga aki for di 2018. Por ehemplo, algun portanan y diferente aspecto cu mester wordo drecha, pero nunca nan no a haya oido.

Tambe Maldonado a bisa cu den e temporada aki nan a purba di bay personalmente na DIP, pero si no tin afspraak no ta atende nan. “Minister di Infrastructura, scucha nos y wak tur e problema cu Welcome Plaza tin, cu no ta habri aworaki, cu no tin ni crucero, ni turista y asina con nos ta haya entrada?” Maldonado a especifica.

Algun otro problema cu infrastructura ta presenta, ta trata cu si awa ta yobe nan no por habri, of si awa ta bay cay nan mester muha pa warda tur e mercancia y asina por

cera e luga. Tin hopi aspectonan cu no ta cuadra pa ta un luga agradable pa e bishitantenan. Ademas di esey nan tin tres baño, cu un so ta wordo usa, y si esunnan cu tin e yabi no t’ey, e bo no por usa e baño. Tambe ora turistanan di edad avansa ta cana, nan no tin un luga pa sinta.

Di loke ta trata e huur, nan tin seis luna di huur cu nan ta pagando sin un turista. Otro comerciantenan a dicide di baha e suma di huur, nan a firma varios peticion pa wak si nan por papia over di e huur. “E idea tabata cu nos kier pa nan stop di cobra huur pa seis luna, y asina nan no cobra nos mes. Pasobra nos ta cera, pero nos no por haya ningun contesta di DIP.”

STA y FTA ta comparti pensamento: Hulanda no ta confia nos politiconan

Sin e sosten di Hulanda situacion economico manca lo bira un caos



Hulanda a muestra di no ta confia nos politiconan cu nan placa y tin biaha mester dal stap patras pa dal dos dilanti despues. Esey ta pensamento di dos lider sindical, cu ta di acuerdo cu kisas ta ora pa acepta e condicionnan di Hulanda pa bienestar general di Aruba.

Pasobra e situacion financiero di famianan ta urgi esey. “E enemigo mas grandi di hende ta hamber. No ta prudente pa pusha nos pais den pobresa y miseria pa motibo di un par di documento cu despues di tempo por cambia,” tabata e palabranan cla di Diego de Cuba, lider di Sindicato di Trahadonan Arubiano, STA.

Hubert Dirksz di FTA, ta sinti cu e condicionnan cu Hulanda ta impone, ta pasobra simplemente ‘nan no ta confia politiconan Arubiano cu nan placa’. E posicion aki sinembargo no ta nifica cu e dos lidernan sindical ta cla pa duna Hulanda un premio pa su actitud. Al contrario. Sinembargo, e realidad ta cu Aruba ta cu su lomba na muraya y tin hopi tension. Particularmente pa motibo cu e recuperacion economico lo tuma por lo menos tres aña y sin sosten Hulandes, e situacion social lo bira uno explosivo.

STA

“No ta asina cu Aruba ta perde autonomia, manera hopi hende ta bisa,” Diego de Cuba a comenta na Bon Dia Aruba. Repasando tur e documentonan, e ta posibel pa sigui negocia despues. Sinembargo, berdad ta cu dirigentenan Hulandes lo por bin ‘snuffel’ den cierto area, ‘algo cu kisas cierto Minister y Parlamentario lo no gusta. Pero si nan no tin nada di sconde, nan lo no tin nada di teme’, De Cuba a bisa. “Ta for di Status Aparte nos a mira cuanto Minister y

Parlamentario a enrikece nan mes. E cos aki mester caba. Como pais chikito, nos mester a maneha nos asuntonan miho.”

Di otro banda, berdad mester un balans. Pasobra e ta di acuerdo cu Profesornan di Ley di Hulanda, kendenan a ilustra cu Hulanda no ta actua correctamente riba nivel estatal. Nos pais ta den un crisis y ta haci uso di e situacion pa bin cu condicionnan pisa. Esaki, mientras cu net awor Aruba a cuminsa bay den bon direccion. “Presupuesto tabatin un surplus. No ta Aruba a bisa esey, ta CAFT a bisa esey. Y como tal, a recomenda pa Aruba a haya e di tres tranche di prestamo. P’esey ta straño cu diripiente Hulanda a mara e prestamo na condicionnan mas estricto.”

Ta poco biaha cu politiconan di diferente partido ta comparti e mesun pensamiento y aki, mayoria ta contra pa acepta e condicionnan di Hulanda. “Mi ta compronde nan punto di bista.” De Cuba ta compronde cu Parlamentarionan tin miedo cu Aruba ta bay den e mesun direccion cu Boneiro y St. Eustatius.

Lo por considera otro rumbo tambe, pasobra tin placa na Aruba. E fondo di Pensioen General di Aruba, APFA tin biyones y banconan tambe, a pesar di a haya sla, tin hopi likides. Aruba lo por saca bononan pa gana tempo y negocia di berdad cu Hulanda. “No ta e intencion pa debilita e fondonan, mas ainda, e prestamonan aki lo ta hopi caro. Ademá, fondonan cu ta disponibel lo bay pa e carga salarionan y ta nifica cu un biaha mas, inversion den diversificacion lo no ta posibel y atrobe esey ta ilustra e posicion vulnerabel cu Aruba ta aden.”

Entre spada y muraya

De Cuba a bisa cu e no lo tin problema pa lanta un revolucion na Aruba pa bringa e condicionnan. “Mi por lanta hendenan. Es mas, mi tin un documento y carta traha caba pa manda VNO, Tweede y Eerste Kamer. Pero kico e ta bay yuda. Rutte y Knops ta para firme den e posicion di Gobierno Hulandes.”

De Cuba ta sinti cu mester sigui negocia cu Hulanda pa cambia pensamento y algun

di e medidanan. Si ta posibel, hasta prome cu acepta e condicionnan. Ideal lo tabata si por a bay Nacionnan Uni of otro organisacionnan global. Riba e pregunta si Aruba tin e tempo pa esey, De Cuba a bisa sinembargo cu: “nos ta entre e spada y muraya.”

Propio responsabilidad

Diego de Cuba a bisa si cu e problema di Aruba, for di Gobierno te na ciudadano, ta cu no ta spaar. “Mi a yega di trece e asunto aki dilanti mas cu cuater aña pasa. Si nos tin 55 mil trahado, y dunado di trabou (incluyendo Hulanda) y trahado spaar hunto sikiera 100 florin pa luna pa un fondo di emergencia, den un aña lo a logra 66 miyon florin. Y si a inicia cu esaki e momento cu STA a sugeri esaki, lo tabatin un fondo di emergencia pa trahado di 264 miyon florin. Lo por a usa parti di dje hasta pa cierto inversion sin cu mester paga interes halto. Algun compania cu si a acepta un fondo di spaar asina y nan ta usando esey awor.” Kisas e ta un les pa nos pa nos siña con vulnerabel y pover nos ta. Nos mester cambia nos sistema di bida. Ta un hecho cu mayoria hende ta biba riba entrada. Si djis mira cuanto auto grandi tin riba caminda, cuanto hoben tin auto grandi.

No ta pa semper

De Cuba ta bisa cu e situacion ta hopi cla. “Yega na unda mester yega. Si esey ta e condicionnan, nan ta pa seis te cu siete aña. Y seis aña ta pasa den un rato. Mi ta prefera pa nos perde un bataya, pero no perde e guerra.”

Diego de Cuba na final, pues, no ta mira unda otro lo por saca e placa pa sostene economia di Aruba. E loonsubsidie y FASE a wanta economia draai y a permiti hende sobrevivi. “E tabata un alivio. Ami mes ta traha na Aeropuerto y turistanan ta keda dreña, y buelonan ta aumentando. Pero nos no ta bay yega na e nivel di 2019 pa awor. Pasobra otro paisnan tambe ta pega cu Covid19.”

Diego de Cuba a bisa cu e pandemia a muestra con vulnerabel y ‘con pover nos ta. P’esey, awor no ta momento di actua cu terkedad,’ e sindicalista a comenta. “Bo ta imagina Aruba dos luna sin loonsubsidie, sin FASE? Lo no tin placa pa paga onderstand, nos

lo ta mal para.”

FTA

Federacion di Trahadonan Arubano, FTA ta sostene e carta cu AHATA y otro gremionan comercial a manda pa Gobierno siman pasa. “Prome Minister mester evita cu tin drama, mester evita cu tin caos, y empeoramento di un economia manca,” su Presidente, Hubert Dirksz a bisa. “Si no tin subsidio di salario, diferente empresa lo cera na porta, hopi hende lo ta na cas y e situacion social lo ta hopi mas grave.”

Dirksz a bisa cu e ta di opinion cu berdad Hulanda ta pone condicionnan fuerte, kisas te hasta ta abusa di su poder. “Si tin espacio pa negocia, negocia. Pero na mesun momento, despues di papia cu diferente sindicato, nos tur a expresa cu nos mester mas transparencia di parti di Gobierno, pasobra si nos no sa kico ta pasando, unda e negociacionnan ta y asina nos no por duna nos aporte tampoco.”

Pasa loke mester pasa, si companianan no tin entrada, ta bay yega un momento cu no por paga salario. Sigur no cu locual tin acorda. “Tin hopi cu ta paga 80 porciento danki na e subsidio y sin subsidio lo no por paga mas cu esey. Nos situacion ta depende di Gobierno. Pero ya caba, manera cu e ta caba, tin hopi negoshi ta pasando dificil, y trahadonan no tin ningun garantia kico ta bay pasa. E ta dificil.”

No tin confianza den politico Arubiano

Segun FTA, e enfoka mester ta pa mira con, hunto cu Hulanda, percursa cu ta surpasa e crisis mas sigur posibel. Dirksz ta compronde cu pa politiconan, e ta dificil pa entrega e maneho total den man di Hulanda, y no solamente e parti financiero.

“Nos por bisa cu Hulanda su posicion ta, basa riba nos record di Status Aparte te cu awo, cu no ta confia nos. Nan no ta confia ni un politico, ni esunnan awor.”

FTA ta consciente cu Secretario di Estado Raymond Knops a bisa no lo duna ningun concesion riba e condicionnan pa e prestamo y e pakete di reforma y recuperacion. “E unico forma pa Aru-

ba por a negocia, ta si tabatin forza pa negocia. Si bo ta man bashi y cu tur locual mester pasa, tur placa, delaster un cen cu nos lo usa na Aruba, ta bin di Hulanda, anto Hulanda lo exigi pa e mes maneha su placa.”

Den pensamiento di Dirksz, e posicion Hulandes aki ta basa riba tur locual a pasa den ultimo 34 aña. “Considerando cu e placa ey, cu ta bay pa fundacionnan, companianan, e no ta mishi e area di Minister di Finanzas so. E placa di Hulanda lo mishi tur otro sector cu ta cay bou maneho di otro Ministernan tambe. Pues nan ta mira e relacion cu tur e otro Ministerionan como importante pa nan mes manch’e.” Den concepto di Dirksz, den e sentido aki, Aruba no por bisa mucho mas.

Autonomia

Pa loke ta e derecho di autodeterminacion, e ta compromete e postura di politiconan Arubiano.

“Mi ta kere cu Hulanda lo mester tene cuenta cu esey. Pero Hulanda ta bay argumenta a cambio cu no ta kita autonomia, ya cu e ta un paso temporal. Hulanda ta bisa cu e situacion ta temporal y mester hancr’e un caminda. Profesor Kunnemans di otro banda a duna espacio pa hiba un negociacion politico. Hulanda mester haya un garantia si. Pero no ta Gobierno so por dicitu. Gobierno ta para su so, y Hulanda ta mira esey.”

Dirksz ta bisa cu si tabatin un union entre gremionan y Gobierno lo por a logra mas. E cumbrenan organisa pa Gobierno no a duna suficiente informacion y sigur no tabata dialogo di forma cu gremionan por a duna nan aporte. “For di politiconan por sinti hopi emocion, unda ta enfoca riba e lucha pa Status Aparte. Mi ta compronde. Pero tin un realidad di hende sin trabou y sin cuminda. Ta bisa cu Hulanda ta mal usa e momento pa bin cu su condicionnan, pero netamente pa e motibo ey mester a sinta hunto pa e fundamento di negociacion ta mas fuerte pa convence Hulanda.”

Sinembargo awor aki e situacion ta insigur y ademá di Covid, e presion ta hopi grandi y e tension t’ey, cu por hasta yega na un explosion social.”

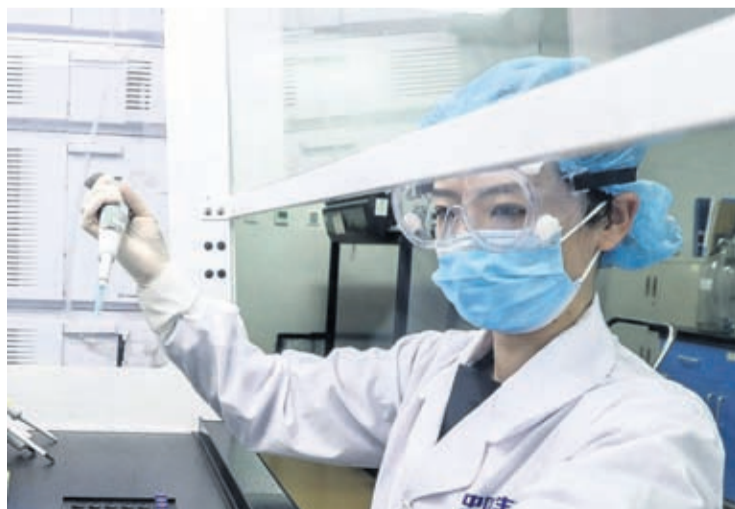

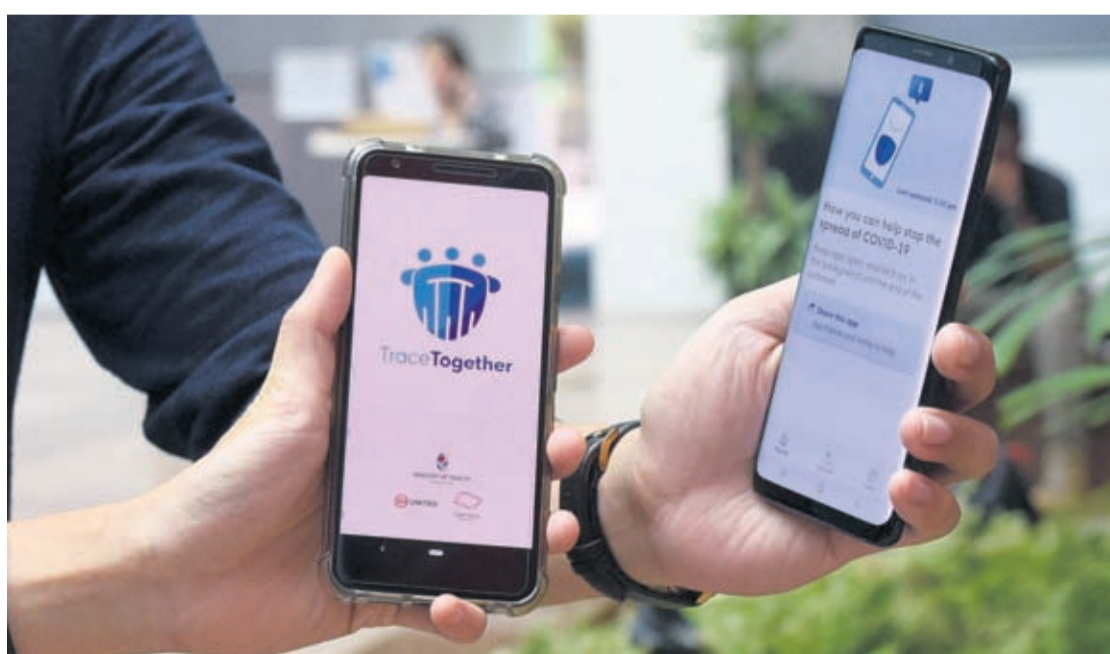

HRW: Migrante Venezolano den riesgo di Covid-19 den centronan di detencion

(hrw.org) – Desde mei, migrantenan Venezolano deteni den e facilidad di detencion administra pa Guarda Nos Costa a participa den cuatro protesta exigiendo pa wordo repatria na Venezuela, segun organisacion pa derechonan humano, Human Rights Watch.

Appeals court keeps Flynn case alive, won't order dismissal

WASHINGTON (AP) —

A federal appeals court in Washington declined Monday to order the dismissal of the Michael Flynn prosecution, permitting a judge to scrutinize the Justice Department's request to dismiss its case against President Donald Trump's former national security adviser.

The decision keeps the case at least temporarily alive and rebuffs efforts by both Flynn's lawyers and the Justice Department to force the prosecution to be dropped without any further inquiry from the judge, who has for months declined to dismiss it. The ruling represents the latest development in a criminal case that has taken unusual twists and turns over the last year and prompted a separation of powers tussle involving a veteran federal judge and the Trump administration. In a separate ruling Monday, a three-judge panel of the same appeals court again threw out a lawsuit by House Democrats to compel former White House counsel Don McGahn to appear before a congressional committee. The Flynn conflict arose in May when the Justice Department moved to dismiss the prosecution despite Flynn's own guilty plea to lying to the FBI about his contacts with the Russian ambassador during the presidential

transition period.

But U.S. District Judge Emmet Sullivan, who had upbraided Flynn for his behavior at a 2018 court appearance, signaled his skepticism at the government's unusual motion. He refused to dismiss the case and instead scheduled a hearing and appointed a retired federal judge to argue against the Justice Department's position. That former judge, John Gleeson, challenged the motive s behind the department's dismissal request

and called it a "gross abuse" of prosecutorial power. His lawyers then sought to bypass Sullivan and obtain an order from the appeals court that would have required the immediate dismissal of the case. They argued that the judge had overstepped his bounds by scrutinizing a decision that both sides, the defense and the Justice Department, were in agreement about and that the case was effectively moot once prosecutors decided to abandon it.

At issue before the appeals

court was whether Sullivan could be forced to grant the Justice Department's dismissal request without even holding a hearing to scrutinize the basis for the motion. "We have no trouble answering that question in the negative," the court wrote in an unsigned opinion for the eight judges in the majority. The judges also rejected defense efforts to have Sullivan removed from the case.

In a concurring opinion, U.S. District Judge Thomas Griffith wrote that the court's

opinion did not concern the merits of the Justice Department's prosecution of Flynn or even its decision to abandon the case. Rather, he said the question before the judges was a much more simple one. He said it was very possible that Sullivan could wind up granting the Justice Department's dismissal request and that it would be "highly unusual if it did not, given the Executive's constitutional prerogative to direct and control prosecutions and the district court's limited discretion" in cases that prosecutors want dropped.

Two judges, Neomi Rao and Karen LeCraft Henderson, each wrote dissenting opinions arguing that Sullivan had usurped his authority by keeping alive a case the Justice Department sought to have dismissed. Both judges were part of a 2-1 ruling in June that ordered Sullivan to dismiss the case.

"In Flynn's case, the prosecution no longer has a prosecutor," Rao wrote. "Yet the case continues with district court proceedings aimed at uncovering the internal deliberations of the Department. The majority gestures at the potential harms of such a judicial intrusion into the Executive Branch, but takes a wait-and-see approach, hoping and hinting that the district judge will not take the actions he clearly states he will take. □"

Delta, American join United in dropping most U.S. change fees

This could be the final boarding call for the \$200 ticket-change fee that has enraged so many U.S. air-

line travelers over the past decade.

Delta Air Lines and American Airlines said Monday that they are dropping the fee on most tickets for do-

mestic flights, copying United Airlines' move one day earlier.

Southwest Airlines didn't levy change fees to start with, so Monday's announcements mean that the four biggest U.S. carriers will have roughly similar policies.

Airlines are being battered by the coronavirus pandemic, as travel restrictions and fear of contracting the virus are keeping travelers at home. Normally in summer, 2 million or more people pass through security checkpoints at U.S. airports each day, but that number hasn't been above 900,000 since mid-March, the early days of the pandemic.

To woo passengers, airlines have required face masks and stepped up cleaning of planes.

A few, including Delta, Southwest and JetBlue, limit seating, although American and United try to sell every seat.

Delta and American said they have permanently eliminated change fees for all domestic flights for premium and most economy fares except the lowest fare, called basic economy.

American said it will let all passengers fly standby for earlier same-day flights without charge beginning Oct. 1. United is making that change on Jan. 1.

Both carriers also extended temporary waivers on change fees for domestic and international flights, so ditching the fees permanently won't make much difference to passengers right away. But by doing so, United, Delta and American

are abandoning a fee that has drawn particular scorn from customers, consumer advocates and members of Congress.

Airline shares fell on Monday after United's decision and the expectation that other big airlines would be forced to ditch their change fees too. Delta and United both ended down 3.6%, American shed 4% and Southwest retreated 3.2%. Even without change fees, plenty of other fees will survive.

Charges for checking a bag were greatly expanded more than a decade ago. Many airlines also charge extra for seat assignments, more legroom, priority boarding and other perks, and they provided a growing source of revenue for airlines until the pandemic hit. □

May 24 trial set for Steve Bannon in fundraising fraud scam

NEW YORK (AP) — A May 2021 trial date was set Monday for Steve Bannon, President Donald Trump's former chief strategist, on charges that he cheated donors to a group seeking to fund a southern border wall. Bannon, 66, of Washington, D.C., was audible but not visible on a video screen as he appeared for the first time before U.S. District Judge Analisa Torres, who set a May 24 trial date.

The hearing was notable, too, as a prosecutor said one of Bannon's codefendants had made inflammatory claims on social media asserting the prosecution was politically motivated and an assault on the freedom of donors.

In an indictment along with three others, Bannon was charged two weeks ago with unlawfully raising over \$25 million for the "We Build The Wall" campaign.

Prosecutors said thousands of investors were duped into thinking all of their donations would go toward the project, even though Bannon diverted over a million dollars, paying salary to one campaign official and personal expenses for himself.

Bannon pleaded not guilty after his Aug. 20 arrest aboard

a luxury yacht off the coast of Connecticut. He was freed on \$5 million bail by a Manhattan magistrate judge.

As he left the courthouse, he shouted: "This entire fiasco is to stop people who want to build the wall."

Also appearing Monday only by audio on a video screen were Bannon's codefendants, including Brian Kolfage, the project founder and an Air

Force veteran who lost both legs and a hand in a mortar attack in Iraq.

Kolfage, 38, of Miramar Beach, Florida, spent some of the over \$350,000 he received on home renovations, payments toward a boat, a luxury SUV, a golf cart, jewelry, cosmetic surgery, personal tax payments and credit card debt, the indictment said.

Assistant U.S. Attorney Ali-

son Moe complained Monday that Kolfage has made comments on social media that violated local rules governing the behavior of parties to legal cases in New York federal court and threatened to taint the potential jury pool.

In a letter to the judge, prosecutors cited "a steady stream" of "highly inflammatory" public statements Kolfage has

made, including claims that the prosecution was an assault on the freedom of donors for "political reasons."

"I gave 3 limbs defending this freedom, and I'd proudly give another to fight back at this injustice to preserve the future of this nation," Kolfage wrote in one Facebook post.

"The witch hunt is on!" he protested in another.

Kolfage's attorney, Harvey Steinberg, said prosecutors were the real violators of local rules because of statements law enforcement authorities made the day of the arrests. He said prosecutors were acting like a schoolyard bully who hits somebody and then "runs to the teacher" when struck back.

The judge warned all parties to obey local rules banning statements that could interfere with a fair trial or prejudice the case.

Also charged were Andrew Badolato, 56, of Sarasota, Florida, and Timothy Shea, 49, of Castle Rock, Colorado. Kolfage, Badolato and Shea entered not guilty pleas Monday. They will be tried alongside Bannon in May. All four are free on bail after being charged with conspiracy to commit wire fraud and conspiracy to commit money laundering. Each charge carries a potential penalty of up to 20 years in prison. □

SAN DIEGO (AP) — A federal judge on Monday blocked U.S. Customs and Border Protection employees

from conducting the initial screening for people seeking asylum, dealing a setback to one of the Trump administration's efforts to rein in asylum.

The nationwide injunction will likely have little, if any, immediate impact because the government has effectively suspended asylum during the coronavirus pandemic, citing public health concerns. The Trump administration argued that designated CBP employees are trained comparably to asylum officers at U.S. Citizenship and Immigration Services, another agency within the Homeland Security Department. U.S. District Judge Richard J. Leon in Washington disagreed.

"Poppycock!" he wrote in a 22-page decision. "The training requirements cited in the government's declaration do not come close to being 'comparable' to the training requirements of full asylum officers."

Leon, who was appointed by President George W. Bush, said CBP employees get two to five weeks of distance and

in-person training, while asylum officers get at least nine weeks of formal training.

Leon also cast doubt on whether CBP, a law enforcement agency that includes the Border Patrol, could do screenings in a non-adversarial manner, as regulations require.

Representatives of the Homeland Security and Justice Departments did not immediately respond to requests for comment. U.S. Citizenship and Immigration Services said it does not comment on pending litigation.

Lawyers for mothers and their children from Mexico, Ecuador and Honduras who failed the screening — known as a "credible fear" interview, in which they must persuade officials they have a credible fear of persecution in their home country — argued that CBP employees were not authorized to do the work and lacked training.

"This decision puts an end to the sham process of using adversarial Border Patrol agents to conduct highly sensitive interviews with asylum-seekers," said Julie Carpenter, an attorney for the Tahiri Justice Center, which sued on behalf of asylum-seekers.

The judge didn't address other arguments, including that the measure was invalid because CBP Commissioner Mark Morgan is serving in an acting capacity and lacks authority under federal law.

The Government Accountability Office, a congressional watchdog, said earlier this month that the Homeland Security Department's top two officials, also in acting roles, are ineligible to run the agency because they improperly appointed under federal law. Homeland Security strongly disagreed. Trump nominated Chad Wolf, the acting secretary, to the permanent job last week. □

NYPD to adopt guidelines for disciplining officer misconduct

NEW YORK (AP) — When the New York Police Department fired an officer last year for putting Eric Garner in a deadly chokehold, the officer's union argued that there was little, if any, precedent within the department's internal disciplinary system for such a penalty.

Now, the nation's largest police department is spelling out potential ramifications for officer misconduct, unveiling on Monday a draft of a discipline matrix that will guide punishment decisions similarly to how sentencing guidelines are used in criminal cases. It will be adopted after a 30-day public comment period.

"We wanted to make it very, very clear that if you do certain things there are certain consequences," said Assistant Chief Matthew Pontillo, who helped develop the disciplinary policies with the help from department officials and outside agencies.

Mayor Bill de Blasio called it a "big step forward for transparency and accountability." Fred Davie, chair of the city's police watchdog agency, said he was "encouraged by some of the clear standards laid out in this new set of rules."

Police reform advocates weren't as enthused, arguing the NYPD still has too much power policing its own and that it rarely enforces top penalties, with just 12 officers fired for misconduct since the mid-1980s.

The head of the city's largest police union blasted the guidelines for different reasons, painting them as a way for elected officials "to manipulate NYPD discipline to further their radical political goals."

"Apparently mandatory minimums and sentencing guidelines are unfair to criminals but perfectly fine for cops," said Pat Lynch, president of the Police Benevolent Association, suggesting the guidelines would be subject to change "based on headlines and poll numbers, rather than any objective sense of justice or fairness."

The NYPD is shifting to formal disciplinary guidelines at a time when law enforcement agencies around the world are being pressed to be more transparent about discipline in the wake of protests over the Minneapolis police killing of George Floyd in May.

Police Commissioner Dermot Shea, who will still have the final say on discipline, said it was important to have a "road map" so the public and officers know what to expect. Development of the matrix was well underway when city council passed a law in June mandating its use. The law also requires

that the public be informed how often Shea deviates from it.

Around the same time, state lawmakers sought to shed more light by repealing a decades-old law that had kept police disciplinary files secret. Police unions suing to block their release are appealing after a judge ruled last week that they should be made public.

A 48-page draft report lists presumptive penalties for dozens of forms of misconduct, including termination for using deadly physical force without justification, engaging in hate speech and

making a false statement. Among the other items covered in the matrix: If an officer forgets to turn on his or her body camera while responding to an incident, he or she can be suspended or docked three days, but if it's done intentionally, it's a 20-day punishment.

Accessing confidential information can be punished with a 10-day suspension or loss of vacation days, while leaking confidential information to the news media can be punished with a 20-day suspension or loss of vacation days. Chokeholds resulting in death and the intentional use of a chokehold are also grounds for firing. The NYPD has long banned chokeholds and lawmakers recently passed laws explicitly outlawing the tactic. One was named for Garner, who died in 2014 after then-Officer Daniel Pantaleo put him in a chokehold.

In developing a discipline matrix, the NYPD is fulfilling one of the last remaining recommendations from a panel of criminal justice experts that examined the disciplinary process on its behalf two years ago.

While the experts found that the disciplinary process generally worked well, they said a set of guidelines would help eliminate perceptions of favoritism or bias in officer punishment. They also called for stiffer penalties for officers making false statements and committing domestic violence. □

St. Louis couple charged after waving guns appear in court

ST. LOUIS (AP) — The attorney for a white St. Louis couple charged for waving guns during a racial injustice protest outside their home said Monday that they're anxious to prove "with absolute certainty" that they did not commit a crime.

One week after Mark and Patricia McCloskey spoke on video to the Republican National Convention, they were in court briefly Monday morning and did not enter a plea. The judge continued their case until Oct. 6.

The couple emerged from their Renaissance palazzo-style mansion with guns on the night of June 28 after protesters veered onto their private street.

The couple said the demonstrators knocked down an iron gate and ignored a "No Trespassing" sign, and they felt threatened.

Mark McCloskey, 63, came out with AR-15 rifle, according to court records, which said Patricia McCloskey, 61, displayed a semiautomatic handgun. No shots were fired.

St. Louis Circuit Attorney Kim Gardner said their actions created the risk of bloodshed during what she called an otherwise peaceful protest. She charged both with felony unlawful use of a weapon.

The McCloskeys did not speak to reporters after the court hearing. Their attorney, Joel Schwartz, reiterated their claims that no laws were

broken.

"We are simply anxious to remove all the noise from this case, move the case forward, and have the facts heard by a jury and let the jury decide whether or not the McCloskeys committed any felony offenses because we are convinced with absolute certainty that there was no felony committed here," Schwartz said.

Missouri law allows homeowners to use force, even lethal force, to defend their homes.

The McCloskeys drew support from President Donald Trump, Missouri Gov. Mike Parson and other leading Republicans.

Last week, the McCloskeys, who are both attorneys, made the case in an opening night

speech of the Republican National Convention that they had a "God-given right" to defend themselves and their property. □

U.S. vetoes UN resolution over Islamic State fighters' return

UNITED NATIONS (AP) — The United States vetoed a U.N. resolution Monday calling for the prosecution, rehabilitation and reintegration of all those engaged in terrorism-related activities, saying it didn't call for the repatriation from Syria and Iraq of foreign fighters for the Islamic State extremist group and their families which is "the crucial first step."

U.S. Ambassador Kelly Craft said the resolution, "supposedly designed to reinforce international action on counter-terrorism, was worse than no resolution at all." She dismissed it as "a cynical and willfully oblivious farce."

Because of the COVID-19 pandemic, the 15-member Security Council voted by email. The result was 14 countries in favor and only the U.S. opposed. It was announced by the current council president, Indonesia's U.N. Ambassador Dian Triansyah Djani, whose country sponsored the resolution. In her statement explaining the U.S. veto, Craft pointed to her comments at a council meeting on counter-terrorism last week. She stressed then that repatriation and accountability for crimes by fighters for the Islamic State extremist group, also known as ISIS, and their family members are essential so they "do not become the nucleus of an ISIS 2.0."

"It is incomprehensible that other members of this coun-

cil were satisfied with a resolution that ignores the security implications of leaving foreign terrorist fighters to plot their escape from limited detention facilities and abandoning their family members to suffer in camps without recourse, opportunities, or hope," she said on Monday. Craft said last week the Trump administration was disappointed that Indonesian efforts to draft "a meaningful resolution ... were stymied by council members' refusal to include repatriation."

That was a reference to Western Europeans, especially, including Britain and France,

who have opposed the return of IS fighters and their families, except in the case of orphans and some children. The British government says those who are in custody in Syria and Iraq should face justice there rather than going on trial in the U.K.

Craft said the U.S. brings its citizens home and prosecutes them when appropriate. She quoted U.S. Secretary of State Mike Pompeo as saying: "We want every country to take their citizens back. That's step one. It's imperative that they do so."

A UK Foreign Office spokesperson, speaking with cus-

tomary anonymity, said after the vote: "We regret the resolution was not adopted. We are working closely with international partners to reduce the risk posed to us collectively by foreign fighters." The defeated resolution did support the return of children, but not fighters of families. It encouraged all countries to cooperate in addressing the threat from "foreign terrorist fighters" or FTFs, "including by bringing them to justice, preventing the radicalization to terrorism and recruitment of FTFs and accompanying family members, particularly accompa-

nying children, including by facilitating the return of the children to their countries of origin, as appropriate and on a case by case basis."

The Islamic State group, which once controlled large swathes of Iraq and Syria, lost its last Syrian strongholds in early 2019. But despite the loss of its self-styled caliphate, U.N. experts said earlier this year that the extremist group is mounting increasingly bold attacks in Syria and Iraq and is planning for the breakout of its fighters in detention facilities.

U.N. counter-terrorism chief Vladimir Voronkov said in July that his office had received information that 700 people died recently in two camps in northeast Syria — al-Hol and Roj — where more than 70,000 mainly women and children connected to Islamic State fighters are detained in "very dire conditions." The camps are overseen by Kurdish-led forces who allied with the United States and spearheaded the fight against Islamic State fighters.

The International Crisis Group reported on April 7 that there are 66,000 women and children in al-Hol and 4,000 in Roj, most of them relatives of IS extremists, "but some former affiliates of the group themselves." The Brussels-based think tank said that the majority are either Syrians or Iraqis, with the numbers roughly split, and around 13,500 are from other countries. □

Arrests made at Hong Kong protest a year after police clash

HONG KONG (AP) — Police in Hong Kong used pepper spray and made several arrests as dozens of protesters gathered Monday at a subway station to mark the anniversary of a violent clash last year that stirred accusations of police brutality during anti-government rallies. Some protesters came to Prince Edward subway station in Kowloon with white flowers, while others chanted pro-democracy slogans and called for Hong Kong's independence a year after video showed police using batons to beat people on a train.

Protesters have accused police of indiscriminately attacking passengers on Aug. 31, 2019, while trying to ar-

rest demonstrators at the station, where reporters and medics were refused entry after the clash.

The semi-autonomous Chinese city experienced months of protests last year after the government announced plans to pass an extradition bill that would have allowed criminal suspects to be sent to mainland China for trial. Anger over the bill, seen as an infringement on the former British colony's freedoms, sparked huge demonstrations that at times descended into violence, and rallies continued even after the bill was shelved.

On Monday, police raised a flag, warning those at the protest that they may be violating the city's national security law, which bans subver-

sion and secession. They used pepper spray to

disperse the crowds and arrested at least 14 protesters

between 16 and 60 years old on a range of charges, including unlawful assembly, disorder in public places and assaulting police officers.

Among those detained was a 17-year-old boy who claimed to be a reporter, according to a statement posted on Facebook by Hong Kong police.

"Police reiterate that we have zero tolerance towards any illegal acts and we will take enforcement action accordingly," the statement said.

An additional 37 people were fined for violating social distancing rules that ban public gatherings of more than two people.

The protest comes amid Hong Kong's third and worst outbreak of the coronavirus, which has infected over 3,000 since early July. □

Thousands rally in Montenegro claiming opposition victory

PODGORICA, Montenegro (AP) —

Several thousand supporters of pro-Serb and pro-Russian parties in Montenegro took to the streets to celebrate on Monday, claiming an opposition victory in weekend parliamentary elections over a pro-Western party that has ruled the country for 30 years.

The long-ruling Democratic Party of Socialists won the most votes at Sunday's balloting — around 35 percent — according to the preliminary official results. However, a coalition of three opposition groupings said they have garnered enough support to form the next government.

The main opposition alliance, For the Future of Montenegro, won nearly 33% of the vote, according to the state election authorities. Two other opposition groups came next with around 12% and 5% respectively. They were followed by smaller parties and those run by ethnic minorities, according to the complete vote tally.

It is unclear when the final distribution of seats in the 81-member parliament will be announced. But it is clear the governing majority could be very slim. Montenegro's opposition parties have already declared victory.

The DPS party and its leader, Montenegrin President Milo Djukanovic, has been a key Western ally in pushing the volatile Balkans toward Euro-Atlantic integration. Djukanovic defied Russia in 2017 to lead his country into NATO after gaining independence from much-larger Serbia in 2006. There have been fears that an opposition-led government would mean a change in Montenegro's

pro-Western policy and a turn away from NATO toward traditional allies Serbia and Russia.

The opposition leaders sought to alleviate those fears on Monday. They said they want to unify the divided nation by forming an expert government that would respect all international agreements and stay the reform course toward membership in the European Union.

Known as the longest-serving European leader, Djukanovic also has faced accusations of corruption, autocracy and criminal links.

The election on Sunday was marked by a dispute over a law on religious rights that is staunchly opposed by the influential Serbian Orthodox Church. The issue has fueled divisions in the nation of 620,000 people that is split over relations with the West

and traditional Slavic allies Serbia and Russia.

For the Future of Montenegro has advocated stronger ties with Serbia and Russia, and backed church-led protests against the religion bill. A more moderate group and a smaller, liberal party are likely future coalition partners.

Carrying both Montenegrin and Serbian flags, the pro-Serb supporters gathered outside the main church in the capital Podgorica and drove around the city in their cars, honking horns and shouting slogans against Djukanovic.

Djukanovic said late on Sunday that his party is ready to acknowledge any election outcome. He expressed hope that the future government will keep Montenegro on the path toward joining the European Union.

International observers from the OSCE Office for Democratic Institutions and Human Rights and the OSCE Parliamentary Assembly said Monday that "while Montenegro's parliamentary elections were managed transparently and efficiently, the widespread abuse of office and state resources gave the ruling party an undue advantage against the backdrop of an intensely polarized debate over issues of church and national identity." □

Former Indian President Pranab Mukherjee dies at age 84

NEW DELHI (AP) — Former President Pranab Mukherjee, a senior leader of India's Congress party who served in multiple Cabinets during five decades in politics, has died.

He was 84.

Mukherjee had emergency surgery for a blood clot in his brain on Aug. 10 at New Delhi's Army Hospital Research and Referral after suffering a fall.

The hospital said he tested positive for COVID-19 after the surgery and his condition was critical. He remained in a coma after the operation.

The hospital said his health began declining on Monday after a lung infection resulted in septic shock.

His son, former lawmaker Abhijeet Mukherjee, tweeted in the evening that he had died. Prime Minister Narendra Modi, who leads the rival Bharatiya Janata Party,

tweeted that Mukherjee "left an indelible mark on the development trajectory" of India.

"His wise counsel on key policy matters will never be forgotten by me," Modi said.

Mukherjee was president from 2012 to 2017, at the end of a long period when the Congress party held power.

The office is largely ceremonial in India, with executive powers resting with the prime minister.

Before that, he had been minister of finance, defense and foreign affairs for three separate prime ministers and helped manage their fractious governing coalitions. Mukherjee was a college teacher in West Bengal state before first running for public office in 1969.

He became a protege of then-Prime Minister Indira Gandhi and was loyal to her during the Internal Emer-

gency she had proclaimed from 1975 to 1977, when elections were suspended and civil liberties were curbed.

Many of her opponents were imprisoned.

He lost his position as finance minister after Indira Gandhi was assassinated in 1984 and her son Rajiv Gandhi became prime minister. Mukherjee formed his own party but later reconciled with Rajiv Gandhi and returned to the Congress party in 1989.

After Rajiv Gandhi's assassination in 1991, Mukherjee joined the Cabinets of his successors, P.V. Narasimha Rao and Manmohan Singh. Mukherjee was awarded India's highest civilian honor, the Bharat Ratna, in 2019.

He is survived by two sons and a daughter.

His wife died in 2015. □

Marlins get outfielder Starling Marte in trade with D-backs

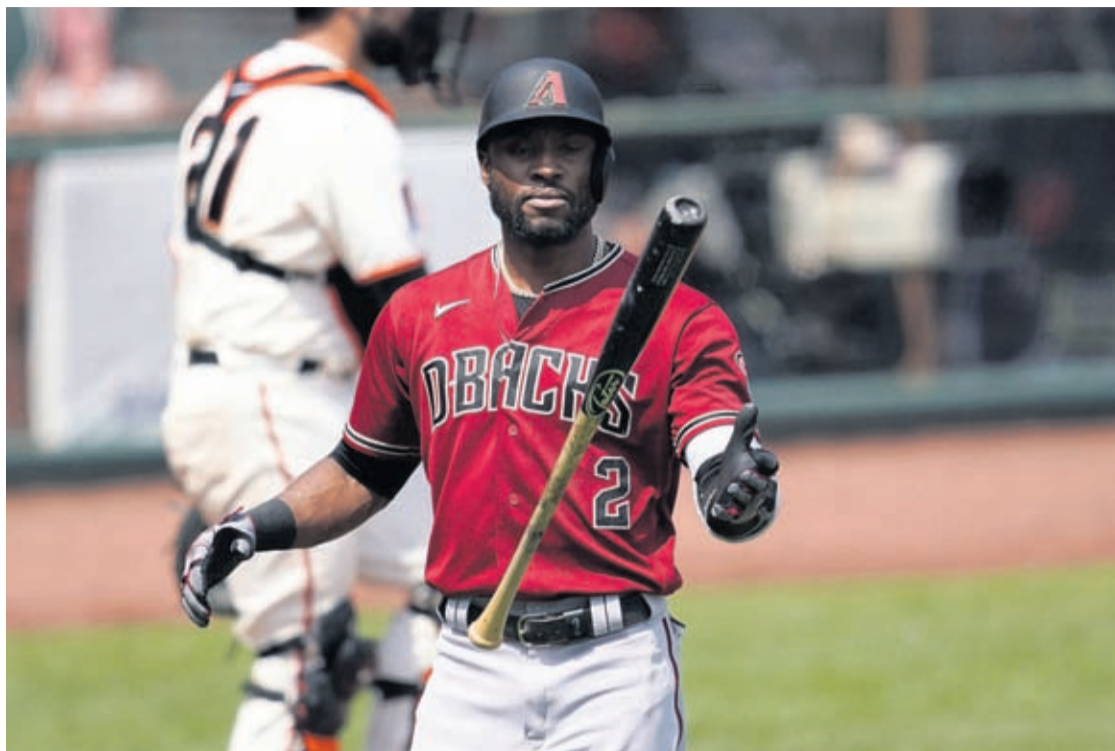
PHOENIX (AP) — Miami acquired outfielder Starling Marte in a trade with the Arizona Diamondbacks on Monday, giving the Marlins a versatile hitter and defender as they try to make a surprising push for the playoffs.

The Diamondbacks received pitchers Caleb Smith, Humberto Mejia and a player to be named.

The 31-year-old Marte played most of his career with the Pittsburgh Pirates, where he was an All-Star in 2016. The two-time Gold Glove winner in left field was traded to the Diamondbacks during the offseason and played well, batting .311 with two homers, eight doubles and five stolen bases while playing center.

"We just get another solid, everyday bat," Marlins president of baseball operations Michael Hill said. "Young players are going to have their growing pains. It's a challenge when you're trying to make it to the playoffs. We're adding a bat that can take some pressure off our young guys and provide support to our existing core players."

Marte has a team option

for next season. He went through personal tragedy in May when his wife, Noelia, died of a heart attack.

The Diamondbacks turned into sellers at the trade deadline after losing 10 of their past 11 games.

They also traded All-Star left-handed starter Robbie Ray to

the Blue Jays and closer Archie Bradley to the Reds.

Arizona expected to be a contender in the NL West this season but currently sits in last place with a 14-21 record. "There are moments in time you can't go chasing something that isn't there," Arizona GM Mike Hazen said.

"For this season, it hasn't been there. I feel like pivoting at this moment in time is what's most appropriate."

The Marlins also traded infielder-outfielder Jonathan Villar for outfield prospect Griffin Conine, son of Jeff Conine, who played on the Marlins' 1993 expansion

team and on their World Series championship teams in 1997 and 2003.

Griffin Conine was a second-round draft pick by the Blue Jays in 2018.

Villar became more expendable when second baseman Isan Díaz, who opted out for the season, changed his mind and applied for reinstatement. Díaz is working himself into shape at the Marlins' complex in Jupiter, Florida.

The Marlins are in the running for a playoff spot in this year's expanded 16-team format. They had a COVID-19 outbreak early in the year that kept them off the field for more than a week but have bounced back and their 15-15 record is good for second in the NL East.

"Our club has fought so hard for the first 30 games for what they endured," Hill said. "We want to do everything on our part to put us in a position to make it to the playoffs."

The 29-year-old Smith has pitched just once this year, giving up one run in three innings on July 25. He was 10-11 with a 4.52 ERA in 28 starts in 2019. The 23-year-old Mejia made his big league debut earlier this year and has a 5.40 ERA in three starts. □

SISTERON, France (AP) — A basketball player weaving through the defense. A skier dancing between the gates. A soccer player dribbling zig-zag toward the goal. Australian rider Caleb Ewan borrowed the playbook from other sports as he slalomed through the bunch to win a sprint finish and claim the third stage of the Tour de France on Monday, while Julian Alaphilippe held onto the yellow jersey that he claimed

with a dramatic stage victory a day earlier.

With about 100 meters to go, Ewan trailed five other riders before slinging himself through a narrow slice of road near the advertising barriers on the right side of the street. Then -- after more than five hours in the saddle -- Ewan darted to the left to overcome Sam Bennett and claim his fourth career stage win in the Tour by more than a wheel.

Ewan slaloms to sprint win; Alaphilippe leads Tour de France

"I found my way through the wheels," Ewan said. "Coming from behind, it's a bit of a risk, but I found my way along the barrier and I came with a lot of speed and it worked."

Living up to his nickname of "Pocket Rocket," the 1.65-meter (5-foot-5) Ewan reached a top speed of 68.8 kph (42.7 mph) in the finale. It was a perfectly timed acceleration.

"In the last k (kilometer) I was a bit too far forward so I dropped back a bit into the wheels," Ewan said. "That gave me time to rest the legs just a little before the last hit out."

Irish champion Bennett, a teammate of Alaphilippe's at Decuninck-Quick-Step, crossed second and European champion Giacomo Nizzolo came third -- both with the same time as Ewan.

Alaphilippe crossed with the main pack and retained a four-second lead over Adam Yates, with Marc Hirschi still third overall, seven seconds

behind. "We had a really good day. The team really controlled everything. We tried to go for the sprint and Sam got second today. You can't see, but I'm smiling," Alaphilippe said behind a mask. "We defended (the yellow jersey) today and we'll do it again tomorrow."

Ewan, who rides for the Lotto-Soudal team, won three stages last year, including the coveted final leg on the Champs-Élysées in Paris. He said this win proved "that last year wasn't just a fluke." Ewan had a difficult start to this race with a crash in Stage 1 and a last-place finish in Stage 2. His team was hurting, too, with Philippe Gilbert and John Degenkolb forced to withdraw after also crashing in the rain-slicked opening leg.

"We need to take every sprint opportunity that we can because they're quite rare this year," Ewan said.

After the opening two stages in the Mediterranean city of Nice, the race veered in-

land over a 198-kilometer (123-mile) route to Sisteron, which is labeled the "Gateway to Provence."

The route featured four minor climbs before a flat finish suited to sprinters.

Three French riders -- Anthony Perez, Jérôme Cousin and Benoît Cosnefroy -- broke away at the start and established an advantage of nearly three minutes.

Cousin then launched a solo attack midway through the stage and created a lead of more than four minutes.

Cousin was finally caught by the main pack with 16 kilometers remaining.

Perez, meanwhile, crashed into his team car on a high-speed descent after puncturing a tire and broke his left collarbone -- forcing him to abandon the race.

Stage 4 on Tuesday features the race's first uphill finish with a climb to Orcières-Merlette that should force the overall favorites -- such as defending champion Egan Bernal -- into action. □

NFL stunner: Jags waive Fournette after failing to trade him

JACKSONVILLE, Fla.

(AP) — The Jaguars moved another step closer to purging Tom Coughlin's tumultuous tenure in Jacksonville. The team waived running back Leonard Fournette on Monday, a stunning decision many outsiders view as the latest in a series of head scratchers that could help the franchise tank the season and get the No. 1 draft pick.

"If that's the case, then the realization is if that happens, then I'm not going to be here," coach Doug Marrone said. "At the end of the day, if I don't win enough games or do enough with this team, I don't foresee me still being employed. I'm doing everything I can to make sure we have the best team to make sure we win football games. That's as simple as I can be on it." Coughlin wanted Fournette as the centerpiece of his old-school, run-first philosophy. It worked in 2017, although it became clear that Fournette needed to be a better pro. He was fined repeatedly for being late and skipping mandatory functions.

The Jaguars spent months trying to trade Fournette, the fourth overall pick in the 2017 NFL draft who's coming off a career year. He was on the block during the NFL draft and again over the summer. "We couldn't get anything, a fifth, a sixth, anything," Marrone said. So they dumped the 25-year-old former LSU star one day after trading former Pro Bowl defensive end Yan-

nick Ngakoue to Minnesota in exchange for a second-round draft pick in 2021 and a conditional fifth-rounder in 2020. Jacksonville also traded Jalen Ramsey, fellow cornerback A.J. Bouye and defensive end Calais Campbell in

the last 10 months. "It's going to fall to me as to who those best players are," Marrone said. "At the end of the day, I've got to be able to field a team that I believe gives us the best chance to win. That's what my role is

and that's what I'm doing." Still, no one expected Jacksonville to part ways with Fournette less than two weeks before the opener. He is due \$4.17 million in guaranteed salary this season if someone claims him. If he

clears waivers, he would become a free agent.

Fournette's time in Jacksonville took a turn in 2018, which ended up being the worst season of his football life. He was injured, suspended and on the bench in crunch time. He was fined, criticized and admittedly not in ideal shape late in the year. The Jaguars voided his guarantees following his one-game suspension for fighting with Buffalo linebacker Shaq Lawson, and Coughlin ripped him for being "disrespectful" and "selfish" for sitting on the bench — while injured and inactive — during the season finale. Adding to the chaos, Fournette was arrested in April 2019 for driving with a suspended license. He bounced back last year with his best season. He topped 1,600 yards from scrimmage in 15 games, carrying 265 times for 1,152 yards and catching 76 passes for 522 yards. He scored only three touchdowns. He also fumbled just once in 341 touches.

Fournette has 2,631 yards rushing, 1,009 yards receiving and 19 touchdowns in three seasons since he was now-fired personnel chief Coughlin's first draft pick since returning to Jacksonville. But with Coughlin gone, general manager Dave Caldwell put Fournette on the block and declined to pick up the fifth-year option in his rookie deal. Marrone insisted Fournette did nothing to prompt his release, instead pointing to his fit in coordinator Jay Gruden's new scheme. □

Horse racing leaders move to set national safety standards

— Looking to halt doping scandals and horse deaths marring their sport, thor-

oughbred racing leaders Monday announced the launch of an integrity and safety authority to create national standards replacing the patchwork of state regulations overseeing the industry.

The authority will help set industry-wide standards for medication use, track conditions and other safety standards to protect thoroughbreds and their riders.

The initiative will be backed by federal legislation to be introduced by Senate Majority Leader Mitch McConnell.

The Kentucky Republican said the horse racing industry "deserves uniform stan-

dards and guidelines that will help protect this sport." The legislation will provide federal recognition and enforcement power for the new Horseracing Integrity and Safety Authority to develop uniform, baseline standards for the industry.

"If we want to preserve horse racing and its future, we needed to act," McConnell said at a news conference at Keeneland in the heart of Kentucky's horse industry. "We owe it to the horses. We owe it to the jockeys. We owe it to the trainers, the breeders and fans to make thoroughbred racing as fair and as safe as possible."

Horse racing has been hob-

bled by schemes to drug horses to make them race faster and by horse deaths. Santa Anita racetrack has been rattled by a number of deaths when horses broke down.

Unlike other professional sports with central league offices, thoroughbred racing is regulated at the state level, resulting in a patchwork of rules on medication standards and testing protocols. The authority will be an independent, non-governmental regulatory body that will bring more transparency to the inner-workings of horse racing, industry leaders said. □

Appeals court again rules out House subpoena for McGahn

WASHINGTON (AP) — A federal appeals court panel on Monday again threw out a lawsuit by House Democrats to compel former White House counsel Don McGahn to appear before a congressional committee. In a 2-1 ruling, U.S. Court of Appeals for the District of Columbia Circuit held that the House of Representatives lacks the authority under the Constitution or federal law to ask courts to enforce a subpoena against an executive branch official.



The latest decision comes

weeks after the full appeals court rejected the panel's initial ruling that would have ended the court fight over

whether McGahn must testify before the House Judiciary Committee as part of its investigation of potential obstruction of justice by President Donald Trump during special counsel Robert Mueller's Russia investigation.

House Speaker Nancy Pelosi said the House would ask the full appeals court to step in and again revive the lawsuit. Court cases over the testimony of presidential advisers are rare because the White House and Congress typically reach an agreement. But Trump directed McGahn not

to appear and the Democratic-controlled House filed suit to enforce the subpoena that was first issued in April 2019. With time running out on the current House session, which ends on Jan. 3, the prospect that McGahn would have to testify already was remote.

House lawmakers had sought McGahn's testimony because he was a vital witness for Mueller, whose report detailed the president's outrage over the investigation into Russian interference in the 2016 election and Trump's efforts to curtail it.

France accuses UK of stalling in post-Brexit trade talks



PARIS (AP) — On the cusp of a crucial month of negotiations on a post-Brexit trade deal between the European Union and the U.K., France has lambasted British Prime Minister Boris Johnson's government for what it sees as deliberate stalling and for harboring unreasonable expectations.

The 27-nation EU and the U.K. remain deadlocked in their talks on future trade ties after a transitional divorce period ends on Dec. 31. That has raised concerns that no agreement will be in place in time and that tariffs and other impediments to trade will be imposed on Jan. 1.

"Negotiations are not advancing,

because of the intransigent and unrealistic attitude of the United Kingdom," French Foreign Minister Jean-Yves Le Drian told his nation's ambassadors Monday in Paris.

His comments underscored the recent pessimistic tone of the EU's chief negotiator, Michel Barnier, who has said the talks seem to be moving backward.

Britain left the EU on Jan. 31 but both sides hoped that a chaotic Brexit departure could be avoided by striking a comprehensive trade deal during the 11-month transition period.

Both sides say September will be a crucial month in the discussions. The EU, for its part, insists that the talks conclude before November to allow time for parliamentary approval and legal vetting of

the trade deal.

And Le Drian insisted that the 27 EU nations won't buckle under pressure from London.

"On Brexit, we always showed unity and proved wrong those who saw signs of an overall implosion of Europe," he said. "It is in staying united that we can stick to our line of a global accord." The main differences appear to center on rules for state aid for businesses and on fisheries.

The EU is insisting on a "level-playing field" for companies from both sides, so British firms can't undercut EU firms by disregarding stringent EU rules on environment or workplace and social standards. The U.K. is also vexed by EU demands for long-term access to British fishing waters.

Britain accuses the bloc of making demands that it has not imposed on other countries it has free trade deals with, such as Canada.

"The EU is still insisting not only that we must accept continuity with EU state aid and fisheries policy, but also that this must be agreed before any further substantive work can be done in any other area of the negotiation, including on legal texts, making it unnecessarily difficult to make progress," the U.K. government said.

Both sides say they want to avoid a "no-deal" scenario and want their divorce not to impede cooperation in the fields of defense, security and fighting crime.

The next round of talks between Barnier and his British counterpart, David Frost, begins in London on Sept. 7.

China's top diplomat dismisses European rights concerns

PARIS (AP) — China's foreign minister defended detention camps in Xinjiang and Hong Kong's new security law on Sunday, brushing off human rights concerns by European countries and cautioning against interference in Chinese affairs.

Foreign Minister Wang Yi is on his first European tour since the virus pandemic erupted, seeking to revive trade and relations strained by the resulting global health and economic crisis.

Speaking in Paris on Sunday, Wang repeated the claim that all those sent to what China calls training centers in Xinjiang have left and been placed in employment — even as rights groups and families report on continuing deten-

tions of Uighur Muslims and the loss of contact with loved ones. "The rights of all trainees in the education and training program, though their minds have been encroached by terrorism and extremism, have been fully guaranteed," he told a conference at the French Institute of International Relations. "Now all of them have graduated, there is no one in the education and training center now. They all have found jobs."

The Chinese government has detained an estimated 1 million or more members of ethnic Turkic minorities in Xinjiang, holding them in internment camps and prisons where they are subjected to ideological discipline, forced to denounce their religion

and language and physically abused. China has long suspected the Uighurs, who are mostly Muslim, of harboring separatist tendencies because of their distinct culture, language and religion.

Asked about Hong Kong's security law, Wang said, "We certainly couldn't sit idly by and let the chaos go on, so we enacted a law maintaining national security that specifically suited Hong Kong's situation."

The law is seen by many as Beijing's boldest move yet to break down legal barriers between the semi-autonomous territory of Hong Kong and the mainland's authoritarian Communist Party system. Wang called both issues internal Chinese affairs and



said foreign powers shouldn't interfere.

At a meeting Friday with Wang, French President Emmanuel Macron expressed "his strong concern about the situation in Hong Kong, and around human rights, notably the Uighurs, and the need for China to respect its international commitments," according to Macron's office.

Foreign Minister Jean-Yves Le Drian raised similar concerns, as did officials on other legs of Wang's Europe trip, which includes Italy, the Netherlands, Norway and Germany. His visit also included discussion of trade, fighting climate change and other issues where Europe depends on China because of its huge global influence.
