No warda riba Gobierno pa anda responsabel cu medio ambiente si kier preserva nos porvenir



Un persona cu ta tira su sushi den mondi na Hooiberg, of hasta e persona mas consciente cu ta tira su desperdicio den bari na Paradera, tur ta causa e mesun impacto pa e lama rond di Aruba. Pasobra e desperdicio cierto momento ta yega lama y consecuentemente e ta afecta calidad di lama y calidad di ocean.

Biologo Marino y Director Interino di Parke Marino Aruba, Sietske van der Wal a refleha riba Dia Mundial di Ocean, cu ta awe, 8 di Juni, unda dia cu rond mundo ta dedica pa enfoca atencion riba e balor di ocean saludabel, pa asina por sostene bida na mundo.

Aunke semper a siña na scol cu mundo tin cinco ocean, realidad ta cu tur ta conecta na otro. Ya ta algun año caba cu oceanografonan a cumenza cualifica e lama riba mundo como un solo, cu su diferente regionnan pero tur conecta cu otro. Y awanan rond di Aruba ta forma parti di e totalidad ey.

Pero mas importante, e calidad di awanan rond di Aruba ta determina e porvenir di e isla y su hendenan, pasobra turistanan ta bin Aruba pa motibo di lama. Y si calidad di lama baha, e implicacion pa bida riba e isla ta enorme.

Di cas pa lama

Calidad di awa ta determina kico ta sosode na su costanan. "Si tuma e descripcion kico ta costa, anto henter Aruba ta un zona costal," van der Wal a bisa. "Costa ta defini como e espacio cu ta keda den e espacio di cinco kilometer di lama." Tur skina di Aruba ta den e espacio aki, cu ta nifica

cu leynan cu ta papia di proteccion di costa, en realidad ta conta pa henter Aruba. Algo cu poco hende ta realisa.

"Acto di un persona biba na Hooiberg tin impacto riba lama. E ta zona straño, pasobra e sushi cu ta tira den naturalesa, a lo largo lo caba na lama despues di un yobida fuerte. Hasta si tira e sushi nechi den bari, e ta bay pa dump y ta bay finalmente den lama tambe."

Palm Beach ta hopi afecta

Van der Wal no por categorisa e calidad di lama rond di Aruba.

Sin estudio specifico no por determina e calidad. Mas ainda, tin areanan di lama rond di nos isla ta muestra di ta den bon condicion of por lo menos tin e potencial pa recuperar. Pero otronan ta muestra decadencia. Y e area mas afecta ta Palm Beach, cu ta net dilanti di tur e hotelnan grandi. E area mas bishita pa turismo, cu mas actividad acuatico. "E ta hopi alarmante y ta bay rekeri decada pa recuperar."

Prome cu por papia pa traha riba recuperacion di Palm Beach lo mester enfoca riba e actividadnan riba tera cu ta afecta e calidad di lama. Den caso di Palm Beach, e cantidad di awa sushi cu ta drenta lama ainda ta grandi, e cantidad di azeta y otro estorbo di fluho ta afecta e awa. E Riool Water Zuivering Installatie na Bubali Plas ta rekeri inversion, y mientras cu esey no sosode, cuaquier yobida ta nifica awa yena cu nutriente ta drenta e lama di Palm Beach cu tur su consecuencianan.

E problema ta concentra na Palm Beach, pero cu cada tereno cu rosa rond Aruba, por spera e stof cay den lama,

y ta tapa e coralnan. Un coral ta un organismo fragil cu cukier estorbo por causa su morto. "E ta un acumulacion. Pasobra riba y den lama tin hopi actividad cu no ta regula. Si por regula kico ta sosode riba lama, por traha riba proteccion." E Director Adhunto di Parke Marino Aruba a bisa cu na momentonan aki, e control riba kico tur ta sosode, for di pescamento te na deporte acuatico no ta controla y regula y como tal dificilmente por tuma paso pa limita e impacto riba e calidad di nos lama. "Tin cierto actividad cu ta mas dañino cu otro."

Kico pa haci

E conclusion ta cu cada individuo na Aruba, cu cada uso di un producto ta impone riba e calidad di lama. E ta un decision personal pa ta mas consciente den kico ta usa y con ta consumi, pero hasta pa esey tin su limitacion. Aruba ta depende di importacion y manera un importado a bisa Bon Dia Aruba, "masha poco producto ta bin den empakenan cu ta sostenibel of cu no ta haci daño na medio ambiente."

Single use plastics

Y van der Wal ta realisa esaki tambe. El a mustra cu Aruba a tuma un bon paso pa elimina e asina yama 'single use plastics,' esta plastic di un solo uso. Pero durante e pandemia a bin e necesidad pa usa productonan di un solo uso pa evita contagio. A importa productonan cu supuestamente ta bio-degradabel. "Pero, e productonan aki ta degrada unicamente si nan ta bay den un proceso industrial diseña pa e proceso aki. Realidad ta cu nan tambe ta bay riba dump, y no ta desintegran mes y ta bira parti di e sashedad cu ta afecta lama," e biologo marino a sigui bisa.

Como tal e unico manera pa baha e sero di sushi cu ta afecta calidad di lama na Parkietenbos y eventualmente esun rond di henter Aruba ta rekeri un conscientisacion di comunidad pa haci escogencia cu ta menos dañino pa medio ambiente. Y no ta tarea di Gobierno so.

Aruba Aloë

Sietske van der Wal a bisa cu un compania cu a tuma un paso pa proteha ambi-

ente marino, sin warda riba instruccion di Gobierno ta Aruba Aloë. Berdad Gobierno a prohibi e uso di sunblocks cu ta contene oxybenzone cu ta malo pa coral. Pero un sunblock regular ta contene nuebe kimico cu ta peligroso pa coral. Elimina e oxybenzone su so, por duna companianan e oportunidad pa mercadea cu nan producto ta bon pa salud di lama, pero esey no ta berdad. "Pasobra e otro ocho kimiconan tambe ta haci daño," van der Wal a splica. Como tal, e hecho cu companianan manera Aruba Aloë a dicidi pa elimina tur kimico peligroso sin cu esaki ta rekeri pa ley ta ilustra un compromiso, cu por ta ehempel pa tur otro na Aruba. Companianan responsable no ta warda riba ley sino ta tuma paso nan mes pa yuda proteha medio ambiente di e isla y a lo largo, lama di Aruba.


Turismo

E ta un cambio di estilo di bida y si pu-sha un hende mucho duro, lo haya resistencia. Ta preferibel pa tuma pasonan chikito. Y mester celebra paso chikito den e bon direccion."



Prome minister demisionario Evelyn Wever-Croes:

Uso di tapaboca no ta obligatorio mas

Durante un conferencia di prensa di Gobierno di Aruba ayera den oranan di atardi, prome minister demisionario Evelyn Wever-Croes a trece dilanti e flexibilisacion di medidanan pa loke ta trata pandemia di Covid-19.

El a informa cu te ainda, tin 64 caso activo di Covid-19 na Aruba y cu tin un averahe di caso nobo pa dia di 11, e ‘positivity rate ta na 13%’ segun e averahe di e ultimo 7 dia.

Loke ta indica cu tur dia tin 11 caso nobo y tambe cu di e testnan di cada dia 13% ta sali positivo. Esaki ta indica cu e aspectonan mas critico di e pandemia ta bao control segun loke Wever-Croes a indica, pero e crisis no a pasa ainda.

Ta p’eseys cu e siguiente flexibilisacion ta hustifica na unda entrante diaran son awor 9 di juni. Un di e punto cu ta wordo flexibilisa ta esun di cuarentena: si un persona ta wordo vacuna no mester bay den cuarentena. Uso di tapaboca no ta obligatorio mas, pero ta recomendabel us’e si no por tin distanciamiento di mas di 1.5 meter, establecimentonan por exigi uso di tapaboca si asina nan ta dicidi.

“Awor e responsabilidad ta cambia, di

ta gobierno cu ta obliga bo di haci’ e y esey ta stop, pero awor a bo ta dicidi” el a bisa.

Pa loke ta trata deporte, for di diaran son awor ta permiti pa deporte tin publico sin limite y tambe contact sport ta permiti atrobe, gebiedsverbod ta wordo elimina.

Otro medidanan como ora di cierre y alcoholverbod ta keda vigente, y no mag di baila ainda den establecimentonan y actividadnan cu aglomeracion no ta permiti.

El a anuncia tambe cu for di awe tin un ‘bubble’ entre e islanan Aruba, Boneiro y Corsou na unda ta haci posibel e ora cu un persona ta baha entre e islanan aki y persona ey ta vacuna, e no tin necesidad di haci un PCR test ora ta drenta back na Aruba.

Igualmente, el a trece dilanti cu diaran son awor tambe ta yega e prome crucero despues di e pandemia na unda lo trece 546 pasahero a bordo di e Celebrity Millennial y otro 770 persona, tur e pasahero cu ta riba 18 aña ta vacuna cu lo segun loke Wever-Croes a señala, menos muchanan bou 18 aña cu no por vacuna pero a haci e PCR test, e barco aki a sali for di Sint Marteen diasabra ultimo.



Aunke aspecto di salud na e momentonan aki ta bao di control el a sigura, te ainda Aruba ta depende hopi di Hulanda den materia economico pa loke ta trata e ayudo di FASE y subsidio di salario.

Den relacion cu cortamento di salario, Wever-Croes a manifesta cu esey tanto den sector publico como den sector semi-publico ta depende di e recuperacion economico algo cu

ta tumando luga y si cosnan lo sigui asina pronto lo yega e momento pa e cortamento di salario tambe lo por wordo elimina.

“Mi no por bisa fecha exacto y nos tur sa cu esaki ta depende tambe di negociacionnan cu Hulanda mirando cu ta Hulanda esun cu a pone e condicion di tot nader order, mester haci esaki pero nos a caba a cuminsa haci cierto dialogo cu sindicatonan” Wever-Croes a bisa.

DVG: “Esnan cu a vacuna caba no tin mester di bay den cuarentena”

Sharline Koolman di Departamento di Salud Publico (DVG) a splica cu suavisacion di medidanan ta caminda, loke ta nifica cu control lo ta menos severo. Pero nan ta pidi ainda pa e comportamiento di comunidad bay huntu cu esey.

El a expresa cu hende tin cu keda mantene e parti higienico y di loke ta trata e cuarentena; e protocol pa cu esaki a wordo suavisa pa esnan cu ta

vacuna so.

Den caso cu un persona ya tin su dos dosis di vacuna, y ya tin mas di 14 dia desde cu a vacuna, na momento di ricibi yamada di DVG den cual ta puntra si e ta vacuna caba, e persona mester duna e fecha di vacunacion y DVG ta controla esaki den nan sistema, pa controla si ta berdad cu e persona en cuestion a ricibi dos dosis di vacuna y ki tempo.

A base di esaki, Koolman a menciona cu lo haci un afspraak cu e persona, y despues di cinco of dies dia nan lo yama back. Si acaso e persona a haya full sintoma di Covid-19, e ora ey e proceso ta cuminsa.

Nan sa cu esaki tin poco casonan y nan ta menos severo. Pero tin caminda na unda nan ta mira cu e vacuna cu ta cubri 95%, tin chens pa haya sintomanan leve y hopi minim,o segun el a sigura. Igualmente nan ta informa cu si e persona ta haya sintoma, e tin cu yama DVG y e proceso di isolacion y test ta cuminsa pa e persona aki.

Pa esunnan cu no ta vacuna of esunnan cu no tin mas cu dos siman desde cu a vacuna cu e di dos dosis, esaki no ta aplicabel. Segun e maneho di cuarentena, e persona mester bay den cuarentena, keda na cas y no por bay traha of bay scol.

Aworaki cu nan no tin informacion confirma cu por vacuna esun bao 18 aña ainda, e decision aki no ta aplicabel.

Di loke ta trata e ABC Bubble, entre e islanan Aruba, Boneiro y Corsou na unda ora cu un persona ta baha entre e islanan aki y persona ey ta vacuna no tin necesidad di haci un PCR test ora ta drenta back na Aruba, Koolman a expresa cu e persona aki ta haya e cer-

tificado di vacunacion den plataforma Aruba Health App y na momento cu ta baha mester tin print esey, ademas cu si e persona a haya Covid-19 den ultimo seis luna, esey tambe ta conta.

“Un baha cu bo a haya Covid esey ta conta como un vacuna, e di dos vacuna ta bira ora cu bo ta completamente protegi y por baha entre e tres islanan aki”, Koolman a sigura.

Tocante e eliminacion di tapaboca, Koolman ta recomienda pa personan cu ta sufri di malesanan cronico of cu tin sistema di defensa hopi abou pa haci uso di dje, esey semper ta keda recomendabel.

Di e barco crucero nan a haya varios pregunta pa lo cual Koolman a expresa cu nan como DVG prome cu Covid-19 a cuminsa, 48 ora prome cu e barco lo a yega na Aruba nan ta ricibi un lista di e personanan cu ta malo y kico nan tin, esey ta wordo controla riba e sistema cu tin riba barconan.

Aworaki, cu Covid-19 tur e protocol ey ta keda vigente y no tin cambian den esey, loke ta cambia ta cu nan mester a manda e lista ey 48 y 24 ora prome cu nan lo drenta Aruba.

E momento cu barco lo yega akinan DVG tambe lo ta presente pa haci control y si e informacion ta cuadra cu loke nan a manda caba.



CAft: Mejoracion den administracion financiero, pero por mas

Gobierno mester sigui baha gasto di personal



Den nos edicion di ayera a publica e promer parti di e evaluacion di e organo di supervision financiero CAft di e reportahe di trimester 1 di 2021. Seguidamente aki e parti concluyente di e evaluacion.

Gasto

Gastonan pa e periodo evalua ta Afl. 437 miyon, 23% di e presupuesto 2021. Esaki ta Afl. 118 miyon mas cu aña pasa, y ta relaciona cu e gastonan di apoyo financiero di diferente forma relaciona cu e crisis di Covid-19. CAft a recomienda pa baha e presupuesto a base di e gastonan na 2021, loke no a sucede ainda, y ta kere cu e gastonan lo muestra mas positivo ainda si haci esaki. Tambe CAft ta anticipa menos gasto di e areglo di TIO pasobra esaki ta bin na vigor mas laat cu tabata e planificacion y tambe a base di menos gasto relaciona cu e areglo pa empresa mediano y chikito (MKB), relaciona cu mejoracion economico.

Gasto di personal maximo segun e protocol di 2018 ta Afl. 479 miyon. Realisacion di e gastonan aki pa 2020 tabata Afl. 428 miyon, cu ta inclui e reduccion di salario y condicion laboral di 12,6% di personal di gobernacion. E protocol segun CAft ta stipula cu gobierno di Aruba mes-

ter logra un reduccion anual nominal di gasto di personal. Den e actual presupuesto tin proyecta Afl. 431 miyon na gasto di personal, cu consecuencia cu segun CAft gobierno no ta cumpli cu e norma aki. CAft ta observa cu a logra cumpli cu e norma aña pasa a traves di e reduccion di solidaridad, pero cu implementacion di e BVP ta quedando atras. CAft ta haya cu pa yega na sanacion di finanzas publico e reduccion ey ta indispensabel. Tambe e entidad ta muestra riba e valor informativo insuficiente di e BVP den e reportahen financiero y e falta di claridad tocante cual instrumentonan den e BVP ta ser usa pa bay den direccion di un reduccion di e gastonan di personal.

Den e promer reportahe di e aña aki (UR-1-2021) pa promer bieha a cuantifica e medidanan di e BVP, loke a mehora e vista riba uso y resultado di e medidanan compara cu e ultimo reportahe di 2020. Pero e resumen ta a base di kwartaal y no tin claridad si ta orienta activamente riba e medidanan. Por lo tanto CAft no por evalua kico e efectonan anual lo ta di e medidanan di e BVP riba gasto di personal. E cambionan den e gastonan di personal di presupuesto 2021 pa CAft ainda no ta suficientemente cla pa

entre otro por monitor e austerracionnan den cuadro di e BVP y e reduccion di 12,6% riba condicion laboral di e ambtenaarnan. CAft ta conseha, manera den su conseho riba e cuentanan anual 2016-

2018, pa fortifica administracion di gasto di personal.

E capitulo di capital ta mostra un saldo positivo pa trimester 1-2021, di Afl. 6 miyon. A ricibi 9 miyon y a paga 3 miyon, e ultimo aki principalmente prestamo pa estudio. Tin Afl. 16 miyon presupuesta pa inversion na 2021, di cual no a usa nada durante e trimester revisa aki. CAft ta kere cu posiblemente lo no tin suficiente tempo pa realiza e inversionnan programa completamente den loke ta keda di aña, tambe en vista di cu no tin un presupuesto aproba ainda.

Sector Colectivo

Cada dos aña segun e protocol Aruba-Hulanda di 2 di mei 2015, articulo IX, mester fiha e sector colectivo pa e proximo dos aña, promer cu 1 di april. Aña pasa no a stipula e sector colectivo pa 2021 y 2022, motibo pa cual CAft ta conseha pa haci esaki mas pronto posible. Esaki mester sucede den colaboracion cu CBS Aruba y CBS Hulanda. CAft ta observa tambe cu den e rapportahe 1-2021 ta proyecta un deficit di Afl. 90 miyon pa SVb, mientras den e presupuesto 2021 ta menciona un deficit di Afl. 12 miyon, pasobra ta contempla uso di

propio fondo di SVb pa compensa parti (grandi) di e deficit, ademas di un perspectiva mas favorable pa recuperacion di economia na 2021 di gobierno mes. CAft den su tabel acompañante a inclui e coreccion aki di SVb caba.

Financiamiento y posicion de debe

Den presupuesto 2021 ta aparece un necesidad di financiamiento di Afl. 1.138 miyon, cu ta consisti di Afl. 878 miyon di (deficit) di presupuesto y Afl. 261 miyon pa refinancia debe cu ta madura. Den e lunanan evalua a paga Afl. 4 miyon na debe y Afl. 61 miyon na interes. Den e mesun periodo debe a aumenta cu Afl. 64 miyon. E aumento ta resulta entre otro di e saldo di prestamo y pago riba debe madura. E prestamonan nobo ta inclui e asistencia di liquidez di Afl. 71 miyon y debenan a corto plazo di Afl. 37 miyon.

Debe total na fin di trimester 1-2021 ta Afl. 5.209 miyon (incluyendo tranche 1 te cu 4 di asistencia di liquidez). E corelacion debe/GDP ta keda na 123% (2020: 124%), unda a tuma como punto di salida e GDP nominal manera calcula pa Banco Central di Aruba.



E motibo pakico formateur Peterson a informa Chong

den un carta cu e no por wordo nomina como minister ta e hecho cu e miembro di PNP tin un record criminal. Chong a wordo condena di corupcion na 2003, tempo cu e tabata ainda un comisionado di isla. Y e ley di screening ta cla riba esey: un persona cu un condena no por bira minister.

Chong ta bisa cu e ta desapunta y lo studia e informacion di e carta di e formateur mas profundamente. E ta considerando bay corte pasobrera e ta mira Esaki como un asunto di principio. "Corsou ta e unico pais den Reino cu un ley asina. Mark Rutte tin un condena civil y simplemente por ta prome minister na Hulanda. Pakico ami no por bira minister? Esaki no ta correcto", Chong ta bisa.

Despues di Eduard Braam – kende voluntariamente si-

liente di PAR y MAN a adopta un propuesta di Ordenansa Nacional pa salvaguardia integridad di ministernan, cual tabata suplemente cu guianan di un conseho anterior di Transparency International y Convencion di Nacionnan Uni contra Corupcion (UNCAC). E propuesta actualmente ta dilanti Raad van Advies.

Nuebe partido di acuerdo pa forma coalicion di minoria na Limburg

(DutchNews.nl) – Nuebe partido na Limburg a cera un acuerdo pa goberna e provincia dos luna despues cu e gobierno anterior

a collapse memey di un scandal di clientismo. E goberno extra-parlamentario ta exclui CDA, cu a domina politica di Lim-

Nan a priminti nan sosten a cambio di concesionnan respectivo riba politica social y asuntonan di medio ambiente, incluyendo medidanan adicional pa reduci emisionnan di nitrogen dioxide.

E cinco miembro di CDA a retira na abril despues cu NRC a revela cu ex-miembro di asamblea di CDA Herman Vreken a cobra centenares di miles di euro den subsidio pa un fundacion ambiental cu e tabata mancha, IKL, cu

despues a duna contract na su propio companianan.

Dos miembro di personal di Limburg, Ger Koopmans y Hubert Mackus, kende tambien tabata afilia cu CDA, tabata responsabel pa aloca e subsidionan. Nan a retira fin di maart, sigui despues pa resto di e administracion y e gobernador di e provincia, Theo Bovens.

Un investigacion independiente di e provincia a haya una pasa cu e pagongan contractual di IKL na e 28 compania di Vreken, cu balor total di 93 miyon euro, no a kibra regulacionnan. Bovens a wordo reemplaza den un capacidad di actua pa e politico veterano di VVD, Johan Remkes, te cu por a forma un administracion nobo.

Ex-alcalde di Maastricht,

Ex-Detroit councilman gets probation for misconduct charge

(AP) — A former Detroit city councilman was sentenced Monday to 2 1/2 years of probation after pleading guilty last month to accepting an illegal cash campaign contribution.

Gabe Leland, 38, admitted before he was sentenced by Wayne County Circuit Judge Gregory Bill that he had “crossed a line.” He also apologized to his family and those who had voted for him.

The Democrat had pleaded guilty in May to misconduct in office and resigned from his council seat representing Detroit’s District 7. Court documents have said he accepted an illegal \$7,500 cash campaign contribution.

A federal grand jury indicted Leland in 2018 on corruption charges tied to \$15,000 in bribes and free auto body



work solicited and accepted from a business owner in return for help on a property

issue.

The federal charges will be dismissed as part of Leland’s plea agreement in the state misconduct case.

“The court has been convinced to go along with this fair disposition, and in light of your resignation from the Detroit City Council, you’re not in a position to breach the trust of the people,” Bill said during sentencing.

But the judge said that if Leland violates the terms of his probation period, he could face five years in prison.

Leland told the court that while few people have the opportunity to serve in elected office, he was honored to do so for 15 years.

“But I crossed the line,” he said during the Zoom court hearing.

Oregon lawmaker faces expulsion for assault on state Capitol



(AP) — Oregon House Speaker Tina Kotek wants to expel a Republican lawmaker who allowed violent protesters into the state Capitol in December. Fellow Republicans said Monday they want him out too.

Video that emerged late Friday in local news reports that apparently showed Rep. Mike Nearman choreographing how he would let protesters into the Capitol, which was closed to the public, exploded like a bombshell in the Legislature on Monday. For even the minority Republicans in the House, it was too much.

“Today, we strongly recommend that you resign from the Oregon State House of Representatives, House District 23 position,” all 22 Republicans in the House said

in a joint letter to Nearman. “Given the newest evidence that has come to light ... it is our beliefs as friends and colleagues that it is in the best interest of your caucus, your family, yourself, and the state of Oregon for you to step down from your office,” they said.

Kotek, a Democrat, also introduced a resolution that says if two-thirds of the members of the House of Representatives concur, Rep. Mike Nearman would be expelled from the House. Minutes before the House opened its floor session late Monday morning, her office announced that Kotek appointed a committee to consider expulsion.

The committee, composed of three Democrats and three Republicans, will convene later this week and take up the resolution, Kotek’s press

release said. But with Republicans now calling for Nearman to step down, his fate appeared sealed. If Nearman does not resign, there was little doubt that an overwhelming number of House members would vote to cast him out.

The incident on Dec. 21 rattled lawmakers and staff inside the Capitol and foreshadowed the Jan. 6 assault on the U.S. Capitol by rioters spurred on by then President Donald Trump. Several of those who were among the crowds in Salem on Dec. 21 later were in Washington during the U.S. Capitol attack.

As lawmakers met in emergency session on Dec. 21 to deal with economic fallout from the coronavirus pandemic, far-right rioters entered the building. They sprayed chemical irritants at police who finally expelled them. Outside, protesters broke windows on the Capitol and assaulted journalists.

Later, security camera video emerged showing Nearman opening a door to the capitol, which was closed to the public because of the coronavirus pandemic, allowing protesters to enter. Nearman allegedly told people in a video days earlier that he would

let them in if they texted him, and he provided his cell phone number. The existence of the video was first reported Friday by Oregon Public Broadcasting.

In her resolution, Kotek said personnel who were authorized to be in the Oregon Capitol described the events on Dec. 21 as intense and stressful, terrifying and distressing.

“Law enforcement officers were visibly injured and shaken due to the demonstrators’ action,” Kotek added.

“The severity of Representative Nearman’s actions and last week’s revelation that they were premeditated require a special committee to immediately consider expelling him from the House of Representatives,” Kotek said. “He knowingly put the physical safety of everyone in the Capitol — lawmakers, staff and law enforcement — in jeopardy.”

Her resolution cites the Oregon Constitution, which empowers the House of Representatives to punish a representative for disorderly behavior.

“With the concurrence of two-thirds of the members of the House of Representatives, Representative Nearman (shall) be expelled from

the House of Representatives,” the resolution says. A reporter went to Nearman’s office in the Capitol to get his reaction. A woman sitting at a desk in the anteroom demanded to know how the reporter got there, then said the lawmaker was not present. She refused to comment, went into Nearman’s office and shut the door.

Nearman, who didn’t respond to messages seeking comment, also faces two misdemeanor criminal charges and has said he will seek a trial by jury.

“The Oregon State Police spent over four months investigating me. ... Do you think these guys have anything better to do?” Nearman said on a conservative radio show last month.

Kotek said police in the state Capitol prevented the situation from escalating.

“As we saw in January at the U.S. Capitol, the ramifications could have been dire if law enforcement had not stepped in so quickly,” Kotek said. Members of the new committee are Rep. Paul Holvey, D-Eugene; Rep. Christine Drazan, R-Canby; Rep. Barbara Smith Warner, D-Portland; Rep. Daniel Bonham, R-The Dalles; Rep. Andrea Salinas, D-Lake Oswego; and Rep. Duane Stark, R-Grants Pass.

2 arrested in California road rage killing of 6-year-old

(AP) — A man and a woman have been arrested in connection with a road rage shooting that killed a 6-year-old boy last month on a Southern California freeway, authorities said.

Marcus Anthony Eriz, 24, and Wynne Lee, 23, were detained Sunday outside a home in Costa Mesa south of Los Angeles, the California Highway Patrol said in a statement.

"They are expected to be charged with murder," a highway patrol news release said. It wasn't known Monday if they have attorneys who could speak on their behalf.

Aiden Leos was fatally shot in the abdomen on May 21 while seated in the back seat of a car driven by his mother, Joanna Cloonan in the city of Orange.

Highway patrol officials said the road rage incident stemmed from "a perceived unsafe lane change."

According to accounts from the mother and witnesses who stopped to help her, another car cut her off and she responded with a hand gesture and the car slipped in behind her and someone inside fired a shot through the rear of her car.

A reward offered for information leading to an arrest had grown to at least \$500,000, Southern California News Group reported.

"On behalf of Border Division Chief Omar Watson, and the Santa Ana Area, we are deeply grateful for the professionalism and tireless commitment of our investigators who have worked on this case from day one to find

those responsible for Aiden's death," California Highway Patrol Commissioner Amanda Ray said in Sunday's statement.

Watson added: "The Department has been in regular contact with the victim's family and I assure you they, like us, are committed to seeing justice served."

The arrests came a day after the memorial service for Leos, who was remembered as a child with a vocabulary beyond his years who exuded warmth and tenderness.

"He gave us such joy, giving us purpose to our life. I felt so honored to be Aiden's mommy," his mother, Joanna Cloonan, said during the service Saturday.

Eriz and Lee were being held in an Orange County jail for lack of \$1 million bail each,

online jail records show. Their relationship was not immediately known.



Water polo players get \$14 million in sex abuse settlement

(AP) — A dozen female water polo players who accused their coach of sexual abuse will split nearly \$14 million after settling a lawsuit against USA Water Polo and a California club.

The athletes alleged that International Water Polo Club and the national governing organization for the sport failed to protect them from

abuse by coach Bahram Hojreh from 2012 to 2017.

In an April ruling involving taekwondo competitors who once aspired to represent the U.S. at the Olympics, the California State Supreme court said that sports governing organizations have a duty to protect athletes.

The \$13.85 settlement filed Friday in Orange County Superior Court with USA Water Polo and International Water Polo Club is being paid by the insurer for both organizations.

"We have heard the plaintiffs' testimony, and their allegations are heartbreaking," Christopher Ramsey, CEO of USA Water Polo, said in a statement. "We hope that this allows them to begin a new chapter in their lives."

Hojreh, 45, has pleaded not guilty to 34 counts of sexual abuse involving 10 victims, nine of whom were children at the time of the acts. The alleged crimes occurred during one-on-one coaching sessions, prosecutors said.

Charges filed by the Orange County district attorney include lewd acts on a child, sexual penetration with a foreign object and sexual battery by fraud, which alleges the

victims were not aware they were being molested because the coach said the "touching served a professional purpose."

The suits said USA Water Polo was negligent for failing to act upon reports in the summer of 2017 that Hojreh's players at the International club had sexually abused opponents during matches and that allowed him to get away with abuse for about eight more months.

The Orange County Register reported that girls on opposing teams had emerged from the pool accusing Hojreh's swimmers of trying to grab and penetrate their genitals underwater. At one match, another coach accused Hojreh of teaching that tactic to his players and a fight nearly erupted on the pool deck with angry parents yelling and threatening each other.

In a court filing, USA Water Polo said it forwarded those complaints from June and July 2017 to the U.S. Center for SafeSport, the watchdog formed in 2017 to handle sex-abuse cases in the Olympic realm.

At the time, however, USA Water Polo said it had not received complaints that Hojreh sexually abused his play-

ers. It said it suspended him from the organization when it first got reports about his alleged abuse in January 2018 from SafeSport.

Scandals involving sexual abuse of young athletes have reverberated across the sporting world and hit several of the 61 Olympic governing organizations, including USA Swimming and USA Gymnastics. The highest-profile case involved Larry Nassar, a doctor for the U.S. gymnastics team imprisoned for assaulting minors that included several gold medalists.

Hojreh has been permanently banned from water polo by SafeSport. He's one of 10 people affiliated with USA Water Polo banned from the sport since 2018 due to criminal matters.

A criminal defense lawyer for Hojreh, who still faces several lawsuits, previously told The Associated Press he never had a blemish on his record after working with hundreds of children over two decades.

Hojreh coached for nearly a quarter-century and said he'd developed "multiple Olympians." Until 2018, he served on the board of directors for the Southern California chapter of USA Water Polo.



Boston police commissioner ousted over domestic abuse claims

(AP) - Boston's police commissioner was fired Monday following a bitter battle to keep his job after decades-old domestic violence accusations came to light.

Acting Mayor Kim Janey announced Dennis White's removal as the city's top cop, four months after White was placed on leave over the allegations just days into his new job.

White had tried to go to court to block his firing, calling the allegations false and saying the mayor has no cause to terminate him. During a hearing held last week, White told Janey: "I am innocent and I ask that you not convict me."

White — a 32-year veteran of the department who replaced William Gross, the city's first Black police commissioner — was suspended after The Boston Globe raised ques-

tions about allegations found in court documents from 1999 that White pushed and threatened to shoot his then-wife, a fellow police officer.

An investigative report released by the city last month said witnesses alleged that White's ex-wife was subjected to "physical and mental abuse." Among the allegations included in the report is that White burned her hair, put her face to a stove and threw a television at her. A judge issued a restraining order against White in 1999, ordering him to stay away from his wife and children and surrender his service weapon.

The city's report said White was also involved in what he described as a "heated fisticuffs" with a young woman in 1993. White admitted striking her with a full swing of his arm and open hand, but says he was acting in self-defense, the report said.

White has vehemently denied ever engaging in domestic violence, and accused his ex-wife of lying to get a financial advantage in their divorce.

"I am a Black man, who has been accused falsely of crimes, I have not yet been given a fair trial, and I'm on the brink of being convicted, or terminated which is the equivalent here," White said during his termination hearing, according to a statement provided by his lawyer. "As you know, that is a pattern that has been repeated in this country for centuries. I believe it will be bad for Boston if that pattern is repeated here with me," he said.

White, who served as Gross' chief of staff, was swiftly chosen to lead the department by then-Mayor Marty Walsh. At the time, Walsh called White a "proven leader who is trusted and respected in the community."

Walsh has insisted that he had no prior knowledge of the accusations and would never have picked White if he did.

But Gross said in an affidavit filed in court that Walsh, now secretary of the U.S. Department of Labor, was briefed on White's internal affairs history when White was promoted to the department's command staff in 2014, and therefore was aware of the allegations before picking him as police commissioner.

White also said in a video released by his lawyer that he told Walsh about the restraining order against him over "false allegations." White said that Walsh "was very sympathetic to what was going on with me as I was about his past and how we had overcome some hurdles in our lives to move on."

Cleared Chicago priest holds first Mass since reinstatement

(AP) — An activist Roman Catholic priest cleared by an Archdiocese of Chicago investigation into claims that he sexually abused several boys decades ago returned to the pulpit of his longtime church on Sunday for the first time in five months.

"It's good to be home," the Rev. Michael Pfleger repeatedly told congregants of the Faith Community of St. Sabina, describing his time away during the investigation as a "painful nightmare."

Pfleger, 72, was placed on leave in January amid allegations from two brothers who said Pfleger sexually abused them as children starting in the 1970s. A third man later also alleged that Pfleger molested him once in 1979 when he was 18. Last month, the archdiocese concluded there was "insufficient reason to suspect" that Pfleger had abused children. A police investigation remains open.

His first service back at the largely Black church on Chicago's South Side was as spirited as ever, with live music, dancing and reenergized congregants who have fiercely backed their priest. Pfleger, who is white, thanked congregants for supporting him and vowed to resume his activism, especially against gun violence, with even more gusto.

"I'm going to fight harder,

because I'm stronger, I'm better and I'm wiser. ... The last five months have been a roller coaster of hurt and anger and depression and pain and not knowing what people are thinking about you," he said, his voice breaking at times.

To support Pfleger, church members have held rallies, flooded archdiocese phone lines, threatened to withhold church dues and launched a letter-writing campaign. On Sunday, some wore T-shirts featuring the priest's photo and the message "Pfleger is

back." Among those in attendance was filmmaker Spike Lee, who is friends with Pfleger and whose 2015 movie "Chi-raq" featured a character inspired by Pfleger and played by John Cusack.

Pfleger is known for his anti-violence activism and for bolstering neighborhood development in the largely low-income neighborhood surrounding the church. He's also been in the spotlight for clashing with church leaders, having been suspended twice before this year, including in 2008 during Barack Obama's

presidential campaign when he mocked Obama's primary opponent Hillary Clinton.

Ordained in 1975 and assigned to St. Sabina, Pfleger became pastor six years later and lived at the nearby rectory until earlier this year, when he temporarily moved to an apartment during the investigation.

Police have said their investigation remains "open and active," but they haven't provided any details about it. Cook County State's Attorney Kim Foxx has said

police haven't presented any information for her office to review or determine if criminal charges are appropriate. Illinois has no statute of limitations for filing charges in major sex crimes.

The Illinois Department of Children and Family Services completed its review in February, concluding there was no credible evidence of child abuse or neglect. The agency, which doesn't investigate allegations of abuse by an adult victim, focused on whether children were currently at risk.

During Sunday's service, Pfleger talked about street violence in Chicago. He also acknowledged the damage that the abuse allegations did to his reputation.

He didn't talk about the allegations in detail, aside from saying the false accusations to "destroy his character" began with an "extortion letter." One of the brothers, who are in their 60s, has acknowledged that he asked Pfleger for a \$20,000 payment in December.

"I know my name will be damaged for the rest of my life," Pfleger said as congregants booed. "But most of that is by people that hated me anyway. There are people watching today that are not happy that I'm back. But take off your party hat and blow out the candles. I'm back."



France fines Google for abusing 'dominant' ads position

(AP) — Google is being fined 220 million euros (\$268 million) by France's antitrust watchdog for abusing its 'dominant' position in online advertising.

The search engine giant is also promising to overhaul the way its platform is used for buying and selling digital ads, at least in France, which could have repercussions on its ongoing legal fights with regulators elsewhere in Europe, the U.S. and around the world.

Google's advertising practices have harmed its competitors along with publishers of mobile websites and applications, the French Competition Authority said Monday. The authority said it is the responsibility of a company with a dominant market position to avoid unfairly undermining its competition.

Google, based in Mountain View, California, did not dispute the facts and opted to settle after proposing some changes, according to a prepared statement from the Competition Authority.

The settlement might serve as a roadmap for other governments that are scrutinizing Google's market power, said Douglas Melamed, a Stanford University law professor.



"I imagine that Google's decision to settle reflected a judgment that it could live with those terms even if it were forced upon it by other jurisdictions," he said.

The head of the authority, Isabelle de Silva, said the decision was unprecedented in the way that it delved into the complex algorithmic auctions that power Google's business selling online display ads.

The fine, along with Google's commitment to changing its practices, "will make it possible to re-establish a level playing field for all players, and the ability for publishers

to make the most of their advertising space," de Silva said.

Google France's legal director, Maria Gomri, said in a blog post Monday that Google has been collaborating for the past two years with the French watchdog on issues related to ad technology, notably the platform known as Google Ad Manager. She wrote that commitments made during negotiations would "make it easier for publishers to make use of data and use our tools with other ad technologies."

After tests in the months ahead, changes will be de-

ployed more broadly, some of them globally, Gomri said. She didn't specify which changes would apply outside of France.

The French authority's investigation was prompted by complaints from Rupert Murdoch's News Corp., French newspaper group Le Figaro and Belgium-based Rossel La Voix. Le Figaro later withdrew its complaint.

U.S. tech giants have been facing intensifying scrutiny in Europe and elsewhere over their business practices. Germany became the latest country to launch an in-

vestigation of Google, using stepped up powers to scrutinize digital giants.

The German competition watchdog said Friday that it was examining whether contracts for news publishers using Google's News Showcase, a licensing platform launched last fall, include "unreasonable conditions."

Google has been facing pressure from authorities to pay for news and signed a deal earlier this year with a group of French publishers that paves the way for it to make digital copyright payments.

European Union regulators have also charged Apple with stifling competition in music streaming and accused Amazon of using data from independent merchants to unfairly compete against them with its own products. They are investigating Google's data practices for advertising purposes and recently opened a formal antitrust investigation into Facebook's advertising practices.

In the U.S., the Justice Department and dozens of states brought antitrust lawsuits against Google last year. They are seeking to prove that Google has been methodically abusing its power as the internet's main gateway in a way that hurts consumers and advertisers.

Greece says many migrants in Turkey could seek asylum there

(AP) — Greece on Monday designated neighboring Turkey as a safe country in which to seek international protection for the majority of asylum-seekers departing its shores for Greece.

A joint decree from the Greek foreign and migration ministries said the designation applies to asylum-seekers from Syria, Afghanistan, Pakistan, Bangladesh and Somalia. It said Turkey meets all criteria to examine asylum requests from these nations, as there "they are not in any danger ... due to their race, religion, citizenship, political beliefs or membership in some particular social group, and can seek asylum in Turkey instead of in Greece."

That, in theory, could reduce migration flows to European

Union member Greece, as it would allow it to return asylum-seekers from these countries to Turkey — which itself has a huge migrant and refugee population.

Nevertheless, despite pressure from the EU and Athens, Ankara has shown little appetite for taking back migrants who reached Greece from its territory, despite a 2016 Turkish-EU agreement that was meant to stem illegal migration into the 27-nation bloc.

Greek officials said Athens has so far this year asked Turkey to take back 1,453 people, without success.

Nevertheless, Migration Minister Notis Mitarachi described Monday's decision as "an important step in tackling illegal migration flows"

which, he said, would "force" Turkey to crack down on illegal migration and smuggling networks.

Mitarachi added that the decision "is fully in line with international law and enhances Greece's legal arsenal against (asylum) requests by citizens of ... Syria, Afghanistan, Pakistan, Bangladesh and Somalia, who objectively have no reason not to consider Turkey a safe country."

Greece and Turkey are historic regional rivals, and military tensions rose dangerously last year over marine boundaries. Athens accuses Ankara of using migration as a weapon, pointing to the Turkish government's failed bid last year, before the military tension, to wave thousands of migrants and refugees towards Greece.

to wealthier EU countries — flows have since been greatly reduced.

So far this year, just over 3,000 people have reached Greece from Turkey, mostly by sea in flimsy craft. According to the U.N. refugee agency, 47% were Afghans, 15% were Syrians and 9% were Somalis.



Train barrels into another in Pakistan, killing at least 51



(AP) — An express train barreled into another that had derailed in Pakistan before dawn Monday, killing at least 51 people and setting off a desperate effort to search the crumpled cars for survivors and the dead, authorities said.

More than 100 other people were injured. Cries for help pierced the night as passengers climbed out of overturned or crushed rail cars. The pleas continued to echo throughout the day at the scene in the district of Ghotki, in the southern province of Sindh.

Heavy machinery arrived to cut open some cars, and more than 15 hours after the crash, rescuers carefully removed wreckage as they looked for anyone who might remain trapped — though hopes were fading for survivors. The military deployed troops, engineers and helicopters to assist.

The Millat Express train derailed around 3:30 a.m., and the Sir Syed Express train hit it minutes later, said Usman Abdullah, a deputy commissioner of Ghotki. It was not immediately clear what caused the derailment, and the driver of the second train

said he braked when he saw the disabled train but did not have time to avoid the collision.

About 1,100 passengers were aboard the two trains, rail officials said.

"The challenge for us is to quickly rescue those passengers who are still trapped in the wreckage," said Umar Tufail, a police chief in the district.

The death toll steadily rose through the day, and the chances of finding survivors were diminishing, said Rizwan Nazir, a district administration official.

Authorities brought in lights so rescuers could work through the night. Relatives of some of the missing passengers waited nearby.

Passengers with critical injuries were to be brought by helicopter to a nearby hospital.

Engineers and experts were trying to determine what caused the collision, said

Azam Swati, the minister for railways who headed to the scene of the crash. He told The Associated Press that all aspects would be examined, including the possibility of sabotage.

The segment of the railway tracks where the crash took place was old and needed replacing, Habibur Rehman Gilani, chairman of Pakistan Railways, told Pakistan's Geo News TV. He did not elaborate.

Aijaz Ahmed, the driver of the Sir Syed Express, told the station that on seeing the derailed train, he tried his best to avoid the crash by braking but failed. Railway officials said Ahmed was slightly injured, and villagers pulled him from the train's engine after the crash.

Pakistani Prime Minister Imran Khan expressed his deep sorrow over the tragedy, saying on Twitter that he asked the railway minister to supervise the rescue work and ordered a probe into the crash.

According to local media,

some of the passengers on the Millat Express were heading to a wedding party.

Mohammad Amin, one of the passengers on the Millat Express who had minor injuries, told the AP from a hospital that before the train departed from the southern port city of Karachi, he and his brother saw mechanics working on one of the cars.

That led them to believe there was something wrong with it, but they were reassured all was fine. Amin said he believed the car that was being worked on was the one that later derailed. Railway officials said they were recording statements of survivors, including the drivers.

Train accidents are common in Pakistan, where successive governments have paid little attention to improving the poorly maintained signal system and aging tracks.

In 1990, a packed passenger plowed into a standing freight train in southern Pakistan, killing 210 people in the worst rail disaster in the nation's history.

Israel suspends ultranationalists' march in east Jerusalem

(AP) — Israeli police said Monday they blocked a planned procession by Jewish ultranationalists through parts of Jerusalem's Old City, following warnings that it could reignite tensions that led to a punishing 11-day war with Gaza's militant Hamas rulers last month.

The parade, which celebrates Israel's capture of east Jerusalem in the 1967 Mideast war, was underway on May 10 when Hamas fired rockets from Gaza toward the holy city, setting off heavy fighting. Some 254 people were killed in Gaza and 13 in Israel before a cease-fire took effect May 21.

The war was preceded by weeks of clashes between Israeli police and Palestinian demonstrators in the Old City and in the nearby neighborhood of Sheikh Jarrah, where Jewish settlers have waged a decades-long campaign to evict Palestinian families from their homes.

Israel's attorney general on Monday declined to intervene in the cases of several of the families, making it more likely the evictions will be carried out — possibly in the coming weeks. That could also reignite violence.

The procession, which had intended

to go through the Old City's Muslim Quarter, is seen by Palestinians as a provocation.

In a statement, police said the proposal to hold the parade later this week was not approved, but new plans would be considered. Organizers accused the police of caving in to pressure from Hamas.

Bezalel Smotrich, leader of the far-right Religious Zionism party, tweeted a warning to embattled Prime Minister Benjamin Netanyahu "not to give in to Hamas threats."

Renewed tensions in east Jerusalem or fighting with Hamas could complicate Israel's shaky politics. Netanyahu's opponents last week said they have formed a coalition that could remove the prime minister from office after a 12-year term. The new coalition is expected to be sworn into office in the coming days.

Over the weekend, Israeli police arrested and released a veteran reporter for the Al Jazeera satellite channel who had regularly been covering the Sheikh Jarrah protests. And on Sunday, authorities stormed the home of a leading activist in the neighborhood, arresting her and her brother. The siblings were later released.

Before Muna al-Kurd was freed, police briefly clashed with a crowd outside the station, throwing stun grenades at the protesters.

Israel captured east Jerusalem, which is home to sites sacred to Jews, Christians and Muslims, in the 1967 war and annexed it in a move not recognized internationally. Israel views the entire city as its capital, while the Palestinians want east Jerusalem as the capital of their future state.

The settlers are using a 1970 law that allows Jews to reclaim formerly Jewish properties lost during the 1948 war surrounding Israel's creation, a right denied to Palestinians who lost property in the same conflict. At least 150 Palestinian households, in Sheikh Jarrah and the neighborhood of Silwan, both near the Old City, are at risk of eventual eviction.

A request by the attorney general at the height of the tensions last month led to the postponement of a Supreme Court hearing on the most imminent evictions, of four extended families comprising six households in Sheikh Jarrah.

But in a statement issued Monday, Attorney General Avichai Mandelblit said "there is no place" for him to intervene in the proceedings. That

sends the matter back to the Supreme Court, which is expected to rule against the families.

Ir Amim, an Israeli human rights group that closely follows the various court cases, says the four families could be evicted within the coming month, and that the attorney general's decision could affect the cases of more than 80 other families threatened with eviction.

"It paves the way for the evictions to be carried out," said Amy Cohen, a spokeswoman for Ir Amim. But she added that Israeli authorities still have various options for postponing or halting the evictions. "There still is room for political intervention," she said.

The threatened evictions have been widely criticized internationally, including by the United States, Israel's closest ally.



Spain again has to weather a storm before a major tournament

(AP) — For the third straight time, Spain's preparations for a major soccer tournament have taken a hit just before it is set to start playing.

After having to overcome problems ahead of the 2016 European Championship and the 2018 World Cup, "La Roja" enters Euro 2020 having to deal with the scare of a COVID-19 outbreak that could jeopardize its title chances.

Captain Sergio Busquets tested positive for the coronavirus on Sunday and has his participation in the tournament in doubt. He is already set to miss the team's opener against Sweden on June 14 after starting a 10-day period of isolation away from the team's training camp.

There were fears more infections could be detected, but no one else in the squad tested positive on Monday. Testing was set to continue among players and staff in the coming days, and coach Luis Enrique called up five additional players to begin practicing at the team's training camp in case they were needed as replacements. The federation said others were expected to be called up later in the week.



The players arriving on Tuesday are Rodrigo Moreno, Pablo Fornals, Carlos Soler, Brais Méndez and Raúl Albiol. The federation said they will not have any contact with the players previously selected for the European tournament.

"Taking into consideration the possible consequences that Busquets' positive result could bring, the coaching staff has decided to incorporate a group of players to complete training during the next few days under Luis Enrique's orders within a parallel bubble," the Spanish federation said.

Spain was yet to announce whether Busquets would be dropped from the squad, but his case was already sig-

nificantly affecting the team's preparations because everyone else in close contact with him also had to isolate. Practice sessions had to be altered and personalized training routines were put in place so health safety protocols could be observed, the Spanish soccer federation said.

The team also won't get to play its final warm-up match scheduled for Tuesday against Lithuania. Spain will use players from the under-21 squad, as well as its coach, for the match in Madrid.

The national team players were not vaccinated against COVID-19, which generated some criticism as Spanish athletes competing at the Tokyo Olympics have been. Busquets started in Spain's

first warm-up match on Friday, a 0-0 draw against Portugal in the Spanish capital. Spain is set to open play in Group E against Sweden, then face Poland on June 19 and Slovakia on June 23. All of its matches will be played in the southern Spanish city of Seville.

Luis Enrique has until Saturday to make changes to the squad in cases of injuries or COVID-19. When he announced his list, the coach said he would probably use under-21 players as replacements if needed. He only selected 24 players instead of the 26 allowed for each national team, saying he didn't want to call up too many players who would not likely be used at the tournament.

The Spaniards had an even bigger problem to overcome three years ago, when the local soccer federation fired coach Julen Lopetegui two days before the team's opening World Cup match in Russia after he took a job with Real Madrid without properly advising federation officials.

The firing left Spain's training camp in chaos, with sporting director Fernando Hierro suddenly taking over as coach. Spain had been among the title favorites at the time, coming off a string of good results under Lopetegui, but it ended up being eliminated by Russia in the round of 16 after winning only one of its three group matches.

The controversy before Euro 2016 also surfaced shortly before the tournament, with starting goalkeeper David de Gea having his name involved in an investigation into a Spanish pornography filmmaker. He immediately denied wrongdoing and eventually was fully cleared.

Then-coach Vicente Del Bosque also couldn't avoid the subject in news conferences. Spain got through the group stage but was eliminated by Italy, also in the round of 16.

Russia chafes at Ukrainian team's shirt for Euro 2020

(AP) — A tense tug-of-war between Russia and Ukraine has spread to soccer, with Russian officials and lawmakers denouncing the design of the Ukrainian national team's shirt for this month's European Championship.

The yellow-and-blue Ukrainian design features a map of the country including Crimea, the Black Sea peninsula that Russia annexed in 2014 following the ouster of its Moscow-friendly president.

Most of the world hasn't acknowledged the annexation and international law still recognizes Crimea as Ukrainian territory. Russia also has cast its support behind separatists in eastern Ukraine, where seven years of fighting has killed more than 14,000.

Andrii Pavelko, the president of the Ukrainian soccer association, presented the new uniform on Facebook on Sunday, hailing it as a symbol of the "single and undivided homeland" that would inspire players to "fight for entire Ukraine."

Pavelko is a member of the executive committee of European soccer body UEFA, which signed off on the design for the tournament.

"The shirt of the Ukrainian national team (and of all other teams) for UEFA Euro 2020 has been approved by UEFA, in accordance with the applicable equipment regulations," the Switzerland-based organization said.

Russia quickly reacted with dismay.

Russian Foreign Ministry

spokeswoman Maria Zakharova scoffed at the design as a "desperate" gesture.

She also ranted against the Ukrainian national slogan — "Glory to Ukraine, glory to the heroes!" — written on the uniform. Zakharova charged that the rant was used by Ukrainian nationalists, some of whom fought against the Soviet Union alongside the Nazis in World War II.

Several Russian lawmakers also lashed out at the Ukrainian uniform's design. Dmitry Svirshchev, a member of the Russian parliament's lower house, denounced the Ukrainian uniform as a political gesture designed to draw sports into politics.

"It's setting the stage for a conflict using the uniform," he said. "Sports arenas aren't for political declarations."

Another Russian lawmaker, former professional boxer Nikolai Valuev, also condemned the Ukrainian uniform as an "unseemly attempt to politicize sports."

"They can dream about what they want," Valuev said, "but Crimea is part of the Russian Federation and it's not up for discussion."

Ukraine and Russia both qualified for the 24-team tournament but a UEFA rule

in place since 2014 to separate the two countries' national teams and club teams prevented them from being drawn together.

The tournament draw also prevents Ukraine and Russia from facing each other in the round of 16.

Russia will host seven Euro 2020 games in St. Petersburg. None will involve Ukraine.



Djokovic, Nadal beat Italian teens to reach French Open QFs



(AP) — For two sets and more than two hours at the French Open on Monday, Novak Djokovic found himself being outplayed by a 19-year-old opponent from Italy making his Grand Slam debut.

And yet, to hear Djokovic tell it afterward, he had the kid right where he wanted him. Which turned out to be true.

Rafael Nadal also faced an Italian who's just 19 in the fourth round — and also needed a bit of time to get going. Nadal's trouble lasted all of eight games and less than 45 minutes Monday before he seized control, ran his Roland Garros streak to 35 consecutive sets and joined Djokovic in reaching a record 15th quarterfinal at the clay-court major tournament.

After dropping a pair of tie-breakers, Djokovic suddenly went from a big deficit to his best tennis. He grabbed 13 games in a row before Lorenzo Musetti stopped playing because of lower back pain and cramps while trailing 6-7 (7), 6-7 (2), 6-1, 6-0, 4-0.

"I like to play young guys in best-of-five, because I feel even if they are leading a set or two sets to love, as it was the case today, I still like my chances," said the top-seeded Djokovic, who is 34, "because I feel like I'm physically fit and I know how to wear my opponent down."

Nadal, who turned 35 last week, trailed 5-3 early on against the 18th-seeded Jan-Lennard Sinner, who served for the first set at 5-4.

But 13-time French Open

champion Nadal took eight games in a row and, after a blip in the second set, resumed his excellent play and closed his 7-5, 6-3, 6-0 win on another eight-game run.

"He played better. That's all there is to say," Sinner summarized.

About the only thing that bothered Nadal down the stretch: He complained to the chair umpire that the stadium's artificial lights shouldn't have been switched on while there was still sunlight.

"They say it is because of the TV," Nadal said. "But my answer is: We used to have TV before we had the lights on here in Roland Garros. I saw plenty of matches here — and from the TV, the quality of the image was great without the lights."

Sinner and Musetti had planned to practice together at Court Philippe Chatrier on Monday morning before their matches there. But Sinner said his coach — Riccardo Piatti, who mentored Djokovic years ago — messed up the timing.

Musetti, a talented Italian so good at the outset with his one-handed backhand and tremendous touch, is hardly used to this best-of-five-set format at the majors and he took a medical timeout after the fourth.

"It didn't make sense to keep playing. I couldn't win any points or stay in the rallies. It was hard for me to move," Musetti said. "I was at my limit."

Djokovic wound up 9 for 9

on his break-point chances and with a 53-30 edge in winners.

How shocking was it just to see Musetti take a pair of sets against Djokovic, who is seeking his second French Open championship and 19th Grand Slam trophy overall?

"Even for me," Musetti acknowledged, "it was a little surprising."

The top-seeded Djokovic never has been beaten at Roland Garros by someone ranked as low as the No. 76 Musetti. Djokovic's only previous loss against a teen at the French Open came back in 2006 against a guy named Nadal. And Djokovic entered the day 14-0 in the fourth round at the place.

Plus, consider Djokovic's recent form: He was 10-0 in

Grand Slam matches in 2021 and hadn't ceded more than four games in any set in Paris — let alone an entire set — while dropping a total of just 23 games until Monday.

Eventually, Djokovic earned his fifth career comeback from two sets down by limiting his mistakes and making Musetti look like what he is: Someone with plenty of promise but not much experience.

Djokovic's 49th major quarterfinal will come against another Italian, No. 9 seed Matteo Berrettini, who advanced without needing to swing his racket Monday.

The man Berrettini was supposed to face, Roger Federer, withdrew Sunday in order to let his surgically repaired right knee and the rest of his 39-year-old body recover with an eye to Wimbledon, which starts June 28.

Just as Nadal vs. Sinner was a rematch from last year in Paris — Sinner also served for the first set in that one before losing in three — Nadal will play No. 10 seed Diego Schwartzman next in a reprise of a 2020 semifinal.

Schwartzman saved seven set points in the opening set Monday on the way to eliminating Jan-Lennard Struff 7-6 (9), 6-4, 7-5.

Earlier, 17-year-old American Coco Gauff became the youngest player since 2006 to reach the women's quarterfinals at a Slam by overwhelming No. 25 seed Ons Jabeur

6-3, 6-1. Gauff now meets Barbora Krejcikova, a 6-2, 6-0 winner against Sloane Stephens, the 2017 U.S. Open champion and 2018 French Open runner-up.

Another quarterfinal will be Maria Sakkari against defending champion Iga Swiatek or Marta Kostyuk. Sakkari eliminated 2020 runner-up Sofia Kenin 6-1, 6-3.

Gauff, Krejcikova and Sakkari are three of the six women making Grand Slam quarterfinal debuts, the most at any major in the professional era.

On an afternoon that began with the sun shining, before clouds intervened, Djokovic's two-handed backhand, his best shot, was off. Way off.

By the second game of the third set, he already had accumulated two dozen unforced errors off that wing alone.

And while Djokovic is normally adept at tiebreakers — he made no errors at all in the three tiebreakers of his 2019 Wimbledon final win against Federer — Musetti was on-target and so good in that high-pressure, high-stakes environment. Musetti is now 10-0 in tour-level tiebreakers for his nascent career.

After that, though, Djokovic took over.

"I never thought I had it won. Absolutely not," Musetti said. "Against a champion like Djokovic, you truly only have a victory when he shakes your hand at the end."
