dioambientalista mr. Jeff Sybesma ta bisa awe na ocasion di Dia di Tera.

Sybesma a mustra riba ehempelnan na cantidad unda hende ta cabando cu locual mundo ta duna. Petroleo y gas ta ehempel. Pero tambe carni y

grano. Mescos cu aire y awa limpi, y e cantidad di sorto di pesca cu a bay den extincion. "A pesar di e conocemento aki nos ta sigui manera nada a pasa. Nos ta hinca nos cabes den santo."







## **NOTES TO THE ABBREVIATED CORPORATE FINANCIAL STATEMENTS FOR THE YEAR 2021**

### **I. General Information**

AIB BANK N.V. (the Bank) is a limited liability company and is incorporated on October 20, 1987 and domiciled in Aruba. The address of its registered office is as follows: Wilhelminastraat 36, Oranjestad, Aruba.

The objectives of the Bank are among others:

- to promote the execution of projects which, in the opinion of the Bank, are important to the economic development of Aruba;
- to provide medium- or long-term capital and other means of financing to individuals who are conducting a business and to corporations among others in the form of granting credits, providing loans, issue of guarantees and other forms of security, participation in equity and serving as intermediary in these matters;

The shares of the Bank are held by a variety of shareholders. None of the Shareholders has power to govern the financial and operating policies generally accompanying a shareholding of more than one half of the voting rights.

These abbreviated corporate financial statements, are derived from the audited corporate financial statements of the Bank which have been prepared in accordance with International Financial Reporting Standards (IFRS) and the relevant provisions of Book 2 of the Civil Code applicable for Aruba. The abbreviated corporate financial statements do not contain all the disclosures required by IFRS.

The corporate financial statements from which these abbreviated corporate financial statements were derived, have been approved for issue by the Board of Supervisory Directors on March 22, 2022.

### **Overall assessment of impact of COVID-19**

Since the outbreak of Coronavirus (COVID-19), Management has been periodically assessing its impact on the future results, cash flows and financial position of the Bank.

The Bank's lending clients that in 2020 and early 2021 (upon the outbreak) received a temporary moratorium with respect to their contractual obligation for interest and principal repayments, have resumed their payment obligations. As per December 31, 2021, there are two clients with Non-Performing loans. The Bank is actively trying to resolve these non-performing loans.

Management has assessed the Bank's future results, cash flows and financial position by estimating the impact of the Coronavirus by:

- Assessing various scenarios with respect to estimating the impact of increased probabilities of default, loss given defaults and decreases in estimated collateral values on the Bank's ECL allowance;
- Assessing various scenarios with respect to estimating the impact on the liquidity of the Bank.

Overall, based on its assessment of the impact of the Coronavirus for the year 2021 and beyond, and taking into account the uncertainties that exist as per the date of issuance of these financial statements, Management concludes that it does not consider the impact to cast significant doubt upon the Bank's ability to continue as a going concern.

### **2. Significant Accounting Policies**

#### **2.1. New or Revised Standards and Interpretations**

##### **2.1.1. New or revised Standards or Interpretations**

Standards and amendments that are effective for the first time in 2021 (for an entity with a 31 December 2021 year-end) and could be applicable to the Bank are:

- Interest Rate Benchmark Reform Phase 2 (Amendments to IFRS 9, IAS 39 and IFRS 7, IFRS 4 and IFRS 16)
- COVID-19 Rent Related Concessions beyond 30 June 2021 (Amendments to IFRS 16)

These amendments do not have a significant impact on this Financial Statements and therefore the disclosures have not been made.

##### **2.1.2. New Standards and Interpretations not yet Adopted**

At the date of authorization of these financial statements, several new, but not yet effective, Standards, amendments to existing Standards, and Interpretations have been published by the IASB. None of these Standards, Amendments or Interpretations have been adopted early by the Bank. Other Standards and amendments that are not yet effective and have not been adopted early by the Bank include:

- IFRS 17 Insurance Contracts;
- Amendments to IFRS 17 Insurance Contracts (Amendments to IFRS 17 and IFRS 4);
- References to the Conceptual Framework (Amendments to IFRS 3);
- Proceeds before Intended Use (Amendments to IAS 16);
- Onerous Contracts – Cost of Fulfilling a Contract (Amendments to IAS 37);
- Annual Improvements to IFRS Standards 2018-2020 Cycle (Amendments to IFRS 1, IFRS 9, IFRS 16, IAS 41);
- Classification of Liabilities as Current or Non-current (Amendments to IAS 1);
- Deferred Tax related to Assets and Liabilities Arising from a Single Transaction (Amendments to IAS 12).

Management anticipates that all relevant pronouncements will be adopted for the first period beginning on or after the effective date of the pronouncement. New Standards, Amendments and Interpretations not yet adopted have not been disclosed as they are not expected to have a material impact on the Bank's corporate financial statements.

### **2.2. Summary of Significant Accounting Policies**

The principal accounting policies applied in the preparation of these financial statements are set out below. These policies have been consistently applied to all years presented, unless otherwise stated.

#### **- Basis of Measurement**

The financial statements have been prepared under the historical cost convention except for the following:

- Financial Instruments at Fair Value through Profit or Loss (FVTPL) are measured at fair value;
- Financial Assets at FVOCI are measured at fair value through other comprehensive income.

#### *Fair value measurement of financial instruments*

Financial assets and financial liabilities measured at fair value in the statement of financial position are categorized in level 3 of fair value hierarchy: unobservable inputs for the asset or liability. The following unobservable inputs are used for Level 3 instruments valuation:

- Trade and other receivables – last recorded transaction;
- Trade and other payables – last recorded transaction

#### **- Presentation**

The assets and liabilities in the statement of financial position are presented based on liquidity.

#### **- Foreign Currency Transactions**

##### *Functional and Presentation Currency*

Items included in the financial statements of the Bank are measured using the currency of the primary economic environment in which the entity operates ("the functional currency"). The financial statements are presented in Aruban Florins, which is the Bank's functional and presentation currency.

##### *Transaction and Balances*

Transactions occurring in United States dollars (USD) are converted at the rate of US\$ 1 to Af. 1.79. Other foreign currency transactions are translated into the functional currency using the exchange rate prevailing at the dates of the transactions, or valuation where items are re-measured. Foreign exchange gains and losses resulting from the settlement of such transactions and from the translation at year-end exchange rate of monetary assets and liabilities denominated in foreign currencies are recognized in the statement of comprehensive income.

Changes in the fair value of monetary securities denominated in foreign currency classified as available for sale are analyzed between translation differences resulting from changes in the amortized cost of the security and other changes in the carrying amount of the security. Translation differences related to changes in the amortized cost are recognized in profit or loss, and other changes are recognized in other comprehensive income.

#### **- Financial Assets**

##### *Classification*

The Bank classifies its financial assets in the following categories: fair value through profit or loss (FVPL), fair value through other comprehensive income (FVOCI) or amortized cost (AC). The classification depends on:

- The Banks' assessment of the overall objective of the business model within which the financial assets are held; and
- The contractual cash flow characteristics of the financial assets.

##### *Business Model Assessment*

The business model reflects how the Bank manages its financial assets in order to generate cash flows, that is, whether the objective is to collect contractual cash flows, sell financial assets or both. The Bank assesses its business model at a portfolio level reflective of how groups of assets are managed together to achieve a particular business objective. Factors considered by the Bank in determining the business model for a group of assets include:

- How performance is evaluated and reported to key management personnel;
- The risks that affect performance and how they are managed;
- How managers are compensated; and
- The frequency and volume of sales in prior periods and expectations about future sales activity.

##### *Contractual Cash Flow Characteristics Assessment*

Where the business model is to hold financial assets to collect contractual cash flows or to collect contractual cash flows and sell, the Bank determines if they give rise to cash flows that are solely payments of principal and interest (SPPI) on the principal amount outstanding that is consistent with a basic lending arrangement. In this context, 'principal' is the fair value of the financial asset on initial recognition and 'interest' is consideration for the time value of money and credit risk associated with the principal amount outstanding during a particular period of time and for other basic lending risks and costs as well as profit margin.

If the Bank identifies any contractual cash flows, such that cash flows are no longer consistent with a basic lending arrangement, the related financial asset is classified and measured at FVPL. In making this assessment, the Bank considers:

- Contingent events;
- Leverage features;
- Prepayment and term extensions; and
- Terms that limit the Bank's recourse to specific financial assets and features that modify consideration of the time value of money.

#### **Recognition and Measurement**

Financial assets are initially recognized at fair value plus transaction costs for all financial assets not carried at fair value through profit or loss. Financial assets are recognized when the entity becomes a party to the contractual provisions of the instrument. Regular way purchases and sales of financial assets are recognized on trade date.

#### *Investment in Subsidiaries*

The Bank holds 100% of the shares in Capital Providers Group N.V. and Alicante Properties N.V., all domiciled in Aruba. The investments in subsidiaries are accounted for by applying the equity method, whereby the investment is initially recognized at cost and adjusted thereafter for the post-acquisition change in the Bank's share of the investee's net assets. The Bank's profit or loss includes its share of the investee's profit or loss and the Bank's other comprehensive income includes its share in the investee's other comprehensive income. Distributions received from an investee reduce the carrying amount of the investment. Investment in subsidiaries is outside the scope of IFRS 9.

#### *Debt Instruments Measured at Amortized Cost*

Debt instruments are measured at amortized cost if they are held within a business model whose objective is to hold for collection of contractual cash flows, and where those cash flows represent solely payments of principal and interest (SPPI). After initial measurement, debt instruments in this category are carried at amortized cost using the effective interest rate method. The amortized cost is the amount at which the financial asset or financial liability is measured at initial recognition amount minus the principal repayments, plus or minus the cumulative amortization using the Effective Interest Rate (EIR) method of any difference between the initial amount and the maturity amount and, for financial assets, adjusted for any loss allowance.

Purchases and sales of debt instruments at amortized cost are recognized at trade date – the date on which the Bank commits to purchase or sell the asset – and are measured at amortized cost when cash is advanced to the borrowers.

Debt instruments of the Bank comprise loans and investment securities that are sovereign bonds. After assessing its business model for loans and sovereign bonds, which are held to collect the contractual cash flows, and where the cash flows represent solely payments of principal and interest, these instruments were measured at amortized cost.

Interest income using the effective interest rate method is recognized in the Statement of Comprehensive Income through profit or loss. Impairment on debt instruments measured at amortized cost is calculated using the expected credit loss (ECL) approach. Loans and debt securities measured at amortized cost are presented net of allowance for credit losses in the Statement of Financial Position.

#### *Debt Instruments Measured at FVOCI*

Debt instruments are measured at FVOCI if they are held within a business model whose objective is to hold both for collection of contractual cash flows and for the sale of financial assets, where the financial assets' cash flows represent payments that are solely payments of principal and interest, and that are not designated FVPL. Subsequent to initial recognition, unrealized gains and losses on debt instruments measured at FVOCI are taken through other comprehensive income (OCI) in full, unless the instrument is designated in a fair value hedge relationship.

When the asset is derecognized, the cumulative gain or loss previously recognized in OCI is reclassified from equity to profit or loss and recognized in 'Net Investment Income'. Foreign exchange gains and losses that relate to the amortized cost of the debt instrument are recognized through profit or loss.

Impairment on debt instruments measured at FVOCI is calculated using the expected credit loss approach. The expected credit loss on debt instruments measured at FVOCI does not reduce the carrying amount of the asset in the Statement of Financial Position, which remains at its fair value. Instead, an amount equal to the allowance that would arise if the financial assets were measured at amortized cost is recognized in OCI with a corresponding amount taken to Credit Impairment Losses in the Statement of Comprehensive Income. The accumulated amount recognized in OCI is recycled through profit or loss upon derecognition of the debt instrument.

#### *Debt Instruments Measured at FVPL*

Financial assets that do not meet the criteria for amortized cost or FVOCI are measured at fair value through profit or loss.

#### *Financial Assets Mandatorily Measured at FVPL*

Financial assets meeting either of the conditions below are mandatorily measured at fair value through profit or loss (other than in respect of an equity investment designated as at fair value through other comprehensive income):

- Financial assets with contractual terms that do not give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding; and
- Financial assets held within a business model whose objective is achieved neither by collecting contractual cash flows nor by both collecting contractual cash flows and selling financial assets. This includes financial assets held within a portfolio that is managed and whose performance is evaluated on a fair value basis. It further includes portfolios of financial assets that are 'held for trading'.

#### *Financial Assets Designated as Measured at FVPL*

A financial asset may be designated at fair value through profit or loss only if doing so eliminates or significantly reduces measurement or recognition inconsistencies (an 'accounting mismatch') that would otherwise arise from measuring financial assets or liabilities or recognizing gains and losses on them on different basis. They are carried in the Statement of Financial Position at fair value, with all changes in fair value recorded in the Statement of Comprehensive Income.

#### *Equity Instruments*

Equity instruments are measured at FVPL, unless an election is made to designate them at FVOCI upon purchase. For equity instruments measured at FVPL, changes in fair value are recognized in the Statement of Comprehensive Income as part of net gain/loss from other financial instruments carried at fair value. Instruments elected to be classified as non-trading equity instruments at FVOCI are made upon initial recognition, on an instrument-by-instrument basis and once made, is irrevocable. Gains and losses on these instruments including when derecognized/sold are recorded in OCI and are not subsequently reclassified to profit or loss. Dividend received is recorded in the income statement.

#### **Reclassification**

The Bank reclassifies debt instruments when and only when its business model for managing those assets changes. The reclassification is applied prospectively from the reclassification date, which is the first day of the first reporting period following the change in business model that results in the reclassification. Any previously recognized gains, losses or interest are not restated.

#### **De-recognition**

Financial assets are derecognized when the contractual rights to receive the cash flows from the financial assets have expired, or when they have been transferred and either:

- The Bank transfers substantially all the risks and rewards of ownership; or
- The Bank neither transfers nor retains substantially all the risks and rewards of ownership and the Bank has not retained control.

#### - **Financial Liabilities**

##### **Classification, Recognition and Subsequent Measurement**

The Bank classifies its financial liabilities as being measured at amortized cost unless it has designated liabilities at fair value through profit or loss or is required to measure liabilities mandatorily at fair value through profit or loss. Financial liabilities are initially recognized at fair value, (normally the issued proceeds, that is, the fair value of consideration received) less, in the case of financial liabilities subsequently carried at amortized cost, transaction costs. For financial liabilities carried at amortized cost, any difference between the proceeds, net of transaction costs, and the redemption value is recognized in the Statement of Comprehensive Income through profit or loss using the effective interest method.

A financial liability may be designated as at fair value through profit or loss only when:

- It eliminates or significantly reduces a measurement or recognition inconsistency (an 'accounting mismatch') that would otherwise arise from measuring assets or liabilities or recognizing the gains and losses on them on different basis; or
- A group of financial assets, financial liabilities or both is managed and its performance is evaluated on a fair value basis in accordance with documented risk management or investment strategy; or
- A contract contains one or more embedded derivatives that significantly change the cash flows of the contract and the separation of the embedded derivative(s) is not prohibited.

The movement in own credit risk related to financial liabilities designated at fair value through profit or loss is recorded in other comprehensive income unless this would create or enlarge an accounting mismatch in profit or loss for the Bank (in which case all gains or losses are recognized through profit or loss).

#### **Derecognition**

Financial liabilities are derecognized when they are extinguished, for instance, when the obligation specified in the contract is discharged, cancelled or expires.

#### - **Impairment of Financial Assets**

##### **Scope**

The Bank recognizes impairment loss allowances for expected credit losses (ECL) for the following categories of financial instruments, unless measured at fair value through profit or loss:

- Financial assets that are debt instruments;
- Loan commitments;
- Financial guarantee contracts issued and not accounted for under IFRS 4 *Insurance Contracts*; and
- Receivables and contract assets recognized under IFRS 15 *Revenue from Contracts with Customers*.

##### **Expected Credit Loss (ECL) Model**

The determination of impairment losses and allowance moves from an incurred credit loss model whereby credit losses are recognized when a defined loss event occurs under IAS 39, to an expected credit loss model under IFRS 9, where credit losses are taken upon initial recognition of the financial asset, based on expectations of potential credit losses at the time of initial recognition. Under IFRS 9, the Bank first evaluates individually whether objective impairment exists for financial assets that are individually significant. It then collectively assesses financial assets that are not individually significant and loans which are significant but for which there is no objective evidence of impairment.

The Bank uses an ECL model developed to meet the requirements of IFRS 9. The allowance for credit losses calculations are outputs of models with a number of underlying assumptions regarding the choice of variable inputs and their interdependencies. This model measures credit loss allowances using a three-stage approach based on the extent of credit deterioration since origination.

New models and systems were developed to meet the requirements of IFRS 9. The Bank assesses on a forward-looking basis, the expected credit losses (ECL) associated with its debt instrument assets carried at amortized cost and FVOCI and with the exposure arising from loan commitments and financial guarantee contracts. The Bank recognizes a loss allowance for such losses at each reporting date. The measurement of ECL reflects:

- An unbiased and probability-weighted amount that is determined by evaluating a range of possible outcomes;
- The time value of money; and
- Reasonable and supportable information that is available without undue cost or effort at the reporting date about past events, current conditions and forecasts of future economic conditions.

##### **Presentation of Allowance for Credit Losses in the Statement of Financial Position**

- Financial assets measured at amortized cost: presented as a deduction from the gross carrying amount of the financial assets;
- Debt instruments measured at FVOCI: no allowance is recognized in the Statement of Financial Position because the carrying value of these assets is their fair value. However, the allowance determined is presented in the accumulated other comprehensive income; and
- Off-balance sheet credit risks including undrawn loan commitments and financial guarantees: presented as a provision within the liabilities section of the Statement of Financial Position.



#### **Write-offs**

When a debt instrument is uncollectible, it is written off against the related provision for credit loss impairment and reduces the gross carrying amount of the debt instrument. Such debt instruments are written off after all the necessary procedures have been completed and the amount of the loss has been determined.

If, in a subsequent period, the amount of the impairment loss decreases and the decrease can be related objectively to an event occurring after the impairment was recognized (such as improvement in the debtor's credit rating), the previously recognized impairment loss is reversed by adjusting the allowance account. The amount of the reversal is recognized in the Statement of Comprehensive Income through profit or loss.

#### **Modified Loans**

Loans are identified as renegotiated and classified as credit-impaired when the Bank modifies the contractual payment terms due to significant credit distress of the borrower. Renegotiated loans remain classified as credit-impaired until there is sufficient evidence to demonstrate a significant reduction in the risk of nonpayment of future cash flows and retain the designation of renegotiated until maturity or de-recognition. A loan that is renegotiated is derecognized if the existing agreement is cancelled and a new agreement is made on substantially different terms or if the terms of an existing agreement are modified such that the renegotiated loan is a substantially different financial instrument. Any new loans that arise following de-recognition events in these circumstances are considered to be purchased or originated credit-impaired financial assets (POCI) and will continue to be disclosed as renegotiated loans. Other than originated credit-impaired loans, all other modified loans could be transferred out of stage 3 if they no longer exhibit any evidence of being credit-impaired and, in the case of renegotiated loans, there is sufficient evidence to demonstrate a significant reduction in the risk of non-payment of future cash flows, over the minimum observation period, and there are no other indicators of impairment. These loans could be transferred to stage 1 or 2 by comparing the risk of a default occurring at the reporting date (based on the modified contractual terms) and the risk of a default occurring at initial recognition (based on the original, unmodified contractual terms). Any amount written off as a result of the modification of contractual terms would not be reversed.

#### **Modified Loans that are not Credit-Impaired**

Loan modifications that are not identified as renegotiated are considered to be restructured. Where a restructuring results in a modification such that the Bank's rights to the cash flows under the original contract have expired, the old loan is derecognized and the new loan is recognized at fair value. The rights to cash flows are generally considered to have expired if the restructure is at market rates and no payment-related concession has been provided.

#### **Non-Performing Loans**

The Bank's approach to classifying performing versus non-performing loans is through utilization of the internal credit risk grading process. With the transition to IFRS 9, all loans graded doubtful and loss are considered credit-impaired and require individual provisions or 'Stage 3' ECL.

#### **- Property and Equipment**

Property and equipment are stated at historical cost less depreciation. Historical cost includes expenditure that is directly attributable to the acquisition of the items. Subsequent costs are included in the asset's carrying amount or recognized as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Bank and the cost of the item can be measured reliably. The carrying amount of the replaced part is derecognized. All other repairs and maintenance are charged to the Statement of Comprehensive Income through profit or loss during the financial period in which they are incurred. Land is not depreciated. Depreciation on all other assets is calculated using the straight-line method to allocate their cost over the estimated useful lives as follows:

o Buildings	25 years
o Automobiles	5 years
o Office Furniture	5 years
o Premises Improvements	2-10 years
o Machines & equipment	3 years

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at each reporting date. Assets that are subject to amortization are reviewed for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount. The recoverable amount is the higher of the asset's fair value less costs to sell and value in use.

Gains and losses on disposals are determined by comparing proceeds with carrying amount. These are included in administrative expenses in the Statement of Comprehensive Income.

#### **- Leases**

Under IFRS 16 a lease is defined as 'a contract, or part of a contract, that conveys the right to use an asset (the underlying asset) for a period of time in exchange for consideration'.

#### **The Bank as a lessee**

For any new contracts entered into on or after 1 January 2019, the Bank considers whether a contract is, or contains a lease. A lease is defined as 'a contract, or part of a contract, that conveys the right to use an asset (the underlying asset) for a period of time in exchange for consideration'. To apply this definition the Bank assesses whether the contract meets three key evaluations which are whether:

- the contract contains an identified asset, which is either explicitly identified in the contract or implicitly specified by being identified at the time the asset is made available to the Bank;
- the Bank has the right to obtain substantially all of the economic benefits from use of the identified asset throughout the period of use, considering its rights within the defined scope of the contract;
- the Bank has the right to direct the use of the identified asset throughout the period of use. The Bank assesses whether it has the right to direct 'how and for what purpose' the asset is used throughout the period of use.

#### **Measurement and recognition of leases as a lessee**

At lease commencement date, the Bank recognises a right-of-use asset and a lease liability on Statement of Financial Position. The right-of-use asset is measured at cost, which is made up of the initial measurement of the lease liability, any initial direct costs incurred by the Bank, an estimate of any costs to dismantle and remove the asset at the end of the lease, and any lease payments made in advance of the lease commencement date (net of any incentives received).

The Bank amortizes the right-of-use assets on a straight-line basis from the lease commencement date to the earlier of the end of the useful life of the right-of-use asset or the end of the lease term. The Bank also assesses the right-of-use asset for impairment when such indicators exist.

At the commencement date, the Bank measures the lease liability at the present value of the lease payments unpaid at that date, discounted using the interest rate implicit in the lease if that rate is readily available or the Bank's incremental borrowing rate.

Lease payments included in the measurement of the lease liability are made up of fixed payments (including in substance fixed), variable payments based on an index or rate, amounts expected to be payable under a residual value guarantee and payments arising from options reasonably certain to be exercised.

Subsequent to initial measurement, the liability will be reduced for payments made and increased for interest. It is remeasured to reflect any reassessment or modification, or if there are changes in in-substance fixed payments.

When the lease liability is remeasured, the corresponding adjustment is reflected in the right-of-use asset, or profit and loss if the right-of-use asset is already reduced to zero.

The Bank has elected to account for short-term leases and leases of low-value assets using the practical expedients. Instead of recognizing a right-of-use asset and lease liability, the payments in relation to these are recognized as an expense in profit or loss on a straight-line basis over the lease term.

#### **The Bank as a lessor**

The Bank's accounting policy under IFRS 16 has not changed from the comparative period. As a lessor the Bank classifies its leases as either operating or finance leases. A lease is classified as a finance lease if it transfers substantially all the risks and rewards incidental to ownership of the underlying asset and classified as an operating lease if it does not.

The agreements of the Bank containing a lease are limited to low value assets. Hence the adoption of IFRS 16 has had no significant impact on the corporate financial statements of the Bank. The entity elected to apply the practical expedients in IFRS 16 for short-term leases and leases for which the underlying asset is of low value. Short-term leases with a term not exceeding 12 months (and no purchase option) as well as leases where the underlying asset is of low value are not recognized using the option under IFRS 16.5.

#### **- Impairment of Non-financial Assets**

Assets that have an indefinite useful life are not subject to amortization and are tested annually for impairment. Assets that are subject to depreciation or amortization are reviewed for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognized for the amount by which the asset's carrying amount exceeds its recoverable amount. The recoverable amount is the higher of an asset's fair value less costs to sell and value in use. For the purpose of assessing impairment, assets are grouped at the lowest levels for which they are separately identifiable cash flows (cash generating units). Non-financial assets that suffered impairment are reviewed for possible reversal of the impairment at each reporting date.

#### **- Trade and Other Receivables**

If collection is expected in one year or less trade and other receivables are classified as current assets. If not, they are presented as non-current assets. The Bank makes use of a simplified approach in accounting for Trade and Other Receivables and records the loss allowance as lifetime expected credit losses. These are the expected shortfalls in contractual cash flows, considering the potential for default at any point during the life of the financial instrument. In calculating, the Bank uses its historical experience, external indicators and forward-looking information to calculate the expected credit losses using a provision matrix.

The Bank assesses impairment of trade receivables on a collective basis as they possess shared credit risk characteristics, they have been grouped based on the days past due.

#### **- Cash and Cash Equivalents**

In the Statement of Cash Flow, Cash and Cash Equivalents comprises cash in hand, deposits held at call with banks, other short-term highly liquid investments with original maturities of three months or less which are subject to an insignificant risk of changes in value and bank overdrafts. In the Statement of Financial Position, bank overdrafts, if any, are shown within borrowings.

#### **- Share Capital**

Ordinary shares are classified as equity.

Incremental costs directly attributable to the issue of new ordinary shares or options are shown in equity as a deduction, net of tax, from the proceeds. Where any group company purchases the company's equity share capital (treasury shares), the consideration paid, including any directly attributable incremental costs (net of income taxes) is deducted from equity attributable to the Bank's equity holders until the shares are cancelled or reissued. Where such ordinary shares are subsequently reissued, any consideration received, net of any directly attributable incremental transaction costs and the related income tax effects, is included in equity attributable to the Bank's equity holders.

#### **- Regulatory Loan Loss Reserve**

Regulatory Loan loss Reserve is based on the applicable State Ordinance on the Supervision of the Credit System (AB 1998 no.16). The Regulatory Loan Loss Reserve is calculated in accordance with the Supervisory Directives as issued by the Central Bank of Aruba.

#### **- Trade and Other Liabilities**

Trade and Other Liabilities are recognized initially at fair value and subsequently measured at amortized cost using the effective interest rate method.

#### - Borrowing Costs

General and specific borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are added to the cost of those assets, until such time as the assets are substantially ready for their intended use or sale. Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalization. All other borrowing costs are recognized in the Statement of Comprehensive Income through profit or loss in the period in which they are incurred.

#### - Current and Deferred Income Tax

The tax expense for the period comprises current and deferred tax. Tax is recognized in the Statement of Comprehensive Income through profit or loss, except to the extent that it relates to items recognized in other comprehensive income or directly in equity. In this case, the tax is also recognized in other comprehensive income or directly in equity, respectively.

The current income tax charge is calculated on the basis of the tax laws enacted or substantively enacted at the reporting date in the country where the company and its subsidiaries operate and generate taxable income. Management periodically evaluates positions taken in tax returns with respect to situations in which applicable tax regulation is subject to interpretation. It establishes provisions where appropriate on the basis of amounts expected to be paid to the tax authorities.

Deferred income tax is recognized, using the liability method, on temporary differences arising between the tax bases of assets and liabilities and their carrying amounts in the financial statements. However, deferred tax liabilities are not recognized if they arise from the initial recognition of goodwill; deferred income tax is not accounted for if it arises from initial recognition of an asset or liability in a transaction other than a business combination that at the time of the transaction affects neither accounting nor taxable profit or loss. Deferred income tax is determined using tax rates (and laws) that have been enacted or substantively enacted by the reporting date and are expected to apply when the related deferred income tax asset is realized or the deferred income tax liability is settled.

Deferred income tax assets are recognized only to the extent that it is probable that future taxable profit will be available against which the temporary differences can be utilized.

Deferred income tax is provided on temporary differences arising on investments in subsidiaries and associates, except for deferred income tax liability where the timing of the reversal of the temporary difference is controlled by the Bank and it is probable that the temporary difference will not reverse in the foreseeable future.

Deferred income tax assets and liabilities are offset when there is a legally enforceable right to offset current tax assets against current tax liabilities and when the deferred income taxes assets and liabilities relate to income taxes levied by the same taxation authority on either the same taxable entity or different taxable entities where there is an intention to settle the balances on a net basis.

#### - Provisions

Provisions are recognized when the Bank has a present legal or constructive obligation as a result of past events; it is probable that an outflow of resources will be required to settle the obligation; and the amount has been reliably estimated. Provisions are not recognized for future operating losses. Where there are a number of similar obligations, the likelihood that an outflow will be required in settlement is determined by considering the class of obligations as a whole. A provision is recognized even if the likelihood of an outflow with respect to any one item included in the same class of obligations may be small.

In accordance with the State Ordinance Cessantia the Bank has a legal obligation to make severance payments at retirement date to employees who meet the criteria set in article 3 of the State Ordinance. The provision is recorded at the present value of the expected expenditures required to settle the obligation resulting from the State Ordinance Cessantia. Furthermore, in accordance with the Personnel Policies of the Bank, the Bank has a legal obligation to pay jubilee grants to its employees. The provision is recorded at the net present value based on the projected unit credit-method as required by IAS 19 Employee Benefits.

#### - Revenue Recognition

##### *The Effective Interest Rate (EIR) Method*

Under both IFRS 9 and IAS 39, interest income is recorded using the EIR method for all financial assets measured at amortized cost. Interest income on interest-bearing financial assets measured at FVOCI under IFRS 9 are also recorded using the EIR method. Interest expense is also calculated using the EIR method for all financial liabilities held at amortized cost.

The EIR is the rate that exactly discounts estimated future cash receipts through the expected life of the financial asset or liability or, when appropriate, a shorter period, to the gross carrying amount of the financial asset. The EIR is calculated by taking into account transaction costs and any discount or premium on acquisition of the financial asset, as well as fees and costs that are an integral part of the EIR.

When calculating the effective interest rate for financial instruments other than credit-impaired assets, the Bank estimates future cash flows considering all contractual terms of the financial instrument, but not expected credit losses.

For purchased or originated credit-impaired (POCI) financial assets – assets that are credit-impaired at initial recognition – the Bank calculates the credit-adjusted effective interest rate, which is calculated based on the amortized cost of the financial asset instead of the gross carrying amount and incorporates the impact of expected credit losses in estimated future cash flows.

If expectations of fixed rate financial assets' or liabilities' cash flows are revised for reasons other than credit risk, then changes to future contractual cash flows are discounted at the original EIR with a consequential adjustment to the carrying amount. The difference from the previous carrying amount is booked as a positive or negative adjustment to the carrying amount of the financial asset or liability in the Statement of Financial Position with a corresponding increase or decrease in interest income or expense calculated using the effective interest rate method.

##### *Interest income*

Interest income and expense are recognized in the Statement of Comprehensive Income through profit or loss using the effective interest rate method and disclosed separately to provide symmetrical and comparable information.

##### *Interest income and expense include:*

- Interest on financial assets and financial liabilities measured at amortized cost calculated using the effective interest rate method; and
- Interest on debt instruments measured at FVOCI calculated using the effective interest rate method.

The Bank calculates interest income on financial assets, other than those considered credit-impaired, by applying the EIR to the gross carrying amount of the financial asset. When a financial asset becomes credit impaired and is therefore regarded as 'Stage 3', the Bank calculates interest income by applying the EIR to the net amortized cost of the financial asset. If the financial assets cures and are no longer credit-impaired, the Bank reverts to calculating interest income on a gross basis.

##### *Fee and Commission Income*

Fee and Commission Income (not in scope of IFRS 9 but in scope of IFRS 15) arises mainly from loan commitments and administration, other financial service-related products (syndication) and fund management.

To determine whether to recognize revenue, the Bank follows a 5-step process:

1. Identifying the contract with a customer
2. Identifying the performance obligations
3. Determining the transaction price
4. Allocating the transaction price to the performance obligations
5. Recognizing revenue when/as performance obligation(s) are satisfied.

The Bank often enters into customer contracts to supply a bundle of products and services, for example financial advisory and fund management services. The contract is then assessed to determine whether it contains a single combined performance obligation or multiple performance obligations. If applicable the total transaction price is allocated amongst the various performance obligations based on their relative stand-alone selling prices. The transaction price for a contract excludes any amounts collected on behalf of third parties.

Revenue is recognized at a point in time, when (or as) the Bank satisfies performance obligations by transferring the promised services to its customers. The Bank has elected to apply the practical expedient not to adjust the transaction price for the existence of significant financing component when the period between the transfer of control of good or service and payment date is one year or less.

The Bank recognizes contract liabilities for consideration received in respect of unfulfilled performance obligations and reports these amounts as other liabilities in the statement of financial position. Similarly, if the Bank satisfies a performance obligation before it receives the consideration, the Bank recognizes either a contract asset or a receivable in its Statement of Financial Position, depending on whether something other than the passage of time is required before the consideration is due.

The Bank provides corporate finance, syndication and fund management services. Revenue from these services is recognized on a time basis as the services are provided or when performance obligations are satisfied. Customers are invoiced as work progresses and/or when performance obligations are satisfied. Any amounts remaining unbilled at the end of a reporting period are presented in the Statement of Financial Position as trade receivable as only the passage of time is required before payment of these amounts will be due.

#### - Employee Benefits


The Bank operates a defined contribution plan. The Bank pays contributions to a separately administered pension insurance fund. The Bank has no further payment obligations once the contributions have been paid. The contributions are charged to the Statement of Comprehensive Income through profit or loss in the year to which they relate and disclosed as pension costs.

#### - Dividend Distribution

Dividends that are declared and paid during the period are accounted for as an appropriation of Retained Earnings in the Statement of Changes in Equity. Dividends that are proposed and declared after the reporting date are not shown as a liability on the Statement of Financial Position but are disclosed as a note to the financial statements.





## Healing ozone hole, less smog, more eagles

**(AP) - With climate change, plastic pollution and a potential sixth mass extinction, humanity has made some incredible messes in the world.**

But when people, political factions and nations have pulled together, they have also cleaned up some of those human-caused environmental problems, including healing the ozone hole, clearing perpetually smoggy air and saving many species from the brink of extinction.

"We can be good at cleaning up our messes, it's whether or not we choose to be and what we prioritize," said Michigan State University environmental sustainability researcher Sheril Kirshenbaum.

For Earth Day, The Associated Press asked more than 25 environmental scientists and policy experts, including two former U.S. Environmental Protection Agency chiefs and the current director of the United Nations Environ-

ment Programme, to share their top stories about environmental problems that the world fixed.

"There are some amazing success stories," said Stanford University environmental scientist Rob Jackson. "It's easy for us to get tunnel vision with everything going wrong, and there is a lot that needs to change quickly. But it's wonderful to remind ourselves that other people in the past have succeeded and that society has succeeded too, both nationally here in the U.S. and also internationally."

Here are the four successes mentioned most often and a key aspect that so many ecological wins have in common.

Fixing ozone depletion was by far the top choice of scientists, officials and environmental policy experts.

"It was a moment where countries that usually compete with each other grasped the collective threat and de-


cided to implement a solution," former EPA chief Carol Browner said in an email.

Scientists in the 1970s had discovered that a certain class of chemicals, often used in aerosol sprays and refrigeration, was eating away the protective ozone layer in Earth's atmosphere that shields the planet from harmful ultraviolet radiation linked to skin cancer.

The ozone layer was thinning everywhere, creating a hole over Antarctica, which not only threatened increased skin cancer cases, but cataracts and widespread changes to ecosystems around the globe, said University of North Carolina atmospheric scientist Jason West.

"It's the first time we created a planet-killing problem and then we turned around and solved it," Stanford's Jackson said.

In 1987, the countries of the world signed the Montreal Protocol, a first of its kind



treaty that banned the ozone-munching chemicals. At this point every nation in the world has adopted the treaty, 99% of the ozone-depleting chemicals have been phased out, "saving 2 million people every year from skin cancer,"

United Nations Environment Programme Director Inger Andersen said in an email.

The ozone hole over Antarctica worsened for a couple decades, but over the last several years it has slowly started to heal in fits and spurts. The

United Nations Environment Programme projects that the ozone "will heal completely by the 2030s."

While activists point to the Montreal Protocol as a hope and example for the fight against climate change, it's not quite the same. In the case of the banned ozone-sapping chemicals the corporations that manufactured them also made their replacements. But with climate change "it's more of an existential threat to the oil and gas companies," Jackson said.

## Florida seeks 100% renewable electricity by 2050

**(AP) — Florida utilities would gradually increase their electricity to 100% renewable by 2050 under a proposed rule unveiled Thursday by the state's agriculture commissioner.**

The proposed rule is an outgrowth of a lengthy court battle involving dozens of young people who claim Florida is violating their constitutional rights by continuing to promote use of fossil fuels that drive climate change. Similar lawsuits have been filed in other states.

The rule announced by Agriculture Commissioner Nikki Fried, a Democratic candidate for governor this year,

came following pressure from young people represented by the nonprofit Our Children's Trust who filed a petition seeking the proposal. It's the first of this magnitude in Florida, which is particularly vulnerable to climate impacts such as coastal flooding, stronger hurricanes and excessive heat.

The rule is not final and could face several challenges, and even afterward, the state Department of Agriculture and Consumer Services would mainly be able to track compliance with it, not enforce it. Still, Fried said it is "a monumental first step" in curbing climate-altering greenhouse gases that flow

from utilities when they burn coal and natural gas.

"This is one of the most urgent issues of our time," Fried said at a news conference in Miami. "We can't afford to deny this reality and the urgency of what is happening to our state."

Under the proposal, utilities in Florida would first have to meet three interim goals for the energy they provide, 40% by 2030, 63% by 2035 and 82% by 2040. Ten years after that, in 2050, the rule envisions 100% renewable energy for utilities. Energy experts agree interim goals are important so that major changes are not put off even further into the future.

According to the federal Energy Information Administration, only about 5% of Florida's electricity in 2020 was produced by sources such as solar, compared with 75% by natural gas, which is mainly methane.

The rule petition was signed by more than 200 young people, including 22-year-old Delaney Reynolds. She said at the news conference Thursday that the rule

is a start at tackling one of the main sources of greenhouse gas emissions in power plants.

"Today, Florida can begin to address the core causes of climate change," Reynolds said. "We have no time to waste."

The state's largest electric utility, Florida Power & Light, and its parent NextEra Energy Inc., said in a statement that it is already investing heavily in solar energy with 50 centers in operation now and plans to quadruple the capacity by 2031. Indeed, Florida has been inching up the national rankings for installed solar.

"As Florida's renewable energy leader and the leader of the nation's largest solar expansion, we will continue to work with state leaders to smartly move Florida with even more cost-effective renewable energy," the FPL statement said.

Another large utility, Duke Energy, said in an email it is still reviewing the proposed rule but noted it plans to have no coal-fired power plants by 2035. And, the company said, it is on pace to reach zero car-

bon emissions from electric generation by 2050.

The Florida Department of Agriculture and Consumer Services headed by Fried also houses the state energy office. The agency will take public comment on the proposed rule for 21 days; there is also the possibility of a hearing and potentially a challenge through an administrative law judge.

Even if the rule goes into effect, the agency has no mechanism to enforce it. But it can collect annual data on whether utilities are making progress. It would be up to the Florida Public Service Commission to take any regulatory actions related to the rule.

Valholly Frank, a 19-year-old member of the Seminole Tribe of Florida, said their traditional home in the Big Cypress Reservation adjacent to the Everglades faces extreme threats from climate change.

"Our culture really depends on this land," Frank said. "Florida cannot exist the way it is now. We cannot continue this way."



## UK lawmakers OK probe into PM Boris Johnson's alleged lies



**(AP) — British lawmakers on Thursday ordered a parliamentary investigation into Prime Minister Boris Johnson for allegedly lying about whether he broke coronavirus restrictions by attending illegal gatherings during the pandemic.**

The move, approved by cries of "aye" and without a formal vote in the House of Commons, means Parliament's Committee of Privileges will investigate whether Johnson knowingly misled Parliament — historically a resigning offense if proven.

The probe piles more pres-

sure on a Conservative prime minister whose grip on power has been shaken by claims he flouted the pandemic rules he imposed on the country, then repeatedly failed to own up to it.

The move was instigated by the opposition Labour Party and passed after the government abandoned efforts to get Conservative lawmakers to block it. Johnson's Conservatives have a substantial majority in Parliament, but many lawmakers are uneasy with the prime minister's behavior.

Labour leader Keir Starmer said the move sought to up-

hold "the simple principle that honesty, integrity and telling the truth matter in our politics."

"It is a British principle ... guiding members from every political party in this House," Starmer said. "But it is a principle under attack."

Johnson was not present for the decision on a scandal that has rocked his leadership of the country and the Conservative Party. He was more than 4,000 miles (6,400 kilometers) away in India, insisting he wanted to "get on with the job" of leading the country.

Johnson was fined 50 pounds (\$66) by police last week for attending his own birthday party in his office in June 2020, when people in Britain were barred from meeting up with friends and family, or even visiting dying relatives. Johnson is the first British prime minister ever found to have broken the law while in office.

He has apologized, but denied he knowingly broke the rules. Johnson's shifting de-

fense — initially saying there were no illegal gatherings, then claiming it "did not occur to me" that the birthday event was a party — has drawn derision and outrage from opponents, who have called for him to quit.

"The truth is simple and it's this — he lied to avoid getting caught, and once he got caught, he lied again," Scottish National Party lawmaker Ian Blackford said in the House of Commons.

Usually lawmakers are forbidden from accusing one another of lying, but Blackford was not reprimanded by the Speaker.

A growing number of Conservatives are uncomfortable about defending a leader who broke rules he imposed on the country. A few have called openly for Johnson to go, and the number is rising. Others are waiting to see whether public anger translates into Conservative losses at local elections on May 5.

"It is utterly depressing to be asked to defend the indefensible," said Conservative leg-

islator William Wragg. "Each time part of us withers."

Lawmaker Steve Baker, until now a prominent supporter, said that Johnson "should be long gone" for violating the "letter and spirit" of the rules.

"I'll certainly vote for this motion," he said. "But really, the prime minister should just know the gig's up."

The Committee of Privileges probe will not start until twin police and civil-service investigations into "partygate" have concluded.

Senior civil servant Sue Gray is investigating 16 events, including "bring your own booze" office parties and "wine time Fridays" in Johnson's 10 Downing St. office and other government buildings. Police are probing a dozen of the events and so far have handed out at least 50 fines, including ones to Johnson, his wife Carrie and Treasury chief Rishi Sunak. Johnson is believed to have attended about six of the gatherings and could face more police fines.

## More Cubans immigrating to the US by crossing from Mexico

**(AP) — For years after leaving Cuba, the mother of two tried to get her children and parents into the U.S. through legal channels.**

Finally, she decided she wouldn't wait any longer: She paid more than \$40,000 dollars to someone to help them sneak in through Mexico.

"I said to myself, 'Enough. I am going to risk everything,'" said the 30-year-old woman, who spoke to The Associated Press on condition of anonymity for fear of reprisals from U.S. authorities.

Her family's story is an example of what tens of thousands of Cuban immigrants looking to escape political and economic troubles are going through as more risk their lives and arrive illegally in the United States. It's a very different reality from years ago, when Cubans enjoyed special protections that other immigrants did not have.

Her children and parents

undertook a 20-day journey, starting with a plane ride from Havana to Managua, Nicaragua. From there, they took buses, vans and taxis across Honduras, Guatemala and Mexico, until they arrived at the U.S.-Mexico border.

"I saw that other people were coming through the border and they were happy, and I, who had done things legally, was still waiting for my children," the woman said.

U.S. border authorities encountered Cubans almost 32,400 times in March, according to figures released Monday. That was roughly double the number in February and five times the number in October.

The increase coincided with Nicaragua's decision starting in November to stop requiring visas for Cubans to promote tourism after other countries, such as Panama and the Dominican Republic, began mandating them.

After flying to Nicaragua,

Cubans travel by land to remote stretches of the U.S. border with Mexico — mainly in Yuma, Arizona, and Del Rio, Texas — and generally turn themselves in to Border Patrol agents.

The Biden administration has been leaning on other governments to do more to stop migrants from reaching the U.S., most recently during a visit this week to Panama by Secretary of State Antony Blinken and Homeland Security Alejandro Mayorkas. The actions of Nicaragua, a U.S. adversary, complicates that effort.

Cuban and U.S. officials will meet Thursday in Washington for immigration talks — the first in four years.

U.S. Customs and Border Protection stopped Cubans more than 79,800 times from October through March — more than double all of 2021 and five times more than all of 2020. Overall, the Border Patrol stopped migrants of all nationalities more than 209,000 times in March, the

highest monthly mark in 22 years.

Cubans who cross the U.S. border illegally face little risk of being deported or expelled under a public health law that has been used to deny asylum to thousands of migrants of other nationalities on the grounds of slowing the spread of COVID-19.

Barely 500 Cubans stopped in March, or about 2%, were subject to Title 42 authority, named after a public health law. The Biden administration plans to end Title 42 au-

thority on May 23.

Jorge Duany, director of the Cuban Research Institute at Florida International University, and other experts estimate the number of Cubans leaving could exceed other mass migrations from the island, including the Mariel boatlift of 1980, when more than 124,700 Cubans came to the U.S.

"There are several intertwined factors that have produced a perfect storm for the intensification of the Cuban exodus," Duany said.



## Lewis Hamilton, Serena Williams part of bid to buy Chelsea

**(AP) — The crowded field to buy Chelsea now features 23-time Grand Slam winner Serena Williams and seven-time Formula One champion Lewis Hamilton.**

A long-standing fan of Arsenal, Hamilton has seized the opportunity to invest in its London rival as three bidders try to buy the Premier League club from sanctioned Russian owner Roman Abramovich.

Williams and Hamilton are part of a consortium that features proposed investment from Josh Harris and David Blitzer, the owners of the NBA's Philadelphia 76ers who would have to sell their stakes in Premier League club Crystal Palace to buy Chelsea.

The reigning world and European champions could be sold for 3 billion pounds (\$4 billion) — a record in world sports — given the interest in the west London club.

Representatives for Hamilton said he planned to invest more than 10 million pounds (\$13 million) in the bid being fronted by former Liverpool and British Airways chairman Martin Broughton and World Athletics presi-

dent Sebastian Coe. Another bid has seen Boston Celtics co-owner Steve Pagliuca partner with Larry Tanenbaum, who has ownership stakes in Toronto with the NBA's Raptors, the NHL's Maple Leafs and the city's MLS team. Peter Guber, a part-owner of the Los Angeles Dodgers, is also backing in the group.

Another part-owner of the Dodgers, Todd Boehly, is leading another consortium hoping to be announced as the preferred bidder.

A New York-based merchant bank, the Raine Group, has been overseeing the sale process that was announced last month by Abramovich following Russia's invasion of Ukraine. The oligarch has been sanctioned by Britain and the European Union over his links to Russian President Vladimir Putin with assets frozen, including Chelsea.

Abramovich has been disqualified from running Chelsea by the Premier League and he cannot profit from the proceeds of the sale, which the British government must approve under terms of a license that allows the team to continue operating.



## Wright resigns as Villanova coach, Neptune takes over

**(AP) — Jay Wright shocked college basketball Wednesday night with his immediate resignation at Villanova, the Big East program he led to two national championships and four Final Fours in a Hall of Fame career.**

The 60-year-old Wright guided Villanova to titles in 2016 and 2018 and just led the Wildcats to the Final Four, where they lost to national champion Kansas. He went 520-197 in 21 seasons at the school and 642-282 overall, also coaching Hofstra from 1994-2001.

"It's time for us to enter a new

era of Villanova basketball," Wright said in a statement. "After 35 years in coaching, I am proud and excited to hand over the reins to Villanova's next coach. I am excited to remain a part of Villanova and look forward to working with (Villanova) and the rest of the leadership team."

Kyle Neptune, who served on the Villanova coaching staff before accepting the head coaching position at Fordham in 2021, returned to replace Wright.

"When looking for a successor, we wanted a candidate who could navigate the changing landscape of colle-

giate athletics and keep Villanova in a position of strength — now and in the future," Villanova athletic director Mark Jackson said. "After meeting with several exceptional candidates, we found all those attributes and more in Kyle Neptune. Kyle quickly stood out for his basketball knowledge, recruiting savvy and natural ability to connect with student-athletes and coaches."

Wright's decision was unexpected and there was no immediate word the move was health related or that he was leaving for the NBA. He was inducted into the Naismith Basketball Hall of Fame in 2021.

Wright will remain at Villanova and stay involved in fundraising, advising, education and more.

He joined North Carolina's Roy Williams and Duke's Mike Krzyzewski as the third coach with multiple championship to step down over the last two years.

Before he arrived, Villanova was known for upsetting Georgetown in the 1985 national championship game and the occasional trip to the

NCAA Tournament.

Wright needed three years to build a foundation before Villanova broke through with a trip to the 2005 Sweet 16. An Elite Eight appearance followed the next year and the Wildcats reached the Final Four in 2009.

Villanova won its first national title under Wright in 2016 on Kris Jenkins' buzzer-beater and decimated the NCAA Tournament field in

2018, winning every game by double digits on its way to the national title.

He was selected AP coach of the decade in 2020.

The 37-year-old Neptune was on Wright's staff for the 2009 Final Four team, then later spent three seasons as an assistant at Niagara before he returned to the Wildcats in 2013. He went 16-16 in his lone season at Fordham.
