

Boston Red Sox outfielder Carl Crawford is going to see Dr. James Andrews to have the soreness in his left elbow checked out, a source told ESPN The Magazine senior baseball writer Buster Olney.

Crawford is out indefinitely and not close to

returning to action, the source said.

CSNNE.com initially reported that Crawford was consulting with Andrews.

Tuesday, Red Sox manager Bobby Valentine said Crawford would seek a second opinion on the elbow.

Crawford, who also had offseason wrist surgery, has taken some at-bats but has not played the field in extended spring training games. No timetable has been set for when he can resume throwing.

Crawford had returned to Florida on Tuesday night, where he has been rehabbing, Valentine said, after being examined in Boston earlier in the day.

Valentine said he had no other information on the condition of Crawford's elbow other than it was "sore." He added that the elbow remains a cause for concern.

"Until a guy is 100 percent, you always have concern," Valentine said.

At the start of spring training, before the elbow issue had surfaced, the most conservative estimates for when Crawford would be playing for the Red Sox was May 1.

The Red Sox outfield could use some reinforcement with center fielder Jacoby Ellsbury expected to miss six to eight weeks with a shoulder injury.

Crawford signed a seven-year, \$142 million contract with the Red Sox before the 2011 season and had one of the worst years of his career, hitting .255 with 11 home runs and 18 stolen bases.



Metta World Peace suspended for 7

EL SEGUNDO, Calif. -- The NBA responded to Metta World Peace's latest act of aggression with a seven-game suspension that will lighten the Los Angeles Lakers troublemaker's wallet and playoff schedule.

World Peace was suspended on Tuesday for throwing a vicious elbow at Oklahoma City's James Harden, keeping the Lakers' starting small forward sidelined for most of the first postseason round.

World Peace was ejected from Sunday's game against the Thunder for striking Harden in the head with the back of his elbow, giving Oklahoma City's top reserve a concussion. The former Ron Artest claimed the blow was an accidental, overzealous celebration of a dunk, yet even Kobe Bryant and his Lakers teammates weren't defending his inexplicable actions.

"It's hard to get into a guy's head and know exactly what happened in that situation," Bryant said. "I haven't really spoken to him about it. You've really got to ask him."

World Peace will miss the Lakers' season finale on Thursday at Sacramento and the Lakers' next six games. The playoffs open Saturday, and Los Angeles is likely to be the Western Conference's third seed -- and Oklahoma City is locked into the No. 2 seed, meaning the clubs could meet right after World Peace's suspension ends in the second round.

He will lose nearly \$348,000 in salary if he serves the entire suspension this year. If the Lakers exit the playoffs swiftly, the remainder of the suspension must be served next season.

World Peace still hasn't answered media questions about his actions, but he issued a brief statement on his website, promising to follow up with a podcast.

"I apologize to the Oklahoma City Thunder fans and the OKC organization," World Peace wrote on ronartest.com. "I look foward (sic) to getting back on the floor with my teammates and competing for the Lakers' fans."

Commissioner David Stern alluded to World Peace's lengthy history of on-court altercations and strange behavior in announcing the penalty in a statement. Although Harden appears to be recovering well, he hasn't been cleared to return to the Thunder.

"The concussion suffered by James Harden demonstrates the danger posed by violent acts of this kind, particularly when they are

directed at the head area," Stern said in a statement. "We remain committed to taking necessary measures to protect the safety of NBA players, including the imposition of appropriate penalties for players with a history of on-court altercations."

Lakers general manager Mitch Kupchak said the team accepted the latest suspension for World Peace, who has two years left on his contract with Los Angeles.

"His most recent lapse in judgment is not to be condoned or accepted," Kupchak said after praising World Peace as largely a model citizen with the Lakers.

"His actions could have seriously injured another player, and his absence during this suspension will hurt our team as well," Kupchak added. "While we accept the league's decision, we will be supportive of Metta and try to help him be more professional on the court."

The suspension is the third career ban of at least seven games for World Peace, whose rap sheet might not fit on a basketball card at this point.

He got an 86-game suspension in 2004 -- the longest ban for an on-court incident in NBA history -- for jumping into the stands at the Palace of Auburn Hills in the Detroit suburbs to fight fans, and he served a seven-game suspension in 2007 for his no-contest plea on a domestic violence charge.

Even before his odd decision to change his name to promote peace last year, he had largely rehabilitated his image during three seasons with the Lakers, winning the NBA's top citizenship award last spring for his charity work in mental-health awareness. Yet World Peace also slammed his forearm into the face of Dallas guard J.J. Barea in the closing minutes of a home playoff loss to the Mavericks last season, earning a one-game postseason suspension.

World Peace leveled Harden moments after dunking over Serge Ibaka and Kevin Durant in the second quarter of the Lakers' double-overtime victory over the Thunder. While pounding his chest with his right arm, World Peace cocked his elbow


and threw it at the back and side of Harden's head.

He claimed the elbow was completely accidental in a brief postgame statement, but later acknowledged on Twitter that the blow "looks bad."

World Peace didn't speak to the media after the Lakers' practice Tuesday, heading to the locker room at the moment media members entered the gym at the Lakers' training complex. But Bryant acknowledged the obvious problem for the Lakers, who lose a starter and their defensive stopper right before the postseason.

"It's an unfortunate situation," Bryant said. "James, from what I hear, is OK. As far as Metta goes, he has to focus on himself, and however many games they give him, they give him.

He just has to be prepared, and when he comes back, just step right in and be ready to go."



Jose Reyes: No offer from Mets

On his first trip to Citi Field in enemy colors, Jose Reyes said the New York Mets did not make any attempt to re-sign him in the offseason, and that their inaction left him to confront a simple conclusion.

"If they don't make me any offer," the Miami Marlins shortstop said, "that means they don't want me to play here. That's why I play for another team now."

Wearing a black muscle shirt and orange wristbands as he sat in the visitors dugout on Tuesday, hours before the Mets played a video tribute to his nine seasons in New York, Reyes repeatedly told a large circle of reporters that he no longer fretted over his former team's decision to sit out his free-agent courtship.

Reyes maintained throughout the 2011 season that he wanted to remain a Met, even after he rejected general manager Sandy Alderson's attempt to open contract negotiations last June. When asked if he would've stayed with the team that signed him as

a teenager in the event it had matched Miami's six-year, \$106-million offer, Reyes said: "That's in the past. If I say yes, if I say no, that's not going to change anything. ... I can't say if I was going to stay here or not because they didn't offer anything."

The Mets' decision to let Reyes go was inspired, in part, by the Bernie Madoff scandal and the possibility that the owning Wilpons could lose hundreds of millions of dollars at trial. With that case now settled, and with Mets owners expected to take a relatively negligible financial hit, Reyes was asked if the Mets might've signed him under the existing circumstances.

"It's too late to think about that," he said. "I know they had a kind of problem there. I feel bad and feel sorry for them, but this is a business. I mean, they don't offer anything. That's in the past. I can't think about that anymore. I have a lot of respect for the organization and wish all of the people there the best."



Jeremy Lin gets some work in

GREENBURGH, N.Y. -- For the first time publicly since his injury, Jeremy Lin was seen doing some light jogging and slow-paced basketball moves during New York Knicks practice Wednesday morning.

Lin is in his fourth week of recovery after undergoing surgery to repair a small chronic meniscal tear in his left knee on April 2.

Working with one of the team's trainers and wearing a brace on his left knee, Lin gingerly moved side to side receiving passes on the left and right corners of the foul line and shooting jump-shots. Occasionally,

when he got the ball, he would execute a few different dribbling patterns

- - some crossovers, some behind-the-backs -- leading into a jump-shot. Afterward, he took some free throws and then did slight knee-ups from one end of the court to the other.


Overall, Lin's basketball moves looked sharp, but he moved very methodically and was hardly getting off the ground. At one point, he almost tripped over himself moving side-to-side, which caused him to be even more cautious.

"He's starting to smell the gym a little bit more now, which is great," Knicks coach Mike Woodson said. "I asked him yesterday how he felt after getting out running a little bit, and he said he felt pretty good. But we've got to put him through drills where he's cutting and

things of that nature just to make sure that the knee doesn't swell up and he's not physically sore. I mean, there's going to be some soreness, but we've got to make sure that when he steps back out on the floor, he's able to play basketball."

Woodson hinted that the best-case scenario is Lin returning for the conference semifinals, which has been the likely timetable since his operation. The recovery was considered six weeks.

"I'd like to think if we're able to get out of this first round, he should be ready for the second round, I would think," Woodson said. "But that's not for me to determine. He's got to come to us, along with the doctors, and say that the knee feels fine and he's confident that he can cut and do things that he once did. Then, we'll put him back in uniform."



Yu Darvish blanks Yanks for 8-plus as 10-K night keys Rangers

ARLINGTON, Texas -- Yu Darvish is getting better each time out for the Texas Rangers.

The Japanese standout may already be getting to a point when he will have a hard time topping himself, after striking out 10 and pitching into the ninth inning of a 2-0 victory over the New York Yankees on Tuesday night.

"After my last start, I mentioned my command is starting to come together. Stuff-wise, there wasn't much difference," Darvish said through his interpreter. "I still like to think that there's still more in me."

Ian Kinsler put the Rangers ahead to stay when he led off the first with a deep homer to left-center off Hiroki Kuroda (1-3), who limited Texas to two runs and five hits over 6 2/3 innings.

In only his fourth major league start, and the seventh MLB matchup of Japanese starters, Darvish (3-0) worked out of some early jams and got through 8 1/3 scoreless innings even while allowing seven hits.

Effective with his large array of pitches, including a fastball in the upper 90s and several biting breaking balls, the 25-year-old right-hander had a season-low two walks, and the 10 strikeouts were the most by a Texas pitcher this season. "He just keeps getting better every time he takes the ball. Tonight, he used everything he had, and he was effective, very effective. He's getting more and more comfortable," manager Ron Washington said. "He was pounding the strike zone. That's what you have to do against that team. He threw everything but the kitchen sink at them."

Washington was going to give him a chance to finish the game but pulled Darvish after Nick Swisher's one-out single on his 119th pitch, his 82nd strike.

Joe Nathan needed only one pitch to coax a game-ending double-play grounder by Raul Ibanez. It was his fifth save in six chances, closing out the Rangers' first shutout victory over the Yankees since Aug. 16, 2000.

The 37-year-old Kuroda, a righty in his fifth season in the majors, struck out five and walked one. Of the Rangers' other 15 outs against him, 12 came on grounders and there were two popups.

But he was still outpitched by Darvish, who had the longest scoreless outing by a Rangers pitcher against New York since Bob Tewksbury's complete game shutout in July 1995.

"You hear a lot of guys get hyped and he was everything that you'd heard," Yankees first baseman Mark Teixeira said. "We had a gameplan to make him throw strikes, and he definitely did that. If you tried to be patient you're down 0-1, 0-2. If you tried to be aggressive every pitch seemed like it started in the zone, then moved out of the zone."

The Yankees had the bases loaded with no outs in the third after Derek Jeter reached on a bunt single. Darvish initially failed to field the ball, apparently expecting someone else to get it.

But Darvish then got Curtis Granderson out on a called third strike before Alex Rodriguez grounded into an inning-ending double play.

"He had a full head of steam after that," Rangers designated hitter Michael Young said. "He started letting his fastball go late in the game, but he didn't sacrifice command for stuff. He was still locating well even though he started throwing harder."

Another sellout crowd at Rangers Ballpark broke into cheers of



"Yuuuuuuu!" that are already becoming quite routine after Granderson struck out, and again when third baseman Adrian Beltre fielded A-Rod's grounder near the bag, stepped on it and threw across the diamond.

Darvish walked off the mound clapping his hand on his glove while watching the replay on the huge video board.

"In that situation I thought to myself, this inning giving up one run or two runs, that was OK," he said. "Somehow I have to get Curtis Granderson out. ... Somehow, I just wanted (Rodriguez) to hit the ball on the ground."

After Robinson Cano hit a leadoff double in the fourth, Darvish needed only seven pitches

to get out of that inning. Teixeira and Swisher both struck out swinging on three pitches before Ibanez grounded out on the first pitch he saw.

Darvish struck out the side in the seventh, getting Jeter on a called strike for the third out.

"He's good. You have to give credit to the way he pitched," Cano said. "He didn't miss any pitch over the plate."

The last matchup of Japanese-born starters was July 22, 2010, when Kuroda threw eight scoreless innings for the Los Angeles Dodgers in a 2-0 win over the Mets and Hisanori Takahashi.

Darvish made his major league debut two weeks ago at Rangers Ballpark, allowing five runs in the first two innings but getting the win in an 11-5 victory over Seattle. Since those first two innings, he has allowed only two earned runs over 24 innings.

"My first outing, I got a standing ovation, but obviously wasn't really satisfied with the way I pitched," Darvish said. "Tonight, I was very appreciative."

Larry Brown talks Bobcats time

It was only a few years ago that Larry Brown had the Bobcats in the playoffs, but Charlotte is poised to become the worst team in league history and the coach had some thoughts Wednesday on what went wrong during his tenure there.

Brown said on "The Dan Patrick Show" that he experienced communication problems with team owner Michael Jordan and then was devastated when he was fired.

"It's one thing for me to get fired, but I have four or five assistants and they're out there not able to work," said the 71-year-old Brown, who was named SMU coach this week. "And it was the worst. And when your hero fires you... I just couldn't believe it. You know I love the guy, think he's brilliant, but he's around people who don't have a clue. And they won't challenge him. And the more you challenge

him, the more you get from him."

"I was sick about it. I haven't spoken to him since. I don't like seeing what's going on."

In 2009-10, Brown guided the Bobcats to a 44-38 record and their only playoff appearance. After a slow start the next season, Jordan replaced Brown with Paul Silas. That team finished 34-48.

"I'm sick about it because we made the playoffs the first time

they ever made the playoffs. We got rid of Raymond Felton without getting anything back -- one of the greatest kids I ever coached in my life. We got rid of Tyson Chandler who only played 50 games or so for us." Jordan has been blasted for some of his personnel moves over the years, infamously drafting high schooler Kwame Brown No. 1 when he was in the Washington Wizards' front office.
