## Floyd Mayweather won't risk health

LAS VEGAS -- Floyd Mayweather Jr. delivered quite a performance Tuesday and it had nothing to do with his boxing skills.

A question sparked a 10-minute speech from Mayweather, regarding the tireless topic of why he and fellow pound-for-pound great Manny Pacquiao have not come to terms on a potential multimillion dollar fight. In a response that eventually drew applause from his entourage, Mayweather once again said it is "basic common sense" that Pacquiao has used performance-enhancing drugs and getting in the ring with him would be a risk to his future health.

"Health is more important than anything," Mayweather said. "Because guess what? When my career is over, if I'm hurt because of something that has happened in a fight, I can't come to you and say, 'I need (money).'"

Mayweather's hardest point came when he admitted that he believes the

boxing world doesn't even care if Pacquiao is using or not -- that the desire to see the two fight now surpasses any concern over his safety.

"People say, 'We don't give a f--- if he's taking or not; we just want to see the fight. We don't give a f--- about your health and we don't give a f--- about your family.'" Mayweather said.

"I care about my family. I love my family. They're going to be there when no one else is there. When my career is over, you're all going to move on to the next one." He went on to accuse Top Rank promoter Bob Arum, who represents Pacquiao, and Don King of not caring about fighters' well being and re-emphasized he won't forfeit health for money. A fight against Pacquiao would be expected to be the highest grossing bout in boxing history.

"Don King and Bob Arum don't see out the eyes of a fighter because they're not a fighter," Mayweather said. "All they care about is

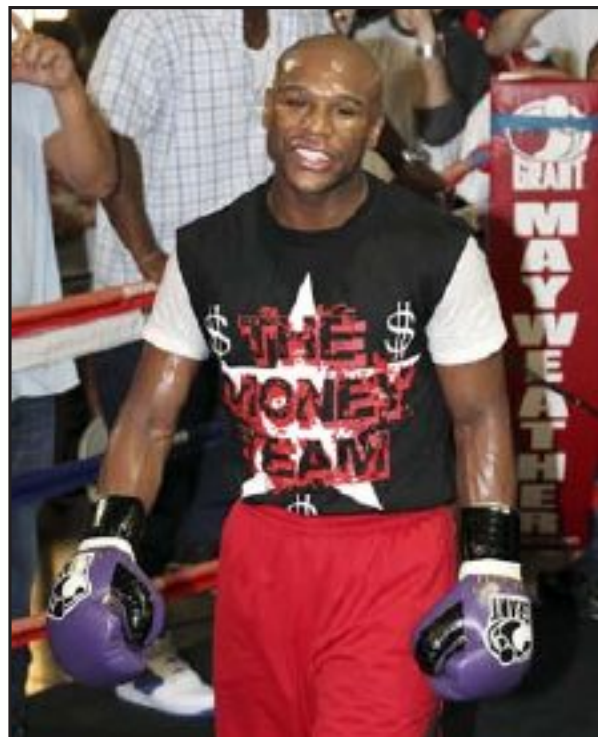
some f----- money. I care about a fighter's well being because I am a fighter.

"I know how it is to have a broken rib the rest of your life. I know how it is to piss blood. You all don't know nothing about this."

Mayweather has pointed to Pacquiao's rise through weight classes and the transfer of his power through them as evidence of steroid use. Since 2008, Pacquiao has won titles in five weight divisions and recorded four knockouts in nine fights.

"It took me years to get to here -- years," Mayweather said. "I'm going up in weight but I'm not walking through no damn fighters. (Pacquiao) is 106; now he decides to walk through (Miguel) Cotto? Cotto can't knock down (Shane) Mosley, but can he?"

Mayweather began his professional career at 130 pounds in 1996. He's fought the majority of his career as a welterweight. Saturday's fight against Cotto will be contested at



154 pounds.

In December 2009, a deal between the two nearly came to terms but ultimately fell through when Pacquiao refused to submit to random blood testing.

The Filipino and Arum, who represented Mayweather earlier in his career, since have softened their stance on that re-

quest. Mayweather scoffed at Arum's comments Tuesday, referring to him as a "professional liar."

"This is how the world is, you get writers saying, 'Floyd is scared,'" he said. "No, Floyd cares about his family. Floyd is smart.

"You all know for a fact I'm not scared. You all know that."

## Josh Hamilton, Adrian Beltre out

Texas Rangers third baseman Adrian Beltre and outfielder Josh Hamilton are not in Wednesday's lineup for their game against the Toronto Blue Jays.

It's the third straight game that Hamilton has missed as he nurses a stiff back, and it's the second straight for Beltre, who

has dealt with hamstring issues this season.

Manager Ron Washington said on ESPN Dallas 103.3 FM's "Ben & Skin Show" that the turf at Rogers Centre in Toronto is part of the reason for holding out both players, who he said are day to day.

"Beltre can pinch hit, but I'm trying to keep him

off this turf," Washington said. "Hopefully, his body can settle down by the time we get to Cleveland and he can play Friday. But this turf just beat him up so bad that he's so sore. But I do have him to pinch hit for me."

Washington also has made it a habit of resting some regulars on day

games before off-days to give them additional time off their feet. He said his club isn't used to playing on turf, which is why he takes a cautious approach if players are dealing with some injuries.

"When you play on turf, it's a little different if you're playing on it every day and coming up in here for

a series and you haven't been used to it. It shocks your body," he said. "Everybody's dealing with soreness the past three days, but we're not using that as an excuse to not win a ballgame."

Washington also said that catcher Mike Napoli's eye is fine and that he's ready to play.



# Andy Pettitte unsure of talk?

WASHINGTON -- Pitcher Andy Pettitte acknowledged under cross-examination Wednesday that he might have misunderstood Roger Clemens when Pettitte said he heard his former teammate say he used human growth hormone.

Asked by Clemens' lawyer if it was fair to say it was "50-50" that Pettitte misunderstood the conversation from 1999 or 2000, Pettitte responded, "I'd say that's fair." Pettitte is a key government witness as the prosecution tries to prove that Clemens lied to Congress when he denied using performance-enhancing drugs. Pettitte's concession could

weaken the government case.

Just the day before, under questioning from a government prosecutor, Pettitte had testified, "Roger had mentioned to me that he had taken HGH." Pettitte had made the same claim in a congressional deposition in 2008, prompting Clemens to say that his friend "misremembers" their conversation. After Pettitte's cross-examination Wednesday, prosecutors tried to salvage their witness in their re-direct questioning of him. They referred to Pettitte's 2005 conversation with Clemens, at the time of earlier congressional hearings on steroids in sport but involving differ-

ent athletes. Pettitte had asked Clemens at spring training what Clemens would say if asked by reporters about HGH use. According to Pettitte, Clemens told him he must have misunderstood the earlier conversation, and that in fact Clemens had been referring to his wife's using HGH.

"He told you that in 1999 or 2000?" prosecutor Steven Durham asked. "I didn't think so," Pettitte said. But after Pettitte's testimony, with jurors out of the room, one of Clemens' lawyers asked U.S. District Judge Reggie Walton to strike Pettitte's testimony as "insufficiently definitive." Walton asked the law-

yer for a filing on that but made it clear he had doubts about Pettitte's testimony.

Durham said that Pettitte's recollection is that his original memory of the 1999-2000 conversation is accurate and truthful, and that Clemens' version was not. But Walton retorted: "I didn't hear it that way," adding, "He is conflicted, he doesn't know what Mr. Clemens said."

Pettitte's hedging on the conversation shouldn't have come as a surprise to prosecutors. Back in his 2008 deposition, Pettitte mentioned a few times he might have misunderstood Clemens.

# Evan Longoria out 4-8 weeks

ST. PETERSBURG, Fla. -- Evan Longoria took a right turn out of the Tampa Bay clubhouse and walked a few feet before stepping in front of a group of reporters huddled around a lineup board that will not list his name for the next four to eight weeks.

The three-time All-Star was placed on the 15-day disabled list with a partially torn left hamstring Tuesday. Replacing his bat and glove won't be easy.

Yet the Rays are confident they'll be OK without their best player, who's hitting .329 with four homers and 19 RBIs.

"I've been in similar situations before and it's just one of those things where I'll stay positive," the third baseman said. "It's going to be tough to watch, but I can't really worry about it right now. I've just got to worry about getting healthy."

The Rays received the test results before Tuesday night's game against the Seattle Mariners.

Longoria was injured Monday while running to second base on an attempted

steal. He

slid

into

the

bag and

remained

on the ground for a moment

before climbing to his feet

and walking to the dugout

without assistance.

Elliot Johnson replaced him after the third inning, eventually delivering a game-winning RBI single in the 12th inning of a 3-2 victory.

The Rays have a knack

for finding someone to step up when star players are struggling or hurt. That's one of the reasons they are confident they can withstand Longoria's absence.

"We're still a really good team. We're going to have to be that much better defensively, that much better with our execution on the basepaths," executive vice president of baseball operations Andrew Friedman said.

"Our pitching's going to be very good. We're going to score runs," he added. "So it's one of those things where it's definitely not ideal, but we do have a ton of talent around him that should still allow us to win a lot of games."

The Rays have made the playoffs three of the past four seasons, including 2008 when they won the AL East and made an improbable run to the World Series. That year, nearly every starter spent time on the disabled list, including Longoria.

Tampa Bay lost the slugger for 26 games early last year and recovered from a slow start to rally from a nine-game deficit in September to win the AL wild card on Longoria's game-ending homer on the final night of the regular season. "I don't have any doubts," that

teammates will step up and help the Rays continue a strong start, Longoria said.

"We've been down this road before," manager Joe Maddon said. "There's no crying in baseball. ... You just try to make the best decisions afterward and move forward. But you can't worry about it. You don't talk about it negatively because that can bring you down."

The Rays purchased the contract of infielder Will Rhymes from Triple-A Durham. To make room on the 40-man roster for Rhymes, reliever Kyle Farnsworth was transferred from the 15-day DL to the 60-day DL.

Johnson was in the lineup again Tuesday night. Another utility infielder, Jeff Keppinger, may also get some starts at third while Longoria is out.

"It's not clear yet how much time he'll miss. It will be a minimum of four weeks. Somewhere in the four to eight (range), depending on how he responds and how treatment goes," Friedman said.

"He's always been a pretty good healer. He's had some hamstring issues in the past and has come back from them pretty quickly, relatively speaking, so we're not going to put a firm timeline on it."



# Amare Stoudemire hopes to play

Speaking for the first time since he injured his hand after hitting the glass case surrounding a fire extinguisher after Game 2 of the New York Knicks-Miami Heat series, Amare Stoudemire called the incident an "unfortunate" one that resulted in unintended consequences.

Stoudemire will miss Game 3 and is listed as doubtful for Game 4, though he is optimistic that he will suit up for the Knicks on Sunday.

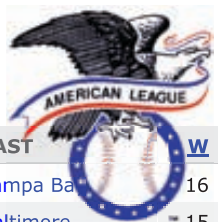
"I persevere through a lot of injuries. And I work hard to recover from injuries. So by the hands of the most high hopefully I'll be ready to play for Sunday," he said.

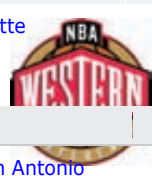
