





\*\*\*Visitors who hold a diplomat status and are in that capacity visiting Aruba for their work are exempt to purchase an insurance.

\*\*\*\*He/she must be an active member of the Dutch Military based in Aruba, and the exemption includes his/her spouse and children.

### E ley ta ensera lo siguiente:

- Prohibicion general pa huma den areanan publico pa proteha salud di hende y descurasha humamento.
- A percura pa tur e definicionnan necesario a wordo duna locual ta haci e implementacion mas eficiente.
- A aumenta e edad pa por cumpra sigaria di 18 pa 21 año.
- Mayornan cu ta huma den compania di un menor di edad ta core riesgo pa haña multa. Esaki ta pa proteha e salud di menornan di edad contra e huma di sigaria.

- Companianan mester percura pa proteha e salud di su trahadornan tambe.
- Lo ser prohibo pa parti sigaria por nada y pa bende sigaria los.

E ley aki a wordo amplia y adapta di un manera cu e ta contene tur e elementonan necesario pa por logra e meta di proteha salud di e pueblo en general (secondhand smokers) y pa descurasha humamento na Aruba. Di e manera aki tambe nos como pais lo cumpli cu e exigencianan di e Framework Convention on Tobacco Control di Organizacion Mundial di Salud (WHO) y cu nos Plan Nacional di Action riba Prevencion di Non-Communicable Diseases (NCDs). Asina Ministerio di Salud ta sigui traha pa salvaguardia e salud di nos hendenan.

Minister Oduber a splica cu si un persona kier stop di huma e por acudi na su dokter di cas cu por dune tratamiento pa esaki, si ta necesario. #### Artikel 7

1. Honden, die in strijd met het bepaalde bij of krachtens de artikelen 3 en 4 worden aangetroffen, dan wel gevaarlijke honden, waarvoor geen geldige vergunning is afgegeven, kunnen door het bevoegde gezag worden gevangen en in bewaring gesteld.
2. Honden, die naar het oordeel van het bevoegde gezag een onmidellijk gevaar vormen voor de veiligheid van mens en dier, kunnen door het bevoegde gezag worden gedood.
3. De in het eerste lid bedoelde, in bewaring gestelde honden, kunnen, indien de houder daarvan niet binnen **tien werkdagen** indien de hond identificeerbaar is en **drie werkdagen** indien dit niet het geval is, kan worden achterhaald, worden gedood dan wel weggegeven. Artikel 6, zevende lid, is van toepassing.
4. De houder is verplicht de kosten van het in bewaring nemen te vergoeden. **De Minister stelt daartoe bij ministeriele regeling tarieven vast.**
5. De Minister kan nadere regels geven ter uitvoering van het bepaalde in dit artikel.


