I wanted to loop you in on this. Please see below email from Jeffrey Delshad (Jimmy's nephew).

For some context: I received a phone call at 8pm on a Sunday night back in August from Jeffrey. He wanted to file a complaint regarding an aggressive encounter he had with one of our security team officers. He wouldn't give me any details. He was sitting on the sidewalk in front of Drip Doctors and one of our officers asked him to move. I checked in with the team (and Ken) that night, but none of the officers recalled any incident.

Jeffrey visited the office on Sept 5th. I was out of the office but he spoke with Wallis and Josh, and they told him more about what the BID does.

Flash forward to this most recent incident. Again, I spoke with Hunter and he said no one from the safety team recalls anything out of the ordinary that would warrant the below email. I called Jeffrey this morning and left a message. He replied with the following texts:

I'm going to stop engaging with him. Not sure if one of you has a relationship with Jimmy, or if it's even worth it to try to communicate with Jeffrey. But I figured I'd give you a heads up.
