

Certified true copy of the Original Deed of Trust executed on stamp paper of Rs. 33/- on 23-11-1968 & registered with Sub Registrar, Bombay on 16-1-1969 under No. 189 of 1969 and regd., in Book No. IV of Sub-Registrar of Bombay.

THIS INDENTURE made at Bombay this 28th day of November one thousand nine hundred and sixty eight Between Mr. RAMESH NANALAL SHAH of Bombay Hindu Inhabitant (hereinafter called "the Settlor" which expression shall unless repugnant to the context or meaning thereof be deemed to include his heirs, executors and administrators) of the one Part AND the said Mr. RAMESH NANALAL SHAH and Mrs. SHANTA NANALAL, D/o (Miss) NIRMALA, R. KAJARIA and BRAHMAKUMARI SHEEL INDRA all of Bombay Hindu Inhabitants (hereinafter called "the Trustees" which expression shall unless repugnant to the context or meaning thereof be deemed to include the survivors or survivor of them and the Trustees or Trustee for the time being of these presents and the heirs, executors and administrators of the last surviving trustee, their or his or her assignees) of the Other Part.

WHEREAS the Settlor is possessed of and otherwise well and sufficiently entitled to the sum of Rs. 2,000/- (Rupees two thousand only)

AND WHEREAS the settlor is desirous of making a charitable trust of the said money.

AND WHEREAS the Trustees have agreed to become the First Trustees of these presents as testified by their being parties to and executing these presents;

AND WHEREAS the said sum of Rs. 2000/- (Rupees two thousand only) has in anticipation of these presents been already transferred, paid and handed over to the Trustees before the execution of these presents.

NOW THIS INDENTURE WITNESSETH AS FOLLOWS :-

1. For effecting the said desire and in consideration of the premises the Settlor both hereby declare that he has prior to the executing of these presents paid, assigned, handed over and transferred and he doth hereby confirm such payments, assignments, handing over and transfer unto the Trustees of all that the said sum of Rs. 2000/- (Rupees two thousand only) AND all the estate right title and interest property and claim and demand whatsoever at law and in equity of the Settlor of and in and to the said keys and every part thereof TO HAVE AND TO HOLD RECEIVE AND TAKE all and singular the said moneys unto the Trustees for ever upon the trusts and with and subject to the powers provisions agreements and declarations hereinafter appearing and contained of and concerning the same.
2. The Trustees do hereby declare that they the Trustees shall hold and stand possessed of the said money (which are hereinafter for brevity's sake referred to as "the Trust Fund" which expression shall also include cash and any other property and investments of any kind whatsoever into which the same or any part thereof might be converted, invested or varied from time to time or such as may be acquired by the Trustees or come to their hands by virtue of these presents or by operation of law or otherwise howsoever in relation to these presents) upon the trusts and with and subject to the powers provision agreements and declarations hereinafter declared and contained of an concerning the same.

3. The said Charitable Trust shall be known as "World Renewal Spiritual Trust."

4. The Trustees shall hold and stand possessed of the Trust Fund as well as all other contributions received by them upon following trusts :-

(a) Upon Trust, in the first instance, to collect dividend, interest, rents and other income of the Trust Fund and premises and from and out of the same in the first plea pay all proper costs, charges and expenses of and incidental to the management, administration and execution of the trusts and powers herein contained.

(b) To pay the principal or interest subject to the provisions of clause (1) for all or any one or more of the following charitable purposes in such shares and proportions and in such manner in all respects as the Trustees shall in their absolute discretion think fit, that is to say :-

(I) Promotion, propagation and research in original and ancient Indian Culture, knowledge, yoga and philosophy with special emphasis on its revival and practice in day to day life to enable character and uplift lives of all human beings.

(II) Making adequate provisions for the study and teaching of and establishing, conducting and managing institutes for the purposes monitored in the sub-clause (i) hereof and providing all other ancillary facilities for the purposes of said studying, teaching and its revival;

(iii) Issuing books, booklets, periodicals, journals ect., in any language for the purpose mentioned in sub-clause (i) thereof;

(iv) For awarding scholarships, grants and appointing persons to spread objects of the Trust in India;

(v) For arranging managing and conducting museums exhibitions seminars lectures and utilising such other equipments of visual guidance and knowledge as may be developed from time to time for the purpose of spreading the main object as mentioned in sub-clause (i) hereof.

(vi) For the purpose of the relief of poor including the establishment maintenance and support of institutions or funds for the reliefs of any form of poverty;

(vii) In giving medical relief including the establishment; maintenance and support of institutions or funds for physical mental medical relief such as hospitals dispensaries, Services centres or the like;
