### MEMORANDUM FOR THE DIRECTOR

Re: Bremer Case.

Mr. Connelley telephoned me from Youngstown, Ohio, to advise that from the informant developed by the Post Office Inspectors, they have ascertained the location of the house in which the subjects of this case are said to be, the same being located at a certain point about seven or eight miles from Hot Springs, Arkansas. Mr. Connelley said that he and Agent Smith are proceeding at once to Cleveland, where he has requested Mr. MacFarland to make arrangements for an airplane from Cleveland to Little Rock, where a meeting will be had and then proceed by automobile to Hot Springs and thence to the place in question. Mr. Connelley said that the Post Office Inspectors are in on this for the reason that the informant is theirs, and it was only through their cooperation that we have the information at all.

Mr. Connelley said that the house in question is said to be on a wooded knoll, and is going to be rather difficult to take. In this regard, he said he would like to have ten men sent in to Little Rock to assist in this matter, which, with Mr. Smith and himself, will make twelve. He suggested the names of Agents Barber of Milwaukee and Hurt of Dallas, elso mentioning Agents Smith, Hansen and Buchanan of the Oklahoma City Office.

He said that it will take about eight hours by air from Cleveland to Little Rock, and if they can get out of Cleveland about 2:30 in the morning, it will put them in Little Rock eround 10:30 A.M. Mr. Connelley said that the expense of this airplene trip will be shared 50-50 between the Agents and the Post Office Inspectors, who are going along.

Time - 11:12 P.M.

Upon your instructions, I telephoned SAC Brantley at the Oklahoma City Office and advised him of the facts in this matter. I told him that you desired him to personally go over to Little Rock and take some men from his office, suggesting Special Agents Frank Smith, Paul Hansen, Buchanan, and John B. Little. Mr. Brantley said that while it will be a little difficult to get in touch with Buchanan and Frank Smith to get them over there by nine o'clock in the morning, he will try to do is. Mr. Brantley mentioned that Special Agent D. A. Bryce is in Oklahome City at this time on sick leave, but that he understends he is about ready to return to his headquarters at Aberdeen; that he will get in touch with Bryce, and his condition permits, he will be taken along

Mr. Brentley said that he would wire the Bureau what Agents are being taken, and assured me that they will go properly equipped, etc.

Time - 11:30 P.M.

I telephoned SAC Smith at the Kansas City Office and advised him of the above situation, advising that we need a couple of men from his office to assist in this raid. Mr. Smith said that he can send Special Agents Cruies, Fierstone and Clary with the appropriate equipment to the Little Rock Office at once by automobile.

Time - 11:47 P.M.

I telephoned SAC Blake at the Dallas Office with regard to this matter, and he said that he can send Special Agents Hurt, Coulter and Mertz to Little Rock so that they will be there at nine o'clock in the morning to assist in this matter. Mr. Blake said that the appropriate equipment will be sent with these men.

Time - 12:20 A.M. on the 29th.

I telephoned SAC MacFarland at the Cleveland Office and inquired if he has arranged for the airplane for Mr. Connelley. He said that they have arranged for a chartered plane.

I told Mr. MacFarland that I had talked with the Director, who wanted certain instructions given to Mr. Connelley, and in this connection, I told Mr. MacFarland that I wanted to make sure that I talked with Mr. Connelley before he leaves on the airplane for Little Rock.

Time - 1:27 A.M.

Mr. Connelley telephoned in and I told him that upon discussing this matter with you, you had stated you wanted Mr. Connelley to be sure that if anything starts on this matter, someone would be designeted to act as informant to the Bureau. I told Mr. Connelley to arrange for a wire to the Bureau to be kept open during the developments so that we can be kept advised. Mr. Connelley said that the place in question is about eight miles out from Hot Springs, but that he would take some man out there unbeknown to the others and see if some form of telephonic communication can't be established to be used in this matter. I particularly pointed out to Mr. Connelley that if some gun battle ensures such as the one down in Florida, the Bureau should by all means be kept advised.

I also particularly pointed out to Mr. Connelley your statement relative to the news angle of this matter, and I am sure that he understands how vitally important this angle of the matter is, especially in view of his knowledge and my information to him concerning your opinion of the Post Office Inspectors.

I then advised Mr. Connelley of the Agents who are going to assist in this matter, as follows: From the Oklahoma City Office - SAC Brantley, Paul Hansen, Buchanen, John B. Little, D. A. Bryce, Frank Smith (possibly); from Dallas - C. O. Hurt, Coulter and J. C. Mertz; from Kanmas City - Clary, Fierstone and Cruise. I then asked Mr. Connelley who else he would like to have, and he suggested that if Agent Barber is sent down from Milwaukee, he would have enough Agents if he can get a couple from the Little Rock Office. Of course, he will have Agent R. E. Smith with him, and there will be about four Post Office Inspectors.

Mr. Connelley said that they are departing at 2:30 A.M.

Time - 2:40 A.M.

I telephoned SAC Peterson at the Milwaukee Office in connection with the above matter, and told him that the Bureau desires Agent Barber to proceed at once to Little Rock to assist in this matter. Mr. Peterson said that he does not know about the availability of transportation at this, but said he would check up and advise me.

Mr. Peterson telephoned me back and said that the best he can do in the way of transportation for Barber is to get him out of Chicago by airplane at 11:15 A.M., which will put him in Little Rock at 7:32P.M. In view of this, I authorized Mr. Barber's transportation by air.

Respectfully,

With reference to the statement of Mr. Connelley that the expense for the chartered plane in this matter would be borne 50-50 by the Bureau and the Post Office Inspectors, I suggested that he hold this in abeyance for the time being, pointing out to him that developments might make it desirable for the Bureau to bear the entire expense.

Mr. Connelley called on the telephone from Cleveland. He said the Post Office Inspectors have finally come to us. It seems the Post Office Inspectors have gotten hold of one Clayton hall, who lives at Youngstown. Clayton Hall says that it was at his house that Karpis and one Fred Hunter stayed when they "cased" the Carrettsville train robbery. Connelley says that the Post Office Inspectors have had Hall under surveillance for sixty days or so and lately have gotten in touch with him and made a real informant out of him. Hall says that Karpis and Hunter have already cased a new robbery involving a \$500,000 theft from a train, and indicates that that was also cased at his home, further stating that he expects Karpis and Hunter 9 to return to his home at Youngstown, possibly tomorrow or some time between now and the first of April to make final plans for the prospective robbery, which is to be that of a payroll forwarded by train the first of every

in the house at the present time two Post Office Inspectors, two State Police, and two of our Agents. I inquired why the Post Office Inspectors. and two of our Agents. I inquired why the Post Office Inspectors came to us with the information and Connelley stated Chief Post Office Inspector Briggs of Cincinnati knew him, Connelley, and came to him for that reason. I rather laughed at that and Connelley said he thought a further reason was that the Post Office Inspectors were somewhat dubious as to the extent of our knowledge, which is possibly more likely. Then Briggs contacted Hettrick, ? the local Post Office Inspector at Youngstown, and they told Connelley they wanted to play ball with us. Connelley also said that probably they thought we knew something more of the set-up of the in this train robbery.

INDEXED The Post Office Inspectors have been securing good information from one Brock, whom they brought from Oklahoma. Brock has been developed and brought to the Post Office Inspectors by one Joe Anderson of the Kansas part State Police. Joe Anderson roams all over the country working for the Kansas State Police. His principal working place is in Oklahoma. I have met him there. Brock as a matter of fact, Connelley states, was in on the Garrettsville robbery with Karpis and Campbell.

Our people have gotten hold of one Letzner, who after the Garretts-ville train robbery flew Brock, Karpis and Campbell south to Evansville, to Memphis and then to Little Rock, where Karpis left the plane, and then to Tulsa with Brock. Connelley went into considerable detail as to how arrangements were made with Zetzner to secure this plane, which details I believe to be immaterial. Each one of the three men was to pay Zetzner \$500 for the plane in question, and Zetzner bought a plane for the \$1500.

Connelley is going over to Youngstown now to talk to Clayton Hall. I told Connelley I would have more interest and confidence in the matter after he had talked with Hall himself. This he is going to do. Connelley will be at the Todd Hotel under the name of Edward J. Conrad. The six men in the Clayton house, i.e., two Post Office Inspectors, two State Police and two of our men, are inside the house and Connelley is to make arrangements somewhere in the vicinity for somebody with a car, because an inside plant is not so good if anything happens to frighten those entering it, as they will jump in a car and go away and maybe it will be a long distance fight and nothing much develop from it.

Of course, if this goes through in accordance with the above, and if Karpis and Fred Hunter are apprehended by the combined Post Office, State Police and Bureau Agents, this incident is going to break into the newspapers coincidentally with the capture.

Enclosed you will find my memorandum for this file dated March 17, 1936, which is self-explanatory.

A list of the associates and contacts of Frank Foster, alias Frank Frost, alias Frank Foreman, developed through surveillance, telephone and dictaphone taps at the apartment occupied by him at 145 West 58th Street, New York City, maintained by agents of this office from April 7, 1935 to May 6, 1935 was furnished to Inspector McDermott through Detectives John Coleman and Thomas Walsh, sent to this office to obtain same by the Inspector. The present whereabouts of Foster as reflected in recent reports from the Salt Lake City office has not been furnished to Inspector McDermott pending Bureau authorization.

Inspector McDermott has advised me that an indictment charging robbery, first degree, armed, was returned against Foster by the Grand Jury of New York County, N. Y. on March 23, 1936 in connection with the robbery of Greenleaf, Crosby & Company, Lewelers, Radio City, New York City, and that Foster has been positively identified as one of the men who participated in this "stick-up".

Detectives Coleman and Walsh informed Special Agent W. F. Seery of this office that they are presently engaged in inquiry through underworld sources (stools, etc.) with a view to locating Foster and that the most recent information received through RECORDED

these sources is to the effect that Foster is presently located in or near Los Angeles, California. The officers repeated to Agent Seery the desire expressed to me by Inspector McDermott to the effect that they would prefer that agents of this Bureau apprehend Foster and arrange that he be held for the New York City authorities rather than to make the request of the local police unit in the city in which he may be located, as they are apprehensive that Foster's underworld connections in said city may learn that the New York City authorities have requested his arrest and thereby permit Foster to escape apprehension.

The Eureau is requested to advise whether the information relative to Foster's present whereabouts should be furnished Inspector McDermott and whether the Salt Lake City office should be requested to effect the apprehension of Foster for the New York police as suggested by Inspector McDermott.

#### MEMORANDUM FOR THE FILE

Re: BREKID

On 3/16/36 INSPECTOR MICHAEL Modermort, accompanied by two detectives, called at the New York Office. He stated that FRANK FOSTER has been positively identified as having participated in the robbery of the jewelry store in Radio City which took place in January of this year, during which jewelry in the amount of over \$100,000 was stolen. The Inspector advised that he expects to secure, in the very near future, an indictment against FOSTER, charging him with the robbery; that he is very anxious to obtain information with reference to the following:

- 1. Pefinitely establishing that FOSTER was in New York City at the time of the robbery;
- 2. Concerning FOSTER'S associates and companions who might have been implicated with him;
- 3. Regarding FOSTER'S present whereabouts.

Inspector McDERMOTT stated that in the event FOSTER is located by the Bureau in some other city, that he has in mind having the Bureau arrest FOSTER who can them be turned over by the Bureau Agents to the local police, to be held for extradition. The Inspector advised that he wanted this procedure followed since, in the event he endeavored to effect FOSTER'S arrest through the local police of the town where he might be in hiding, FOSTER might be tipped off. He feels that once he has been arrested by the Agents and turned over to the police, they, of course, will have to hold him pending extradition.

I advised the Inspector that the New York office had FOSTER under surveillance for several weeks about a year ago in connection with the BREMER case, in an effort to ascertain whether he was in contact with HARRY SAWYER; that since that time the Bureau, as far as I know, had no further interest in FOSTER. I informed the Inspector, however, that I would have the file in this office reviewed and would furnish him with any information available which might be of assistance.

I am attacking a copy of a lotter received from Theriff Tom J. Gibbons of Hamsey County, St. Paul, Minn., relating to KARTIS having been seen in Aliquippa and Conway. Tennsylvania.

Mr. Cibbons was interviewed and stated that his information come from a storekmeper in the neighborhood, who had helped out the two young men referred to by giving them something to est, and had obtained the information from these young men, whose identities he did not know. Mr. Gibbons stated that he had promised his informant that he would not in any way become involved in the inquiry, and for this reason suggested that he not be interviewed, particularly in view of the fact that his informant had stated that these two young men were transients, and that he could suprly no 8 further information than contained in Sheriff Gibbon's letter.

Mr. Gibbons stated that his informant is sort of an extremist and he does not place much oredence in the information furnished, but that he felt it his duty to turn it over to the Bureau.

Gentlemen:

Just received the following information which was given to me by one of my neighbors who had contact with two young men around the ages of 20, 21, or 22, who apparently, at one time, were confined in the House of Correction at Morganzie, Pa. These young men are supposed to have run away from Morganzie some five or six years ago, formerly residents of Carnegie, Pa., on 6th St.

My neighbor is quite sure that this information regarding Alvin Karpis has been assured by these two young fellows, who claim they know his whereabouts. The supposed Alvin Karpis now is supposed to have red hair. He and several companions carry on the sale of silk stockings and cheap silverware in the vicinity of Monture, Fa., Alliquipa, Pa. and Conway, Pa., Monture: When here, they stop at an old hotel, formerly owned by a Dick Joy, and known as the Dick Joy Hotel by the old timers. Alliquipa: Across the river from Conway, they live on what is known as Residential Hill, when in town. Conway; They stop in an old boarding house across the street from a saloon.

Other towns in this vicinity are McKees Rocks, Rock-ester, Arrigile, on the Wabasha Railway, and Cecil, located on the Pennsylvania Railway.

The above two men claim they saw Karpis about three weeks ago. I cannot guarantee the spelling of the towns above named, nor the information given me, but I felt a responsibility of turning it over to you.

However, it is possible that the instance which Agent Wynn has in mind is in connection with Fred and Loc Barker and not with Alvin Karpis and Harry Cumpbell. In the report of Agent R. E. Lawrence, Little Rock, Arkenses, dated October 2, 1934 (serial 98 of this office's file) mention is made that Joe lidrards, who is now night Chief of Police at Elwood, Indiana, had known the Barkers at Fort Smith, Arkansas and had at one time herbored a burglar there. This report also states that the wife of Joe Edwards was well acquainted with Free Barker, and could get her husband to harbor the Barkers if she wanted him to do so. It appears that Agent Fynn reported on the investigation of this lead end his report is dated at Indianapolis, Indiana, December 28, 1934 (Indianapolis Bureau Office serial number in this case is 160), which report makes no mention of the wife of Edwards.

It does not appear that the sheriff's office there has ever been mentioned in connection with the members of this group except in connection with the arrest of Willie Harrison at that point several years ago.

#### MEMORANDUM

It was reported on October 17, 1935, that individuals, one of whom was Harold King, occupied a cabin on Lake Hamilton in the vicinity of Hot Springs, Arkansas, from approximately the period June, 1935 to October, 1935, and while there were in possession of two Hudson automobiles, one bearing a 1935 Ohio license number H-372M, and the other a 1935 Ohio license H-85M. Information has also been obtained by the Cleveland, Ohio office of this Bureau to the effect that the car bearing license number H-372M was purchased by E. F. Parker, who was accompanied by Fred Hunter, a professional gambler and possible contact of the fugitive subjects of this case.

From investigation conducted to date, it appears that Fred Hunter is an associate of Thomas J. Shaw, alias Milton, ett; that both Lett and Hunter were wanted by the Post Office Department as suspects in the Carrettsville, Ohio mail train robbery which occurred on November 7, 1935. Subsequent investigation has failed to disclose the identity of the purchaser of the car bearing license plate H-85M.

It was learned from Inspector Hettrick of the Post Office Department that they were conducting investigations at Coffeyville, Kansas and Oklahoma in an effort to locate Milton Lett inasmuch as reports received by him indicated that Lett was last seen at Coffeyville during the middle or latter part of December, 1935. Through investigation conducted by the Post Office Department, it appears that Lett has been definitely connected with the Garrettsville mail train robbery which occurred on November 7, 1935. The Post Office Department have concentrated their efforts in the vicinity of Youngstown, Ohio, in an effort to locate him. Hettrick further advised the Bureau that he had learned that Agents of this Bureau were making inquiries concerning one Fred Hunter. In this connection the Post Office Inspectors have also been making an extensive investigation to locate Hunter who is a possible suspect in the Garrettsville mail train robbery inasmuch as Hunter is reported as having been in the company with Milton Lett. On the night of October 24, 1935, inquiries were made by them at the Plymouth Agency of the Knowles-Brown Company, 1440 West 25th Street, Cleveland, Ohio, regarding the Plymouth sedan which was purchased from that company on October 25, 1935, and used in the Gerrettsville mail train robbery which occurred subsequently.

The harvard Club, located at Cleveland, Ohio and operated by Art neberbrand and James "Shimmy Patton, is believed was frequented from time to time by Karpls and Campbell and other subjects who were in Cleveland in the spring and fall of 1934... Fred Hunter, a known gambler, has also frequented the Harvard Club. The records of the Identification Division of this Bureau, under FBI #54440, indicates that, as Fred John menderson,

alias Fred Hunter, No. 9995, he was arrested by the Police Department at Toledo, Ohio, on June 3, 1920, charged with suspicion, carrying concealed weapons. On June 22, 1920, he was fined \$200. and cost, and sent to the County jail. As Fred Hunter, alias Fred Harris, Police Department Akron, Ohio, No. 8140, he was arrested on October 28, 1922, charged with being fugitive from Warren, Ohio, and on April 17, 1923 he was sentenced to serve a term of three to twenty-seven years in the Ohio State Penitentiary on a charge of larceny and possession of dynamite. He was received at this institution as Fred Hunter, number 51873, on April 17, 1923.

An identification of the photograph of Fred Hunter as being identical with Harold King, one of the occupants of the cabin on Lake Hamilton, was reported by the Little Rock office in the report of Special Agent B. L. Damron on February 8, 1936. The photographs of Milton Lett and William Funter were not identified as associates of Fred Hunter on that occasion.

From information furnished by a confidential informant at Hot Springs, Arkansas, it appears that a person resembling Karpis had been in Hot Springs during November, 1935, and had arrived in a private airplane at the Municipal Airport. Johnny Stover, who is in charge of the local air ort at Hot Springs and who was a Government witness in the Kansas City Massacre case, related on November 11, 1935 a Stinson, four passenger, airplane, bearing number NC-12180, arrived in Hot Springs, Arkansas, about noon and apparently came from the East. It contained three passengers and a pilot. Stover identified one of the passengers as Fred Hunter and stated that the other party bore a slight resemblance to Karpis, particularly the facial characteristics "from the nose down". It should be noted that Stover stated that this information was given to the Post Office Inspectors and his identification was effected through information furnished by the Post Office Inspectors. He further related that the person traveling with Hunter, who is possibly Karpis, wore his hat pulled down over his eyes and also wore shell-rimmed glasses. He did not observe any scars on the face of this person and was of the opinion that the person possibly identical with Karpis had an impediment of speech.

Upon leaving the plane, Stover related that Hunter made inquiries as to whether a woman had been at the airport to meet them and, upon being informed that no person had inquired concerning Hunter, he (Hunter) made a telephone call from the hangar, and thereafter Stover drove these persons to Hot Springs.

Efforts to trace this telephone call did not materialize. Hunter and the other person with him, possibly Kerpis, were driven by Stover to downtown Hot Springs and they left the car at a point on Central Avenue near the Como Hotel, and were not seen by Stover until approximately one week later at which time Hunter returned to the airport in a taxicab, accompanied by a young girl who was described as being 18 years of age, 5 feet two inches tall, weight 115 pounds, medium dark complexion, dark bobbed curly hair, and well dressed. At this time Stover was hired to fly Hunter and the girl to San Antonio, Texas. Upon arrival at San Antonio and landing at the Army Auxiliary Field, Hunter immediately thereafter, accompanied by the girl, left the airport in a taxicab. The registration of the arrival of Stover's plane at this point was registered with the officials of the Army Auxiliary Field at San Antonio and soon thereafter Stover returned alone to Hot Springs, and has not seen either of the parties since.

At a later date, relative to the first appearance of Hunter and a person possibly identical with Karpis, at Hot Springs, Arkansas, at which time they were observed by Stover, it appears that Stover learned from one of the employees of the airport that some women in a Hudson sedan had made inquiry at the airport on the morning of November 11, 1935, and Stover assumed that these were the women about whom Hunter made inquiry

It should be noted that on November 11, 1935, two persons got out of the plane which arrived in Hot Springs, one being Hunter and the other a person possibly identical with Karpis. The remaining two passengers left the airport after the plane was refueled, Stover, however, obtaining the number of the plane which bore number NC-12180, the pilot at this time giving the name of Fetquer.

From information recently furnished the Bureau, it appears that the Post Office Inspectors at Tulsa, Oklahoma, had interviewed Stover and had informed him that Karpis was the associate of Fred Hunter, who disembarked from the airport at Hot Springs, and that the Post Office Inspectors had further told him that the Stinson airplane, after leaving Hot Springs, proceeded West and was forced down about twenty-five miles from Fort Smith, Arkansas. After this forced landing, the plane proceeded to Fort Smith and thence to Tulsa, Oklahoma. Stover was further informed that the Post Office Department were seeking the apprehension of Hunter and in addition thereto had offered a \$2,000 keward for the apprehension of Karpis.

Arrangements have been effected to have Stover immediately advise the Little Rock office on receipt of any further information relative to the appearance of persons previously referred to.

It was ascertained by the Washington Field office that the Stinson plane referred to was owned by John Letzer of Port Clinton, Ohio, who purchased this plane from the Gross Sales Air Service, East Toledo, Ohio. From the records reviewed, it does not appear that Zetzer is a licensed pilot at the present time. It also appears that Stover was advised by the Post Office Inspectors that the airplane had been purchased by the gang.

An informant of the Cleveland office, upon viewing the photograph of Fred Hunter, stated that Hunter was employed at the Harvard Club in the spring of 1935 and, while employed there as a card dealer, appeared to be very intimate with Art Heberbrand and Tony Amersbach. Tony is known as a strong-arm man about the Harvard Club. It was further ascertained that Hunter was believed to be residing somewhere in the vicinity of Madison and Rocky River Road in an apartment building in Cleveland, Ohio. However, Hunter could not be identified as ever having resided in this vicinity.

From information furnished by Detective Robert Van Steneberg of the Akron Police Department, it appears that J. T. Dunn, a local gambler, viewed the photograph of Milton Lett and that he knew this person by the name of Thomas J. Shaw, it appearing that he first became acquainted with him over a year ago, at which time Shaw was brought to Dunn's place by Fred Hunter. Dunn knew Hunter under the name of Fred King. It also appears that Lett played cards at Dunn's gambling place and also appeared to be "well heeled", having in his possession at all times sums of money aggregating \$1,000.

The criminal record of Lett as contained in the Bureau's files indicates that he was arrested on October 19, 1935, by the Akron Police Department as Thomas J. Shaw, number 26337, on a charge of suspicion. At the time of this arrest, one Clayton Hall of Youngstown, Ohio, was picked up with him and was later released.

On the occasion of Lett's arrest, Fred Hunter came to Dunn and requested Dunn to intercede on behalf of Lett who was being held by the Akron Police Department. However, since that time Lett has been released and was subsequently arrested by the Coffeyville, Kansas Police Department on November 6, 1935, on a charge of robbery, first degree.



It is interesting to note that the Gerrettsville mail train robbery occurred on November 7, 1935. The record contained in the Identification Unit of this Bureau reflects that Milton Lett was arrested by the Sheriff's office at Yates Center, Kansas, on November 7, 1935, the date of the Garrettsville mail train robbery on a charge of holdup investigation and that he was subsequently released.

Detective Van Steneberg also has furnished the Cleveland office with information to the effect that Fred Hunter was in Akron, Ohio on October 18, 1935, being interested in the sale of some gambling equipment in Cleveland. Hunter was taken to Cleveland by a local Akron man on October 18, 1935 and was introduced to Art Heberbrand of the Harvard Club, and "Shimmy" Patton, who is also associated with the Harvard Club. It appears that both Heberbrand and Patton placed orders for equipment with the Akron man, who in turn gave Hunter a commission for the sale of such equipment.

It further appears that Hunter told the Akron man that he had traded a Ford coupe in Cleveland for a new Ford V-8 sedan and that the deal would go through in several days. The Ford V-8 referred to has been previously mentioned in this memorandum.

It also appears that Fred Hunter was in Washington, D. C. sometime in October and sold to one John Evans, a gambler in Washington, D. C., a large order of gambling equipment.

With reference to the Ford V-8 car which was allegedly purchased by Fred Hunter, under the name of Harold King, and which was supposed to have been registered in Warren County, Ohio, as reflected by the information furnished the Cleveland office by Detective Van Steneberg of the Akron Police Department, investigation disclosed that there was no record of the registration of this car by Harold King at Warren, Ohio. It further appears that no new Ford V-8 car has been registered by Fred King or in the paid of any of the known aliases of Fred Hunter.

The photograph of Fred Hunter was also exhibited to Al Dyer, owner of Dyer's Landing, who identified the photograph on Fred Hunter as being identical with the person known to him as Harold King. Dyer is located at Hot Springs, Arkansas.

Dr. Paul Zi Browne, located in the Medical Arts Building, Hot Spring, Arkansas, identified the photograph of Fred Hunter as being the person treated by him in June and July, 1935, and giving the name of Fred Hunter.

The criminal record of John Zetzer, who is probably identical with John Zetzer mentioned herein as the airplane pilot, as disclosed by the Identification Division records, indicates that,



MANOFANDUM FOR THE DIRECTOR

Rea Doris Berton

I telephoned SAC Andersen at the Phoenix Office inquiring of him as to the information in his personal possession as to the above named parson, the wife of Eddic boll.

fr. Andersen said that most of the information which he has concerning the reputation of this woman was furnished to him by Kethryn Kelly, wife of George Kelly, subject in the Urschel Kidnaping Case.

Kathryn Kelly told kr. Andersen that Doris Burton used to work in a cell house.

I asked Mr. Andersen what kind of a woman he would consider this person. He said that while he could not state that she is definitely the criminal type, she is the type who would knowingly live off of the proceeds of criminal activities. Mr. Andersen said that the only time he ever talked with her was one time while Doll was in jeil at Tampa, Florida; that during this interview, he gained the impression that this woman was just a "push over". She puts on a good front and "is a simple maiden to talk to", but Mr. Andersen said that he has always had his doubts as to her sincerity. He said that she denied having knowledge of Doll's criminal activities before his arrest, but admitted to Mr. Andersen that she knows the Kellys, and knew them before the Urschel Case.

Mr. Andersen said that he would not say that this woman is a person of character, but is on the contrary, weak; that he would not at all classify her as being a "decent" person, although she tried to give the impression of being one. SAC MacFarland telephoned me from the Cleveland Office and said that at Youngstown, Ohio, there is information to the effect that Karpis and Campbell have been in and out of there for the past few days casing a \$500,000 robbery. This robbery is scheduled, according to the information, to be executed on or about April 1, 1936. The Post Office Inspectors have ten men in Youngstown covering this matter, and the Cleveland Office has four men there. Mr. Connelley, who is at this time in Toledo, has been advised of this situation, but is unable to return to Cleveland tonight for the reason that they have located at Toledo the man who carried Karpis and Campbell from Toledo by airplane at the time they made their escape from Atlantic City. However, Mr. Connelley will be in tomorrow morning, and is going to confer with the Chief Post Office Inspector, a Mr. Briggs. Mr. MacFarland said that he does not know at this time what Karpis and Campbell are going to rob, some information being that it is to be a bank, and other information indicating that it is going to be a large industrial payroll.

My questioning of Mr. MacFarland as to the source of this 57d information developed that the Post Office Inspectors have an informant he being used in connection with what is known whose name is as the Garrettsville robbery. Special Agents of the Cleveland Office last night picked up and questioned this man at some length, and he gave only a little information to them, after which he was released. Thereafter, the Post Office Inspectors picked the informant up to keep us from questioning him further and "gumming up their works", and they at this time have the informant hid away, and we do not know where he is. The information set out in the first paragraph of this memorandum was furnished to the Cleveland Office by the Post Office Inspectors.

When Mr. Connelley gets back to Cleveland, he is going to confer with Mr. Briggs, the Chief Post Office Inspector, and possibly both of them are going to question this informant further. With regard to the sufficiency of the number of Agents in Cleveland at this time, Mr. MacFarland stated it was his opinion the four who are there with sufficient equipment would be enough for tonight; that, however, it is possible that in the very near future, possibly tomorrow, they will request the Bureau for additional men

### MEMORANDUM FOR THE DIRECTOR

Re: Bremer Case.

Mr. Connelley telephoned me from Arkansas, and said that while they failed to get either of the subjects at the house south of Hot Springs it is known definitely that both Karpis and Hunter and two women were in there as late as Thursday of last week. Mr. Connellay said that he believes he has the identity of one of the women, and knows the contact through which she got out of there, which contact is the contact of our informant in Youngstown. He said that they are going to try tonight to get in touch with this contact, a woman named Grace Goldstein, who operates a house of prostitution. Grace Goldstein is the one who made the arrangements for Connie Robinson, who is the sweetheart of Hunter, to get out of Hot Springs on last Thursday. This was the result of the contacts which the Post Office Inspectors and the Police had made over there with a taxi driver who is also a sweetheart of Connie. The four of them were at this house until around noon on Thursday, taking their two dogs, one of which is the animal given to Karpis by our informant in Youngstown. Mr. Connelley said that while he does not believe these parties are anywhere close to Hot Springs, the place still has possibilities. He said that while they are undoubtedly going to get inquiries as to the raid, all of the information which has been given out  ${\cal Y}$ at your direction has not indicated that it is Karpis for whom we are looking.

I told Mr. Connelley that the International News telephoned you and told you they had a story to the effect that the Agents were concentrating around Hot Springs and had been sent from Washington by plane, etg., and that there was a possibility of apprehending Karpis. I told Mr. Connelley you had told the newspaper that you doubted if there was any prospect of the apprehension of Karpis; that the activities of the Agents are just routine, and there was nothing unusual about this whatever. Mr. Connelley said that this same conception of the matter seems to exist down there; that in so far as the newspapers know, except for some wild guesses, there is nothing unusual going on. Mr. Connelley said that he got 21 men out of the building last night and into the automobiles with three reporters across the stree PLCCR PLEO keeping watch, and the reporters did not know that the Agents even left the building:

INDEXED Mr. Connelley said that the reporters checked Office Inspectors, the informant and Jos Anderson of Kansas into the hotel down there, and if the reporters check up further on this situation, they will just work the matter up to the best interests of the Bureau. He said that the Inspectors will possibly get out of there tomorrow sometime.

Mr. Connelley said that they have a plant on at the house out there. He said that someone went into this house for about an hour last night specifies we saw the lights in the house; that, however, it is entirely/this person was a Negro caretaker. Mr. Connelley said that there was no especial disturbance in that vicinity, other than the cars coming in there, and the fact that they shot a couple of gas shells into the house before they went in.

I then advised Mr. Connelley of the information relative to. John Zetzer, the airplane pilot, and Brock, who is in the custody of the Post Office Inspectors, and the suggestion of Mr. MacFarland that we confront Zetzer with Brock and see if we couldn't get some information from him. Mr. Connelley said that he does not believe we should do this at this time, primarily for the reason that ultimately we can turn this man Zetzer over to the Post Office Inspectors and they will file on him in connection with the Garrettsville robbery. He said that the Inspectors undoubtedly have a statement from Brock to the effect that Zetzer was present in addition to Brock at the time the mail sacks were burned at Zetzer's house. I pointed out to Mr. Connelley that you had cautioned about holding this man Zetzer too long, and he said it was his opinion if nothing further breaks on this matter, Zetzer would have to be turned over to the Inspectors possibly tomorrow night. He said that if the Inspectors don't want him, we will put him in the position of confidential informant and put him back out on the streets.

I told Mr. Connelley that Mr. MacFarland advises the informant in Youngstown stated if Karpis and Hunter went out of Arkansas, they would probably go to Toledo, Ohio and there contact Joe Roscoe. Mr. Connelley said that this is an entirely logical conclusion, and it is his personal opinion that Joe Roscoe is as a matter of fact a contact for them in Toledo and vicinity; that just as soon as he gets out of Little Rock, this possibility will be looked into. Mr. Connelley said that he is going to call Mr. MacFarland on some other angles of this matter, at which time this particular angle will be discussed, so that the Cleveland Office might get something going on it.

I mentioned to Mr. Connelley the plant on the Campbell home in Tulsa, Oklahoma, and asked him if he thought it worth while to continue this matter at the present cost. He said that he believes if the new setup can be worked out, it will suffice although it won't be as good as the other setup; that, however, he would discuss the matter with Mr. Brantley

Mr. Connelley said that he is going to get a little sleep and is then going back to Hot Springs to work on this Grace Goldstein to see if we can get her to furnish us the desired information with of course a little monetary inducement.





Memorandum for Mr. Fisher. Criminal Division.



I am still unable to understand the statement contained in the Director's original memorandum of January 23, 1936, that there are certain clothing concerns, etc., in Miami, Florida, with bills aggregating \$426.24, covering purchases presumed to have been made by these witnesses, or at their request, and for which the creditors desire an early payment. The records show that the American Consul at Havana advanced to Special Agent McKee the sum of \$1030, which was to be expended by him in securing outfits for the Cuban witnesses. The Department had specifically limited the amount to be allowed each witness for that purpose. The arrangement was that Special Agent McKee was to attend to the purchasing of the outfits, within the authorized limitation, and refund any balance. It appears that certain of the witnesses exceeded the authorized allowance ( the difference, of course, being payable by them personally) and that Special Agent McKee refunded the sum of \$2.40 covering the balance of \$1030 advanced to him by the Consul General. If any other expenses were incurred, they were apparently not authorized and I see no reason why the Department should be concerned with the payments.

It seems to me that this matter should be referred, by the Bureau, to Special Agent McKee for a report. In any event, we cannot make any additional payments from the appropriation chargeable with the other expenses in this case for the reason that the total amount of the allotment, for the entire fiscal year, has been expended.

Reference is made to your memorandum of March 24, 1936, transmitting a further memorandum from the Director of the Federal Bureau of Investigation concerning the expenses incurred in connection with the attendance of witnesses in the McDonald case at St. Paul, Minnesota. It now appears that the bills for clothing represent purchases made for the Florida witnesses subpocnaed for the trial of said case, instead of the Cuban witnesses. It further appears that the clothing was secured by a Special Agent of the Bureau, acting upon instructions from the United States Attorney that "proper arrangements be made for the securing of proper and suitable clothing for all Florida witnesses subpoenaed for the trial of the above entitled case in St. Paul". You are, of course, aware of the fact that, under the arrangements previously made, the witnesses from Cuba were provided with clothing. However, the situation with reference to the Florida witnesses differs very materially from that of the Cuba witnesses. In the former case the witnesses reside within the United States, where the subpoenas would run, whereas in the case of the Cuban witnesses, the conditions under which they would attend were based entirely upon contracts or agreements. We are, of course, not permitted to make any such contracts or agreements in the case of witnesses residing within the United States. The United States Attorney was, of course, entirely without authority to give any such instructions to the Special Agent. I may add that the clothing for the Cuban witnesses was paid out of the allotment of {10,000 under the appropriation "Fees of Jurors and Witnesses, U. S. Courts" which, by its terms, is disbursed under the exclusive direction of the Attorney General, whose authorization with respect thereto is conclusive. Unfortunately, this allotment is now entirely exhausted and is, therefore, not available for the payment of this expense, even if we were disposed to give favorable consideration thereto. Mr. MacForland/telephoned me from the Cleveland Office with refer ence to the above matter and said that they contacted the people from whom the plane was secured, the Sundroph Aeronautical Corporation, and they indicated that they did not give out any information at all. They indicated when the plane left that it was going to Louisville, since some destination had to be shown in accordance with Department of Commerce regulations. When the plane arrived in Louisville, they had to place on the register that they were going to Little Rock, where, upon arrival, a reporter asked them who they were, etc. Mr. Sundroph, who was the pilot, told the reporter that his passengers were merely some business men who he transported quite a bit. Mr. Sundroph believes that the leak occurred through the office of the United Air Lines at Cleveland, where a contact was first made to charter the plane. Mr. MacFarland said that at the time they were conferring with the United Air Lines, the district manager of that company came to the office to confer about the matter, as a result of which he advised that they had no plane available at that time which would suffice. This man was cautioned about the secrecy of the situation, but he sent a telegram to his Chicgo Office for the purpose of seeing if a plane was available there which could be sent over to take the Agents out. According to Mr. Sundroph, there were a number of employees of the United Air Lines present during the district manager;s telephone calls and telegrams about this situation. Mr. Sundroph said that when he went over to the coffee shop to get some coffee, Mr. Ralph Troftich of the United Air Lines operations department, came up to him and Indicated to him that he, Sundroph, was going to have a hard time making the trip to Little Rock on account of the head winds. Mr. MacFarland said that it appears everyone from the most important to the lesser employees knew about the situation and accordingly a lot of falking was done. Mr. MacFarland said that they have not as yet contacted Mr Galbos of the United Air Lines, for the reason that Mr. Connelley suggested this angle be held in abeyance for the time being.

Mr. MacFarland mentioned, incidentally, that the UnitedPress carries a story to the effect that the Agents of the Bureau are supposed to have taken two men and a woman into custody at Little Rock. He said that while he has not heard anything about this, he thought he would pass the information on to the Bureau.

Mr. Pinkerton of the Associated Press, contacted me at home through the Bureau switchboard, and stated that he had a message from their Cleveland office to the effect that a group of Special Agents had taken a plane from Cleveland to Little Rock; that he did not expect me to tell him what they were doing but that he would like to know if we expected any developments, so that he could stay around and cover it. I advised Mr. Pinkerton that I knew of no such movement and that if there was, I would probably know of it.

I asked Mr. Pinkerton that, going on the assumption that there was such a movement, not only out of Cleveland but from any point, would the Associated Press or anyone else put anything out on it. He stated that they would not write anything on it; that they wanted the information so that it could be covered here in Washington. He stated, in answer to my inquiry, that the information came in from Cleveland over the wire, but confidential to them, about 3 A. M. this morning.

I advised Mr. Pinkerton that I would get in touch with the office and try to verify this information; that I would call him at his office within the next hour or so if there was anything to the story; that if he did not hear from me within that time, he could take it for granted that there is nothing to the rumor.

MELIORANDUM FOR THE DIRECTOR

Re: Bremer Case.

SAC Richmond telephoned me from the Trenton Office to discuss the plant being maintained by the Agents of his office at the drug store in Atlantic City. He said that he has five men tied up on this plant at this time, which, with the other plants going, leaves him with only two men in the office, both of whom are accountants. Mr. Richmond said that further questioning of the people in the drug store reveals that they insist the men in question was five feet nine or nine and ahalf inches in height, while Campbell is only five feet five inches; that, - however, they state the photograph of Campbell is very identical with the man who they saw in the drug store. Mr. Richmond said that the man in question has not been seen since, and has not been back in the drug store.

In view of the discrepancy in the description of the person thought to be Campbell, and the necessity for five men to work on this plant, Mr. Richmond said he wanted to suggest that he withdraw all of the men with the exception of Agent Erwin, who is working on the cigar counter in the drug store. He said that in the event this person comes in, Erwin can get a look at him and quickly change from his drug store coat to his street coat and follow the man if possible or get license numbers, descriptions, etc.

I believe that this action is desirable under the circumstances, and told Mr. Richmond that he might remove all of the men with the exception of Erwin; that, however, arrangements ought to be made for the Agents working in Atlantic City to be advised immediately in the event this person makes his appearance again.

#### MEMORANDUM FOR THE DIRECTOR

Re: Bremer Case.

I telephoned Mr. Connelley at the Little Rock Office with refer ence to the teletype from the Cleveland Office stating that the suggestion had been made by Mr. Connelley that the Bureau send six additional men into that district at once to conduct investigation and work telephone taps in connection with the follow-up investigation in that district in this case.

I told him that while we will, of course, authorize the requested expenditures, and will send the Agents in for him, what we particularly wanted to know at this time is what kind of Agents he desires for this latest investigation; that is, men who can just work a telephone tap, or men who will be able to take some definite and affirmative responsibility and action in the event of an emergency situation. Mr. Connelley said he wants the kind of men who can not only work telephone taps, etc., but who will be heavy enough to take the appropriate action in the event something tangible is obtained.

In this regard, I pointed out to him that most of the men of this type were sent into the Little Rock district in connection with the Hot Springs lead, and consequently, the pickings are rather slim at this time. Further discussion of the subject resulted in Mr. Connelley's stating that he will look over the men who are with him in Little Rock and discuss with Mr. Brantley the situation in the Little Rock and Oklahoma City districts, and see if five or six men can't be taken out of there and sent into the Cleveland district to cover the instant need. He said, incidentally, that he would like to leave four or five men in Little Rock to take care of any situation which might arise at Hot Springs, Arkansas. He said that he has been talking with this Grace Goldstein, and while she denies she is a contact for the gang, she has agreed to try to turn them up for us. Mr. Connelley said that he would teletype the Bureau what Agents he would recommend for the Cleveland need.

Hereafter when Agents are needed on cases such as this, I will see that some of the new men are given an opportunity to get some experience, in order that the number of men qualified to perform such work may be increased.

### MEMORANDUM FOR THE DIRECTOR

Re: Alvin Karpis

I talked with SAC Richmond of the Trenton Office about the lead on Karpis, and told him that after his call to me last evening, I had discussed this matter with you; that you had pointed out that you have personal knowledge that Karpis used to go into a drug store located near 10th and the Board Walk, which drug store is operated by reliable and intelligent people who know Karpis when they see him. Mr. Richmond said that the drug store in question is a Whelan Drug Store located at Illinois and the Board Walk, directly across the street from the Traymore Hotel on Illinois. I then told Mr. Richmond that you had particularly wanted to caution him about the Atlantic City Police Department. Mr. Richmond said that he is fully aware of the situation and tactics of the Atlantic City Police Department, and will certainly take the proper steps and act in such a manner as to offset anything on their part.

Mr. Richmond said that he and the Agents arrived in Atlantic City about nine o'clocklast evening, and talked to both the man and the woman in the drug store in question. They state that the person in question is not Karpis, but Campbell. They state that on Sunday, this person who they believe to be Campbell, came into the drug store and sat down and ordered something to eat. He then paid his check and went out. This person was about five feet and seven inches tall. Later, a dark man with a mustache came in accompanied by a girl. They had bouillon, paid their check and departed. Approximately the same thing happened again yesterday. These persons; that is, the dark man with the mustache, and the girl, came in, had their bouillon, paid their check and left.

Mr. Richmond was favorably impressed with the attitude and actions of the persons in the drug store; that is, they are conservative enough to say that they cannot positively state the person in question is Campbell from the photographs, but state that if the photograph were older, the two would appear more identical. It occurred to Mr. Richmond that possibly this dark man with the mustache, who is about as talk as Karpis, could in fact be Karpis, and this is being kept in mind during the course of the investigation.

The Bureau will be advised of developments in this matter.

SAC Richmond telephoned me from Atlantic City to report the developments in the investigation of this case in that city.

Robert Lehman, a clerk in the drug store located across the street from the Traymore Hotel on the Board Walk at the corner of Illinois, stated that on Sunday night after 9:30 o'clock, and again Tuesday at three o'clock, one man came into the store, who he recognized as Campbell. The reason Lehman recognized this man is because about a year ago, the day before the shooting scrape in Atlantic City, this same person had come into the store, and after the photographs had appeared in the newspapers, he recognized Campbell as being that person. A year ago, this same man went into the wash room in the basement of the drug store, at which time he was accompanied by a woman who was pregnant. Lehman said that this same fellow came into the store in the Summer of 1934. In view of the fact that this man comes rather regularly into the store, it appears desirable to arrange a plent in the store. In this connection, Special Agent Erwin can work behind the cigar counter in the drug store, he having worked in a drug store in Washington for some years. Down the street a few yards is a garage from which the Agents can maintain a surveillance on the drug store, and where they can cover a direct-line telephone from the drug store.

On both Sunday and Tuesday of this week, the person identified as Campbell came into the drug store alone, and left alone. On each of Sunday and Tuesday before Campbell left, the tall dark man with the mustache came into the drug store with a woman. On Sunday, the woman was a brunette, but on Tuesday, the woman had a reddish tint to her hair. This man and woman do not come into the store at exactly the same time, but the man comes in first, orders two cups of bouillon, drinks them, and then the woman comes in, gets the check, pays it, and they depart together. On Tuesday, Lehman got suspicious of these parties, and watched out the window after the man with the mustache and the woman left, whereupon he observed them getting into what he termed as a greyish, bluish, greenish automobile, which he believes was a taxicab. In this cabat the time they got in were a man, a woman and the driver. Lehman did not get the license number, he does not know what color the license tags were, but believes it m ght have RECORDED been a New Jersey license.

The thing we should do at this time is to locate and interview the driver of this cab, if in fact the automobile into which they got was a cab. The doorman at the Traymore and various persons along the Board Walk and taxicab drivers could, of course, be questioned, but to do so would arouse suspicion. There are only two persons on the entire Atlantic City Police Department who we can trust, and these two are the Board Walk detail, who have occasion to question the cab drivers and others about various things almost every day. In this connection, it is believed that we can ask these two officers to question the cab drivers along the Walk and others who frequent or remain there for the purpose of determining if they noticed a car of the description of the car in question pick up these two persons at the time specified. Both of these police officers know about the instant investigation, and we could not hurt ourselves any at this time by asking them to make this one inquiry for us. We do not desire, of course, that the Atlantic City Police have anything further to do with this matter if we can help it, and it appears that as a matter of fact, they do not particularly desire to have anything to do with it. The Atlantic City Police got into a jam over the other deal, and the Chief of Police and the Captain who reported this matter to Mr. Richmond told him this morning that anything he wanted was all right.

Elizabeth Paulin, a woman clerk in the drug store, on Sunday identified Campbell at the time he came in, and got so excited that she could hardly talk when she asked him for his order.

The only connection between No. 1 Man (Campbell) and the other, referred to as No. 2 Man, is the fact that the people in the drug storebelieve that the person already in the automobile at the time No. 2 Man and the women got in was in fact No. 1 Man, although they are not sure, and never saw No. 1 Man get into the automobile in question.

Mr. Richmond said that they have to locate this automobile and interview the driver in order to find out just what is what, efter which they are going to consider placing the plant in the drug store mentioned in the first paragraph of this memorandum. He said that the plant will as a matter of necessity have to be an elaborate affair, and they want to ascertain if possible the identity of these persons before starting it.

All of the foregoing articles are transmitted under cellophane cover.

A large black suitcase was packed with various articles of clothing taken from all over the house and brought to the Little Rock Office.

Agents who assisted in the gathering of the material herein mentioned, were Paul Hansen, J. C. Mertz, A. P. Barber, C. O. Hurt, L. E. Kingman and Dwight Brantley.

Extensive efforts were made to develop latent fingerprints on smooth surfaces, such as woodwork, mantels, furniture, light globes, bedsteds, etc., with negative results. The apparent reason for the lack of success in developing any prints is attributable to the fact that the surfaces mentioned have been exposed for some time to the elements and dust and were impregnated with dust and dirt, to the extent that the powder on tops of tables and entire fronts of dressers failed to bring out even any fragmentary prints.

It is requested that the articles mentioned herein be processed in the Laboratory for latent fingerprints and that any prints obtained be compared with the prints of the following named individuals:

Alvin Karpis, with alieses
Harry Campbell, with alieses
Fred Hunter, with alieses (fingerprint record available at the Bureau)
Milton Lett, with alieses.



A report containing the results of a fingerprint examination of the various bottles will be ferwarded to your office upon completion of photographs which are now in the process of development.

In connection with the submittal of these bottles it was noticed upon their receipt in the Bureau that they were loosely wrapped in soft absorbent cotton. It is possible that as a result of this method of packing, latent finger-prints may have been wiped off of these articles during the course of their shipment. In addition, in one of the cases containing these glass specimens it was found that the bottles were piled on top of each other and that three of them were broken. It is suggested in the future that articles bearing latent finger-prints be wrapped in cellophane or packed in such a manner that the continuous

Louis (Snipe) Thornton, an adopted brother of Ted Thornton, Nevada, Missouri, was apprehended by Agents near Anderson, Missouri, on the night of March 19, 1936 in connection with efforts to locate Milton Lett. Thornton confidentially advised Special Agents G. H. Franklin and W. E. Hopton on the afternoon of March 21, 1936, that he knew the source from which Agents learned of his location and stated that it came from Charles McCabe, Coffeyville, Kansas. However, Thornton states he has no bitter feeling whatever toward McCabe and mentioned that this individual holds the confidence of the underworld and is in a very good position to get a line on the location of Milton Lett.

Thornton stated also that in addition to McCabe the following persons usually have some idea where Lett is located. His mother, who resides near Wann, Oklahoma; a sister, who resides about two miles north and two miles east of Lett's home near Wann, Oklahoma. He stated also that Clifford Collins, Michita, Kansas is frequently in touch with Lett.

Thornton advised further that about five weeks ago he talked to Al Sherwood, Coffeyville, Kansas for the purpose of ascertaining whether he, Sherwood, could sell a machine gun for him for about \$250.00. At this meeting Sherwood intimated to him, Thornton, that he could probably get in touch with Alvin Karpis. Thornton stated he did not have the machine gun in his possession at that time but knew where he could get one. He would not state how he could do this. It will be recalled that the information relative to the location of William Weaver originally came from Al Sherwood.

RECORDED & INDEXED He further stated that information had come to him from underworld sources that Milton Lett is wanted by the Bureau for questioning because he has received Bremer money. He was jo unable to furnish details concerning this statement.

Thornton stated he feels quite certain Lilton Lett will try to get money to him when he learns that he, Thornton, is in jail. In this connection he suggested that an Agent contact him in about three weeks and in the event he receives any information of value he will furnish same at that time. The Sheriff at Iola, Kansas, took Thornton from the Jackson County Jail, Kansas City, Lissouri, on the evening of March 21, 1936, and removed him to Iola, Kansas, to answer to charges of sale and possession of guns stolen near Iola about six months ago.

It is suggested that the Oklahoma City Office maintain close contact with Charles McCabe and continue their efforts to gain the confidence of this individual.

The report of special gent E. J. Bynn, Claveland, Chie, dated March 24, 1936, contains information that the widow of Charter Marks, former Toledo hoodlan, is one Edith Marks, who resides at 2650 Broadway, Toledo, Chio, telephone number Walbridge 2549, which is also the telephone number of Captain Timiney of the Toledo Police Repertment. Further information was contained in the report of Igent Hynn that Edith Marks has recently been absent from Toledo, and it was thought that she was somewhere in Florids; however, she recently appeared in Toledo, and it was not definitely known where she was during her absence.

It appears that Edith Merks is not identical with the Holon Marks referred to in the reference report of Agent Euran, and it is therefore suggested that the leads set forth in the report of Agent Euran not be covered at the present time and that the same be held in abovance until further information is obtained concerning the identity of Helan Marks and har possible connection with the fugitives in this case. This is formation might possibly be secured in the future insecuce as a telephone tap has been placed on the telephone of John B. Davenport at Minneapolis, Minneapor, from which telephone the telephone number Nevada 5563 at Chicago, Illinois, was called on November 5, 1935. It is possible that further telephone calls

#### MEGORANDUM FOR THE DIRECTOR

Re: Leak on Publicity in Bremer Case.

During a telephonic conversation with Mr. Connelley at Little Rock, Arkansas, I mentioned the inquiry which the Cleveland Office is making relative to the above matter, advising him that SAC MacFarland told me that he, Connelley, did not think that certain inquiries should be made in connection with the matter. I pointed out to Mr. Connelley that what you want in this situation is complete and correct information as to the names of the ranking officials of the organizations with which persons who gave out this information are connected.

Mr. Connelley said that at the time he told Mr. MacFarland this, the publicity relative to Karpis had not broken in the Arkansas papers, and the newspapers had only rumors, unconfirmed, of someone they thought were Federal Agents proceeding by plane to some undisclosed destination. However, since the publicity has broken in papers all over the United States, and since we have conducted the raid without success, he said that there appears to be no reason why this inquiry can't be carried out completely.

Hopton, in accordance with telephonic request of the latter met him at the Walker Drug Store, Picher, Oklahoma, at which time he stated that he had been with ToriHill, of Coffeyville, Kansas, practically all of that day and had accompanied Hill to Miami, Oklahoma, for the purpose of having him arraigned and getting his bond fixed at a low figure in order that Hill could furnish same. He stated also that he succeeded in postponing the trial indefinitely. RECORDED & INDEXED APR 3-1936 As has been previously stated n indictment was returned against Tom Hill in Miami, Oklahoma, several weeks ago for possessing stolen property. In addition to assisting ... 36 Hill, as stated above, for which stated he expects to receive information from Hill concerning Karpis and Campbell. stated he eliminated all suspicion by telling Hill that he could turn a couple of large diamonds to exhibitors in the motion picture industry and if he, Hill, could put him in touch with the C. boys, meaning Karpis and Campbell, he would put the proposition to them, and in that manner they all could make a few thousand stated that Tom Hill informed him he last dollars apiece. saw Karpis and Campbell about seven months ago at which time they stopped for a few moments at Hill's airport in South Coffeyville, said he was unable to ascertain where the Subjects Oklahoma had come from or where they were going at that time. He stated that Tom Hill did not say anything to him about any effort on his part during the last seven months to get 角 touch with Karpis or Campbell nor did Tom Hill say where he might contact them. He in-S DESPROYE dicated that he has not attempted to reach them inasmuch as he has lost interest in the boys, especially in view of his recent conviction at Independence, Kansas, which he blames, to a great extent, on the testimony given by Jimmy Lawson, tioned to him the following contacts of Karpis and Campbell through

which he would locate them if he were interested in doing so:

"Red" Henderschott, Peoria, Illinois, exact address unknown. As stated by this individual formerly worked for Tom Hill at his airport in South Coffeyville and is now living in Peoria, Illinois. According to Tom Hill told him that Henderschott frequently harbors Karpis and Campbell at his place in Peoria, for which he receives a substantial sum of money from them.

An individual by the name of Wimbish, who is colored and reported to be a shrewd lawyer in Chicago, Illinois, is supposed to be an important contact of Karpis and Campbell when they are in the vicinity of Chicago. Stated he has met Wimbish and known he owns some large holdings in the state of Oklahoma.

Jack Starr, Shreveport, Louisiana, is supposed to be a contact of the Subjects. His exact address was not furnished by However, he mentioned this party has a criminal record and is known to be engaged in various criminal activities. He stated that Jack Starr is a nephew of Henry Starr, who was a notorious bandit in the Southwest.

An individual known as "Chick", whose address is 720 College Street, Jackson, Mississippi, was mentioned as a contact.

George Eason, Riverton, Wyoming, is supposed to be a contact for the gang.

He stated an individual known as "Virginia", who operates a rooming house or apartment hotel called Virginia's Place, located in Duluth, Minnesota, is a spot where Subjects spend a little time when in that vicinity.

J. C. Murray, Box 352, Sand Springs, Oklahoma, was mentioned by as a likely contact for Karpis and Campbell.

He stated that the gang, when in the vicinity of Tulsa, Oklahoma, would get in touch with Ray Watson, through his sister Mildred Watson, who resides at 1118 East 6th Street, Tulsa, Oklahoma. Claims to know Ray and Mildred Watson. He stated also he received information from Hill that a red headed girl, name unknown, address 315 South Frisco Street, Tulsa, Oklahoma, is a girl friend of either Karpis or Campbell. He stated this girl gives steam baths.

Willie Mason, 120 L.A. Street, Durant, Oklahoma, was mentioned as a contact of the Subjects.

Mention was made also of Mrs. Katie Shepard, who spends a great deal of her time at the Annex Hotel, Tulsa, Oklahoma, and

whose grandmother owns a farm near Bentley, Oklahoma. With respect to this individual it is noted in the report of Special Agent Paul Hanson, Oklahoma City, dated 8-24-34 that Fiami, Oklahoma, informed that Catherine Shepard is a likely contact of the Barker Karpis gang. As noted in the Summary Report of Special Agent Paul Hanson, Oklahoma City, dated 2-26-36, Catherine Shepard, 5182 East 3rd Street, Tulsa, Oklahoma, is presently being used as an informant of the Oklahoma City Office.

mentioned the name of Les VanCleave, 2521 East 7th Street, Joplin, Missouri, as a possible contact of Subjects.

He advised further that Tom Hill stated to him that he had been propositioned by Kansas Authorities that he would not spend a single day in jail if he would tell where Karpis and Campbell are presently located.

also advised that the gang formerly dropped into Picher, Oklahoma, and would put up at the Connell Hotel, which is owned by Tom Hill and operated by his cousin, "Red" Hill.

Campbell through the above individuals that he would be willing to quit his job with Warner Brothers, at which place he makes \$5.00 per day, and start out in his own automobile and locate them in order that he might receive the sum offered by the Bureau for confidential information relative to their location. However, he stated he would expect the Bureau to pay his expenses, which he figured would be \$15.00 per week for a period not to exceed six weeks. In this connection he stated he would agree to let an Agent accompany him or keep in touch with him at all times. When asked how he would go about locating Subjects he stated he would first go to Shreveport, Louisiana, then to Jackson, Mississippi, Peoria, Illinois and Chicago, Illinois and make connections with the above contacts.

There is some doubt as to whether his sincere in his statements in view of the fact he is known to be somewhat of an unreliable although shrewd individual who was formerly the legal advisor and fixer for the Barker-Karpis gang, and also in view of the fact that he requested Special Agent Hopton to contact him at Walker's Drug Store in Picher, Oklahoma, which place, as noted in report of Special Agent Paul Hanson, Oklahoma City, dated 8-28-34, has been previously mentioned by information furnished to her by her husband, as being a contact place for members of the gang. Notwithstanding this it appears

advisable for the various offices receiving copies of this letter to conduct appropriate investigation in its districts to determine whether Karpis and Campbell may be in touch with the individuals listed above.

### MEMORANDUM FOR THE DIRECTOR

Re: Bremer Case.

Mr. Connelley said that one thing which he particularly has in mind is this: They are having Special Agent Frank Smith of the Oklahoma City Office come over there for the purpose of establishing a contact with Dutch Akers, Chief of Detectives at Hot Springs. He said that the Post Office Inspectors have Joe Anderson of the Kansas State Police over at Hot Springs, and they are depending almost entirely on what Anderson can produce. Joe Anderson is acquainted with and friendly to Dutch Akers. Mr. Connelley said that Agent Smith, in addition to being a good friend of Dutch Akers, is also a good friend of Joe Anderson, and Joe Anderson, who is rather talkative, will undoubtedly give Smith everything he gets even before he gives it to the Post Office Inspectors.

With reference to the situation of this fellow Rochet in Ohio, Mr. Connelley said that the Agents and the Post Office Inspectors have Rochet under observation, and he is to be taken shortly into custody. He said that while there is an automobile in the garage at the house, there are no indications that anyone is in the house with the exception of Rochet, although a possibility exists that Milton Lett might be there. Rochet is one of the contacts of Clayton Hall, the informant who gave us the information resulting in the investigation in Hot Springs.

I asked Mr. Connelley what he intended to do with Zetzer, who is the airplane pilot who flew Karpis and Campbell right after the Atlantic City affair. He said that he was talking with MacFarland relative to this man today, and MacFarland said Zetzer has given us absolutely nothing that will hurt himself, and it appears that he does not intend to do so. Consequently, Mr. Connelley said he had in mind asking the Post Office Inspectors if they want him. If the Inspectors do not want him, we will put him in the status of a confidential informant, and turn him out to get certain information, which, of course, he will not get. We will get rid of him in this manner. However, Mr. Connelley said that he believes the Post Office Inspectors will file on him if we turn him over to them.



OBremer Case.

I contacted Mr. Connelley in Little Rock with ference selection of Agents to be sent to Cleveland to assist in the <u>investig</u>s in that district, and pointed out to him that he has selected Agent Barber of the Milwaukee Office, and Agents Hurt and Coulter of the Dallas Office. In this connection, I told him that to take Agent Barber from Milwaukee would leave SAC Peterson with about one or two men in the office, and to take the two Agents from Dallas would leave a very few men in the district, thus materially crippling both of those offices. I suggested, therefore, that possibly Agent Madala of the Louisville Office could take the place of Agent Barber, and one of the Agents from Chicago, possibly Boone or Arms, would take the place of one of the men from Dallas. Mr. Connelley said that there is no reason why Madala cannot take the place of Barber, and stated that he would like to have Agent Arms rather than Boone from Chicago to take the place of Coulter. There will be four men left in Little Rock.

Mr. Connelley said that he is going to remain in Little Rock for another two or three days, stating that this Grace Goldstein, while agreeing to give us information if possible as to the subjects or their contacts, has not in his opinion told us all she knows about this metter. Mr. Connelley said that the Post Office Inspectors and Joe Anderson have some man over in Hot Springs tho they are questioning about this matter, and the indications are that the Chief of Police at Hot Springs and this prostitute went out to this hideout of the subjects and got their clothing, etc., after they had left, this possibly accounting for the lights having been seen in the house on either Saturday or Sunday night.

Mr. Connelley said that Agents Barber and Coulter would get out of their for their respective headquarters today.
