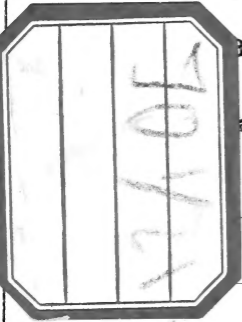

Witnesseth: That for and in consideration of the covenants hereinafter entered into by the said party of the first part, said part..... of the second part does hereby purchase of said party of the first part the quantities and varieties of seeds below named, and agrees to pay therefor at the prices attached to the seeds contracted below on a basis of sixty days net acceptance from date of shipment, or 2 per cent. discount if paid on receipt of goods.

Said first party in consideration of the foregoing, does agree to cause to have planted sufficient seed or roots to ordinarily produce the quantities of seed named herein and amounts set opposite each variety below contracted, provided the season permits the growing of same, but in event of short crops will fill pro rata only, then such quantity or quantities will be accepted by the said second party on the terms, conditions and stipulations herein outlined and set forth as a complete fulfillment of the contract herein entered into; to deliver said seed f. o. b. cars at nearest California point with the conditions being expressly understood and agreed to by both parties to this contract.

Shipments to be made as soon as possible after the harvest of..... crops.

Bags and containers will be charged at cost.

It is further agreed by both parties hereto that said party of the first part gives no warranty, express or implied, as to description, quality, productiveness, or any other matter pertaining to the seeds herein contracted, said seeds being sold under the usual seedsmen's disclaimer, and that this order is taken subject to the approval of, and confirmation of the Braslan Seed Growers Company, Inc., by an authorized officer thereof.
