Terms: Our terms are net cash in sixty days from date of invoice, less 2% for cash in 30 days from date of invoice. All seeds f. o. b. our shipping point.

WITNESSETH, That for and in consideration of the covenants hereinafter entered into by the said party of the first part, said party of the second part does hereby purchase of said first party the quantities and varieties of seeds hereinafter named, and agree to pay therefor at the prices attached, on a basis of 60 days' acceptance, or 2 per cent discount for cash within 30 days from date of invoice.

Said first party, in consideration of the foregoing, does agree to cause to have planted sufficient seed or roots to ordinarily produce the quantities of seeds named herein and amounts set opposite each variety below, provided the season permits the growing of same; to deliver said seed on cars at our shipping points. Shipments to be made to the party of the second part as soon as possible after the harvest of 192.....
