SUBJECT: PROPOSED STUDY ON THE "PLYING SAUCERS" PREMOMENA; INTELLIBENCE ADVISORY COMMITTEE

Pursuant to instructions, Surervisor M.W. Euhrtz of the Lisison Section attended the Intelligence Advisory Committee (IAC) meeting on December 4, 1952.

None of the igends items are of direct interest to the Bureau; however, directed the members' attention to some aspects of the "flying saucers" phenomens. He said that a recent presentation of a theory on "saucers" was made by a Germin atimic scientist, which fact has cased the British to initiate confiderable intelligence effort into this matter. According to the forts are being made to obtain the German scientist's paper on this theory. Also, it was stated that a recent "saucers" observation in Africa presents some evidence that the "saucers" are not a meteorological phenomena, which theory has been held to date by the Air Force. Instead, this latter incident indicated the possibility of the "saucers" being a scientific development. The details of this African observation were not presented; however, appropriate contact will be made by the Fursau's Ligisan Baction with the Air Force to determine the details of this latter meront.

As a result of the above, the Military members suggested a logical abreach which would call for a group of scientists to make a study of the new "saucers" data in an effort to identify the phenomena. If an identification can be rade by the scientists and it can be determined that the "saucers" are a scientific development, then IAC should determine a further course of action for the U.S. Government. It was further suggested that the IAC should only concern itself with this matter on the basis that a competent scientific group right determine the "seaucers" to be a scientific development under the control of our energy.

IAC consideration. Upon receipt of this draft, appropriate Bureau recommendations will be made prior to IAC appropriate.

ACTION: Lieison will obtain the details of the "flying saucers" observation in Africa from the Air Porce. - Makelw
