At the suggestion of the Department, the New Orleans and Memphis Offices are conducting an investigation of the "Association of Citizens Councils (of Mississippi)" for consideration by the Department pursuant to Executive Order 10450.

The Mobile Office is also conducting an investigation on the Citizens Councils of Alabama.

The first Citizens Council was organized July 11, 1954, at Indianola, Mississippi, and as of February, 1955, councils were formed in twenty-five counties of Mississippi with a total membership of approximately 30,000. The Citizens Councils of Alabama pattern after the councils organized in Mississippi and were first formed in Selma, Alabama, in October, 1954.

The Citizens Councils disclaim affiliation with or similarity to the Ku Klux Klan. The stated objectives include discouraging Negroes from voting and maintaining segregation in public schools. These objectives are being carried out by economic pressure brought to bear on Negroes seeking to vote or who are in favor of integration in schools. The councils claim no violence will be used and only legal means employed.

All offices receiving copies of this letter are instructed to be alert for the formation of Citizens Councils in the territory covered by your offices. Upon the receipt of such information you should advise the Bureau immediately by letter setting forth all pertinent data concerning the organization and the offices thereof. No investigation should be conducted without prior Bureau authority.

Soviet citizens are to be placed into effect immediately. They were also advised that despite the exemptions set forth in the note to the Soviet Ambassador, source material of any type (such as Coast Pilots and Tide Tables) which supplement navigational and hydrographic maps and charts will not be made available for procurement by Soviet citizens in the United States.

(N) CITIZENS COUNCILS AND STATES' RIGHTS MOVEMENTS - INTERNAL SECURITY
--X -- Since Supreme Court decision of May 17, 1954, re integration of Negroes and whites in public schools, autonomous organizations under various names have been formed in ten states for the ostensible purpose of maintaining segregation. These organizations are for the most part made up of prominent citizens who are opposed to any use of force and violence. These groups disclaim affiliation with or similarity to the Ku Klux Klan and avowedly intend to achieve their objective by exerting economic pressure on members of the National Association for the Advancement of Colored People, Negro voters and integrationists.

Bureau policy is that we do not investigate groups that advocate and employ legal means to achieve their objective; however, where advisable the field is authorized to investigate organizations established for purpose of combatting or advocating affirmative action against racial minorities or seeking to deprive individuals of their rights under the Constitution.

Upon receipt of information concerning formation of such an organization in your territory you should advise the Bureau immediately by letter setting forth pertinent data relative to the organization and individuals connected therewith. No investigation should be conducted without prior Bureau authority.

The Department has advised that conspiracy to injure or intimidate Negro citizens in their rights to vote by threats of personal injury, application of economic pressure or otherwise, would seem to be violative of the provisions of Title 18, U.S.C. 241. At such time as integration is made mandatory under the Supreme Court decision of May 31, 1955, or prior thereto, these organizations or individual members may take extralegal action possibly resulting in civil rights violations. I am vitally concerned with this possibility and desire that we have complete data relative to these organizations and their members prior to any incidents which may take place. You will be held personally responsible to furnish the

Bureau promptly data relative to the formation of these organizations and thereafter to take necessary action to keep the Bureau apprised on a continuing basis of all pertinent developments.

In view of the nature of these groups, your inquiries should be handled most discreetly in order to avoid any embarrassment to the Bureau. Whenever possible inquiries should be directed to established reliable sources only.

For your information reports submitted on these organizations will be furnished the Department for consideration under Executive Order 10450 whereby the Attorney General may designate any organization which has "adopted a policy of advocating or approving the commission of acts of force and violence to deny others their rights under the Constitution of the United States."

A meeting of the Citizens Council at Orangeburg, S. C., on Monday evening, August 29, 1955, drew a crowd of more than 3500, according to an article in The Times and Democrat, daily newspaper at Orangeburg, S. C., in its issue of 8/31/55. The article stated speakers included State Senator MARSHALL WILLIAMS, former U. S. Representative HUGO S. SIMS, and former State Senator T. D. ERYANT, Jr., now chairman of the South Carolina State Probation, Pardon and Parole Board.

Press reports concerning these organizations, which reports are the basis of all information set forth above, have not indicated whether these local groups are connected with a state organization.

ReBulet to Atlanta, 3/22/55, and mylet to Bureau 9/2/55, both with copies for other offices listed below, and SAC Letter 55-40, dated 6/21/55, Paragraph N.

My letter of 9/2/55 listed 11 places in South Carolina where local Citizens Councils had been organized. These Councils are mushrooming in lower South Carolina, particularly where the number of Negro inhabitants exceeds the white population. Overflow crowds are attending the meetings, the meetings are being widely publicized, and speakers and officers are for the most part men prominent in business life, the professions, and politics. Ministers of various denominations and mayors of some of the towns are participating in the programs. Members are being solicited through public advertising for a membership fee of \$2.00 each. Employees of at least one municipal government (Orangeburg) have had their affiliation publicly sanctioned by the Mayor and City Council.

Lieutenant Governor ERNEST F. HOLLINGS of South Carolina has accepted an invitation to attend the permanent organizational meeting of the Citizens Council of Charleston, S.C., on 9/27/55. That particular council has succeeded the Charleston County States Rights League. The Governor of South Carolina has been invited to this meeting.

The office of Senator OLIN D. JOHNSTON of South Carolina has stated the Senator "expressed his absolute agreement with the principles of the various Citizens Councils that are being organized throughout South Carolina."

Citizens Councils have now been organized at the following additional places in South Carolina:

Publications of the Association of Citizens Councils, Winona, Mississippi, are being distributed at some or possibly all of the organizational meetings.

At least one of the councils, that at Orangeburg, has obtained a State Charter of incorporation. This group is incorporated in perpetuity as a non-profit group whose purposes are set forth in the charter:

"To maintain good relations among the members of all races residing in School District #5, City of Orangeburg, Orangeburg County.

"To oppose the use of force by radicals and reactionaries who attempt to disrupt the peace and good relations among the races of this area.

"To make every legal and moral effort to save the segregated public schools.

"To study ways and means for providing an adequate education for children in School District #5 if radicals and agitators force the abandonment of the public schools.

"To acquaint well-meaning, but misled, public officials from outside South Carolina with the local conditions and attitudes which make integration impossible in said school district.

"To acquaint officials with the fact that the vast majority of the citizens of said school district, both white and colored, favor continuing segregation in the public schools."

Purposes of various councils have been set forth more informally in various press reports, which reports are the basis of all information contained herein. For example, the Orangeburg Council upon initial organization declared, among other things, it would "combat all efforts of the NAACP with every means at its command but without the use of violence."

A moving factor and frequent speaker at the various meetings has been S. E. ROGERS, an Attorney of Summerton, S. C., who represented Clarendon County in the school segregation litigation resulting in the Supreme Court decision of May 17, 1954. Mr. ROGERS was quoted in the Morning News of Florence, S.C., on 5/30/55, as saying before a meeting at Lake City "that he is practicing economic discrimination against signers of petitions sponsored by the NAACP."

An article in the Columbia Record, Columbia, S. C., of 9/7/55 quoted Mr. ROGERS as saying, "I don't condone economic pressures or anything like that. I would like to see an equitable solution that would be for the good of both races involved."

On 7/30/55 a petition prepared by the NAACP was presented to the Board of Trustees of District #5 (Orangeburg) asking that "immediate, concrete steps be taken to reorganize the public schools on a non-discriminatory basis." This petition bore the signatures of 57 individuals who said they were parents of school age children. As of 9/10/55, the number of signatures on this

petition had been reduced to 34 because of the number of requests by original signers that their names be stricken from the petition.

A similar petition filed with the Elore School District containing 38 signatures has been reduced by at least 14. Twenty-five of 126 signers of two petitions in Sumter County had withdrawn their signatures as of 9/1/55. One of the individuals who withdrew his signature pointed out he was a college graduate and that the petition he signed was not the petition which was presented to the school board in District 17.

The NAACP, also according to press reports, is quietly negotiating with officials of major firms to take action against southern employers and franchise holder who apply economic pressures to NAACP members.

CLARENCE MITCHELL, Director of the Washington Bureau of the NAACP, has been quoted as saying, "We are trying to put out the fire and if we can do it by building a bigger fire, that's what we'll do."

Another Washington representative of the NAACP has indicated that organization intends to appeal to the courts.

No investigation being undertaken on the basis of this newly developed information UACB.

(E) CITIZENS COUNCILS AND STATES' RIGHTS MOVEMENTS - INTERNAL SECURITY - X -- Re SAC Letters 54-67(C) and 55-40(N).

Bureau inquiries concerning citizens councils and similar organizations engaged in pro-segregation activities have as their purpose: (1) to ascertain the influence in the organizations of Ku Klux Klan members and other advocates of illegal repressive tactics against minorities, (2) to determine whether their programs and activities bring groups within the purview of Executive Order 10450, and (3) to develop data indicating groups' potential for violence.

Conduct these inquiries strictly in accordance with the policy outlined below:

1. Advise Bureau promptly of formation of organizations; furnish on a continuing basis any additional pertinent data received.

2. Conduct no overt inquiry in absence of specific Bureau instructions.

3. Confine inquiries ordered by Bureau to contacts with established reliable sources who have been advised of our objectives and clearly understand the Bureau is not interested in nor inquiring concerning legitimate activities of responsible citizens groups.

4. The term "established sources" means public records, informants, confidential sources, panel sources, sources of information or citizens who in time-proved dealings have been found discreet, reliable and are in a position to furnish or obtain pertinent information.

5. Convert inquiries to full-scale investigations under 87D, Manual of Instructions, only on specific Bureau instructions.

Subject to the limitations of available coverage, reports, should reflect the founding, principles, aims and purposes, methods employed or advocated, identity of the officers and persons who are controlling figures within the organizations and describe any reported activities of interest engaged in by the organizations or their members.

(F) OPERATION CRACKER JACK - U. S. AIR FORCE -- The Office of Special Investigations (OSI) has advised that the above exercise is a simulated air strike against Greenland, Alaska, Canada, and the United States, which will take place between December 1, 1955, and February 15, 1956. Units of the Strategic Air Command will make up the strike force, while the Continental Air Defense Command, the Alaskan Air Command and the Royal Canadian Air Force will participate as defenders in their respective areas of responsibility.

OSI has advised that there will be a news release advising that such an exercise will be held during the winter, but that the exact date and time for the planned strike is classified Top Secret. It is of vital importance that the exact magnitude and time of the strike be afforded maximum security. All OSI district offices have been instructed to contact the local field offices of the FBI advising them of the proposed exercise and soliciting cooperation in the prompt reporting of any pertinent information. All offices should be alert for any information concerning the above exercise indicating unauthorized disclosure or compromise. Pertinent information should be promptly furnished to the Bureau and to the OSI locally.

(G) DOCUMENTATION - JOHN CARTER VINCENT -- SAC Letter 55-44 (P) set forth a brief summary of Supreme Court decision in case of John Punnett Peters. SAC Letter 55-56 (E) contained instructions regarding documentation of Peters and John Stewart Service. Vincent, former State Department employee, investigated under Executive Order 9835. After favorable decision by employing agency, Loyalty Review Board by memorandum dated July 3, 1953, advised Vincent "retired after adverse decision on loyalty by Loyalty Review Board." Civil Service Commission considers this case analogous to John Punnett Peters v. Hobby where Supreme Court ordered Civil

The Bureau has seen fit to restate the purposes of Bureau inquiries relative to citizens councils and similar organizations purportedly engaged in pro-segregation activities, as follows:

1. To ascertain the influence in the organizations of Ku Klux Klan members and other advocates of illegal repressive tactics against minorities.
2. To determine whether their programs and activities bring groups within the purview of Executive Order 10450.
3. To develop data indicating groups' potential for violence.

The Bureau instructed that inquiries be conducted strictly in accordance with the policies mentioned as follows:

The Bureau is to be promptly advised of the formation of any such organizations, and the Bureau is to be kept currently advised, on a continuing basis, of any additional pertinent data developed.

Unless Bureau specifically so instructs, no overt inquiry is to be conducted.

Such inquiries as are ordered by the Bureau should be limited to contacts with established reliable sources, who have been advised of our objectives and who understand clearly that the Bureau is not interested in nor inquiring concerning legitimate activities of responsible citizens groups.

The Bureau further pointed out that the term "established sources" means public records, informants, confidential sources, panel sources, sources of information, or citizens with whom we have had dealings in the past and who have been found to be reliable, discreet and in position to make available pertinent data.

Inquiries are to be converted to full scale investigations as provided in Section 87-D, Manual of Instructions only when specific instructions so to do are given by the Bureau.

Information received at the Bureau relative to citizens councils which have been formed for the purpose of perpetuating segregation indicates racial tension is mounting in connection with this situation. In one state two Negro organizations have been formed for the purpose of combating the activities of the citizens councils. It is not unlikely that similar organizations will be formed in other states.

Under review

Each office receiving copies of this letter is instructed to furnish the Bureau no later than November 14, 1955, a succinct summary of the racial situation in the territory covered by that office. This summary should include detailed information regarding incidents which have arisen in connection with the problem of segregation; the names of any organizations formed for the purpose of perpetuating or dissolving segregation; information concerning the potential for violence of groups formed; outside influence being asserted on pro-segregation and anti-segregation organizations, such as by the Communist Party, and any additional information which will give the Bureau a complete picture of the racial situation as it now exists in relation to the segregation question.

Thereafter, the Bureau should be furnished promptly any pertinent information received relative to racial tension in connection with the citizens councils or their opposites.

Each office receiving copies of this letter is conducting inquiries concerning pro-segregation organizations which have been formed in opposition to integration of Negroes and whites in public schools. The reports being submitted concerning these groups are furnished the Department for its consideration in connection with the provisions of Executive Order 10450.

The Department has advised that "In connection with designation under Executive Order No. 10450, it would be necessary to show that such an organization adopted a policy of advocating or approving the commission of acts of force or violence to deny others their rights under the Constitution. While the Executive Order refers only to organizational policy, the acts of individual members thereof might reflect such policy. It is requested therefore that you bring to our attention, insofar as may be practical, all acts of force or violence committed by individuals who are members of such captioned organizations."

In accordance with the above request of the Department, each office receiving copies of this letter is instructed to promptly furnish the Bureau any pertinent information received relative to acts of force or violence to deny others their rights under the Constitution which are committed by individuals who are members of or connected with any of these pro-segregation organizations.

This report being furnished you does not reflect the results of a full investigation of this organization but only information obtained through limited inquiries being made to ascertain the influence, if any, in this organization of Ku Klux Klan members or others who advocate repressive tactics against minorities; to determine whether its programs and activities bring it within purview of Executive Order 10450; and to develop data regarding this group's potential for violence.

Up to the present time no incidents have arisen in this division which can be directly connected with the problem of segregation.

The American States Rights Association was organized at Birmingham, Ala. on 2-18-54. 269 Alabama citizens signed Articles of Incorporation, which states that the purpose is "to promote and defend the basic principles of states rights and develop economic, social and civic programs for the betterment of the several states." Although the articles of incorporation make no mention of segregation specifically yet the actual activity of this group such as distributing literature and radio broadcasts advocates the retention of a segregated society. This group has held no public meetings since its inception, as far as can be ascertained, and there is no reason to believe this organization plans on using violence to perpetuate segregation.

The Ku Klux Klan organization is functioning in this area in a small way. There is a small Klavern at Tarrant City, which is an incorporated community adjoining Birmingham. About ten members meet weekly. No acts of violence have been committed as far as is known. E. L. EDWARDS, Imperial Wizard of this organization, with headquarters at Atlanta, Ga. has repeatedly stated opposition to violence.

Information has been received that a White Citizens Council has been organized at Tarrant City, Ala. within the past week. Also at Anniston, Ala. since November 1, 1955, attempts have been made to organize a White Citizens Council. These matters will be followed at Anniston and Tarrant City.

The Alabama Council of Human Relations, a new organization affiliated with the Southern Regional Council, an organization which has been in existence for many years, has been meeting for several weeks in Birmingham. The purpose of ACHR is to dissolve segregation. The only indication of Communist Party interest in this group is that

Information has been received which indicates the Department is actively considering designating the Association of Citizens Councils of Mississippi pursuant to Executive Order 10450. As you were advised previously, copies of all reports on prosegregation organizations are furnished the Department for consideration in connection with this Executive Order and the possibility exists that a number of these groups may be designated in the future.

Therefore, it is the responsibility of this Bureau to obtain not only data of an intelligence nature but evidence which may be used at future hearings.

The offices conducting inquiries or investigations of groups advocating the maintenance of segregation are instructed to make arrangements to secure on a regular basis all literature being published by each organization. As an aid in this matter, you are referred to SAC Letter 54-74. An original and one copy of the literature received should be furnished the Bureau by routing slip marked "Attention: Central Research Section." A copy should be retained in the field office file.

Arrangements should be made to have panelists informants and other sources attend meetings of these groups for purpose of obtaining information concerning the aims and objectives thereof and the methods used or advocated to attain these objectives. Any literature distributed at these meetings should be retained by your office for future use. You should not exceed the limitations placed on the field in connection with conducting inquiries relative to these organizations as set out in SAC Letter 55-60 without prior Bureau approval. Two Photostats of pertinent material obtained should be furnished Bureau.

Tuskegee Reports Desegregation Gain

Negro College's President Says Resistance Growing To Laws Drawing Color Line

TUSKEGEE, Dec. 30 (AP)—The South made "defensive progress" toward racial integration in 1955, says Tuskegee Institute, even in areas where tension or conflict predominates.

But there was no indication of "substantial adjustment or of extensive conflict," President L. H. Foster observed in his second annual race relations report.

"There are islands of tension and conflict in areas where adjustment has been made," he commented, "and some measures of adjustment are noted in areas where tension or conflict predominates."

"Over all, there seems to be definite progress toward desegregation."

The race relations report was inaugurated last year to replace the annual lynching survey which the famed Negro school used for two decades to measure white and Negro relationship.

The lynching report was abandoned because Dr. Foster said it no longer accurately mirrors racial feelings.

Looking toward the new year, the Tuskegee president said further improvement in race relations "seems possible through many avenues."

As evidence of progress, Dr. Foster called attention to the growing list of court decisions resulting from basic integration rulings by the Supreme Court.

He also mentioned the interstate Commerce Commission's anti-segregation decree on interstate travel and waiting rooms.

Although no Southern state has enacted legislation to promote desegregation, the Tuskegee report said, efforts to abandon the public school system and enact other laws which would strengthen segregation have frequently met resistance from educational organizations, government administrations and community leaders.

Hundreds of formerly segregated schools have been desegregated without creating serious tensions or conflict, he continued. "In many more communities throughout the South, plans for segregation have been and are being worked out."

There were evidences of rejection, too, Dr. Foster said, and "in many areas of the South, government officials and civic leaders have tended to let matters drift, and there has been very little effective communication between the two racial groups."

As obstacles to integration, the Tuskegee report mentioned:

Passage of a bill by the Alabama Legislature to require a license fee for solicitors in rural Wilcox County where Negroes outnumber white residents; it was aimed at the National Association for the Advancement of Colored People.

Action in Louisiana to authorize the hiring of lawyers to fight segregation suits.

Mississippi's action to use po-

The first Citizens Council was organized July 11, 1954, at Indianola, Mississippi, and as of February, 1955, councils had been formed in twenty-five counties of Mississippi with a total membership of approximately 30,000. The Citizens Councils of Alabama pattern after the councils organized in Mississippi and were first formed in Selma, Alabama, in October, 1954. At the present time (December 8, 1955) only one council has been formed in the Northern District of Alabama. This is the Tarrant, Alabama, Citizens Council, organized on November 19, 1955.

The Citizens Councils disclaim affiliation with, or similarity to, the Ku Klux Klan. The stated objectives include discouraging Negroes from voting and maintaining segregation in public schools. These objectives are being carried out by economic pressure brought to bear on Negroes seeking to vote or who are in favor of integration in schools. The councils claim no violence will be used and only legal means employed.

The Bureau advised on March 22, 1955, that, at the suggestion of the Department, the New Orleans and Memphis Offices were conducting an investigation of the "Association of Citizens

Councils of Mississippi" for consideration by the Department pursuant to Executive Order 10450. The Mobile Office was conducting an investigation of the Citizens Councils of Alabama. The Bureau advised that the indicated offices should be alert for the formation of Citizens Councils in their territory; that upon receipt of such information you should advise the Bureau immediately by letter setting forth all pertinent data concerning the organization and the officers thereof. No investigation should be conducted without Bureau authority.

On June 21, 1955, the Bureau reiterated its stated policy of March 22, 1955, regarding handling of information concerning captioned movements. The Bureau re-emphasized that we do not investigate groups that advocate and employ legal means to achieve their objectives. However, the Bureau pointed out that where advisable the field is authorized to investigate organizations established for the purpose of combatting or advocating affirmative action against racial minorities or seeking to deprive individuals of their rights under the constitution. No investigation is to be conducted without Bureau authority. Bureau further pointed out that conspiracy to injure or intimidate Negro citizens, according to the Department, in their rights to vote by threats of personal injury, application of economic pressure or otherwise, would seem to be violative of

the provisions of Title 18, USC, 241. At such time as integration is made mandatory under the Supreme Court decision of May 21, 1955, or prior thereto, these organizations or individual members may take extra-legal action possibly resulting in civil rights violations. The Bureau wants complete data relative to these organizations and their members prior to any incidents which may take place. The Bureau should be kept advised of the formation of these groups and all pertinent developments concerning them. However, in view of the nature of these groups all inquiries should be handled most discreetly in order to avoid embarrassing the Bureau. Established sources should be contacted when possible. Reports on these organizations will be furnished the Department for consideration under Executive Order 10450.

SAC Letter No. 55-66 dated October 25, 1955, supersedes all previous instructions pertaining to the handling of inquiries concerning captioned groups. Bureau inquiries have as their purpose: (1) to ascertain the influence of Ku Klux Klan members and other advocates of illegal repressive tactics against minorities; (2) to determine whether their programs and activities bring groups within the purview of Executive Order 10450 and (3) to develop data indicating groups' potential for violence. For the most part the policy remains the same. Conduct no overt inquiry in the absence of specific Bureau instructions.

Contact only established sources. This means public records, informants, confidential sources, panel sources, sources of information or citizens who in time-proved dealings have been found reliable and discreet.

The Bureau advised on October 23, 1955, that racial tension is mounting in connection with the organization of captioned groups. Two Negro organizations have been formed in one state for the purpose of combatting the activities of the citizens councils. The same policy prevails concerning the formation of these Negro groups: advise the Bureau promptly but conduct no investigation or inquiry.

On December 6, 1955, the Bureau advised that the Department is apparently actively considering designating the Association of Citizens Councils of Mississippi pursuant to Executive Order 10450. Bureau instructed that all offices concerned in these investigations or inquiries make arrangements to secure, on a regular basis, all literature being published by each organization. An original and one copy of the literature should be furnished the Bureau by routing slip marked: "Attention: Central Research Section." A copy should be retained in the field office file. We should arrange for panelists and other sources to attend meetings of these groups. We should concentrate on getting information which indicates or

reveals the organization has adopted a policy of advocating or approving the commission of acts of force and violence to deny others their rights under the Constitution.

The only other group in the Birmingham territory which apparently is working for segregation and against de-segregation is the American States Rights Association which was organized in Birmingham on February 18, 1954. Two hundred and sixty-nine prominent Alabama citizens signed the Articles of Incorporation for this group, which states that the purpose is "to promote and defend the basic principles of states rights and develop economic, social and civic programs for the betterment of the several states." Although the Articles of Incorporation make no mention of segregation specifically, yet the actual activity of this group, such as distributing literature and radio broadcasts advocates the retention of a segregated society. The American States Rights Association has held no public meetings since its inception, as far as can be ascertained, and there is no reason to believe, from the information received to date, that this organization plans on using force and violence to perpetuate segregation. OLIN H. HORTON, President of this group, apparently is doing quite a bit of research concerning the hiring of Negro police in various cities, etc. His findings are mailed to the membership.

The same policy prevails at this time for handling inquiries concerning the American States' Rights Association as pertains to the Citizens Councils which, of course, has been discussed.

This concludes my remarks concerning Citizens Councils and States Rights Movements and if there are questions we can discuss them now.

Reference is made to Memo All Agents No. 83, dated 11-1-55, wherein you were advised that the purposes of Bureau inquiries relative to citizens councils and similar organizations purportedly engaged in pro-segregation activities are:

1. To ascertain influence of Ku Klux Klan members and other advocates of illegal repressive tactics against minorities.
2. To determine if programs and activities bring groups within purview E.O. 10450.
3. To develop data indicating groups' potential for violence.

You were also advised therein that the Bureau is to be promptly advised of the formation of such councils or organizations and the Bureau should be kept currently advised on a continuing basis. It was also set forth therein that inquiries are to be limited to contacts with established reliable sources, who have been advised of our objectives and who understand clearly that the Bureau is not interested in nor inquiring concerning legitimate activities of responsible citizens groups.

"Established sources" was pointed out to mean public records, informants, confidential sources, panel sources, sources of information, or citizens with whom we have had past dealings and who have been found reliable, discreet, and in position to make available pertinent data.

As you are aware, separate case files are being opened in the Birmingham Division on each citizens council reportedly organized. This is in accordance

The Bureau has instructed that in transmitting copies of the initial report to these local intelligence agencies, the report should be transmitted to each by letter, which letter contains the following statements:

This report being furnished you does not reflect the results of a full investigation of this organization but only information obtained through limited inquiries being made to ascertain the influence, if any, in this organization of Ku Klux Klan members or others who advocate repressive tactics against minorities; to determine whether its programs and activities bring it within the purview of Executive Order 10450; and to develop data regarding this group's potential for violence.

In the event an investigation of this organization is initiated as a result of data obtained through inquiries being conducted, you will be furnished the results of investigation and at that time informed that an investigation rather than an inquiry is being conducted.

The information being furnished you concerning this organization is for your confidential use and should not be disseminated outside your agency.

You are further instructed that reports concerning citizens councils ordinarily should not be classified. As you know, only those reports containing information, the protection of which is necessary in the interest of national defense, are to be classified. If, however, a

report concerning a citizens council contains such information, it should be appropriately classified.

It is mandatory that each Agent follow strictly the requirements relative to the preparation of reports concerning these matters. The fact that these matters are handled as limited inquiries does not alter the prevailing administrative regulations which render delinquent a case in which no report or other postable communication has been submitted within 45 days.

With regard to the use of individuals to obtain information on Citizens Councils and States' Rights Movements, no additional 134 files should be opened merely because such individuals are used from time to time on these matters. If an individual is furnishing considerable assistance you should consider opening a 134 file and handle in accordance with Section 107 C of the Manual of Instructions.

Concerning payments to such individuals, the SAC is authorized to pay up to \$100 to anyone for information of value relating to security matters. In utilizing this authority the SAC must justify the payment on appropriate blue slip. If an individual is furnishing considerable information on security matters and it is necessary to pay him more than \$100 or authority is desired to make regular payments, a recommendation to make such payments should be submitted to the Bureau in accordance with Section 107 N of the Manual of Instructions.

Although reports have been submitted to the Department on all citizens councils concerning which we have conducted investigations and inquiries to date, the Department has indicated the activities of these organizations do not fall within the purview of Executive Order 10450. In view of this fact, there is no basis upon which to base justification for further inquiry. Therefore, you are instructed to immediately discontinue inquiries concerning all citizens councils upon receipt of this letter. It is your responsibility to also immediately notify auxiliary offices of the discontinuance of the investigation.

In order that the Bureau may continue to carry out its responsibilities of keeping interested Government agencies informed of information of interest to them, you must continue your efforts to keep abreast of developments in order that the Bureau may be apprised of any situation which indicates a potential for violence. In obtaining information, however, absolutely no inquiries are to be made by you. You must secure the desired information through close scrutiny of the public press plus whatever information may be volunteered to you.

Re: CITIZENS COUNCILS

With respect to the use of confidential informants, I want it clearly understood that no informant is to be given any assignment in connection with obtaining information regarding the activities of citizens councils without prior Bureau authority. If you have a confidential informant already reporting on citizens councils matters you may continue to accept information volunteered by the informant but you must not give him any additional assignments in this field. If you feel it is necessary for some specific reason to continue an informant in a particular citizens council you must immediately advise the Bureau, together with the identity of the informant, his reliability and your assurance that continued operation of the informant will not result in any embarrassment to the Bureau.

Each office receiving copies of this letter must submit to the Bureau a monthly summary of information concerning the activities of citizens councils in your respective territories. The first such letter is to be submitted to reach the Bureau by January 15, 1957, and each succeeding letter must be submitted to reach the Bureau by the fifteenth of each month. This summary, which shall consist of an original and seven copies, must be submitted in memorandum form suitable for dissemination and forwarded to the Bureau by cover letter. These summary memoranda and your cover letter must bear the caption "Citizens Councils, (name of field office)." Each of these summary memoranda must also be dated.

As in the past, information received concerning citizens councils which requires expeditious handling must not be delayed for inclusion in the monthly summary but must be furnished to the Bureau promptly by whatever means of communication is required by the nature of the information.

This matter must receive your personal attention and it is your responsibility, insofar as is possible, to see to it that the Bureau will continue to be in a position to furnish pertinent information concerning potential violence to interested Government agencies.

With respect to the administrative handling of current cases, you should submit a closing report within 30 days from the date of this letter. This report should incorporate any information which has been obtained to date not previously reported. If there is very little information to be reported, you may at your discretion submit a closing letter. On the administrative page of the closing report or in the closing letter make reference to this letter in order that the administrative handling at the Seat of Government may be facilitated.

The fact that we are discontinuing our inquiries concerning citizens councils is not to be discussed or made known in any manner to anyone outside your own office. This includes your confidential informants.

"The Tuscaloosa News," Tuscaloosa, Alabama newspaper, carried an article August 3, 1957, entitled, "South Can Keep Segregation - For A Price, Says Davis." This article referred to a speech by State Senator ALBERT DAVIS of Pickens County, Alabama, at an open-air rally of the West Alabama Citizens Council, August 2, 1957, in the Alberta City Park, a suburb of Tuscaloosa. LEONARD WILSON, Citizens Council Chairman, presided. Among the remarks made by DAVIS, "The Tuscaloosa News" quoted the following:

"We must drag out the beasts and expose them for what they are. It's a fight that demands courage and not for weaklings. We are looking for strong men and women, the kind that'll lay down their lives if need be to support a cause they love."

.....

"Preservation of our way of life in the South can be had, but it'll require eternal vigilance, courage and not weakness."

.....

"It'll take the character that folks showed in the 60's, men like those who staggered back home in defeat, men of the Confederate Army who loved the heritage that was theirs. They found big-footed niggers in key places who had armed soldiers to carry out their orders. But our men had the manhood, the stuff that it took to save our souls from the curse."

"....You need not expect the big politicians to carry the flag in this fight. They're too scared..."

.....

"You must be willing to go into our colleges and say I wanta know something about the stuff you are cramming down the throats of our young people. Some of them are putting on cap and gown to pour out poison to the youth of America. Some are hiding behind the Cross of Calvary to do their dirty work. You must be willing to go into the pulpits of the land and question the preaching of a social doctrine. The folks who write religious literature are poisoning our youth."

.....

"As for the left-wing press, I say to hell with them. Too many are owned and controlled by Eastern capital. I'd just as soon they'd not be down here."

.....

"If we don't do something about this, your son or daughter will in time tell you that the stuff you talk about is poppycock and strong men will be heard to cry.

"It's certainly coming if you don't rise up and inquire into every nook and cranny about those who teach our young, those who make our laws here and in Washington. The victory is ours if we but pay the price.

"We have been federalized until the little farmers of America can no longer make a living on their farms. They must go to town and beg somebody for a job."

According to "The Tuscaloosa News", Senator DAVIS characterized the United States Supreme Court as "that bunch of nine old buzzards who sit up there on one roost and attempt to federalize all our schools in one stroke." The article further quoted Senator DAVIS as saying, "It's gonna take guts, sacrifice, toil and willingness to take abuse, but the price is the youth of this country and children of the next generation. By the help of God we'll win."

This article further reflected that Judge GEORGE WALLACE of Barbour County also spoke briefly on this program. He told about his experience in testifying in Washington against the proposed Civil Rights Bill and said we in the South must do three things: "We must never succumb to the idea that the mingling of the races is inevitable because it isn't. We must continue a fight within the law and we should tell the Negroes we are their best friends, which we are. Through it all we must try to maintain peace and tranquility among all people. Our system is not based on ill will but what we in our own hearts feel is best for both races."

"The Birmingham News" for August 8, 1957, carried an article concerning a meeting of the Bessemer Citizens Council on that date. This article said that GROVER S. McLEOD, Birmingham Attorney, and a defense lawyer at the recent Clinton, Tennessee, trial would address the meeting. The meeting was to have been held at the Bessemer Court House, beginning at 7:30 p.m. According to this article, Reverend J. J. BECK, Chairman of the Bessemer Citizens Council, announced that the meeting would be held.

The "Birmingham Post-Herald" for June 26, 1957, carried an article which said that Judge GEORGE C. WALLACE, Third Judicial Circuit of Alabama, would speak at a meeting of the Independent Bessemer Citizens Council, Friday night, June 28, 1957. The article stated that the public was invited to attend, according to Rev. J. J. BECK, Chairman of the Bessemer Citizens Council. The article stated that Judge WALLACE would be introduced by JOSEPH S. MEADE, Birmingham attorney. Rev. J. J. BECK was quoted as saying that Judge WALLACE was invited to speak because of his "wide knowledge of the problems now confronting this and other Southern communities."

Reference is made to Bulet dated December 13, 1956, which instructed that inquiries concerning all citizens councils be discontinued immediately; that in order for the Bureau to continue to carry out its responsibilities you should continue your efforts to keep abreast of developments and apprise the Bureau of any situation indicating a potential for violence; and that no informant was to be given any assignment in connection with information regarding the activities of citizens councils without prior Bureau authority.

As you are aware, a very tense situation has arisen in Little Rock, Arkansas, in connection with the matter of integration of public schools. The Attorney General has stated that in view of the Little Rock situation and the fact that a number of the principal disturbers of the peace there were members of citizens councils he believes the Bureau should take steps to obtain the necessary coverage, including informants, in citizens councils but should exercise such coverage with the utmost discretion.

I desire to stress the fact that the Bureau is not investigating citizens councils and has no interest in the actions of citizens councils as such. The sole interest of

the Bureau is the gathering of intelligence in advance of possible violence or interference with Federal court orders or injunctions, and the gathering of information which will permit the development of witnesses in the event such violence or interference takes place.

In view of the Attorney General's desires you are instructed to institute immediately a program for the development of coverage, which will accomplish the above aims, in citizens councils in those areas where trouble might arise due to integration problems.

It is desired that you examine the coverage you had previously when discreet inquiries were being conducted concerning citizens councils for the purpose of reinstating coverage along the same lines. You should bear in mind the recruitment of proven informants in both the security and criminal fields who could become members of these organizations. Panel sources should be considered to see if they are of the caliber and reliability to be used in this regard. Consider also members of minority groups or persons who have openly expressed opposition toward the use of violence in any form. It is noted that some of the leaders and members of citizens councils have voluntarily contacted your offices expressing antipathy to violence. Sources should be re-established who can obtain literature published or circulated by citizens councils which will keep your offices informed of possible trends toward violence. Newspapers and other publications should be closely scrutinized for the same purpose.

It is not desired that informants be developed in each and every citizens council within the territory covered by your office but it is imperative that efforts be made to develop informants in citizens councils in areas where there might be integration trouble. Your efforts in this regard are to be most circumspect. No unnecessary risks should be taken in this matter which might have any adverse effect upon the Bureau or which might cause the Bureau any embarrassment. No attempts should be made to develop informants on a wholesale basis. No person should be considered in connection with this matter unless the individual is completely trustworthy. No individual should be contacted until Bureau authority is obtained. All individuals contacted under this program should be advised and must understand that the Bureau is not interested in the activities of citizens councils as such but is interested in only such information

indicating violence on the part of such councils or their members and in such information that is or at some future date might be in violation of matters over which this Bureau has jurisdiction. It is realized that the development of informants in this regard is a delicate situation and I want to be certain that anyone used as an informant is trustworthy and will not get the erroneous impression and think that the Bureau is interested in citizens councils other than from their potential for violence.

Each office receiving instant communication should institute immediately a definite program in this regard. The Bureau is to be furnished with a letter setting forth the program instituted, which letter is to reach the Bureau by October 25, 1957, without fail. Thereafter each office should submit a letter every 30 days setting forth the steps taken to insure the success of the program; the steps taken to implement and expand upon the program; results achieved under the program, setting forth the names of the individuals and sources developed and any informant symbol numbers, if assigned, during the preceding 30-day period; and summarize accomplishments achieved under the program since its inception. After the second 30-day letter is submitted you should list only in the letters submitted in June and December of each year the names and symbol numbers of all the individuals developed since the inception of the program.

Requests for Bureau authority to contact individuals under this program should be submitted under individual council captions and should include the following information:

- (1) Full name of individual.
- (2) Residence address
- (3) Occupation and business address
- (4) A statement whether individual is an officer and/or member of the council. If not an officer or member a statement as to the individual's being in a position to furnish information.
- (5) A statement as to individual's trustworthiness, including a statement if individual has furnished

information to your office in the past, if such information was determined to be accurate, and a brief resume of matters concerning which he has furnished information.

- (6) Any information in the files of your office which might make a contact inadvisable.
- (7) Your recommendation

A separate letter should be submitted on each individual request.

It is your responsibility to give this matter preferred and expeditious attention to insure the success of this program. It is also your personal responsibility to insure that all information concerning the activities of citizens councils which might result in violence in connection with the integration matter or which might develop into another Little Rock situation is furnished the Bureau promptly. In this regard you should secure the desired information through close scrutiny of the public press, through information which may be volunteered, and through the informants which are developed in connection with the afore-mentioned program.

The above instructions in no way rescind the instructions set forth in reBulet concerning active inquiries of citizens councils. No active inquiries should be conducted concerning such councils.

MONTGOMERY, Ala., Dec. 7 —The Citizens Councils of Alabama is getting ready to fire a broadside of questionnaires at avowed and prospective candidates for governor and other public and party office aspirants in the May Democratic primary election.

State Sen. Sam Engelhardt, Jr. of Macon, executive secretary of the organization, indicated that the queries to be directed at the candidates for governor would be broader than the ones submitted to office seekers in the election two years ago.

"This time we'll probably have eight or 10 questions to ask the candidates, especially those run-

Some ignored queries:

A NUMBER of candidates for both public and party offices bridled at questions directed at them in the last election, with some considering the queries too bullying and intimidating.

However, many of them answered the questionnaires, while others ignored the queries.

One of the candidates ignoring the questionnaire then was Gov. James E. Folsom, who was defeated for Democratic national committeeman by Rep. Charles W. McKay Jr. of Talladega.

McKay, who was head of the Citizens' Council, at Sylacauga at that time, answered the questions.

Livingston push

THERE'S A NEW movement under way to propel Supreme Court Chief Justice J. E. Livingston into the governor's race, despite the fact that he apparently at one time had given up the idea of running.



But in recent days there has been a quiet but forceful attempt by some of the state's most influential citizens including attorneys, business men and some members of the judiciary, to persuade him to run.

Would Chief Justice Livingston be eligible, under the State Constitution, to run for governor?

The answer, given by able constitutional lawyers, is yes.

This is because the Supreme Court presiding justice's term, to which he was elected, expires at the end of 1958.

If it extended beyond that time, he would not be eligible to seek or hold the governorship, under the constitution, they point out. They also cite sound reasons why such a prohibition was placed in the State Constitution.

Significant changes

CHIEF JUSTICE Livingston has not given any indication as to whether he will run for governor, or seek renomination to the high court.

Indications are that if he seeks reelection to the bench, he won't have any opposition. But it would be a different story, if he ran for governor.

There's always a hot fight for the state's top office.

Attempts to induce Livingston to jump into the governor's race were renewed since Alabama's gubernatorial picture underwent rapid and significant changes during the last week.

These occurred in rapid succession, with veteran U. S. Rep. Albert Rains, who had been regarded as one of the strongest prospective candidates, announcing he would not run. Instead, Rains said he would seek reelection to Congress where he feels he can best serve the state.

No sooner had Rains bowed out of the governor's race than former U. S. Rep. Joe Starnes of Guntersville, the man Rains had unseated as Fifth District congressman several years ago, indicated he was preparing to jump in.

And State Agriculture Commissioner A. W. Todd, former state senator from Russellville, plunged into the tussle. Todd long has been mentioned as a probable entrant.

Endorses amendments

JUDGE GEORGE Wallace of Clanton, who huddled with a group of some 75 persons in Birmingham Friday night to

shape organization plans in his bid for governor, announced his support of the first six amendments on the Dec. 17 ballot, plus Amendments Nos. 10 and 11.

No. 1 is the \$10 million inland docks measures, while Nos. 2 through 6 are generally described as health amendments.

No. 10 provides that the Legislature may authorize use of any portion of the proceeds of any special public hospital county taxes for care of indigent residents of the county.

No. 11 provides that obligations for public improvements or for school buildings would, not under certain circumstances, be considered an indebtedness in municipalities of less than 6000 population—same as already provided for larger municipalities. "As the author of the Wallace Industrial Development Act," said Judge Wallace, "Amendment No. 11 is especially important because it would enable municipalities of less than 6000 population to provide for school and other facilities that cities of larger population already have the right to provide."

The Bureau has said in view of the Attorney General's desires, the Birmingham Office has been instructed to institute immediately a program for development of coverage concerning the possibility of violence or interference with Federal Court orders on the part of Citizens Councils. The Bureau stated on October 9, 1957, that it was not desired that informants or sources be developed in each and every Citizens Council, but efforts should be made to develop informants in Citizens Councils in areas where there may be integration trouble. The Bureau pointed out that efforts should be most circumspect. The Bureau said, "No unnecessary risk should be taken in this matter which might have any adverse effect upon the Bureau or which might cause the Bureau any embarrassment. No person should be considered in connection with this matter unless he is completely trustworthy. No person should be contacted until Bureau authority is obtained." The Bureau said the field could recruit and develop informants--both Security and Criminal--who might become members of Citizens Council organizations; panel sources could be utilized.

It is not believed that there has been any serious integration trouble in the Anniston, Huntsville or Florence Resident Agencies; however, it is recalled that some of ASA CARTER's close friends from Anniston helped attack NAT "KING" COLE at the Municipal Auditorium in Birmingham.

You are requested to give consideration to the situation in your territory as concerns the possibility of any Citizens Council or any of its members committing violence or interfering with Federal Court orders or injunctions in connection with the possible integration of public schools.

Please advise if you know of any schools in your territory where integration is being considered. The

Bureau pointed out the situation at Little Rock, Arkansas and Attorney General said in view of the Little Rock situation and the fact that a number of the principal disturbers of the peace there were members of the Citizens Councils, he believed that this Bureau should take steps to obtain the necessary coverage, including informants, in Citizens Councils, but should exercise such coverage with the utmost discretion.

After considering this matter as relates to your territory, please advise whether or not you feel you have adequate informant coverage of the situation whereby we could advise the Bureau in advance of potential violence or trouble as mentioned above, or whether you should develop a good source of information in certain Citizens Councils or request Bureau authority to utilize one or more of your established confidential informants, either Criminal or Security.

When the original communication was received from the Bureau in October, it was felt at that time that there was no pressing integration problem in the Anniston, Florence, or Huntsville Resident Agencies. The Bulet was discretionary as to what Citizens Councils should be considered in the light of possible violence, etc; however, your comments are desired at this time to bring the picture up-to-date.

Attached hereto are the pertinent facts from the Bureau's letter to Atlanta dated October 9, 1957, which includes the seven items of information to be submitted to the Bureau requesting authority to contact individuals under this program.

On October 9, 1957, the Bureau, in a letter to Atlanta and other offices, made reference to Bulet dated December 13, 1956, in the case entitled "Citizens Councils; IS - X." This Bulet of December 13th instructed that all inquiries concerning citizens councils be discontinued immediately. The Bureau mentioned the situation at Little Rock, Arkansas, and pointed out that the Attorney General said that a number of the principal disturbers of the peace there were members of citizens councils. He desires the Bureau to take steps to obtain the necessary coverage, including informants in citizens councils, but should exercise utmost discretion. The Bureau pointed out that we are not investigating citizens councils and have no interest in the actions of citizens councils as such; that the Bureau's sole interest is the gathering of intelligence in advance of possible violence or interference with Federal court orders or injunctions and the gathering of information which will permit development of witnesses in event such violence or interference takes place.

The Bureau said in view of the Attorney General's desire, the Birmingham Office is instructed to institute immediately a program for development of coverage which will accomplish above aims in citizens councils in those areas where trouble may arise due to integration problems. The Bureau states we should bear in mind the recruitment of proven informants in both the security and criminal fields who could become members of these organizations.

It is not desired that informants be developed in each and every citizens council, but the Bureau states it is imperative that efforts be made to develop informants in citizens councils in areas where there may be integration trouble. Efforts should be most circumspect. "No unnecessary risk should be taken in this matter which might have any adverse effect upon the Bureau or which might cause the Bureau any embarrassment. No person should be considered in connection with this matter unless he is completely trustworthy. No person should be contacted until Bureau authority is obtained." Bulet states we should advise all persons contacted that the Bureau is not interested in activities of citizens councils as such, but is interested only in such information indicating violence on the part of such councils or their members, etc.

Request for Bureau authority to contact individuals under this program should be submitted under individual council captions and should include the following information:

- (1) Full name of individual
- (2) Residence address
- (3) Occupation and business address
- (4) Statement whether individual is an officer and/or member of the council. If not an officer or member, a statement as to the individual's being in a position to furnish information.
- (5) A statement as to individual's trustworthiness, including statement if individual has furnished information to this office in the past, if such information was determined to be accurate and a brief resume of matters concerning which he has furnished information.
- (6) Any information in the files of our office which might make contact inadvisable.
- (7) Your recommendation.

A separate letter should be submitted on each individual request.

"The above instructions in no way rescind the instructions set forth in resulet concerning active inquiries of citizens councils. No active inquiries should be conducted concerning such councils."

Alabama Seen Is Outdoing Little Rock

Engelhardt Expects
Outbreaks To Follow
Any Mixing Order

BY IVAN SWIFT

State Sen. Sam Engelhardt Jr. told a radio and television audience yesterday if school integration is ordered in Alabama he thinks it will make Little Rock look like a garden party.

The executive secretary of the Citizens Councils of Alabama, taking over Stations WABT and WAPI on Alabama Press conference, told interviewers Taylor of The Birmingham News and Leroy Simms, Associated Press Alabama correspondent, there are more school districts in the South than Army divisions.

Engelhardt, who claims about 60,000 members in his segregation organization, said the councils haven't as many members as they had 18 months ago "but the enthusiasm still is there."

He said the 60,000 membership figure is a guess because membership drives have been completed in only 12 counties by the state-wide organization. Engelhardt didn't disclose his personal political plans under any questioning from Taylor

about them but he did say the councils "will not back or fight any particular candidate."

The Macon senator said the questionnaire the councils plan to send every candidate will ask questioning similar to the 1954 query sheet, and he mentioned two of them approximately as:

1. WILL THE CANDIDATE deny the Negro vote?

2. WILL THE CANDIDATE submit a list of financial contributors to his campaign?

He told Simms in answer to a question, the publication of the answers will be the councils' way of informing Alabama voters about candidates.

Engelhardt himself is not expected to be a candidate for the office he now holds because the post is shifted customarily between Macon and Bullock Counties. Both counties make up the 26th District.

Engelhardt said the present political condition is a "state of confusion" so far as who is going to qualify and run for office is concerned.

He told the interviewers recommendations about the disposition of Macon County now under study, after an affirmative vote Dec. 17, partly depends on the action of the Presidential Civil Rights Commission.

sure they (the commission) will come here" and he said he "hopes we will be ready when they come into the state."

On other issues, Engelhardt said:

He doesn't think the state can take over Tuskegee Institute, a private school, but consideration should be given to transferring schools contracted to Tuskegee, such as engineering, to state Negro schools.

Tuskegee merchants will "withstand" the boycott now going on, which followed the gerrymandering of Negro voters out of the city. Boycotts are "a two-edged sword" and "the NAACP and Tuskegee Civic Assn. will rue the day they started the boycott."

Additional school appropriations are needed, especially in the case of Auburn.

HOWEVER, THE COUNCILS have fewer members than they had 18 months ago, he said. "But the enthusiasm is still here," he added.

Regarding any use of federal troops to force school integration in Alabama, the Macon senator declared, "We have more school districts than they (the army) have divisions."

Engelhardt, sponsor of the bill passed by the Legislature gerrymandering the City of Tuskegee to remove from its corporate limits most of the Negro voters, said he would not be willing to change that.

"AND I THINK Tuskegee's white citizens will be able to withstand the Negro boycott of merchants," he added.

He explained the citizens are building their economy with merchants cutting down inventories, which he said formerly were large.

"The NAACP and Tuskegee Civic Assn. (Negro organization) will rue the day they started the boycott," predicted Engelhardt. "This is a two-edged sword."

HE EXPLAINED the white people there could resort to a boycott, too.

Engelhardt, who earlier had advocated that the state take over Tuskegee Institute, said he is decided against introducing a bill in the Legislature to do this.

"But I think it would be wise to transfer some of its functions to other schools, such as sending the engineering and veterinary medicine schools to the Negro college at Huntsville," he said.

Engelhardt, who said he had voted for state appropriations for Tuskegee Institute, favors continuing these appropriations.

Engelhardt, whose Citizens Councils organization has completed membership drives in 12 counties, said questionnaires could be sent candidates for governor, Legislature and other public and party offices.

HE SAID queries would be substantially the same, although worded a little differently, as those fired at public and party office aspirants two years ago. Among the questions, he said, would be:

"Will candidates 'solicit the Negro vote?'"

"Will they 'deny the Negro vote?'"

"Will candidates be willing to submit to the Citizens Councils group a list of financial contributors and amounts of contributions?"

ENGELHARDT SAID he does not see any need for a special session. And he added that his support of the Folsom administration's \$20 million road bond proposal would depend on whether "it could be tied down so the money could be used only for federal matching."

Engelhardt, who met today at Montgomery with legislators representing counties surrounding Macon to consider a course of action, said "a lot of our decision depends on action of the Civil Rights Commission."

HE SAID he is "perfectly willing"

for proposals changing Macon's boundaries "to annex portions of it to adjoining counties to be submitted to voters of all counties concerned, before any final legislative action is taken."

"But if it takes abolition of Macon County to preserve the status quo, then I'm ready for it," he said.

Questioning Engelhardt were Leroy Simms, chief Associated Press Correspondent in Alabama, and this reporter. Charlie Davis was moderator.

[redacted] would retain forty percent to pay his salary and expenses. This motion carried at the meeting; however, before [redacted] can perform his duties, he must have authority from Charles Creal, State Treasurer of the State Organization of Citizens Councils and also President of the Citizens Bank of Bunnell, Florida. Creal has stated he will not consent to this arrangement.

ReBulet 10-9-57 captioned as above instituting a program for the development of coverage in citizens councils.

Until such time as a community is actually faced with immediate integration, it cannot be determined with any degree of certainty exactly what action citizens councils in that area will take.

When desegregation attempts become a reality in a community each council in that area must decide whether or not to comply with existing court orders. If the decision is to resist, the Bureau must be in a position to know if acts of violence are contemplated or if plans are being made for action violative of laws within the Bureau's jurisdiction, particularly relating to civil rights. Identities of individuals responsible for such action must also be known.

The program for development of coverage in citizens councils was instituted for the above-stated reasons only. The Bureau is not interested in legitimate activities of any of these groups. This fact should be impressed upon those individuals contacted and should be kept in mind by personnel of your office who are involved.

Efforts to obtain coverage in councils should be continued until such time as you can assure the Bureau that you have sources in a position to supply, when it becomes necessary to do so, information the Bureau must have.

In this regard numerous requests are being received for authority to contact police officers. Unless these officers are actually council members who will be aware of decisions made and action contemplated after councils have decided to resist compliance with court orders relating to integration, they will not be in a position to furnish needed data. Therefore, they should not be considered as part of your coverage. This should not be considered as denial of authority to contact law enforcement officers concerning councils. This scroll is being put together with Scotch tape and contains the names of thousands of Alabama citizens and when completed, will be a rather large document. Upon its completion, the Council is considering asking Senator JOHN SPARKMAN of Alabama, or some other representative in the U. S. Congress to present this scroll to President EISENHOWER.

On January 13, 1958, [redacted] advised that the CITIZENS COUNCIL OF WEST ALABAMA has broken up, but GENE J. WALLACE, a director of this group, plans to reorganize it. On April 1, 1958, Birmingham Confidential Informant T-1, with whom contact has been insufficient to determine his reliability, furnished a leaflet captioned "Reds to Back NAACP." This leaflet praises the American Legion and its publication, "The Firing Line". It mentions that this publication, "The Firing Line," brings facts before the public's attention that newspapers often overlook or do not receive. The leaflet cites the issue of March 15th and states this issue contains interesting passages on relationship of the Communist Party of the United States to the many Communist front enterprises which play so vital a role in its attack on society. This leaflet indicates that the Communist Party intends to penetrate such "liberal-socialist" organizations as the NAACP (NATIONAL ASSOCIATION FOR THE ADVANCEMENT OF COLORED PEOPLE).

Informant T-1 furnished a four-page leaflet allegedly published by the National Citizens Protective Association, 3154a South Grand or P. O. Box 156, St. Louis, Missouri. This four-page leaflet concerned Uniform Crime Reports of the Federal Bureau of Investigation and was headed, "FBI Reveals Menace of Integration - Negro Crime Increases." An opening paragraph read:

"The following figures on negro crime were taken from the Annual Bulletin of the FBI, J. Edgar Hoover, Director. The figures are based on 1,861,764 arrests in 1,477 cities and towns of more than 2,500 population comprising a total of 41,792,800 people. The figures are based on arrests made during 1955 of White and negroes and do not include Indians, Orientals, Filipinos and non-White Mexicans. The FBI's numerical figures were broken down into percentages by the "White Sentinel."

It is noted that this four-page leaflet further identifies the "White Sentinel" as follows: "For further

information on the menace of racial integration, read 'The White Sentinel' and the 'White American News Service' each month. Subscription rates are \$2.00 a year. The 'White American News Service' is sent free of charge to all 'White Sentinel' subscribers." Other topics in this leaflet are: "Arrests by Race, 1956, as Reported by The FBI;" "24% Increase in Negro Crime During 1956;" and "Negro Crime Explodes Racial Equality Myth."

T-1 also furnished a one-page leaflet allegedly published by the Association of Citizens Councils, 207 West Market Street, Greenwood, Mississippi, entitled "Venereal Disease Infections by State and Race". This leaflet sets forth the venereal disease infections according to white and Negro infections and the percentages. It also treats illegitimate births in various states in the same manner.

This is furnished for your information and should not be disseminated to unauthorized persons or agencies.

The Bureau again desires to emphasize the necessity for developing coverage in councils prior to the time racial difficulties may arise in order that we may discharge our responsibilities. Your consideration in this regard should not be confined to possible trouble due to integration in schools but should encompass the entire field of racial relations wherein councils could become involved.

Results of the program of developing coverage to date reveal that the offices receiving copies of this letter are utilizing a total of only 12 Klan informants and potential informants as sources in citizens councils. The same offices have approximately 125 informants and potential informants in Klan matters. Since Klans and citizens councils both favor segregation it would not be inconsistent for an individual to belong to both types of organizations.

In order to supplement present coverage in councils each office is instructed to review information available regarding all informants and Bureau approved potential informants now being used in connection with Klan organizations to determine which are suitable for membership in citizens councils. This determination will have to be made on an individual basis keeping in mind the background and character of the informant and weighing such information against the type of individuals who are members of the council on which the informant may be in a position to furnish information. //

The informant has been [REDACTED] local civic organizations in the past and is [REDACTED] with [REDACTED] in the Gadsden, Alabama area. On 4-11-58, the informant advised that he had [REDACTED] Gadsden, Alabama, and was now employed as an [REDACTED] for the [REDACTED] City of Gadsden, Gadsden, Alabama. The informant is also an [REDACTED]

The informant has been contacted by the Birmingham office since a PSI case was opened on him as a result of his having voluntarily come to the Gadsden, Alabama RA office and advised that he was a [REDACTED] of the Ku Klux Klan and wanted to volunteer his services to supply information. Since that time the informant has refused to accept any money for his cooperation, stating that he was supplying information purely from patriotic motives. This case was opened on 7-1-56.

(2) It should be noted that the White Citizens Council, Gadsden, Alabama, according to available information, was disbanded approximately one year ago as a result of lack of interest on the part of its members, and has not been reorganized. During the period of its existence, it appeared to be composed of responsible members of the community who were in favor of supporting the maintenance of segregation through legal means.

It should be noted that the White Citizens Council at Gadsden, Alabama, according to available information, was disbanded approximately one year ago as a result of lack of interest on the part of its members, and has not been reorganized. During the period of its existence, it appeared to be composed of responsible members of the community who were in favor of supporting the maintenance of segregation through legal means. It is believed that [REDACTED] would be suitable for membership in the Citizens Council at Gadsden should it be reorganized. It is not believed that [REDACTED] should be utilized at this time in connection with Citizens Council. b7D

Recently an individual contacted under this program advised the press of the contact resulting in inquiries being received by the SAC and at the Seat of Government as to whether the Bureau is investigating integration in public schools. The individual contacted appeared to have been cooperative and had agreed to keep the contact confidential.

This incident clearly indicates the extremely delicate nature of this program, and the absolute necessity that every precaution be taken that contacts in the matter will not result in embarrassment to the Bureau.

Your attention is again directed to the provisions of reBulet October 9, 1957. It is mandatory that all contacts in this matter be handled in the circumspect manner outlined in reBulet, and that each SAC personally afford this matter the most careful supervision.

ReBulet October 9, 1957, in which you were instructed to institute a program for the development of coverage in citizens councils and Bulet June 10, 1958.

As you were advised in Bulet June 10, 1958, an individual contacted under this program informed the press of the contact resulting in allegations being made that the Bureau is investigating integration in the public schools. The injudicious manner in which this contact was handled clearly indicates the inability of the field to implement this program successfully and without embarrassment to the Bureau. Therefore, I have no alternative but to discontinue the program and you are instructed to immediately discontinue all efforts to develop informant coverage in citizens councils upon receipt of this letter.

The discontinuance of this program in no way alters the Bureau's responsibility of keeping interested Government agencies and officials advised of actual or contemplated acts of violence in connection with the segregation issue; plans for action violative of laws within the Bureau's jurisdiction, particularly those relating to civil rights; and the identities of the individuals responsible for such actions. You have a continuing responsibility
