

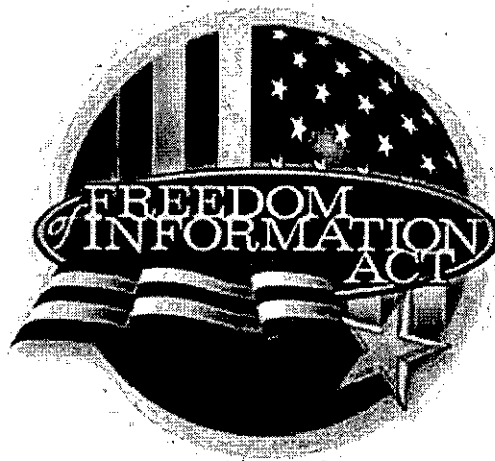

Current contact with established sources on college campuses within the Savannah territory has developed no indication of any pertinent New Left activity or the existence of any such organization or disruptive activity.

Savannah has a minimum of two sources on each college campus, including junior colleges within this territory, and such individuals are periodically specifically contacted to remind them of our continued interest in the possibility of such groups being organized on any campus.

As noted, there have occurred no disruptive activities on any of the campuses during the past year.

Savannah has no assurance, of course, such an organization will not organize a unit within the territory during the coming year, but is continuing to follow this closely since the establishment of any New Left unit could lend itself to future potential for violence.

As the Bureau is aware, the Savannah Division currently has no reported New Left groups active in this area. Accordingly, the comments in this letter refer to preventive measures which this Office believes can be utilized in connection with already existing Bureau programs, such as development of sources on college campuses.

During periodic canvassing of college campus sources concerning New Left organizations, the opportunity can be taken to educate the contact not only with the names and leaders of such groups, but also specific examples of the immorality and chaos that inevitably accompanies the activities of the New Left.

Although there are many exceptions, undoubtedly some school administrators have a feeling that academic freedom is being infringed when such groups are firmly squelched at the outset. Others obviously have only a surface knowledge of New Left organizations, and a consequent inability to footnote their own arguments within the college community against such groups with specific, current adverse information.

It is believed that a knowledgeable discussion or a suggestion of public sources during regular contacts with established sources would assist in firming some of the indecision shown by college administrators toward dealing with the New Left. At the least, it would insure that such sources are aware of some examples of the depravity and immorality that such groups bring to the college campuses.
