1/21/71.

Referenced Buffalo letter set out a proposed Counter-Intelligence Technique in the form of a leaflet, which was to be distributed at various off-campus student hang-outs in the vicinity of State University of New York at Buffalo (SUNYAB). Referenced Bureau letter granted authority to disseminate this leaflet. The leaflet was, subsequently distributed in accordance with instructions set out in referenced letter.

## Tangible Results

As a result of the distribution of this leaflet, informants have reported this leaflet was the subject of considerable discussion and concern by the individuals mentioned in referenced leaflet and New Left. Much speculation was made as to the origin and purpose of the leaflet. Because of the travel to the Middle East by [redacted] and [redacted] they expected the Jewish Defense League or Israeli Intelligence as the source of this leaflet. Further concern was expressed over the use of revolutionary funds for travel to the Middle East by these three individuals. Also suspected as being responsible for this leaflet was [redacted] who is considered by some individuals in the New Left in the Buffalo, N.Y. area as being a "Pig", inasmuch as he got off "scot free," following his arrest on a drug charge.

For the information of the Bureau, [redacted] mentioned in the leaflet has recently commenced serving a three year term in a Federal Penitentiary, after being convicted of assault on a Federal Officer.

[REDACTED] Editor of "Cold Steel" is presently awaiting trial in Local Court in connection with the printing of this publication.

[REDACTED] has departed the Buffalo area for California, due to the heavy pressure he has received from right wing individuals.

[REDACTED] is physically incapacitated for a period of approximately six months, due to a serious eye operation.

[REDACTED] who has been in the Coast Guard Reserve for a lengthy period was recently called to active duty and is no longer residing in the Buffalo area.

[REDACTED] activities have been greatly reduced inasmuch as the vehicle he previously operated was "trashed" by vandals, leaving him without the necessary transportation so that he could attend meetings.

[REDACTED] and [REDACTED] have now affiliated themselves with the Young Workers Liberation League and are not involved in activities of the Niagara Liberation Front or of New Left nature.

[REDACTED] is presently incarcerated on charges stemming from his activities in connection with a fire bombing at SUNYAB during disturbances in 1970.

Potential Counter-  
Intelligence Action

Recently five individuals departed the Buffalo area for a trip to Cuba, as part of a Venceremos Brigade Contingent. The identities of these individuals and sufficient background data is available, from which it is believed that possible counter-intelligence proposals could be developed. Buffalo is in the process of developing these proposals and submitting same to the Bureau for their opinion.

In referenced letter Buffalo advised that [REDACTED] and [REDACTED] all former SDS activists at State University of New York at Buffalo, recently returned from an extended tour of the Middle East. This "junket" has been a source of irritation to New Left type groups and to former SDS members in the Buffalo area who remained behind to fight the revolution while [REDACTED] and [REDACTED] squandered their revolutionary funds. It is anticipated that the surreptitious dissemination of an anonymous leaflet sharply criticizing the three former SDS activists, as proposed by Buffalo in referenced letter, is likely to result in a serious split between them and other New Left groups and individuals.

## Potential Counter-Intelligence Action

There is no Potential Counter-Intelligence action pending. A previous request by the Buffalo Office to implement a Counter-Intelligence technique against the Venceremos Brigade was deemed inadvisable by the Bureau.

## Proposed Counter-Intelligence Tactic

During the recent past, three individuals from the Buffalo area returned from an extended tour in the Middle East. This junket to the Middle East by [REDACTED], [REDACTED], and [REDACTED] all former SDS activists, State University of New York at Buffalo, has been a source of considerable irritation to the local chapter of YAWF and the NLF (Niagara Liberation Front), a newly formed group comprised of many former SDS people in Buffalo. With the objective in mind of causing further friction between these organizations and to the aforementioned individuals, Buffalo is offering the following proposed Counter-Intelligence technique in leaflet form for the Bureau's consideration:

Relet indicated that television station [REDACTED] had afforded TV coverage to the departure of participants in the third Venceremos Brigade (VB) from Buffalo and St. John's, New Brunswick, Canada. It proposed that public source data including data identifying local VB organizers and members as persons active in local campus disturbances be furnished to [REDACTED]. It was apparently felt that such exposure on local TV would serve as a deterrent to future VB recruiting efforts and as public embarrassment to the individuals involved in these activities.

Bureau authority is not being granted at this time for the purpose outlined above. Because of the small number of VB members from the Buffalo area, it is not felt the risk involved in attempting to positively identify the individuals depicted in the third VB TV coverage with persons who have participated in local campus disorders is worthwhile. One erroneous identification could lead to great embarrassment of the [REDACTED] and possibly subject the [REDACTED] to legal action.

NOTE:

Only 14 subjects in the Buffalo area have participated in VB. Failure of Buffalo to furnish names of these individuals who have also participated in campus disorders indicates that there are very few to whom this counterintelligence program would apply. It is not worth the risk to subject the [REDACTED] to a possible libel action through a misidentification on our part.

## Potential Counter- Intelligence Action

Referenced letter set forth a suggested possible counterintelligence technique. This proposal was in the nature of a "letter of resignation" to the State University of New York at Buffalo (SUNYAB) administrative authorities from a "New Left type professor".

A survey was conducted and no suitable prospect was developed. After further consideration of this potential counterintelligence technique, it was decided another action of this type would possibly cast suspicion on the legitimacy of the original letter submitted which resulted in the "New Left type professor" not being rehired by SUNYAB.

Subsequent to submission of this letter, a contingent of local Venceremos Brigade (VB) individuals departed Buffalo for Cuba. Although their departure was to be in a secretive, clandestine manner, they were afforded television coverage by a local TV station. Both the local VB organizers and the group departing were stunned, greatly irritated and acted in a rude and uncouth manner in responding to questions posed to them by the television reporter. In addition, the same television station covered the departure of not only the local VB people but also other VB groups when they boarded the boat at St. John's, Newfoundland, Canada, for the trip to Cuba.

information could be furnished identifying the local organizers and some of the VB members as being active in the past in local campus disorders. The television station mentioned above is [REDACTED] an affiliate of [REDACTED]. The information furnished to [REDACTED] would be of such a nature that no embarrassment could result to the Bureau.

It is believed that the exposure of local VB leaders and its members by the television media would not enhance their future organizational and open-type activities. Furthermore, it would in all probability prove to be a deterrent in their future recruitment efforts and could be a factor in the organization gaining further support from students and New Left individuals.

Bureau authority is, therefore, requested to establish contact with [REDACTED] Buffalo, and to make public source information available. No action will be taken by Buffalo in this matter pending Bureau approval.

## Potential Counter- Intelligence Action

During the campus disturbances of February, March, and May, 1970 at the State University of New York at Buffalo, (SUNYAB) some of the individuals actively involved have been faculty members or graduate teaching students. In some instances these individuals are hired on a yearly basis, and their contracts, therefore, are renewed each year.

In June, 1970, a letter of resignation was received by SUNYAB authorities from a "New Left type professor." This letter was flavored with strong revolutionary language commonly used by New Left type, and was also critical of the establishment per se.

On the basis of this letter, the professor was not re-hired. Copies of this letter were placed on bulletin boards in various areas on the SUNYAB campus by SUNYAB officials for students to read. The student reaction to the letter was one of admiration for the strong independent stand taken by the professor. Shortly after the placing of this letter on the bulletin boards, the professor in question issued a strong protest in which he vehemently denied writing this letter and claimed it was a complete fraud. School authorities at SUNYAB have resolved this issue by not re-hiring the professor and have declared him to be eligible for arrest, should he appear on the SUNYAB campus, as a trespasser. Inasmuch as it has never actually been established by the SUNYAB officials that the letter of resignation was not actually written by the professor, it is believed under similar conditions a letter could be directed to SUNYAB officials concerning other New Left professors.

## Potential Counter- Intelligence Action

A proposed counterintelligence technique has been submitted to the Bureau for approval. It is believed that if this technique is authorized, it will result in a complete breakdown of relations locally between Youth Against War and Fascism (YAWF) and Students for a Democratic Society (SDS). The proposal was submitted because of the already existing strained relations between YAWF and SDS locally. Inasmuch as the successful implementation of this proposal could render considerable disruption within the local New Left faction, its anticipated further follow-up CI activity will possibly be derived from this action.

## Pending Counter- Intelligence Action

Although there is no pending counterintelligence action, local New Left sources have been advised to remain alert for any information indicating personality clashes or feelings of distrust among the leadership which could be employed to create disruption and reduce the effectiveness of future New Left activities.

[redacted] is a Security Index subject of the Buffalo Office who is an SDS member and who has shown a propensity for violence. There is a rift between the local chapter of the Youth Against War and Facism (YAWF) and the local chapter of SDS at State University of New York at Buffalo. Buffalo suggests preparing an anonymous mailing on YAWF letterhead ridiculing Stanton and inferring that he may possibly be cooperating with the police. Buffalo does not furnish information as to how this material would be disseminated other than to say it would be anonymous. We need more information to approve this. ✓

As a counterintelligence technique, Buffalo is submitting the following proposal which, if utilized, could possibly result in furthering the existing rift between the local chapter of Youth Against War and Fascism (YAWF) and the local chapter of Students for a Democratic Society (SDS) on the State University of New York at Buffalo (SUNYAB) campus, Buffalo. Enclosed is a copy of the flier with the YAWF letter-head which would be disseminated with Bureau approval.

It is believed this proposal, if utilized, would cause disruption between [REDACTED] who is included in the Security Index of the Buffalo Office and who reportedly has a propensity for violence, and the SDS membership. Commercially purchased stationery would be used in preparation of this flier, and it would be disseminated in the area of local student hang-outs. The necessary precautions would be taken to prevent this flier being traced to the Bureau and to prevent any embarrassment to the Bureau. Any tangible results resulting from this proposal would be furnished to the Bureau. Buffalo will take no action in this matter pending Bureau approval.

Buffalo has mailed anonymous letters to the editors of the daily newspapers in Buffalo, New York, and will await results. Because of the identifying data required of any student mailing a letter to the editor of the campus newspaper of State University of New York at Buffalo (SUNYAB), this Office, in the interest of security, did not deem it advisable to send such a letter.

In light of the situation described in Buffalo airtel, dated 10/1/69, this Office feels that in order for the posters on bulletin boards to be effective, they had to be placed in the student union within several days after the fight between the leftists took place in downtown Buffalo. Due to the lapse of time, this particular technique will not be utilized.

Buffalo will await results of the aforementioned mailing of letters and advise the Bureau accordingly.

This letter should be mailed to the editors of the newspapers in Buffalo and also to the editor of the campus newspaper at the University of Buffalo. All necessary steps should be taken to protect the identity of the Bureau as the source of these letters.

Prior to authorizing the placing of posters in the Norton Union, it is desired that you advise the manner to be utilized in placing these posters on bulletin boards. One of the specific questions to be answered is whether such action will in any way jeopardize sources of your office. In addition, the nature of the poster should be spelled out.

It is also noted that you requested a response by the Bureau by 10/3/69. Your airtel arrived too late to be handled by that date. It failed to give a reason for such expeditious handling. In the future, use a suitable form of communication for handling matters requiring an immediate answer.

NOTE: The Buffalo Nine Defense Committee (BNDC) has been conducting demonstrations in downtown Buffalo protesting the trial in Federal court of nine individuals for assaulting Federal officers. SDS and the YAWF, the youth group of the Workers World Party (WWP), have been participating in these demonstrations. At a demonstration on 9/30/69, an SDS

leader became embroiled in a fight with one of the demonstrators who turned out to be a member of the WWP from New York City and a leader of the YAWF. The latter was severely beaten and kicked in the fight which resulted from the use during the demonstration of a particular banner which bore the name YAWF. Buffalo has suggested an anonymous letter signed "A disillusioned Buffalo student" be sent to Buffalo newspapers deploring this incident and it also suggested the placement in the Norton Union at the State University of New York at Buffalo of a poster taking issue with the actions of the SDS demonstrator in fighting with the YAWF member. The letter could serve to force a wedge between the two groups. We need more detail on the placing of posters before authorizing it.

Buffalo wishes to propose the following counterintelligence measures:

On 9/30/69, the customary demonstration sponsored by the Buffalo Nine Defense Committee (BNDC) took place in downtown Buffalo at Niagara Square to support six defendants of the Buffalo Nine being tried in Federal Court for assaulting Federal officers. There were about 75 participants in this demonstration. The BNDC is a coalition of a number of groups of the Left, the two most prominent of which are the chapter of Students for a Democratic Society (SDS) on the campus of the State University of New York at Buffalo (SUNYAB) and the Buffalo Chapter of Youth Against War and Fascism (YAWF). Generally, [REDACTED] one of the SDS leaders, is in a leadership capacity during the demonstrations.

and leader of YAWF, from New York City, over the use in the demonstration of a certain banner which bore the name [REDACTED] [REDACTED] fought furiously with [REDACTED] and before he was pulled away from [REDACTED] he had him on the ground and was kicking him with his heavy boots. This act of violence against a fellow member of the Left logically lends itself to captioned program.

Buffalo proposes to send to one, or both, of the daily newspapers, a letter to the Editor, signed by "A Disillusioned University of Buffalo Student." The letter to the Editor will read as follows:

"The other day I witnessed an act of violence at the McKinley Monument in Niagara Square during a demonstration by my fellow students in support of the Buffalo Nine who were on trial in the Federal Court House. I saw (and I still can't believe it) one of our campus SDS leaders severely beating a demonstrator and at the end of the fight he had the guy down on the ground and was actually kicking him with his heavy boots. He may have stomped the poor guy to death except a number of the demonstrators pulled this SDS leader away from him. I didn't see the fight start but I found out a few things about it from people who witnessed its beginning. The victim of the beating and the SDS leader had a disagreement about the use of a banner in the demonstration. The guy who took the beating turned out to be somebody from New York City connected with Youth Against War and Fascism.

"We anticipated that the pigs would give us a hard time during these demonstrations but we never dreamed that an SDS leader, upon being enraged about an argument over the use of a banner, would act like a gestapo storm trooper and actually try to kick the life out of a fellow demonstrator. Does it make sense to complain about violence in Viet Nam and Chicago and then perpetrate it on our own in Buffalo?"

The second part of the counterintelligence activity consists of the preparation of posters for display in a prominent place in Norton Union on the SUNYAB Campus. Norton Union is used by SDS and YAWF as a focal point for publicity in the form of wall posters of various sizes. The posters relating to this incident would identify the assailant as [REDACTED] and the victim as [REDACTED] a leader of YAWF in New York City, and will accuse [REDACTED] using fascist tactics. These posters, through a reliable contact in Norton Union, can be put up at night without fear of observation.

Buffalo will insure that neither of the aforementioned counterintelligence tactics will be traceable to this Office.

## Potential Counterintelligence Action

Buffalo is analyzing the new crop of leaders of Students for a Democratic Society (SDS) at both the State University of New York at Buffalo (SUNYAB) and the University of Rochester (U of R). After examining the personalities of these new leaders and after inquiring into the program of these SDS chapters, Buffalo will be in a better position to make recommendations about counterintelligence action.

It is interesting to note that some of the defendants of the "Buffalo Nine" currently being tried in Federal Court for assaulting Federal officers, are or were activists in the SUNYAB Chapter of SDS. The Buffalo Office is following this matter closely for possible counterintelligence action, especially in connection with the demonstrations and activity under the sponsorship of the Buffalo Nine Defense Committee.

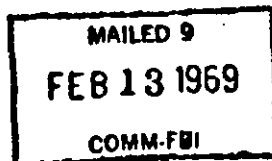

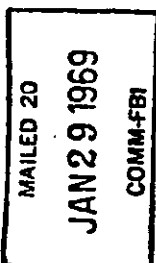

The first issue of "Buffalo Town Crier," dated 1/6/69, came off the press and is being sold in Buffalo, New York, through various outlets but mainly by young people on the streets. The initiating force behind the paper appeared to be [REDACTED] who is an activist in the New Left in the Buffalo, New York area. The working force behind this paper is the leadership and membership of Peace and Freedom Party (PFP) of Buffalo. The content of the paper is radical. Because of the number of people affiliated with the New Left who are connected with the paper it is believed that "Buffalo Town Crier" falls within the intent of captioned program.

A review of Volume I, Number 1 of "Buffalo Town Crier" discloses that it does not bear the union label. This leads to the conclusion that the paper is being prepared and printed by non-union personnel in the "Buffalo Town Crier" offices and shop located at 531 Elmwood, Buffalo. Since Buffalo is a strong trade union city and since it is one of the major printing centers in the country with forceful unions allied with this industry, it is reasonably certain that the appearance of a newspaper without the union label will not be well accepted by the locals concerned with the production of a news publication. Since "Buffalo Town Crier" is hurting for funds and since most of its help is donated, it undoubtedly cannot afford to pay union wages to those connected with producing this paper.

In view of this, it is recommended that the Bureau authorize this office to anonymously make known to trade union leaders, especially those connected with the printing

In early December 1968, the Student Senate of St. Bonaventure University, St. Bonaventure, New York recognized the right of certain students to form Chapter of Students for a Democratic Society (SDS) on this campus. This was done despite a non-binding referendum by the student body which voted to reject SDS recognition by 586 to 460.

Many of the faculty members of St. Bonaventure University including the [REDACTED] are opposed to the recognition of an SDS Chapter. However, the Student Senate has the right to recognize an SDS Chapter, the University President must most certainly remain neutral. It is known, however, that [REDACTED] opposes the prospect of an SDS Chapter on his campus and he is expected to take unofficial steps to either prevent the actual formation or to bring about early dissolution of such a Chapter.

Buffalo wishes to propose the following:

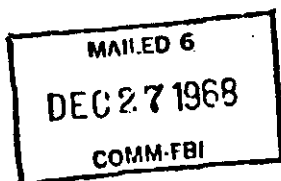

For information of Albany, referenced Bureau letter, in substance, advised that Federal funds could not be used for the National Defense Education Act, in connection with the last listed and activists. The letter directed, however, that on the basis of administrative action, various Government agencies, which might be providing funds to such students, might be able to deny such funds if they were aware of the disruption-intel activities.

## Potential Counterintelligence Action

As mentioned in referenced letter, the Selective Service case regarding [REDACTED] one of the leaders of the New Left at the State University of New York at Buffalo (SUNYAB), offers some potential for counterintelligence action. The Selective Service case, however, is under appeal; and according to District Court mandate, no action can be taken against him until the latter part of November, 1968. Buffalo, however, will continue to follow this matter. ✓

There is a possibility of counterintelligence action regarding plans of the New Left to embroil SUNYAB in a huge demonstration against interviewers of Dow Chemical Company, who are scheduled to appear on campus 11/25/68. As mentioned at a meeting of the SUNYAB Chapter of Students for a Democratic Society (SDS), held on 9/24/68, the plans for taking action against SUNYAB are in the embryonic stages. Through the local press, this office can consider exposing the New Left for its totalitarian procedure in imposing the will of a small minority on the entire university.

Consideration can be given to calling to the attention of a highly placed established source at SUNYAB the disruptive plans of the "New Left." Buffalo is following this matter closely.

This is a follow-up on our telephone conversation regarding [REDACTED] whom your school recently hired and who, according to my friend, is a leader of the New Left at the University of Buffalo. I think my friend's evaluation of Mr. Mayrl is probably correct especially in the light of certain newspaper clippings which place [REDACTED] high in the New Left at the University of Buffalo. These references in local newspapers describe [REDACTED] in these ways:

"Buffalo Courier Express," May 5, 1965: [REDACTED]  
[REDACTED] UB Graduate Student from Rochester, New York, is referred to as being head of the Steering Committee of the Buffalo Chapter of Students for a Democratic Society.

"Spectrum," the UB paper, October 22, 1965, contained an article by [REDACTED] entitled "The University As A Corporation."

Brochure, "Announcing the John Brown Institute of Marxist Studies," Buffalo, New York. This concerns the curriculum for the summer of 1966. Among the sponsors is William Mayrl. My friend advises that the [REDACTED] also listed in this brochure was the actual founder of this institute. Following the hearings of the House Committee on Un-American Activities, Wolfenstein's name appeared in the newspaper as having been a Communist Party member in Buffalo.

Another John Brown Institute of Marxist Studies brochure relating to classes beginning October 10, 1966, which contains the name of William Mayrl as a member of the faculty.

"Spectrum," November 17, 1967, contains a letter regarding the Left on the UB campus written by [redacted]

"Spectrum," December 15, 1967, in an article regarding a demonstration against Dow Chemical Company recruiters, [redacted] acted as a spokesman and was described as a member of Students for a Democratic Society and Student MOB. My friend says that Student MOB is a contraction for Student Mobilization Committee which was described in June 1967 in "Spectrum," as a new UB group dedicated to opposing the war in Viet Nam to resisting the draft and to peace activities.

"Spectrum," December 19, 1967, tells about an emergency Students for a Democratic Society meeting conducted by William Mayrl.

"Spectrum," December 19, 1967; with regard to the demonstration against the Dow Chemical Company recruiters, [redacted] described as a leader of the demonstration, thought that his side won a victory.

"Spectrum," March 5, 1968: [redacted] is described as a Coordinator of University Community for National Alternatives which was planning a strike on campus March 19-21, 1968. The purpose of the strike is to suspend the usual business of the University in order to educate the students about the war in Viet Nam.

"Spectrum," March 12, 1968; [redacted] was moderator at an open meeting to gain support for the Buffalo Draft Resistance Union held at UB.

"Buffalo Evening News," March 21, 1968; an article about the strike on the UB campus against the war in Viet Nam referred to [redacted] as a program official and discussion moderator who referred to approximately \$500.00 having been collected since the student strike began a few days previously. [redacted] said that this money would be used to set up a Draft Counseling Center in downtown Buffalo.

"Spectrum," March 19, 1968; an article refers to the student strike which began that day at UB. It contains a picture of [redacted] sitting next to [redacted] who was speaking into a microphone against American Universities for their "large role in all wars." According to my friend, this is the

same [redacted] who was listed in brochures of the John Brown Institute of Marxist Studies as a member of the faculty.

"Spectrum," June 14 and 23, 1968: [redacted] is teaming up with others, including [redacted] to form a new group at UB known as People Against Racism.

Since I do not know [redacted] personally, I cannot comment on his character or patriotism. I can say, however, that my friend at UB who has followed the New Left since its inception on that campus, has a very high regard for [redacted] ability as a leader and organizer of demonstrations and programs of the New Left. Since you are probably wondering how reliable my friend usually is, I must say in all honesty that he is a trustworthy and responsible person who has a high regard for the United States without displaying it by waving the flag.

I hope that this will be of some help to you in evaluating [redacted] and if he remains at your institution, I trust he will not cause you any unsolvable problems.

COINTELPRO - NEW LEFT

The Bureau is aware of no provisions of the National Defense Educational Act that can be used to deny funds to those New Left leaders and activists causing disruptions on college campuses.

The National Defense Educational Act authorized allocations of Federal funds to educational institutions and left it to the discretion of these institutions, within prescribed limits, as to the dispersing of the funds. No real restrictions as to conduct of the students were placed upon these grants by the Government.

Some Government agencies, however, do make grants in aid to students. These funds do not come under the above act, but are administered by the agencies themselves.

While the Bureau would be desirous of taking steps to deny Federal funds to these individuals, there does not appear to be any means by which this can be accomplished at this time.

As you may be aware, Congress, during the current session, has been considering legislation which would deny Federal funds to students who participate in campus disorders. No final action has been taken on these measures, however.

Until the above Congressional action is passed, any decision to withdraw funds from student disruptionists would have to be made by an agency actually sponsoring a subsidy.

As of the present, therefore, it appears that any denial of funds to these students must be made on the basis of administrative decisions reached by the agencies involved and not by force of statute.

The Bureau feels that no action can be taken, therefore, other than to notify agencies involved of the disruptionist's activities. For this reason, it is important that when information is obtained that a student, who has a subsidy, has participated in student disorders or is an active leader in the New Left movement, a letterhead memorandum under his caption should be promptly prepared and submitted to the Bureau for dissemination to the agency involved. This memorandum should specifically point out that the subject is attending the institution under a subsidy and identify the agency providing the funds.

In this regard, you should assure that all Agents engaged in investigations of the New Left are aware of the above and are instructed to determine during the course of their investigation whether Federal subsidies are being received by their subjects.

NOTE:

Relat took note that the activities of certain/<sup>student</sup>New Left leaders and activists would be impaired by cutting off their Federal subsidies. BU specifically pointed out monies furnished through the National Defense Educational Act. BU inquired as to the attitude of various Federal agencies in this regard should the Bureau furnish them with information concerning the students' activities. BU also wanted to know whether these Federal agencies would comply with a request by the Bureau that certain New Left leaders or activists be penalized by having their funds cut off. We should make no recommendations to these agencies, but we should leave the decisions to the agencies themselves. Of course, we should furnish all available information concerning these particular students to the interested agencies.

A suggestion was made that certain New Left leaders and activists would be impaired by cutting off funds furnished them by the Federal Government. This would undoubtedly be true, in connection with monies furnished through the National Defense Education Act.

In this regard, Buffalo wishes to inquire of the Bureau if any of the agencies of the Federal Government are of such persuasion that they will be interested in complying with a request by the Bureau that a certain New Left leader or activist be penalized by having these Federal Funds withheld or cut off. It is realized, of course, that such a request of another agency on the part of the Bureau could lead to considerable criticism, especially on the part of newspaper columnists who might become aware of the tactic.

The Bureau's comments are requested.

Coverage of SDS at the University of Rochester (U of R) is quite comprehensive. In addition to liaison with the local and state police, there are a number of established sources on campus in a position to furnish accurate information about SDS, not to mention two PSIs who are in the process of penetrating this group. It is anticipated that these PSIs will develop into valuable Security Informants.

The program of penetrating the New Left at the U of R is a continuing one. There are no known factors at the U of R which would lead to the conclusion that violence is likely to occur there during the forthcoming school year.

Because of the relationship between the student body and the administration at State University College at Fredonia (SUCAF), the Dean of Students there, who is a source, is able to provide good coverage. Efforts are being made to place

a source inside the Independent Student Union on that campus.

The potential for violence on campus is small because of the size of the Independent Student Union and the lack of an issue on campus.

Because of Alfred University's policy regarding demonstrations which requires that any demonstration be cleared with the Dean of Students; it is advantageous that the Dean of Students be a source for proper coverage on SDS. This Dean has furnished valuable information; however efforts are being made to develop a source within this SDS Chapter. This will, of course, depend on whether this tiny SDS group continues to exist on campus. It is the belief of the school administration that the harmful consequences to SDS resulting from that group's interference with an ROTC review minimizes the potential for violence on campus during the forthcoming school year.

At SUNYAB during the past school year [redacted] and [redacted] provided comprehensive coverage on SDS, Buffalo Student Mobilization Committee (BSMC), The Resistance, and Draft Resistance Union. These informants were aided by [redacted] and [redacted] together with a PSI who is in the process of being qualified. The prospects for coverage on the New Left at this University are improving for the forthcoming year because of the development of at least two additional PSIs who are students. Although during the past school year there were two incidents of a disruptive nature caused by the New Left, these did not result in violence, vandalism or even disorderly conduct. It would appear that the present climate at SUNYAB does not lead to the conclusion that violence will be forthcoming in the foreseeable future; for a few months The Resistance at SUNYAB was extremely active in connection with SDS and BSMC. For a number of reasons it became dormant and for the past several months has been completely inactive. Although it is mentioned in the enclosed LHM as a New Left group at SUNYAB, it is not treated in detail as are the other campus organizations of this type because during the late winter of 1968 it ceased to function.

The New Left at State University College at Buffalo (SUCAB) consists only of a small SDS chapter which is made up of non-militant students. The only student who can be regarded as somewhat militant is the Chairman. The source coverage on this group is excellent in that each member has been identified.

It is the aim of this office to place an informant in the ranks of this SDS group. Because of the non-militant character of this SDS Chapter and because of the placid campus atmosphere there is little reason to believe that the New Left will cause any violence at SUCAB.

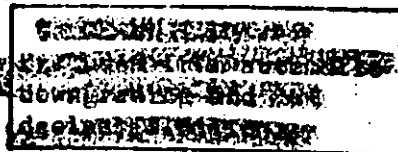

A brief summary of [redacted] activity is described

at which he frequently acted as Chairman.

[redacted] is known to have participated in numerous  
demonstrations protesting United States involvement in  
Vietnam, on-campus recruiting of CIA and Dow Chemical  
Corporation, and the policies of the Selective Service  
System.

[redacted] was ordered to report for induction at  
Buffalo, New York on February 29, 1968, after being  
declared a delinquent registrant by his Draft Board.  
He appeared at the Armed Forces Examining and Entrance

Station, Buffalo, New York, as ordered, but refused to cooperate with examining officials and was declared an uncooperative registrant.

[redacted] has regularly attended weekly meetings of SDS. On occasion he has acted as Chairman of meetings, and following the resignation of [redacted] as President of SDS, in the absence of [redacted] he acted as President of SDS. He has participated in many demonstrations including a sit-in demonstration against the Dow Chemical Company recruiters at the University of Rochester. He and [redacted] supra, were among approximately 85 students who were "suspended" for obstructing a Dow recruiter at the U of R.

To avoid the "suspension" which did not result in curtailment of any academic or social privileges, it was merely necessary for students to sign a form stating they were appealing. Despite this, however, SDS reputedly under [redacted] leadership, organized a strike or boycott. Approximately 500 students stayed away from classes. About 350 students and faculty members demonstrated peacefully in protest of the university "suspension." [redacted], Provost Marshal at the University, announced his resignation and the school created a new committee with student representation to handle student disciplinary actions. Disciplinary "suspension" of the students was rescinded.

### The Resistance

The University of Rochester Chapter of the Resistance was formed in the winter of 1967. Its chief organizer is [redacted] who, as mentioned earlier, refused to cooperate with examining officials during his induction physical.

Membership in The Resistance is approximately ten. Activities are limited to weekly discussion groups. Another sixty persons have attended these meetings, and indicated interest in serving as draft counsellors.

Although The Resistance contemplates opening a draft counselling office at 116 St. Paul Street, Rochester, New York, sources are unaware of any illegal counselling activities. None are known to have urged deceiving draft boards or examining facilities, fleeing to Canada, or submitting false conscientious objector claims.

Primary goal of The Resistance is to counsel high school males on draft alternatives.

During 1960, Campus Americans for Democratic Action (CADA), an organization which sympathizes with the principles of the Students for a Democratic Society (SDS), but has no direct affiliation with any SDS group in Western New York, was active on the SUCAF campus. During January, 1967, the SUCAF chairman for CADA was dismissed from school and shortly thereafter became affiliated with CADA in New York City.

During February, 1967, at a national board meeting in New York City, a split occurred between the parent organization, CADA and the students, which resulted in the CADA national headquarters being moved to Washington, D.C. To protest this move, several national leaders of the CADA resigned, resulting in the formation of ISU, which would carry on the basic principles and programs of CADA.

The primary goal of ISU is the education of students concerning the true nature of the government and its subsequent actions and the influence of economic issues on Governmental action. ISU offers moral support to Black Power and to Civil Rights movements. Their immediate aim was to inform students about the group and to ease the predominant feeling of adversity toward active members.

During the school years 1967-1968, ISU at no time had a membership on the SUCAF campus of more than thirty students, and their only action was to demonstrate against military recruiting on campus and to participate in several nationally-scheduled demonstrations regarding the United States policy in Vietnam.

At the present time, ISU is inactive as school is closed for the summer recess. Source stated that its Vice Chairman and original chairman during

the formative years, [REDACTED] has left school and will not return in September, 1968. Its chairman, [REDACTED] will return in September, 1968. However, the plans for ISU will have to be formulated at that time, as its activities have been curtailed since May, 1968.

Identity of Leaders

[REDACTED] took part in the SDS demonstration against Dow Chemical Company interviews at Alfred University on February 29, 1968, and a demonstration at an ROTC review at Alfred University on May 11, 1968. As a result of her refusing to leave the field during

the ROTC review, she was provisionally suspended, and is no longer attending Alfred University. [redacted] also participated in a parade on April 27, 1968, at Alfred, New York, concluding a mock convention of one of the major political parties. SDS halted the parade briefly at a point in front of the Alfred University Administration Building, while [redacted] spoke on SDS objections to the war in Vietnam, racial oppression, and the draft.

[redacted] is Chapter Secretary of SDS at Alfred University. He was born December 9, 1946 at Yonkers, New York. He transferred to Alfred University on September 21, 1966 from the University of Dubuque, Dubuque, Iowa. His home address is [redacted] 76 [redacted] His mother is [redacted] also took part in the demonstrations against Dow Chemical Company on February 29, 1968, and demonstrated during the ROTC review on May 11, 1968.

Inasmuch as [redacted] conformed to University policy concerning dissent during the demonstration at the ROTC review, he was not provisionally suspended from the University.

Summarization of  
Campus Disruptive  
Activities During  
The Past Year

SDS demonstrated against Dow Chemical Company interviews on campus on February 29, 1968. The demonstrators protested the presence of Dow Chemical Company recruiters on the Alfred University campus, and the firm's participation in the Vietnam war through the manufacture of napalm. Approximately fifteen students and three faculty members participated in the demonstration, which was peaceful and terminated on February 29, 1968 at the conclusion of the Dow Chemical Company interviews.

On April 26, 1968 [redacted] Faculty Advisor of SDS, spoke at a teach-in, which was held in front of the Campus Center at Alfred University from 9:00 a.m. to 12:00 noon. The purpose of the teach-in was to show opposition to the war in Vietnam, to racial oppression, and to the United States Selective Service System.

On April 27, 1968, a parade was held on Main Street, Alfred, New York, at the conclusion of a mock convention of one of the major political parties held at Alfred University. Approximately 25 persons, including members of SDS, carried placards during the parade protesting United States involvement in the war in Vietnam, the Selective Service System, and racial oppression. At a point in front of the Alfred University Administration Building, the protestors halted the parade while SDS Co-Chairman [redacted] spoke on SDS objections to the war in Vietnam, racial oppression, and the draft. At the conclusion of her speech, SDS co-chairman [redacted] and another Alfred University student, [redacted] and an English Professor, [redacted], allegedly turned in their Selective Service cards to Reverend [redacted] who was also marching with the protestors.

On May 11, 1968, [redacted] and fifteen students, marched onto the Alfred University athletic field carrying placards critical of the ROTC and the United States involvement in the war in Vietnam. Alfred University's policy on demonstrations was invoked, and the demonstrators were ordered to leave the field. Seven students departed, but the other eight and [redacted] continued their demonstration. The eight students were provisionally suspended by Alfred University, and [redacted] an Associate Professor of History, was dismissed from this university.

No violence erupted at either of the above demonstrations. There was no evidence of any outside influence during the above demonstrations.

The article disclosed that the program of BSMC will encompass peace activities, including anti-Vietnam war action, Draft resistance, and a community education program.

BSMC, during the summer of 1967, has been meeting regularly on the SUNYAB campus. Its membership and leadership is comprised of the "New Left" which consistently opposes all phases of United States policy, both foreign and domestic. The local publication, which usually carries the line of the Buffalo Student Mobilization Committee is "The Buffalo Insider."

On the morning of December 18, 1967, approximately 200 students demonstrated against the presence on the SUNYAB campus of representatives of Dow Chemical Company. They were, however, not able to carry out their plans to interfere with the interviewing of student applicants because they could not locate the building in which the interviews took place. The sponsoring groups of this demonstration were SDS and BSMC.

On March 19 to 21, 1968, a temporary group of the "ad hoc" type, known as University Community for Rational Alternatives, held "Strike for Knowledge - Stop the War," on the SUNYAB campus. The purpose of the strike was to emphasize the seriousness of the war in Vietnam by disrupting classes. After the strike was over, its value was assessed by New Left leaders. It was generally agreed that since the strike demonstrated anti-Vietnam war sentiment even by those who were previously

Between 2:00 and 6:00 p.m., May 9, 1968, approximately 60 students occupied the offices and adjacent corridor of the SUNYAB President. While there, they prepared a letter using the official stationery of the SUNYAB president. The letter contained a resolution previously passed by the Faculty Senate, the Student Senate, and the Graduate Student Association of SUNYAB, which condemned the war in Vietnam, and also included a special amendment calling for complete non-cooperation between the University and the Selective Service System.

Certain New Left leaders including [REDACTED] and [REDACTED] devised a plan to take over the President's Office and use his stationery to prepare the letter in order to support the claim that the resolution and amendment were the official policy of the University. No violence or damage occurred.

## Potential Counterintelligence Action

An opportunity for counterintelligence action is shaping up in connection with [redacted] of the leaders of the New Left at the State University of New York at Buffalo (SUNYAB), and one of the leaders of the Draft Resistance Union, Buffalo, New York, who will probably be considered for prosecution for violation of the Selective Service Act, 1948. [redacted] he is under review by higher Selective Service boards; but in the not too distant future, he will probably be adjudged draftable. Buffalo plans to follow this case closely to insure that if [redacted] is found in violation of the Selective Service Act, his prosecution will be handled with reasonable dispatch. This, of course, will act as a deterrent to others in the New Left. Whenever specific counterintelligence action presents itself, Buffalo will furnish the information for Bureau approval.

## Pending Counterintelligence Action

On 5/11/68, approximately 15 students representing the Alfred University Chapter of SDS purposely interfered with an ROTC (Reserve Officers Training Corps) Review being held on campus. When seven of the students and an Associate Professor, after being requested by the Dean of Students to desist from interfering with the review, refused to comply, the seven students were suspended and the Associate Professor was dismissed.

[REDACTED] set forth University policy as follows:

"Responsibility for making decisions and setting policy lies with the administration, the faculty, and the authority dictated by the Board of Trustees. Students who differ from this arrangement would be well advised to transfer to another institution."

[REDACTED] showed some firmness with students who participated in an SDS staged campus sit-in, on 11/8/67, to protest recruitment by the Dow Chemical Company. A total of 31 University of Rochester students were placed on probation. Of this number, 23 Graduate Students were suspended.

As a result of this, on 12/13/67, the University of Rochester Student Government voted to strike to protest the administration's decision to suspend the 23 Graduate Students. On 12/17/67, after a three-day student strike, the University rescinded the suspension of the 23 Graduate Students.

[REDACTED] State University of New York at Buffalo (SUNYAB), has refrained from showing firmness with the New Left at that University.

On the afternoon of 5/9/68, 60 students led by various New Left leaders who were then or had been active in such organizations on campus as SDS, the Buffalo Student Mobilization Committee, the Resistance, and the Draft Resistance Union, took over [redacted] office in order to prepare and mail a letter which included a statement that an anti-Draft amendment to a previous anti-Viet Nam War resolution passed by various faculty, graduate school students and student body members was the official policy of SUNYAB.

[redacted] was out of town when this incursion took place. The mailing on the stationery of the SUNYAB President was made to each college and University in the United States and to numerous leaders of Government. Despite the fact that the group took over the facilities of [redacted] office, no disorder or vandalism resulted.

It is interesting to note that [redacted] observed at this time that New Left leaders at SUNYAB have a low regard for [redacted] because they blame him for the decline of the New Left at the University of California at Berkeley, California. B2

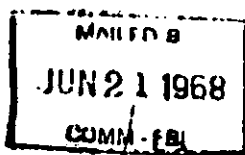

As prior investigative reports on [redacted] will confirm, he is one of the leading members of the New Left in the Buffalo, N.Y., area. His New Left activities ranged from the SUNYAB Chapter of Students for a Democratic Society (SDS), Buffalo, Student Mobilization Committee, the Resistance, up to his current project, Draft Resistance Union. He is a leader of New Left activities at SUNYAB. [redacted] on several occasions was the local organizer of New York City and Washington, D.C., demonstrations against the war in Viet Nam. He is presently on the Security Index.

Buffalo proposes the following:

Inform an official at Rosary Hill College regarding [redacted] New Left Activities and the probable results of his presence on the staff at that college. This may be discreetly accomplished through [redacted] who is known by a Buffalo Agent; [redacted] which will be followed up by public source material of a New Left nature regarding [redacted] such as appeared in the SUNYAB student newspaper or by a third party who is responsible and completely trustworthy. One who would be very suitable for this third party assignment is [redacted] -who is a long-time friend of a Buffalo Agent.

It is not anticipated that any of the above three methods of notifying the college about [redacted] will result in any embarrassment to the Bureau. This office is positive that the last two methods will definitely not result in the subject ever learning that the Bureau was connected with this strategem.

If Buffalo receives Bureau authorization to act on this proposal on time, it could result in [redacted] being without a job in the Sociology Department at Rosary Hill College and also being without his Teaching Assistantship at SUNYAB. It would prevent a nucleus of the New Left being formed at Rosary Hill College. It would most likely result in other colleges in the Buffalo, N.Y., area being alerted to [redacted] desire to secure employment as a Teacher of Sociology.

There are being set forth the observations and plans of this office to participate in this necessary and important program.

The summer of 1968 offers an excellent time to plan this program rather than put it into operation. With the school year coming to a close, some of the New Left leaders have departed this area permanently. Others have left for home, not to return before September. With regard to organizations, some have become inactive, for example, the Chapter of Students for a Democratic Society (SDS) on the campus of the State University of New York at Buffalo (SUNYAB) has not held a meeting since March, 1968. The Resistance has not had any activity since the end of February, 1968.

By waiting until the resumption of the new school year, when the New Left organization and leaders will be known, it will be possible to execute plans against specific objectives, which should be conceived during the present period. The technique of exposure probably will have little or no effect on the New Left. On the contrary, the New Left appears to thrive on it. It is apparent that the New Left in this Division makes no effort to hide its plans, always gives plenty of publicity to its activities, and conducts open meetings. Actually, it is easier to follow such groups which furnish this amount of publicity about themselves.

If the New Left went underground or entered into a clandestine phase, the Bureau's problems would multiply considerably. Attempts to hold the New Left and its leadership up to ridicule will probably result in their winning the sympathy of the portion of the uncommitted students at the colleges and universities.

Buffalo recommends the technique of disruption and neutralization, the most effective. In this area, the most disruptive influences on the New Left have been the application of the law to the leaders. For example, one of the key students in the New Left in Buffalo, New York during the past year was [REDACTED]. After receiving a notice to report for induction and after refusing to be inducted, he fled to Canada with his girl friend, [REDACTED] who was by far a leading female of the New Left in this Division.

Another example of the fear of the law can be found in the case of [REDACTED] a Canadian who was one of the founders of SDS on the SUNYAB campus, and who remains the most effective leader SDS has ever had in this area. After the United States Immigration and Naturalization Service called him in for questioning and after he realized that he might be drafted, he hastily left SUNYAB to re-establish residence in Canada.

A third example is the case of [REDACTED] who was extremely active between September, 1967 and January, 1968, when he was President of the Buffalo Student Mobilization Committee (BSMC). He suddenly ceased activities and is not known to have the remotest connection with the New Left since January. It is the opinion of the informants that [REDACTED] was fearful of his anti-Government activities, which might have placed him in jeopardy with the Federal Government law.

Another example of the application of the law having a curtailing effect on the New Left may be found in the anti-draft demonstrations of December 4 and 5, 1967 in Buffalo, New York.

On 4/5/68, in particular, outside the Armed Forces Induction Center, a disposition toward violence came to a peak, which resulted in the arrest of nine persons on local charges. Since then, the many anti-draft demonstrations outside the Armed Forces Induction Center have been tame.

In view of the foregoing, Buffalo wishes to make its first proposal that each New Left organization activist be scrutinized for application of the law, both Federal and local.

The prompt and proper exercise of power of the administrator of a college or university can also effectively disrupt the New Left. Recently, the SDS Chapter at Alfred University, Alfred, New York, decided to interrupt a ROTC review. This resulted in the dismissal from the school of one professor, a consideration for dismissal of another professor, and the suspension of seven students, two of whom are in a leadership capacity at SDS. This effective type of action can lead to total disruption of a New Left group.

This prompts a second proposal that consideration be given to attempting to establish discreet liaison with persons in authority at colleges and universities where the New Left has some strength. After establishing a relationship, on a confidential basis, furnish the administrators key information about the New Left and its plans. This will tend to establish a rapport between an office and the responsible heads of the university, both of whom are working toward a common goal.

This organization, therefore, would have to be done on a selective basis. It may be that the president or chancellor of a university would not be the person to approach directly; but instead, it may be preferable to work through certain assistants of his, who may be reliable sources and known to be completely trustworthy.

If the New Left in this Division has a summer program, Buffalo will, in keeping with current instructions, give consideration to applying counterintelligence techniques.
