As to the remaining five security index subjects of this office, the following situations, of which the Bureau has been previously advised, are set forth:

- (7) [redacted], formerly a resident of [redacted] [redacted], Birmingham, Alabama, has moved from Birmingham, and is believed to be residing at or near [redacted], Fresno, California. San Francisco Office is currently attempting to verify his permanent residence.
- (8) SAM J. HALL, Jr., and [redacted]
- (9) [redacted], have vacated their former residence, [redacted], Birmingham, and shipped their household goods to New York City. HALL has most recently been reported as Chairman of the Louisiana Communist Party and both the New York and New Orleans Offices are attempting to verify his permanent residence.
- (10) HOSEA HERMAN HUDSON appears to have no permanent address at this time, and is known to be a transient. He has resided in numerous Birmingham addresses and was most recently reported as late as February 1951, to be in New York City, at the birthday dinner of WILLIAM Z. FOSTER.
- (11) HENRY OBIE MAYFIELD last resided in Birmingham at 1513 West First Court, and his present whereabouts is unknown. His household goods have been stored for several months at the Continental Van Line Warehouse at Birmingham and the Cleveland Office is currently attempting to locate the subject in that city, as he has been reported to have been seen there recently.

This information is to the effect that he is a CP member through the national organization of MINE, MILL AND SMELTER WORKERS at Denver, Colorado, of which organization he is a Vice-President. It is necessary to continue investigation to fully develop his CP connections. A summary report will be prepared in the near future and a recommendation will be made regarding placing this subject on the Security Index.
