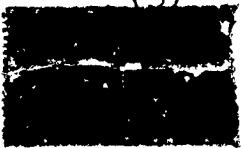

Out of the 162 original cases on the Communist Index, Indianapolis Office, plus the additional ones which have been received from other offices due to the subjects having moved to Indiana, Indianapolis Office has completed investigation on all but 9. Of these 9 which are still currently under investigation, 2 were received from another division during the past month. Of the remaining 7, 4 are to be interviewed as the only remaining bit of investigation. These 4 are all from Lake County, and these interviews have been complicated by the steel strike which has delayed their completion.
