SECURITY INDEX -

There are approximately 100 members of the Communist Party in the San Diego area. Reliable informants have estimated that about 50 members are active to the extent that they evidence sufficient interest in the Party to pay dues. At the present time there are 73 pending cases in the entire "100" category. San Diego is origin in 52 of these cases which concern individuals reportedly engaged in Communist activities. This figure includes 7 cases on members designated as key figures.

As set forth in SAC Letter Number 44 dated 4-14-47, investigative effort should not be diffused in an attempt to cover the activities of every individual reported as a Communist Party member. Rather, such effort should be concentrated on following the activities of only those whose position or active interest in the Party warrants such attention. The implementation of the redirected program prescribed by the Bureau is dependent upon careful evaluation of each case individually.

Upon the basis of a review of 30 pending cases, it is recommended that consideration be given to closing numerous cases administratively in accordance with instructions contained in the referenced SAC Letter. For example, the following fourteen cases appear to have all information specifically required on subjects with their degree of activity in the Party:

A spot check of these files reveals no recent pertinent activity on the part of these individuals. It is recommended, therefore, that consideration be given to a review of pending Security Matter - C cases in which San Diego is origin in order that each may be properly evaluated in the light of present circumstances. Such evaluation should determine whether or not each case is deserving of further investigation. If not, the case should be closed administratively, and subsequent material should be merely channeled to the file until such time as that subject is reported active or believed dangerous, in which event it should be reopened.

A review of the general file on Communist Activities in the San Diego area reflects that the great majority of information is obtained from one informant who is a Communist Party member in San Diego. A second informant, who is a Communist Party member in the Riverside area, has been developed during the past month. Reports submitted covering general Communist activities in this area reflect no information regarding possible Communist activity in either Orange or Imperial Counties.

Coverage of activities in the headquarters office of the Communist Party in San Diego is effected through one microphone surveillance and one technical surveillance. By memorandum for the file dated 10-6-48 SAC W. A. MURPHY recorded the fact that it was necessary to eliminate covering these surveillances from 4-10-48 to 8-30-48 due to the extreme demands upon the personnel of this office under the Loyalty Program. Coverage of these surveillances was reinstated on 8-30-48.

Log sheets prepared in connection with these surveillances have been bound by Acco fastener and numbered. They are maintained in this form in the closed section of the files. At the present time the last bound log sheet is dated 9-21-48. Log sheets submitted since that time have been reviewed and placed in the file jacket without having been numbered or bound. There is no indication that this information in loose-leaf form has been considered for indexing, and such indexing would be impossible since the pages are not numbered.

It is recommended that after a review of log sheets prepared each day, each sheet be numbered, marked for indexing, handled by the Chief Clerk's Office, and placed in chronological order in the bound file. This operation is necessary to insure that the office index reflects current information available at all times.

Security Index Cards

There are 57 Security Index Cards maintained in a box which is located in the office safe. In view of the estimated total membership of 100 in this area, it is evident that more than fifty per cent of the estimated membership have been deemed of such importance as to warrant preparation of a Security Index Card.

A spot check of the cards reflects that several members who are presently subjects of Security Index Cards have not engaged in recent important activities on behalf of the Party, nor does available information reflect any evidence to indicate that they should be deemed dangerous. It is recommended that cases on the following individuals be reviewed to determine the advisability of canceling Security Index Cards presently maintained:

Referenced letter points out that on occasion a new individual becomes active in Communist Party activity and is readily accepted by other Party members. Your letter then suggests that the Office receiving such information should attempt to determine the identity and previous residence of such an individual and when this is accomplished, a letter should then be directed to the Office covering the place of previous residence and advise of the presence of such individual in the new location. Your letter further suggests a method of locating and identifying individuals that are moving about the country. Present instructions on Security Index subjects require that the data on Security Index cards shall at all times be in an up-to-date status and addresses must be checked at least once every six months. Arrangements must be made so that the Field Divisions will be advised of any change in the subject's residence or business address. Whenever it has been determined that a subject has moved to an address located in another Field Office, the Office in whose territory the individual is now residing will be immediately notified in order that the new residence address can be verified.

In any instance where an individual comes into your territory and immediately becomes active in Communist Party activities and you find it impossible to determine his true identity your Office should notify the Bureau of full particulars concerning the individual, furnish a detailed description and enclose a photograph, if possible, and the Bureau will then render whatever assistance it may be in a position to give.

The Bureau feels that there will be very few instances arise wherein the facts would justify the circularization of the fifty-two Offices in the country in order to try and identify one individual Party member.

Referenced letter further suggests that prior to closing a case in which the subject is listed in Security Index, arrangements would be made for a reliable neighbor of the subject to be developed as an informant to advise of any move on the part of the subject.

Reference is made to mylet dated 3-31-51, captioned "MRS. [redacted] - SECURITY MATTER - C" (Bureau File 100-375485), wherein the results of interviews with Mrs. [redacted] and her husband [redacted] were pointed out. It was shown that the information furnished by [redacted] was limited to events taking place in a period from one to two years ago, when he was active in the Civil Rights Congress and the International Workers Order, but he was unable to furnish any information of current value.

It is believed that additional interviews with other subjects of Security cases would be of great assistance in determining the present or potential dangerousness of a particular subject. It would appear, however, that such interviews should not be restricted to subjects who have defected from the Communist Party, since those who have defected are no longer in a position to furnish any current information of value.

In this connection, reference is made to the suggestion of SA [redacted] of this office, dated July 13, 1950, captioned "INTERVIEWS OF CP MEMBERS" wherein it was suggested that unless a special reason exists for not interviewing a particular CP member, that such interviews be conducted on a wider and less selective basis. Subsequent instructions as issued by the Bureau permitted more leniency in requesting Bureau authority to interview subjects but these instructions considered defection from the Communist Party or Communist Party sympathy as a prerequisite before allowing such interviews.

Reference is further made to the comment of Inspector NAUGHTEN in the Inspection Report relative to the San Diego Office Inspection held during January, 1951, wherein comment was made concerning the refusal of the Bureau to allow Agents of this office to interview certain subjects because defection from the Communist Party had not been clearly shown and the Inspection Report also stated that defection should not be a prerequisite for such interview.

It is accordingly requested that the Bureau give consideration to interviews of currently active Communist Party members who appear to be either not vigilant members or members who for some reason might be

willing to be of assistance to this office in furnishing information concerning their activities. In this connection I have reference specifically to Communist Party members who are negroes who might have joined the party at the urging of other Communist Party members whose desire was merely to have a negro in a cell or club. There are several negro members of the Communist Party in San Diego, whose activity in the party has been far from militant and a definite impression has been received by Agents of this office that some of these members have no actual interest in Communism and would be very cooperative upon being approached for information concerning their current activities.

It is requested that the Bureau advise as to whether interviews with persons falling within these categories would be considered by the Bureau and if so, individual requests will be made for permission to interview them.

An early reply will be appreciated.

In those instances when the subject makes admissions as to his own participation in Communist Party activities or activities in violation of the Federal code and it is obvious to the Agents conducting the interview that prosecution may be expected at a later date, the Agents should be certain that Bureau instructions in this regard, as they apply to interviews and the taking of signed statements, are closely followed.

I am sure you realize the importance of the interview program as a means of developing informants and information of intelligence value which are the primary purposes. The purpose of an interview is not to build the case for prosecution. Tact must be used in handling interviews if we are to obtain the best results possible.

REPORT WRITING

The Bureau is requested to advise the San Diego Division concerning the manner it desires the following types of information to be reported and handled:

(1) Prior to abolition of the Administrative Page it was not permissible to mention "The National Guardian" in the details of a report. Is it now necessary to forward information regarding "The National Guardian" in a cover letter or may that newspaper be referred to in the details of a report?

(2) Is it permissible to indicate in the details of a report that a Security Flash has been placed? Is it mandatory?

(3) In the last paragraph of No Number SAC Letter, dated June 11, 1951, regarding interviews of individuals who are not being recommended for the Security Index, the Bureau instructs that any information of value obtained as a result of interview should be reduced to a signed statement, if possible. Bureau advice is requested regarding its desires in respect to the following situations which may arise when these interviews are to be conducted:

1. When it is not known whether the person interviewed will be cooperative, is it necessary to warn that person that any statements he may make may be used against him, that he need not make any statement, and that he is entitled to legal counsel?

2. In the event the person interviewed consents to execute a signed statement, what information does the Bureau desire the preamble to such a statement to contain under the following conditions:

- (a) In the event the person interviewed makes admissions as to his own participation in Communist Party activities.
- (b) In the event the person interviewed furnishes only information regarding Communist Party activities on the part of others.
