Reference Bulet 9/14/56 requesting accomplishments of the San Francisco Division during the intensification of the above captioned investigation.

The scope of the problem in this Division has been outlined by information received from confidential sources which have furnished up-to-date figures by counties of the Communist Party membership. In order to ascertain how effective our efforts have been to identify the individuals comprising this membership, this Office has set up a procedure of making a complete compilation, every four months, of all identified CP members and the group to which they are assigned. By letters dated 2/29/56 and 6/28/56 under the caption "CP USA Organization-Membership," this Office has furnished the Bureau copies of this compilation.

The 1956 CP registration figures as of March 1956 show a total of 947 members for all counties within the San Francisco Division. We feel we know who these people are; they are on the Security Index. Moreover, 630, or two thirds of the total membership, can actually be placed in the particular club or position assigned. The total number of individuals included in the Security Index of this Office is 1358. Substantial progress under this intensification program has been made during the past year as reflected in these surveys and the next four month survey due on 10/20/56, will reflect additional gains.

The approach to the problem of complete identification of all CP members in the San Francisco Division has been as follows:

- 1) Security squad assignment of personnel has been patterned to conform to the organization structure of the CP. In metropolitan areas where CP sections are large there are co-ordinators assigned to direct the efforts of personnel investigating neighborhood and industrial sections. Office space is also assigned in conformity with this breakdown.
- 2) A co-ordinator and agents with specialized experience are assigned problems in developing highly confidential sources. 26 new, highly confidential sources have been developed within the past six months. During this period these sources have furnished 5600 photographs of CP records.
- 3) A surveillance calendar is maintained on which correlation is made of information coming from informants, highly confidential and technical sources regarding the scheduled CP meetings. This calendar has afforded advance information so that productive physical surveillances of CP meetings have been scheduled.
- 4) The periodic survey of the membership and organization mentioned above has provided direction for concentrated investigative efforts in those areas where our penetration of the CP was not well developed.
- 5) The importance of long term coverage of the CP through live informants has been strongly emphasized. Five informants have been admitted as new members into the CP within the past six months.
- 6) The current political and organizational crisis within the CP has caused several defections and stirred much critical discussion within the Party. This has been followed closely for the purpose of turning these members and utilizing them as informants.

- 7) The growing factionalism within the CP leadership and the divergent opinion and direction of the membership is being studied so that the future programs and organizational form of the CP may be anticipated.
- 8) A program of concentrated physical surveillances has been instituted in those areas where identification of CP membership was not adequate. In the East Bay region a successful surveillance of the 20th Century Bookstore, a distribution point for CP literature, was conducted. Identification of club literature directors and CP meetings which they attended was effected in this manner. Selected surveillances of CP functionaries have been conducted at night which has led to coverage of section and club meetings.

The future plans for effecting the identification of the entire CP membership within the San Francisco Division includes the continued application of the above methods to future investigative opportunities. These opportunities are expected to develop out of reorganization of the party; the scheduled conventions on the section and county levels prior and subsequent to the National Convention in February 1956 and the new CP policy of de-emphasizing security precautions.

The San Francisco Office feels that ALBERT JASON LIMA (Aka. MICKEY LIMA) should be designated a top functionary by the Bureau since LIMA is both a member of the Communist Party National Committee and the Communist Party National Executive Committee. LIMA is also the paid full-time Chairman of the Northern California District Communist Party Organization.

The San Francisco Office believes that LIMA as Chairman of the Northern California District Communist Party and a member of the National Communist Party Executive Committee, requires continuous investigative attention. LIMA in his position as Chairman of the Northern California District Communist Party and as a member of the National Communist Party Executive Committee is on a high policy making level of the Communist Party, USA.

It is therefore recommended by the San Francisco Office that the Bureau again consider designating MICKEY LIMA a top functionary.

Since LIMA has previously been designated a key figure by the San Francisco Office, photographs and handwriting specimens have previously been sent to the Bureau.

The Bureau has just undertaken a new program to review the Communist Index and to bring it up to date as an auxiliary and a "back stop" to the Security Index.

The current practice is to remove the Security Flash when a person is removed from the Security Index. Each person removed from the Security Index automatically is placed on the Revised Communist Index. Since individuals removed from the Security Index are of more importance to us now than they have been in the past, and since no expense or additional administrative effort should be involved, SA FRANCIS M. CONNOLLY of this office has suggested that we no longer remove the Security Flash when we remove an individual from the Security Index. *2-12*

The benefit of leaving the Security Flash on the subject would be that we would learn of his arrest, his application for certain types of employment, or the fact that he had moved from our territory, by means of such retention.

The following analysis of the Communist Index in the San Francisco Office may be of some aid to the Bureau in determining the effects of relet upon the Field as a whole.

The old Communist Index in this Division consisted of about 12,000 cards. Upon the receipt of SAC Letter 55-56 (L), 10/30/56, which set up new standards for the revised Communist Index and stated the purpose of the Communist Index to be an auxiliary to "back up" the Security Index in time of emergency, it was realized that the 12,000-card Communist Index in this Division was too unwieldy and out-of-date to serve its purpose.

Therefore, it was decided to bring it into line with the standards of the revised Communist Index as simply and as quickly as possible. Each Agent assigned to the five Security and Espionage Squads was assigned a proportionate number of cards in alphabetical order. He was asked to review the files represented by the cards - nearly all closed - and advise the Security Index Clerk if the person was eligible for the revised Communist Index. These file reviews took place on a strictly voluntary basis at night in the closed files section. No cases were opened and no administrative detail was involved.

The survey was completed between 11/15/56 and 2/15/57 and reduced the old Communist Index of 12,000 to about 1,350, which truly represented an auxiliary to the Security Index.

Subsequently, the Supervisors noted that material indicating continued subversive activities was being channelized into the files of persons on the Revised Communist Index. Between November of 1957 and June of 1958 the Supervisors systematically reviewed - in alphabetical order - each of the cases on the Revised Communist Index. A certain number of cases were reviewed each day; cases were opened for investigation only when the facts warranted, principally for Security Index and informant consideration.

Since the San Francisco Revised Communist Index is approximately one-tenth of the old Communist Index, the number of cases opened in San Francisco under Bulet of 10/2/58 will be considerably less than those opened in offices which have not yet purged their old Communist Indices.

If the experience of this office prevails throughout the Field, the Bureau can expect that the old Communist Indices in the various offices will be reduced to about one-tenth their former size.

It is believed that the Bureau's present program as set out in Bulet 10/2/58 is an excellent one. It carries out the Bureau's responsibility to make certain that there are no "sleepers," that subjects are placed on the Security Index when they belong there, and that the Bureau is taking advantage of every potential informant situation. The San Francisco Office is following this program with great interest and enthusiasm.

Referenced SFlet noted that a previous program in this division had reduced the communist index from approximately 12,000 cards to 1,350.

The present program, initiated by referenced Bulet, provides that each Communist Index case be opened. They are being opened in alphabetical order.

Statistics for the period ending 12/30/58:

- (1) 1350 on CI at beginning of program
- (2) 1322 on CI as of 12/30/58
- (3) 28 removed from CI during period
  - (a) 18 were removed in cases opened under this program.
  - (b) 7 of these were RUC'd to other divisions (The remaining 10 deletions (the difference between 18 and 28) from the CI were prompted by information received through our regular coverage and were not yet opened specifically under the alphabetical program. In this group 5 were placed on the SI, 3 were RUC'd to other divisions and 1 died.)
- (4) No informants or potential informants have been developed thus far.
- (5) 1 subject was placed on the SI as a result of this program and two others have been recommended.
- (6) No espionage cases have been opened.
- (7) Four subjects were found to be employed at key facilities; appropriate action taken.
- (8) No other instances occurred where this program turned up subjects with delicate or sensitive employment or relationships requiring additional dissemination in line with the FBI's over-all security responsibilities.

# NOTICE TO ALL OFFICERS AND EMPLOYEES OF THIS FACILITY

---

The Secretary of Defense has designated this facility as a "defense facility" pursuant to section 5 of the Internal Security Act of 1950 as amended (64 Stat. 987, 992; 50 U.S.C. 784).

I. When a Communist organization as defined in section 3(5) of the Act as amended (64 Stat. 987, 990; 50 U.S.C. 782(5)) is registered with the Attorney General of the United States or there is in effect a final order of the Subversive Activities Control Board requiring such organization to register, it is unlawful for any member of such organization, with knowledge or notice that such organization is registered or that such order has become final—

(a) in seeking, accepting, or holding employment in any defense facility, to conceal or fail to disclose the fact that he is a member of such organization;  
or

(b) if such organization is a Communist-action organization, to engage in any employment in any defense facility.

II. It is unlawful for any officer or employee of a defense facility, with knowledge

or notice that a Communist organization is so registered or that such an order has become final—

- (a) to contribute funds or services to such organization; or
- (b) to advise, counsel or urge any person, with knowledge or notice that such person is a member of such organization, to perform, or to omit to perform, any act if such act or omission would constitute a violation of the provisions set forth in Paragraph I above.

The Communist Party of the United States of America, since October 20, 1961, has been and is under a final order of the Subversive Activities Control Board to register with the Attorney General as a Communist-action organization. Therefore, the foregoing provisions of the Internal Security Act are presently applicable as to the Communist Party of the United States of America and its members.

Section 15(c) of the Act (64 Stat. 987, 1002; 50 U.S.C. 794(c)) provides that any individual who violates any of the above prohibitions shall, upon conviction thereof, be punished for each such violation by a fine of not more than \$10,000 or by imprisonment for not more than five years, or by both such fine and imprisonment.
