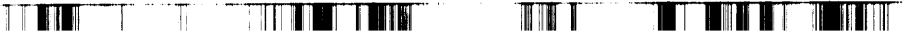

In connection with the Security Index review now in progress, airtels from the field of June 24, 1955, reflect that, of the 26,328 cases to be reviewed, 16,943 have been reviewed and the required data furnished to the Bureau. Of this number, the field has recommended that the Security Index cards on 7,779 subjects be canceled. These figures indicate that the field has reviewed approximately 64 per cent of the cases and has recommended that the Security Index cards be canceled in 46 per cent of the cases reviewed.

These cases are being processed at the Bureau in accordance with previously approved procedure and, as of June 27, 1955, 11,303 cases have been processed. Of these, 5,975 cards, or 53 per cent, were canceled.

Re SAC letter 55-1, dated 1-4-55, requesting all offices to advise the Bureau by 7-1-55 that cases in which no subversive activities have been reported since 1-1-49 have been identified and appropriate communications directed to the Bureau concerning interviews with the subjects.

Since the instructions set forth in SAC Letter 55-30 regarding our over-all Security Index review have been tantamount to superseding the instructions in SAC Letter 55-1, it is desired that the Bureau desire no further action with reference to the first SAC Letter. This is to advise, of course, that no individuals remain in the Security Index in the Chicago Division on whom there are no subversive activities reported since 1-1-49.

In connection with the Security Index review now in progress, airtels from the field of July 1, 1955, reflect that, of the 20,000 cases to be reviewed, 14,700 have been reviewed and the required data furnished to the Bureau. Of this number, the field has recommended that the Security Index cards on 8,760 subjects be cancelled. These figures indicate that the field has reviewed approximately 72 per cent of the cases and has recommended that the Security Index cards be cancelled in 46 per cent of the cases reviewed.

These cases are being processed at the Bureau in accordance with previously approved procedure and, as of July 1, 1955, 13,077 cases have been processed. Of these, 7,009 cards, or 54 per cent, were cancelled.

SAC Letter 55-30 dated April 19, 1955, set a 30 day deadline from date of receipt for offices with more than 1000 Security Index cases to complete review and forward to the Bureau memoranda with regard to Security Index cases. The Seattle Office with 673 Security Index subjects failed to meet the deadline.

The SAC of the Seattle Office in a circular dated June 10, 1955, in weekly airtels that because of (1) unusual amount of investigation being handled by the Seattle Office, (2) the Seattle Office and an inspection of the Seattle Office which began on May 31, 1955, (3) necessity for the preparation of a large number of reports in criminal cases prior to the convening of the Grand Jury in Seattle on June 21, 1955, the stenographic problem in the Seattle Office was in a critical condition making it impossible to process numerous memoranda in connection with the Security Index review which had been prepared in rough draft form by agents. Seattle airtel June 10, 1955, pointed out that all rough draft memoranda had been completed and rough draft memoranda prepared and Seattle airtel of June 14, 1955, noted that the deadline had been met insofar as the review was concerned; however, 299 rough draft memoranda awaited typing.

The SAC noted in his airtel of June 17, 1955, that a special effort was being made to assure typing of these memoranda by July 10.

## RECOMMENDATIONS:

The Internal Security Section feels that the reasons given by the Seattle Office for failure to meet the Bureau deadline in this matter are satisfactory. Seattle will be followed closely to assure completion of this project by the earliest possible date.

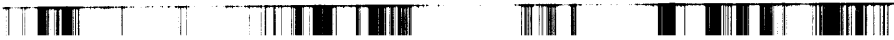

There are 22,321 persons represented in the Security Index (as of June 15, 1955). This is a net decrease of 2,941 or 11.6% under last month. Of the total, 20,777 or 92.2% are active.

The race of Chinese in the index are now shown separately in the race breakdown on the attached table.

A detailed table is attached in duplicate. The table shows as of June 15, 1955, the distribution of the subjects by field office, nationalistic tendencies, dangerousness, sex, race, and citizenship. Also the number on "special lists" are shown. A key to abbreviations is attached.

In connection with the Security Index review now in progress, airtels from the field of July 8, 1955, reflect that, of the 26,328 cases to be reviewed, 20,230 have been reviewed and the required data furnished to the Bureau. Of this number, the field has recommended that the Security Index cards on 9,358 subjects be cancelled. These figures indicate that the field has reviewed approximately 77 per cent of the cases and has recommended that the Security Index cards be cancelled in 46 per cent of the cases reviewed.

These cases are being processed at the Bureau in accordance with previously approved procedure and, as of July 8, 1955, 14,630 cases have been processed. Of these 7,903 cards, or 54 per cent, were cancelled.

No. 7 of the Attorney General's memorandum of July 7, 1955, was then taken up, dealing with the matter of the Security Index. I advised the Attorney General of the necessity of applying the new criteria to the Index. I also had occasion to urge the necessity for some review of the Index by Departmental personnel. Assistant Attorney General [redacted] stated that there were no attorneys or funds available for this to be done. I pointed out the imperative necessity for some action being taken along this line. The Attorney General directed that Assistant Attorney General [redacted] should assign one attorney who would "sample" the cases of persons in the Security Index. I would like to be advised not later than August 15, whether we receive any word from Mr. [redacted] Division indicating initiation of this action.

SUBJECT: DELINQUENCY IN SECURITY INVESTIGATIONS

SYNOPSIS:

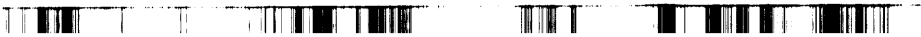
Each month we follow the field closely on the status of security work by analyzing the backlog of pending cases and delinquency in Espionage, Internal Security, Security Matter and foreign intelligence cases in classifications. Status of these cases as of June 30, 1955, is set forth herein.

In June there was a decrease in pending active matters in the entire field in the security classifications from 20,600 to 18,198. Delinquent matters also decreased from 6,377 to 5,077 with the resultant over-all statistical decrease from 30.8 per cent to 27.9 per cent.

Letters are being sent to the large offices indicated by asterisks on page 4 and to the smaller offices indicated by asterisks on page 5 herein, commenting upon their delinquent condition and pointing out the necessity of bringing their security cases to current status.

RECOMMENDATION:

The field will continue to be followed closely regarding security delinquency and you will be advised of the results of the review of the July, 1955, administrative reports.



Memorandum for Mr.

DETAILS:

Since December, 1951, we have been following, on a monthly basis, the twelve field offices having a large proportion of our pending security work and since March, 1952, all offices. We have written letters to the twelve offices and to other offices where progress in reducing the backlog of work and delinquency has not been satisfactory.

The June, 1955, administrative reports from all offices reflect that the total pending active matters in the classifications and 105 decreased substantially from 20,680 to 18,198. The delinquent items decreased from 6,377 to 5,077 which represents a statistical decrease of from 30.8 per cent to 27.9 per cent.

The following statistics reflect the status of pending work including both pending active and pending inactive matters and delinquency for all field divisions as of December 31, 1951, and the progress for the last four months:

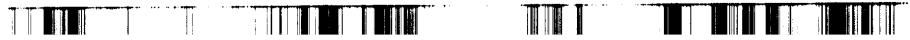

SPECIAL SECTION CASES BEING REVIEWED BY  
DEPARTMENT UNDER REVISED SECURITY INDEX CRITERIA

At 11:35 a.m. today, [redacted], Department Attorney Internal Security Division, telephonically contacted [redacted] Supervisor and advised that reviews in all cases where names of subjects are maintained in the United Nations Employees, Foreign Government Employees and U. S. Government Employees subdivisions of the Special Section of the Security Index were being completed. Reviews made in light of revised Security Index criteria. He stated it is anticipated that advice in all of the cases would be received by the Bureau this month.

[redacted] stated he wanted to clarify the point as to whether the Pro-Tito Yugoslav Special Section was one of the Special Section lists which the Attorney General had agreed to review and advise the Bureau whether the names should be continued in the Security Index. He was advised we would check into the matter.

The Attorney General advised on September 30, 1953, that he had discontinued the general review of all Security Index cases. Bulet October 15, 1953, urged review of all cases but suggested that if general review discontinued that Department review limited number of special types of cases; namely, subjects identified as United Nations employees, Foreign Government employees, U. S. Government employees and Atomic Energy Program employees, certain individuals prominent in the business and professional fields not then included in the Security Index (34 at that time) and in addition a limited number of cases which would be referred to the Department from time to time when investigations indicate individuals are prominent in the business and professional fields or other special or peculiar facts exist.

The Pro-Tito Yugoslav group was not included in Bureau request because they are only set aside in Special Section for



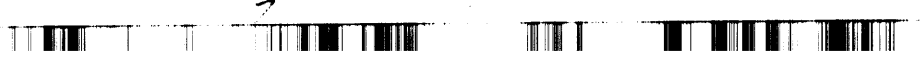

administrative reasons since they are followers of Tito and action to be taken in an emergency will depend on Tito's position at that time. Attorney General's memorandum dated November 17, 1953, agreed to review and advise Bureau concerning special types of cases listed in Bureau letter dated September 30, 1953, which did not include the Pro-Tito Yugoslav Special Section.

Department completed review under revised Security Index criteria of specifically named persons prominent in the business and professional fields on June 9, 1955. Under old Security Index criteria Department had approved one of three names remaining in United Nations Employees subdivision and 15 of the 30 names remaining in the Foreign Government Employees subdivision. None of the three remaining names in U. S. Government Employees subdivision approved by Department under old criteria. No names remain in Atomic Energy Program Employees subdivision.

ACTION:

If you approve, Mr. [redacted] will be telephonically referred to Bureau letter dated October 15, 1953, and Attorney General's memorandum dated November 17, 1953, neither of which made reference to the Pro-Tito Yugoslav Special Section.

At the conference in your office today attended by the Deputy, Mr. Hoover, Mr. [redacted], and [redacted], you will recall that I furnished information relative to the Security Index - advising that the cases of the 32 Prominent Individuals have been completed and that the status of the Special Categories Cases was as follows.

Atomic Energy Program (1) - completed  
United Nations Employees (5) - completed  
U.S. Government Employees (4) - completed  
Foreign Government Employees (40) - 31 completed, 9 remaining to be reviewed

It is anticipated that the remaining nine cases will be completed in the immediate future and upon completion, the person conducting the review will be assigned full time thereafter for the purpose of reviewing a sampling of those cases reviewed by the FBI and forwarded to the Department with a recommendation for inclusion or non-inclusion on the Security Index.

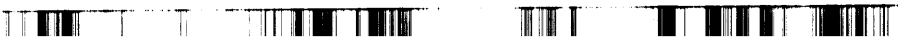

In connection with the Security Index review now in progress, airtels from the field of July 15, 1955, reflect that, of the 26,328 cases to be reviewed, 21,030 have been reviewed and the required data furnished to the Bureau. Of this number, 21,110 cases have had the Security Index cards on 9,730 subjects cancelled. These figures indicate that the field has reviewed approximately 80 per cent of the cases and has recommended that the Security Index cards be cancelled in 46 per cent of the cases reviewed. All offices have reversed the project completed with the exception of the New York office.

These cases are being processed at the Bureau in accordance with previously approved procedure and, as of July 15, 1955, 16,611 cases have been processed. Of these 9,110 cards, or 54 per cent, were cancelled.

The Los Angeles Division has requested advice re retention of stops now in place for subjects cancelled from the Security Index whose cards were maintained in the Unavailable Section-Out of the Country.

Section 170, Manual of Instructions, issued at Passport Division, Department of State, and Bureau of Customs mandatory for Security Index subjects residing outside the United States or its territories. Such stops are not required for security officers and are optional and the stops are optional conditioned by the needs of the individual case. In those instances where the stop is to be cancelled the Office of Origin should review stops and unless reason to the contrary exists they should be cancelled.

ACTION:

1. A letter to Los Angeles is attached. It advises that stops in cases where the "Out of the Country" Security Index card has been cancelled should be reviewed unless some reason to maintain them exists. It notes that such stops are permissive in non-Security Index cases. If you agree, it will be sent.

2. An SAC letter is attached. It advises that in these instances (out of the country Security Index card cancellations) stops should be scrutinized and unless reason to the contrary exists they should be cancelled. It notes that such stops are permissive in non-Security Index cases. This SAC letter has been prepared to insure that SAC's will take the initiative to eliminate unnecessary stops. It does not change existing policy that these stops be continued for persons who continue on the Security Index.

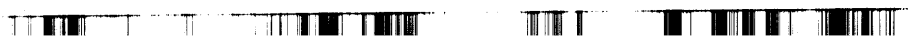

Referenced SAC letter on page 3, paragraphs 2 and 3, deals with the filing of Security Index cards in the geographical sections to the effect that these sections should be divided into two distinct parts, one to include only the Security Index cards for subjects who are tabbed Detcom under the new instructions set out in referenced SAC letter, and the second part to include the geographical Security Index cards for all subjects not tabbed Detcom.

This is to advise that the geographical section of the Security Index at Los Angeles is broken down to include 129 subdivisions as to the outlying communities that fall within the local law enforcement jurisdiction of one of several substations of the Los Angeles County Sheriff's Office as well as the several precincts of the Los Angeles Police Department. This system of subdivisions has been found to be most practical by the Los Angeles Office in the administration of the Security Index, particularly so as an aid to the clerical employees who fill and refile many changes to data which is received from the Bureau in newly prepared Security Index cards.

The Los Angeles Office has therefore maintained those Security Index cards which are tabbed Detcom in the geographical section behind a separate tab clearly marked Detcom behind each of the 129 subdivisions and distinctly separated from the Security Index cards which are not tabbed Detcom in each of these subdivisions.

The Los Angeles Office seeks the Bureau's approval for the maintaining of S.I. cards tabbed Detcom in the geographical sections as described above.

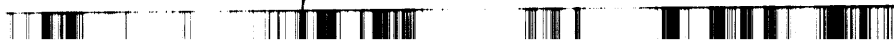

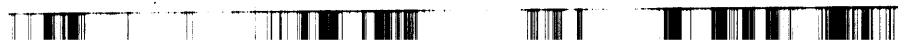

We presently have in the Security Index cases approved by the Department under the old Security Index standards. The Security Index cards in these instances contain an asterisk in the upper left-hand corner to distinguish them from those cases not reviewed by the Department.

The Department has reviewed cases relating to 32 prominent individuals under the new criteria, approved 7 for inclusion in the Security Index and disapproved 25. The Department is presently reviewing cases in the Special Section of the Security Index, i.e. foreign Government employees, United Nations employees, United States Government employees and Atomic Energy employees, (total 36 as of July 18) under the new criteria.

In order to distinguish cases approved by the Department under the new criteria from those approved under the old standards and those not reviewed by the Department, it is recommended that a small square be placed in the upper left-hand corner of the Security Index card in these instances. This can be handled on the IBM machine in the Statistical Section.

As you will recall, in our Summary Report Program, we permitted the field to submit reports to the Bureau without completing the documentation. It had been determined that documenting summary reports was difficult and time-consuming, especially where it was necessary to obtain documentation from an auxiliary office. The Bureau did not set a dead line for the field to complete outstanding documentation. The Supervisors at the Seat of Government set ticklers on a sixty-day basis, but did not press the field in this regard.

In accordance with Mr. [redacted] instructions, I discussed this matter with the Supervisors of the Internal Security Section on the morning of August 8, 1955. I pointed out the necessity for requiring the field to submit the outstanding documentation promptly. I also reiterated the necessity for the Supervisors to follow the field closely on all delinquent items and to see to it that the field either complies promptly with Bureau instructions or explains the failure to do so.

I will continue to keep a close check to insure that the field is required to explain any undue delay in complying with Bureau instructions and, where necessary, we will continue to recommend appropriate administrative action.

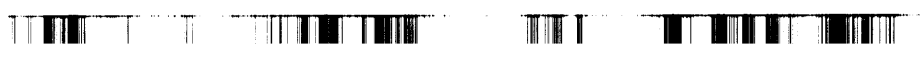

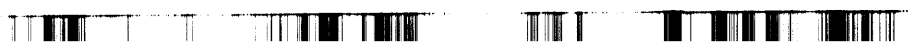

If for any reason this is impossible, submit letter to the Bureau containing a request for additional authority to conduct the interview and setting forth specifically the reasons why you were unable to effect the interview within the specified period. This letter should also contain any new information received which might have bearing upon the desirability or advisability of conducting the interview.

SYNOPSIS:

The Attorney General's Portfolio provides persons detained under Security Index Program must be afforded hearings within 45 days from time of arrest. Bureau has responsibility to furnish United States Attorneys information regarding subversive activities of subjects. In order to be prepared, Bureau initiated Summary Report Program 9/22/51. Program completed 7/14/54. Since then, annual investigative reports have been required on each Security Index subject. In order to have reports complete, it was necessary to document information contained in them. Documentation proved difficult and time consuming and by No. 1 Number SAC Letter 3/14/52, Bureau instructed field not to delay reports solely for purpose of obtaining documentation from other offices. Such reports were submitted to Bureau without complete documentation. No deadline for completion of documentation was set because extensive file reviews and communications between offices necessary to complete the documentation are time consuming. In future, field will be required to complete all documentation prior to submission of reports. This can be done by field since Security Index Review reflects our Security Index will be cut in half, leaving approximately 13,000 cases.

Due to use of personnel on Security Index Review, Annual Report Program is delinquent in a number of offices. In order to bring cases up to date, each office will be required to advise Bureau by 9/1/55 condition of this Program and offices which cannot advise delinquency will be current by 10/1/55, must outline on staggered basis time required to remove delinquency. Offices with large number of delinquent cases will be allowed until 3/1/56 to complete. After that, each office will advise Bureau on September 1 and March 1 of each year status of Annual Report Program.

Memorandum for Mr. .

New York Office has not been required to submit summary reports nor annual reports because of volume of work. However, when New York Office completes Security Index Review (deadline 10/12/55), consideration will be given to having New York submit summary reports in all cases.

RECOMMENDATION:

(1) There is attached for your approval an SAC Letter which instructs:

(a) That all documentation in security cases be completed prior to the submission of reports to the Bureau.

(b) That offices which have become delinquent in the submission of annual reports due to the Security Index Review must remove the delinquency and offices with volume will, where necessary, be given until 3/1/56 to bring the program into a current status. After that, each office will advise Bureau on September 1 and March 1 of each year the status of the Annual Report Program.

(2) After the New York Office completes the Security Index Review, consideration will be given to having the New York Office submit summary reports in all Security Index cases.

Memorandum for Mr.

DETAILS:

Summary Report Program

The Attorney General's portfolio provides that every person detained under the Security Index Program must be afforded a hearing within forty-five days from the time he is apprehended. The cases against Security Index subjects will be presented to hearing boards by United States Attorneys and it is the responsibility of the Bureau to make available information concerning the subversive activity of the subjects to the United States Attorneys. As our Security Index grew, we realized that during an emergency we would not have time to prepare summaries concerning our Security Index subjects for United States Attorneys. Therefore, a program for the preparation of summary reports was instituted by SAC Letter #95 dated September 22, 1951. Program completed July 14, 1954. Since then annual reports have been required on each Security Index subject.

Documentation of Reports

At the time the Summary Report Program was initiated a great deal of discussion was had between field and Seat of Government representatives regarding documentation of the reports. The field pointed out that it was necessary to go back to old reports in order to get back to the original source of much of the information. The field also stressed the point that during the early 1940's security reports were written from an intelligence point of view rather than from an evidentiary standpoint. Despite the protestation of the field regarding the difficulties of the project, the Bureau insisted that it had to be done. However, in order to alleviate the task in some measure, the field was instructed by No. 14 Number SAC Letter I dated March 14, 1952, that reports should not be delayed solely for the purpose of obtaining documentation information from another office. This SAC Letter further instructed that the report be submitted with a statement on the administrative page to the effect that other offices had been requested to furnish necessary information to complete the documentation. However, the Bureau did not set a deadline for the completion of outstanding documentation because extensive file reviews and communications between offices necessary to complete the documentation are time consuming.

Suggestion

The field has completed approximately eighty-five per cent of our Security Index review. All offices have finished with the exception of New York and New York's deadline is October 12, 1955. At this stage, it appears that our Security Index will be cut in half. This will mean we will have approximately 13,000 cases remaining on the Security Index. The field is required to submit an annual report on each Security Index case. Due to this reduction in case load, the field should be required to complete all documentation before reports are forwarded to the Bureau. This will cause a savings in administrative time required in the forwarding of amended administrative pages to the Bureau and auxiliary offices after documentation has been completed.

Submission of Annual Reports in Security Index Cases

During 1953-1954 we required all offices except the New York Office to submit summary reports in all Security Index cases and current instructions are that after the submission of the summary report, annual investigative reports must be submitted in these cases to keep the cases in an up-to-date status.

The deadline for completion of the summary report project was July 14, 1954, and many offices, particularly the large offices, submitted a heavy volume of summary reports shortly prior to the deadline. Consequently, many annual investigative reports are now due in these cases.

These offices have been heavily loaded during the past three months in connection with the Security Index review, a deadline matter, and have been unable to submit annual investigative reports in many cases.

Suggestion

In order to bring these cases up to date as early as possible, the field will be required to advise the Bureau by letter not later than September 1, 1955, of the condition of the Annual Report Program in each office. Any office with a delinquency which cannot be brought into a current condition by October 1, 1955, will be instructed to submit

with the September 1 letter, a chart reflecting the number of delinquent cases and showing on a staggered basis the time which will be required to work out the delinquency. Offices having a large number of delinquent cases will be allowed until March 1, 1955, to complete the program. Once the program is completed, each office will be required to submit a letter to the Bureau on September 1 and March 1 of each year indicating the status of the delinquent cases.

The New York Office has not been required to submit summary reports in its Security Index cases because of the tremendous volume of work in that office. However, when New York completes its Security Index review (deadline date, October 12, 1955), consideration will be given to having New York submit summary reports in all of its Security Index cases.

Reference is made to the memorandum from the Director dated July 13, 1955, pertaining to a conference attended by the Director in the Office of the Attorney General on that date dealing with war plans.

The Director noted that he had occasion to urge the necessity for some review of Security Index cases by Departmental personnel and noted that the Attorney General had directed Assistant Attorney General \_\_\_\_\_ to assign one attorney who would "sample" the cases of persons in the Security Index. The Director requested to be advised not later than August 15, 1955, whether we ever received any word from Mr. \_\_\_\_\_ division indicating initiation of this action.

Memorandum from Mr. \_\_\_\_\_ to the Attorney General dated July 14, 1955, (Photostat attached) noted that the review of the cases in the Special Section of the Security Index was being completed in the immediate future and that upon completion the person conducting the review was to be assigned full time thereafter for the purpose of reviewing a sampling of cases reviewed by the Bureau and forwarded to the Department.

Each month we follow the field closely on the status of security work by analyzing the backlog of pending cases and delinquency in reporting, internal security, security matters, and other security cases in classifications. Status of these cases as of July 31, 1955, is set forth herein.

In July there was a decrease in the number of pending matters in the entire field in the security classification of 10,100 to 10,800. Delinquent matters also decreased from 5,017 to 4,844. The percentage of delinquent matters remained static at 27.9%.

Letters are being sent to the large offices indicated by asterisks on page 4 and to the smaller offices indicated by asterisks on page 5 herein, commenting upon their delinquency condition and pointing out the necessity of bringing their security cases to current status.

RECOMMENDATION:

The field will continue to be followed closely regarding security delinquency and will be advised of the results of the review of the August, 1955, administrative reports.

DETAILS:

Since December, 1951, we have been following, on a monthly basis, the twelve field offices having a large proportion of our pending security work and since March, 1952, all offices. We have written letters to the twelve offices and to other offices where progress in reducing the backlog of work and delinquency has not been satisfactory.

The July, 1955, administrative reports from all offices reflect that the total pending active matters in the classified categories decreased from 10,148 to 11,512. The delinquent matters decreased from 5,077 to 4,544. The percentage of delinquent matters remained static at 27.9%.

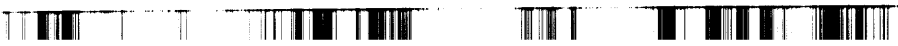

(G) SECURITY INVESTIGATIONS --  
A. Documentation of Reports

As in the past it will be necessary to document all security-type reports, both investigative and summary. In view of the tremendous volume you were permitted in the past to forward reports to the Bureau with incomplete documentation where such documentation had to be obtained from another office.

Henceforth, offices preparing reports must complete such documentation prior to the submission of reports to the Bureau. In this manner only completed reports will be received at the Bureau and there will be a saving in the administrative time required in the forwarding of amended administrative pages of reports to the Bureau after the documentation has been completed.

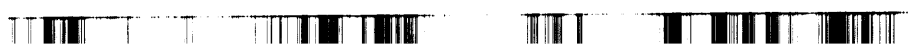
The office of origin having outstanding documentation in reports previously forwarded to the Bureau must get this documentation completed promptly. You will be required to explain any undue delay.

B. Submission of Annual Reports in Security Index Cases

In order to bring the annual reports in Security Index cases up to date as early as possible you must advise the Bureau by letter not later than September 1, 1955, of the condition of the annual report program in your office.

Any office with a delinquency which cannot be brought into a current condition by October 1, 1955, must submit with the September 1, 1955, letter, a chart reflecting the number of delinquent cases and showing on a staggered basis the time required to work off the delinquency. Offices having a large number of delinquent cases must bring them up to date as soon as possible but in any event all delinquency must be removed by March 1, 1956.

Once the annual reports are in a current status it will be the responsibility of each Special Agent in Charge to keep them current on a continuing basis. In this regard a letter must be forwarded to the Bureau on September 1 and March 1, of each year, advising of the status of this program.

EMPLOYEE SUGGESTION

Attached herewith are Recommendation for Incentive Award forms completed in behalf of Miss [redacted], who proposes a revision of Bureau Form FD-154 (Verification of Information on SI Card), Revision of 5/18/54. A sample of the new form as proposed by Miss [redacted] is also attached herewith.

Study of this proposed revision indicates the following major changes:

- A. Listing of the items RESIDENCE and EMPLOYMENT in the same order on both the top and bottom halves of the form. The transposition of these two items on the present FD-154 has led to placing of misinformation behind appropriate captions on the lower half of the form when filled out by Agents. It is an error that occurs through carelessness on the part of Agents making verifications, but the change suggested by Miss [redacted] would eliminate the possibility of such an error.
- B. The addition of the following phrases or captions:
  - 1. The addition of "SA" after the notation "Verified by" (under both RESIDENCE and EMPLOYMENT on lower half of form) eliminates the possibility of an Agent filling in this blank with the name of an informant or the name of a person other than his own.
  - 2. Inclusion of the date that the Key Facility list was checked insures that the Geographical Reference Number is actually checked from the KF list for any change and not from the number previously listed on the Security Index card.

3. Addition of the caption "Access to Classified Information" provides a check of this information at the time the verification is made. This data is then available for use in writing the next report and eliminates the necessity of having to make another call at the place of employment shortly thereafter just to check this particular item.
  4. Addition of the caption "If NO, was FD-9 submitted within one year?" eliminates the possibility of a long period elapsing without having the Identification Division checked.
- C. Elimination of the items "Method of Verification," "Employment Source," and "Neighborhood Source" rids the form of extraneous terms consistent with the simplified and neater form proposed.

I feel that this revised FD-154, as proposed by Miss BARTELS, has considerable merit and that its use would be beneficial to the Bureau. I recommend that Miss [redacted] be commended in line with the proposal set forth on attached Recommendation for Incentive Award form.

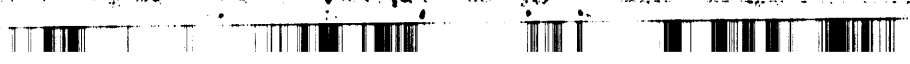

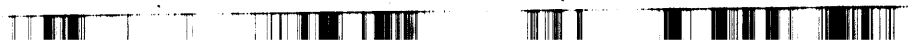

SYNOPSIS:

Each month we follow the field closely on the status of security work by analyzing the backlog of pending cases and delinquency in Espionage, Internal Security, Security Matter and foreign intelligence cases in classifications. Status of these cases as of August 31, 1955, is set forth herein.

In August there was a decrease in pending active matters in the entire field in the security classifications from 16,480 to 15,385. Delinquent matters also decreased from 4,544 to 3,874. The percentage of delinquent matters decreased from 27.9% to 25.2%.

Letters are being sent to the large offices indicated by asterisks on page 4 and to the smaller offices indicated by asterisks on page 5 herein, commenting upon their delinquent condition and pointing out the necessity of bringing their security cases to current status.

RECOMMENDATION:

The field will continue to be followed closely regarding security delinquency and you will be advised of the results of the review of the September, 1955, administrative reports.

Memorandum for Mr.

DETAILS:

Since December, 1951, we have been following, on a monthly basis, the twelve field offices having a large proportion of our pending security work and since March, 1952, all offices. We have written letters to the twelve offices and to other offices where progress in reducing the backlog of work and delinquency has not been satisfactory.

The August, 1955, administrative reports from all offices reflect that the total pending active matters in the classification decreased from 18,200 to 15,653. The delinquent items decreased from 4,544 to 3,537. The percentage of delinquent matters decreased from 27.9% to 22.6%.

1. Transposing the Residence and Employment blanks (bottom half) to be in same order as upper half (executed from Security Index card) of form to eliminate possibility verifying Agent who may transcribe new information in error.
2. The addition of "SA" in Residence and Employment blanks to insure verifying Agent will not fill in name of source when he should insert his own name.
3. Adding a blank to carry date Key Facility List was checked to insure this list, rather than the Security Index card, was checked.
4. Adding "yes or no" blanks for "Access to Classified Information" to insure this is done at the time of verification to eliminate need at time report is written.
5. Adding question as to Security Flash placement and if none placed, Request for Identification Record to Identification Division within one year.
6. Eliminating three headings to make the form neater.

OBSERVATIONS:

A. Changes 1,2, and 3, are minor in nature, made in an effort to insure the executing Agent does not make an error in executing the form.

B. Change 4 is not needed since reports on Key Facility Employees are submitted semi-annually (same frequency as FD-154 is prepared) and the question of access to classified information must be resolved at the time the report is prepared.

C. Changes<sup>5</sup> would, by implication, cause FD-9 to be sent to Identification Division annually where no Security Flash is placed. It is not the desire of the Bureau that FD-9 be sent to Identification Division for Security Index subjects unless some reason exists to believe there is an Identification Record, that is, prior military service, Government employment, police arrests, Civil Defense Reserve, et cetera.

RECOMMENDATION:

The Internal Security Section feels that the changes suggested do not materially improve the already existent FD-154 and does not recommend adoption of Suggestion #103-56.

Addendum by Training and Inspection  
Division 8/17/55 - hcc/pe

Training and Inspection agrees with recommendation that suggestion not be adopted, insofar as concerns recommendations 4, 5 and 6 listed on page 1 of this memorandum. Training and Inspection recommends ~~un~~favorably, however, on suggestions 1, 2 and 3 because these changes will give added assurance that the form will be correctly executed by the Agents. These changes have been incorporated into the enclosed revision of Form FD-154.

RECOMMENDATION: 1. That the enclosed revision of FD-154 be approved

2. That, since no money saving can be shown and the contribution to efficiency is probable but not definite, the award in this case be limited to the enclosed commendatory letter advising Miss Bartels that her suggestion has been adopted in part.

There is not a Resident Agency space in the BA Division which precisely meets the requirements set forth in relet. No Resident Agency has any type of safe or cabinet other than a regular file cabinet except the Aberdeen RA. This Resident Agency has a combination lock safe type cabinet which should be sufficiently secure; the Aberdeen space is not at this time completely under BW control. It is an office in the provost marshal's office and the safe cabinet itself is the property of the Army. The Army, of course, does not have the combination or access to the cabinet. Since the provost marshal's office is manned 24 hours a day, this space actually is more secure for the purpose indicated than is any other Resident Agency space which is occupied for only a few hours each day.

Since I cannot recommend the use of any other space unless a secure safe of some type is obtained, I have no alternative but to recommend that the Security Index be maintained in the Aberdeen Resident Agency.

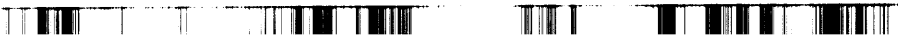

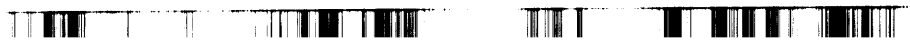

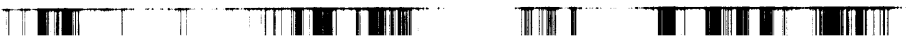

(1) .If the name of a subject on the list is not included in your Security Index, you should check that subject's case file to determine his correct Security Index status. An appropriate notation should be placed adjacent to the subject's name on the list reflecting the correct Security Index status for the subject. If his name should be deleted from the Bureau's Security Index, the notation should refer to the previous communication from your office which recommended cancellation. If you do not have a Security Index card for the subject and a card should be in your Index, the notation should request the Bureau to forward cards to your office.

(2) . If this check discloses the names of subjects in your Security Index which do not appear on the list, the names of such subjects and the Bureau file number (where known) should be set forth on a separate sheet of paper with the date that the subject was recommended for inclusion in the Security Index. Instances of this nature will occur in those cases where subjects have recently been recommended for inclusion in the Index and were not included therein at the time of printing of the list but cards have subsequently been prepared at the Bureau. Instances of this nature may also occur in those cases where cancellation of a Security Index card has recently been recommended by you and you have not yet received Bureau authorization to cancel.

(3) In checking the Special Section of your Security Index against the list, you should be certain that the subjects are in the same subdivision as those indicated on the list. Appropriate notations should be placed on the list if there are any discrepancies between your Special Section and the list.

(4) To avoid an increasing number of discrepancies between the list and your Security Index due to current changes being made in the Security Index, this check must be instituted immediately and completed within ten days [of the receipt of the Security Index list and the additional set of Security Index cards]. Upon completion, the Security Index list and appropriate notations should be returned to the Bureau by cover memorandum under instant caption.

Upon completion of the check, the additional set of Security Index cards should be set up in exactly the same manner as your Geographical Section Security Index breakdown with the Unavailable and Special Sections cards filed in back of the regular section cards. It will be necessary to place descriptive data and photographs on the reverse side of these cards in the same manner as your present geographical breakdown. In those instances in which your present cards are stamped "Detcom," it will be necessary for you to stamp or print "Detcom" on the new cards.

Those offices having both the residence and employment geographical breakdowns, Detroit, Cleveland and Los Angeles, will set up the new set of cards according to one of the above breakdowns most nearly fitting the needs of the office.

SAC Letter 55-57 (Q) dated September 7, 1955, advised the field that an additional set of Security Index cards is being furnished each office, together with specific instructions as to how this Index should be maintained. This Index is to be placed in the personal custody of the Senior Resident Agent at the Resident Agency affording the utmost security and one in which the Bureau has complete control of the space.

The attached letter to all offices except Honolulu and New York contains detailed instructions regarding the handling of the new list. It also instructs that the Security Index lists maintained in the field must be reconciled with Bureau records.

New York is not included inasmuch as approximately 1,600 cases remain to be reviewed under the Security Index Review and the Domestic Intelligence Division feels that this list should not be forwarded to New York until the Review is complete. After survey and consideration of all resident agencies, I recommend the Richland Resident Agency as the most secure for the retention of the additional set of security index cards.

In none of our residencies do we have complete and exclusive control of the space. All residencies are afforded custodial service and to the extent necessary to clean the premises daily are entered by persons other than Bureau personnel.

The Richland Resident Agency is located in a building of the Atomic Energy Commission. This space is serviced daily by janitorial employees of the AEC who provide providing them access in the absence of Bureau personnel. The space also is patrolled after regular hours by AEC Security Patrol employees who physically enter the premises occupied by the Richland residency. The general public has no access either to the FBI space or to the building in which our space is located. AEC employees working in the "700 Area," in which our space is situated, have access to the building housing our space, but not to our space itself. All persons having access to the building have "Q" clearance from AEC and anyone in the building after regular hours has to sign in and out on a building register.

The Richland Resident Agency is equipped with combination-lock file cabinets, the property of AEC. The combinations to the cabinets are changed frequently and are known, of course, only to Bureau personnel.

It is realized that Richland, headquarters of the Hanford Operations Office of the AEC, is a likely enemy target. The Hanford Operations Office, however, is cut in on all defense communications and in all probability would be alerted in sufficient time to permit the removal of these records prior to any attack. The Senior Resident Agent at Richland resides only five minutes away from the office and is in a position to remove the records within a few minutes in event of an alert.

The only other two suspected resident Agencies are those at Spokane and Yakima. Our space in those towns is in federal buildings and is entered for janitorial purposes by custodial employees. In Yakima we have one room to which we have the only keys, but that room is on a separate floor from our office space and is used for storage purposes. I do not consider it as secure as the space at Richland.

I recommend that the Richland Resident Agency be designated as the repository for the extra set of security index cards. I consider it as a secure site for this purpose.

I would like, however, to make the suggestion that the Bureau consider allowing retention of this extra set of security index cards in headquarters city until an emergency appears more imminent than at present. Since we do not have exclusive control of our resident agency space, greater security is afforded in headquarters city. At such time as the international situation might dictate that the extra set be re-located, that action could then be taken.

BACKGROUND: Offices handling cases on unusually active Communists are required to prepare a "thumbnail sketch" card which synthesizes that subject's identity and activity. This is used when reference to him is necessary in another file. Per SAC Letter 55-30 each office is also required to review all its Security Index cards and submit a summary memorandum to the Bureau recommending for or against retention on the Security Index. This project is nearly completed.

SUGGESTION: Eliminate preparation of the thumbnail sketch cards. When a Security Index Review Program memorandum is prepared for the Bureau, pursuant to SAC Letter 55-30, simply index it in the office indices so that an Agent needing a synopsis of that subject can get it from the file copy of the Security Index Review Program memorandum or letter.

ADVANTAGES STATED: Eliminate necessity for having a thumbnail sketch prepared. Eliminate time spent in reviewing a case file for which no thumbnail sketch has been prepared.

OBSERVATIONS: SAC, New York, recommends unfavorably for the following reasons:

1. The thumbnail sketch cards are brought up-to-date periodically whereas the Security Index Review Program letter or memorandum is not, so far as current instructions require.
2. In a large number of instances where Security Index Review Program letters have been prepared there is no need for a thumbnail sketch, hence the indexing of these letters in the office would accomplish no purpose.
3. The Security Index Review Program letters sent to the Bureau do not contain the type of documentation needed for a thumbnail sketch.

Inspector recommends unfavorably, agreeing with the points set out by SAC .

Inspector points out that as the SOG indices have grown we have found it necessary to put additional identifying data on index cards and when a summary is prepared a summary index card is also typed up. When name searches are made later they can in most cases be brought up-to-by the summary card. Although there is a question whether field office indices are sufficiently voluminous to make a summary card economically feasible, perhaps it should be given consideration in larger offices.

Training and Inspection recommends unfavorably on the principal suggestion, agreeing with SAC and Inspector . Also recommends unfavorably on Inspector McGuire's suggestion on basis that thumbnail sketch cards are adequate to the needs of the field for summary as indicated by SAC .

RECOMMENDATION: That the suggestion not be adopted.

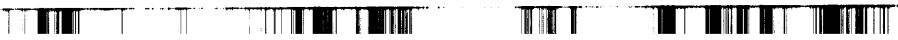

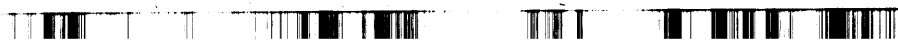

As the Bureau was advised in mylet dated 9-12-55, the Resident Agency space in Ponce, Puerto Rico, has been guaranteed by the Assistant Postmaster, U. S. Post Office, Ponce, Puerto Rico. In view of the necessity, however, for making sure that the Bureau would be guaranteed exclusive use of this space, I instructed the Resident Agent in Ponce to obtain a communication in writing from the Postmaster at Ponce. The Postmaster thereafter checked the communications which he had received concerning the space allocated and found that his records show the space is assigned to the U. S. Marshal at San Juan and is on an on-loan basis to the FBI. He pointed out that he saw no reason why the Bureau would be asked to evacuate the space; however, it appeared that the U. S. Marshal actually had the space allocated to his office. In view of these circumstances, I do not believe that the Ponce Resident Agency should be used for the additional set of security index cards mentioned in referenced SAC Letter.

This office currently has leased space in Room 208 at 1024 Munoz Rivera Avenue, Rio Piedras, Puerto Rico. This space is occupied by Resident Agent \_\_\_\_\_, and is the only resident agency space which is either not on an on-loan basis or resident agency in an agent's home. It is noted that the resident agency in Mayaguez, Puerto Rico, is located in the U. S. Post Office building and is also on an on-loan basis. The resident agencies in Aguadilla and Roosevelt Roads, Puerto Rico, are in the agents' homes.

It is my recommendation that the resident agency space in Rio Piedras be considered as the resident agency in which the additional set of security index cards should be maintained. I have inspected this resident agency office, and it is my belief that it is a secure site. The telephone number is San Juan 6-3148. The only feature about this resident agency which may be considered undesirable is its proximity to San Juan. It is noted that Rio Piedras lies approximately seven miles southeast of San Juan. There does not appear to be any alternatives at this time, however, in the selection of another location to which only the Bureau has exclusive access.

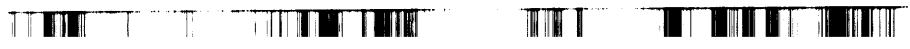

The San Jose Resident Agency, San Jose, California affords the logical location for maintenance of the additional set of Security Index cards since the San Francisco Office has designated that city as its relocation site.

This Resident Agency is located in Room 216, United States Post Office, San Jose, California. The Bureau has complete control of this office and SA

is the Senior Resident Agent. A survey of available storage facilities disclosed that the San Francisco Office does not presently have at its disposal a filing cabinet or safe which will afford utmost security in connection with the maintenance of the additional Security Index cards.

It is believed desirable that the cards be maintained in a four drawer, legal size, fireproof filing cabinet equipped with a combination lock. This type cabinet will reasonably insure against physical removal of the cabinet from the premises and the additional unused space can be readily utilized at San Jose.

The Shaw-Walker Company and Huntington Road Incorporated both manufacture this type cabinet.

The Shaw-Walker Company four drawer, fireproof file cabinet, legal size, key lock cabinet with IP combination lock in lieu of key lock and two cross file trays, lock would be used on top two drawers for maintenance of the Security Index cards would cost \$10.00 plus shipping.

The Huntington Road Co. 4124 file, four drawer, legal size, with IP combination lock and two cross file trays to cover top two drawers for maintenance of the Security Index cards would cost \$10.00 plus shipping cost.

In order to comply with the instructions set forth in referenced SAC Letter and at the same time insure adequate security for the maintenance of the SI cards at the San Jose Resident Agency, the Bureau is requested to authorize the San Francisco Office to purchase either of the above safe file cabinets.

Re SAC letter #55-57, 9/7/55, (C) re that portion relating to the placing of an extra set of Security Index cards and a copy of the Emergency Detention Program in a Resident Agency of the New York Office.

For the information of the Bureau, the Resident Agencies of the New York Office have the following disadvantages from the viewpoint of maintaining the extra set of Security Index cards and a copy of the Emergency Detention Program:

Each Resident Agency consists of a one-room office in a Post Office building. The Post Office building has a key to the outer door of the room. Cleaning persons, who are not furnished by the Post Office, enter the building at various times at which Agents may not be present. The Post Office doors are closed at midnight to the general public; however, access to the building can be obtained by Post Office employees who are on duty throughout the night.

The New York Office, therefore, does not have such complete control over any of the Resident Agency offices as to assure utmost security to the extra set of Security Index cards and copy of the Emergency Detention Program to be maintained under present conditions, in any one of these offices.

The Suffern and Bay Shore Resident Agencies are located in the basement of the respective Post Offices and might be flooded in the event of an enemy bombing attack in their area.

The Mineola and Bay Shore Resident Agencies are in close proximity to large aircraft plants. In addition, they are located on Long Island. The State Island Resident Agency is on the island of that name. In case of a hostile air attack on New York City, the bridges leading to and from these islands might well be knocked out, thus isolating these Resident Agencies.

Similarly, the Suffern and Kingston Resident Agencies are located on the other side of the Hudson River from New York City. It is felt that an enemy air attack might also make the bridges and tunnels across the Hudson River impassable.

The remaining Resident Agencies of the New York Office are located at Yonkers, White Plains and Poughkeepsie and in each instance the Post Office has ready access. All are to the north of New York City and on the same side of the Hudson River as that City.

Of these three, the New York Office considers the Poughkeepsie Resident Agency as the best of the three. The City of Poughkeepsie is located on main highways and on the banks of the Hudson River, thus providing access by car or by boat both to New York City and to Chappaqua, the relocation site for the New York Office.

In view of the fact that the New York Office does not have complete control and cannot afford the utmost security to the Security Index cards and copy of the Emergency Detention Program if same were to be placed in the Poughkeepsie Resident Agency, the New York Office suggests as an alternative recommendation that the above cards and program be placed in the New Haven Office, where such security and control could be had. It is pointed out that the New Haven Office is approximately seventy-eight miles from New York City or about the same distance away as Poughkeepsie.

Both of the referenced communications also indicate that the New Haven Office would be a more desirable records repository than the New York Office.

It is the Bureau's desire that you consider the Poughkeepsie Resident Agency as the repository for the Security Index and "Prodip" records mentioned in referenced communications.

The Security Index and "Prodip" records to be placed in the selected Resident Agency must be stored in a fireproof vault, safe or file cabinet having a three-way combination lock. A fireproof-type file cabinet equipped with a vertical steel lock bar and three-way combination-type padlock, the combination of which can be changed by the user may be used, if the steel lock bar runs through the cabinet drawer handles and is anchored at the bottom as well as being secured at the top by the above combination-type lock.

If you cannot make adequate storage facilities available to the Resident Agency from the storage facilities now available to your office, the Bureau should be so advised by return mail and in the near future the necessary equipment will be forwarded to the Poughkeepsie Resident Agency. Neither the Security Index nor the "Prodip" records should be forwarded to the Poughkeepsie Resident Agency until appropriate storage facilities are available at that site.

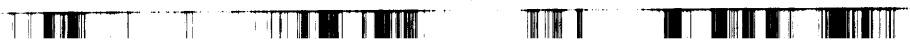

Reference is made to SAC Letter 55-57 (Q) instructing that an additional set of Security Index cards pertaining to your office would soon be made available to you to be placed in the personal custody of a senior Resident Agent. These records, when placed in a Resident Agency, must be stored in a fireproof vault, safe or filing cabinet equipped with a three position dial-type combination lock. If a fireproof filing cabinet without a dial lock is available, it may be used if it is equipped with a steel bar running through the cabinet drawer handles and anchored at the bottom. This bar must be secured at the top by a Sargent and Greenleaf combination-type padlock, the combination of which can be changed by the user.

If you cannot make comparable storage facilities available to the Resident Agency selected to retain the Security Index cards, the Bureau should be advised by return mail and, thereafter, appropriate storage facilities will be forwarded to the selected Resident Agency.

The additional set of Security Index cards now in your possession should not be forwarded to the Resident Agency until adequate storage facilities are available at that site.

Careful consideration was given to the Bureau's suggestion of placing the additional copy of the Security Index in a location not listed as a critical target area. In this connection, it is observed that of the Resident Agencies currently operating in the Cleveland Field Division, only three agencies located in the following cities occupy office space: Akron, Canton, Toledo and Youngstown.

Inasmuch as only those Resident Agencies occupying office space were considered as qualified from the standpoint of Security, only those were considered. However, reference to SAC Letter 54-30 (3) dated 7/1/54, "Critical Target Areas" dated June 15, 1954, disclosed that a list of those cities, Akron, Canton, Toledo and Youngstown, appear on this list as target areas. Since this list was prepared for a choice, the city of Akron was selected because it was the most conveniently located both as to the Headquarters City, thus facilitating the maintenance of the Index, and also since it was the closest to the alternate headquarters to be located at Hiram, Ohio, in the event of an emergency. As an additional advantage, the alternate Senior Resident Agent at Akron, who has been designated to assist the Senior Resident Agent, is thoroughly experienced in all phases of Security work and familiar with the operation of the Security Index. For these reasons, it was concluded that the Resident Agency in Akron, Ohio, was the logical location. We will, however, maintain the additional copy of the Index in Headquarters City pending the Bureau's further advice.

By memorandum dated July 14, 1955, the Department advised that it would undertake a review project of sampling cases currently included in the regular section of the Security Index. By memorandum of September 13, 1955, [redacted] General [redacted], Internal Security Division, advised that 31 cases named in such memorandum had been reviewed and that all of such cases were approved by the Department for retention in the Security Index.

In the course of our own review project of the Security Index, these same 31 cases had been reviewed by the Bureau and in 28 of these cases, the same conclusion, i.e. that the Security Index card should be retained, had been reached. The other three cases are borderline cases and, as a result of our review, the Security Index cards on these individuals were cancelled. Hereto attached is a brief summary of each of the three borderline cases involved. These cases are:

OBSERVATIONS:

The application of fixed criteria for measuring potential dangerousness of an individual is, of course, a matter upon which minds may differ, particularly in questionable cases such as the three here involved. It is, nevertheless, felt that it would be desirable to discuss with representatives of the Internal Security Division of the Department these cases so that we may, as nearly





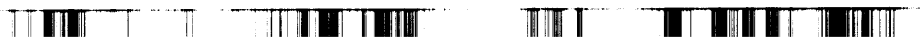

possible, accomplish a meeting of minds as to the application of the Security Index criteria to given sets of circumstances. In accordance with the placement of the duplicate security index outlined in SAC Letter 55-57 (Q), the decision of this office that the duplicate security index cards should be kept in the Roanoke Resident Agency, Roanoke, Virginia.

In arriving at this decision, consideration has been given to geographical location, nearness to the relocation site of this office, nature of buildings in which RAs are located, security within each of the buildings concerned and Bureau control of the space in the buildings. The Roanoke Resident Agency is located in room 309, U. S. Post Office Building, Roanoke, Virginia. Three RAs are assigned there, the Senior RA being . . . . . The two stairways leading from the main lobby to the upper floors of the building are locked with large steel gates each evening at 6PM. Also a guard patrol is maintained throughout the building from 6PM until 7AM everyday. The lock to room 309 has been changed in order to prevent it being opened by the master key utilized by the cleaning force of the Post Office Building. Arrangements have been made with Post Office officials, Roanoke, whereby the only key fitting room 309 not in possession of RAs assigned there is kept in the personal possession, along with other confidential material, of the Postmaster. The cleaning force of the building do not enter room 309 to clean except when Bureau personnel is present.

Of this equipment, it would appear that the four drawer steel filing cabinet owned by the Bureau would be more suitable for maintaining above material, but if utilized, it is recommended by this office that it be equipped with a locking bar running from the top downward across the bottom drawer. As an alternative to the use of this filing cabinet in the manner indicated, it is possible that the Bureau has among its surplus property in some other field office a small steel office safe which would be suitable for this purpose. The Bureau is requested to advise if such a safe is available and will be shipped to the Resident Agency at Roanoke, Virginia, or if it is satisfactory to have the above mentioned steel filing cabinet equipped with a locking bar in order that it can be used for the purpose indicated.

This office maintains a one-room Resident Agency in Post Office Building, Salem, Oregon, which city is likewise the site of our reallocation site under the War Plans.

The Resident Agency has two four drawer steel cabinets, the locks of which have been changed so that the keys are not common keys. Sometime within the next 30 to 60 days, our Resident Agency room will be moved to another part of the building, which room will have one window. Post Office Department will install security bars on the window. The usual type of security is exercised in the building by the Post Office Department during nonworking hours.

Recommendation

I consider that the Resident Agency in the Post Office Building is secure as any office in any building not under the full time control by our employees. I do not feel, however, that four drawer steel cabinets are sufficiently secure to retain a complete set of Security Index cards. It is believed that in order to afford fuller security to these cards that a four drawer safe lock type cabinet should be utilized. We do not have such a cabinet available. We have two such cabinets assigned to this office, one is utilized for encoding materials in the radio room and the other is utilized in the SAC's Office for personnel and personal and confidential files. I realize that a four drawer safe lock type cabinet costs approximately \$400. In view of the current economy program, I do not recommend the purchase of one.

If the Bureau has any four drawer safe lock cabinets available in other offices for transfer, it is respectfully recommended that one be furnished this office. If there is none available, then it is believed that if the Bureau desires to have a complete set of Security Index cards available in the Salem

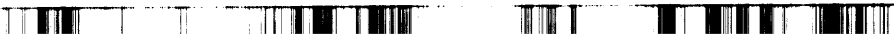

By memorandum of September 30, 1955, you were advised that the Department in reviewing a sampling of the cases currently included in the regular section of the Security Index had advised by memorandum of September 13, 1955, of the approval of thirty-one (31) such cases for inclusion on the Security Index. Of these 31 cases, the Bureau reached the same conclusion, i.e. that the Security Index cards should be retained. <sup>on 28</sup> As to the other three borderline cases, the Bureau upon the review under the revised Security Index criteria had cancelled the Security Index cards.

The Resident Agency at Topeka, Ks., does not have a fireproof vault, safe or filing cabinet for storage of Security Index.

This office, however, has in storage a "Remington Rand Safe Cabinet" which is fire resistive for two hours. Contact with a transfer company in Kansas City as to cost of transportation from U. S. Court House Building, Kansas City, Mo., to Topeka Post Office Building, Topeka, Ks., resulted in information to the effect that minimum cost would be \$35.00. It is possible, however, because of difficulty in transporting the safe cabinet to the third floor of the Topeka Post Office Building because of lack of freight elevators, the cost might be considerably more.

I am having a check made by the Senior Resident Agent at Topeka to determine if the elevators in the Post Office Building can handle this safe which weighs less than 1,000 lbs., and also to determine if the particular space occupied by the Resident Agency is so situated that the floor could withstand this weight.

The delay in this communication was occasioned by the fact that a representative of the Remington Rand Company, familiar with the specifications of this safe, was not available for contact until 10/10/55.

SYNOPSIS:

Each month, we follow the field closely on the status of security work by analyzing the backlog of pending cases and delinquency in espionage, internal security, security matter and foreign intelligence cases in classifications. Status of these cases as of September 30, 1955, is set forth herein.

In September, there was a decrease in pending active matters in the entire field in the security classifications from 15,635 to 15,180. Delinquent matters also decreased from 3,537 to 3,278. The percentage of delinquent matters decreased from 22.6% to 21.6%.

Letters are being sent to the large offices indicated by asterisks on page 4 and to the smaller offices indicated by asterisks on page 5 herein, commenting upon their delinquent condition and pointing out the necessity of bringing their security cases to current status.

RECOMMENDATION:

The field will continue to be followed closely regarding security delinquency and you will be advised of the results of the review of the October, 1955, administrative reports.

Memorandum for Mr.

DETAILS:

Since December, 1951, we have been following, on a monthly basis, the 12 field offices having a large proportion of our pending security work, and since March, 1952, all offices. We have written letters to the 12 offices and to other offices where progress in reducing the backlog of work and delinquency has not been satisfactory.

The September, 1955, administrative reports from all offices reflect that the total pending active matters in the classifications decreased from 15,635 to 15,180. The delinquent items decreased from 3,537 to 3,278. The percentage of delinquent matters decreased from 22.6% to 21.6%.

The following statistics reflect the status of pending work, including both pending active and pending inactive matters, and delinquency for all field divisions, as of December 31, 1951, and the progress for the last four months.

*DELINQUENCY IN SECURITY INVESTIGATIONS*

An analysis of the monthly administrative reports for the month of September, 1955, reveals that, on an over-all basis, the percentage of delinquent matters in security classifications stood at 21.6% as of September 30, 1955, the lowest delinquency figure for years in the security field. This is commendable and shows the results which can be achieved by an earnest desire on the part of all field divisions to work toward a common goal.

*I note further that the September field delinquency in all classifications was computed at approximately 14.5% while the delinquency in classifications other than \_\_\_\_\_ was computed at approximately 12.4%. While I realize that in the field of security we have a larger percentage of full investigations as opposed to cases involving leads only in the various field offices, and while the short deadlines in applicant-type cases and other cases not in the security classifications have a definite reflection on delinquency figures, I do feel that the disparity between the delinquency in security classifications and the delinquency in other investigations being conducted in the field is entirely too great.*

*All field offices must take immediate steps to insure that the status of the security investigations is brought to and maintained at a proper level in line with other investigations being conducted. Each SAC is being held personally responsible to insure that the above instructions are complied with.*

*Your monthly administrative reports will be analyzed thoroughly at the Bureau to determine your progress in effecting a reduction in security delinquency and to determine if you have complied with Bureau instructions with regard thereto.*

In December, 1951, the Domestic Intelligence Division, noting that over-all field delinquency in security classifications stood at approximately 66.2%, initiated a program by which we closely follow those field offices having excessive delinquency by monthly letters. Since that time, we have kept constant pressure on the field to cut down security delinquency, and the monthly administrative reports for September, 1955, reflect that, throughout the field as a whole, the delinquency in these classifications stood at 21.6%, the lowest delinquency percentage in many years. The over-all field delinquency for September, 1955, was computed at 14.5% while the delinquency in all classifications other than stood at 12.4%.

While we realize that in the field of security we have a larger percentage of full investigations as opposed to cases involving leads only and while the short deadlines in applicant-type cases and other cases not in the security classifications have a definite reflection on delinquency figures, the Domestic Intelligence Division feels that the disparity between the delinquency in security classifications and the delinquency in other investigations being conducted in the field is entirely too great. Therefore, it is felt that, at this time, we should point out to the field the absolute necessity of bringing the status of security investigations in line with the status of other investigations being conducted.

ACTION:

If you approve, there is attached a proposed letter to Albany, copies to all offices, instructing that the status of security investigations be brought to and maintained at a proper level in line with other investigations being conducted. We will continue to analyze monthly administrative reports to determine the field's progress in complying with these instructions.

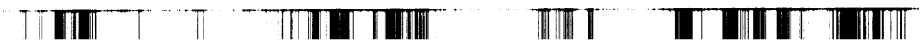

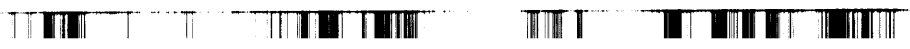

All offices have completed the Security Index Review project. The field has recommended cancellation of 13,122 Security Index cards, which is approximately 50% of the reviews submitted. The Bureau has processed 25,880 cases and has cancelled 13,575 cards or approximately 52%. All memoranda in connection with this project are being processed as rapidly as possible in the Subversive Control Section.

There remain 13,015 on the Security Index as of October 14, 1955.

To date the field has submitted 26,033 memoranda of which 13,100 recommended cancellation (50%).

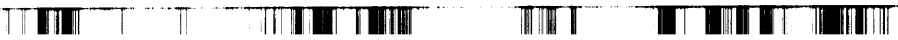
The Bureau has completed processing of 25,395 of these cases and has canceled 13,326 cards (52 1/2%).

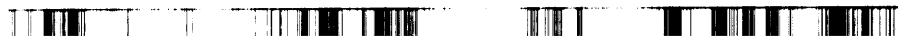
