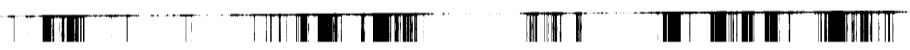

SUBJECT: DELINQUENCY IN SECURITY INVESTIGATIONS *of Inside*

General

SYNOPSIS:

Each month we follow the field closely on the status of security work by analyzing the backlog of pending active cases and delinquency in espionage, internal security, security matter, foreign intelligence and racial matters cases in classifications 65, 100, 105 and 157. Status of these cases as of March 31, 1966, is set forth below.

In March, 1966, there was an increase in pending active matters in the field in classifications 65, 100 and 105 from 19,234 to 19,242. Delinquent matters increased from 1,311 to 1,353. The percentage of delinquent matters increased from 6.8 per cent to 7.0 per cent.

During the same month, pending active matters in the 157 classification increased from 4,832 to 4,864 while delinquent matters increased from 655 to 712. The field-wide delinquency in this classification increased from 13.6 per cent to 14.6 per cent.

Letters are being sent to the offices indicated by asterisks on pages 4 and 5 herein, commenting on their delinquency and pointing out the necessity for bringing their cases in these classifications to a current status.

The field will continue to be followed closely regarding delinquency in the 65, 100, 105 and 157 classifications and you will be advised of the results of the review of the administrative report for April, 1966.

RE: DELINQUENCY IN SECURITY INVESTIGATIONS

DETAILS:

The March, 1966, administrative reports for all offices indicate that the total pending active matters in classifications 65, 100 and 105 increased from 19,234 to 19,242. Delinquent items increased from 1,311 to 1,353. The percentage of delinquent items increased from 6.8 per cent to 7.0 per cent. These same reports disclose that in the 157 classification total pending active matters increased from 4,832 to 4,864; delinquency increased from 655 to 712; and the percentage of delinquency increased from 13.6 per cent to 14.6 per cent.

NOTE:

Subject, a US citizen, was placed on SI in December, 1964, in view of his statements indicating sympathy for the Castro regime and an expressed opinion that the only way to make the US great again was to completely overthrow our present Government and do away with its present leaders. These statements were written by the subject in a letter to his parents while the subject was incarcerated at [redacted] Records show subject to have served three months in Cuba with the Castro forces. When interviewed, the subject claimed the information regarding his serving with Castro was not entirely correct but refused to discuss whether or not he had ever been in Cuba or any prior relationship with the Castro forces. An extensive investigation has been conducted in an effort to determine if subject has ever been in Cuba. The investigation has failed to show that subject has ever been in Cuba or that he has ever been engaged in activities which could be considered of a subversive nature.

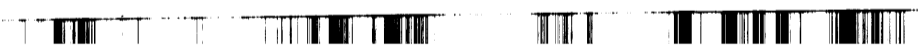

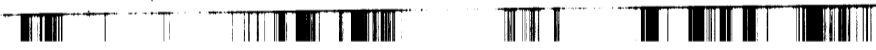

DOMESTIC INTELLIGENCE DIVISION (4/26/66)

A Form FD-305 is prepared by the field to accompany the annual reports prepared in Security Index cases. It is a check-off page which serves to insure that various matters pertaining to investigations of Security Index cases are not overlooked. Item 4 on the form requires the field to state whether or not a photograph of the subject is available and, if so, if it is suitable. There is now no way the Seat of Government Supervisors can check on the suitability of the photographs but there would be an indication as to their suitability if the dates of the photographs were given. It has been observed that in a number of field office inspections the inspectors have ordered the offices to obtain new photographs because the field office files showed from the dates of the photographs that they were too old and therefore unsuitable. It is important to have up-to-date photographs in these cases in view of the purpose of the Security Index.

If the suggestion is approved, it is recommended that the change be made at the next printing of the Form FD-305.

We of the Domestic Intelligence Division Streamlining Committee believe this suggestion has merit and recommend its adoption.

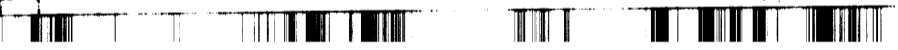

By routing slip dated 4/20/66, New York, suggested that Form FD-122, which is used to recommend that a subject be placed on the Security Index, be revised by lowering the preprinted inscription "Registered Mail" which appears on the lower left side of the form. explained that this would provide more space in which to type copy court and dictator's and typist's initials.

Training Division discussed matter with Domestic Intelligence Division, which advised that additional space would be helpful for the field. Training Division recommends that the idea be adopted with the following modifications: "Registered Mail" cannot be lowered on the form since the space presently provided on the bottom is needed for the printing press to grip, but additional space can be provided by changing the spacing of the other printed items; Form FD-122a, which is used for placement of subjects on the Reserve Index, also presents a similar problem and should be revised as well. Inasmuch as the revision is not of an urgent nature, it is believed it should be made when the forms are next printed and existing supplies are exhausted.

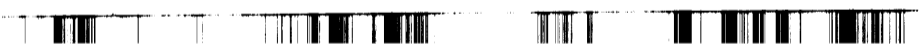

SYNOPSIS:

Each month we follow the field closely on the status of security work by analyzing the backlog of pending active cases and delinquency in espionage, internal security, security matter, foreign intelligence and racial matters cases in classifications 65, 100, 105 and 157. Status of these cases as of April 30, 1966, is set forth below.

In April, 1966, there was an increase in pending active matters in the field in classifications 65, 100 and 105 from 19,242 to 20,455. Delinquent matters increased from 1,353 to 1,367. The percentage of delinquent matters decreased from 7.0 per cent to 6.7 per cent.

During the same month, pending active matters in the 157 classification increased from 4,864 to 5,101 while delinquent matters decreased from 712 to 589. The field-wide delinquency in this classification decreased from 14.6 per cent to 11.5 per cent.

Letters are being sent to the offices indicated by asterisks on pages 4 and 5 herein, commenting on their delinquency and pointing out the necessity for bringing their cases in these classifications to a current status.

ACTION:

The field will continue to be followed closely regarding delinquency in the 65, 100, 105 and 157 classifications and you will be advised of the results of the review of the administrative report for May, 1966.

DETAILS:

The April, 1966, administrative reports for all offices indicate that the total pending active matters in classifications 65, 100 and 105 increased from 19,242 to 20,455. Delinquent items increased from 1,353 to 1,367. The percentage of delinquent items decreased from 7.0 per cent to 6.7 per cent. These same reports disclose that in the 157 classification total pending active matters increased from 4,864 to 5,101; delinquency decreased from 712 to 589; and the percentage of delinquency decreased from 14.6 per cent to 11.5 per cent.

The following statistics show the status of pending active matters and delinquency for all field divisions for the last six-months.

There is a need to reduce the volume of material coming to this office where it can be done without sacrificing essential controls.

There was a very substantial increase in the volume of mail when the Crime Records Division was placed under the over-all supervision of this office. A recent mail count revealed an average of over 360 items daily (incoming and outgoing) crossing my desk.

At the present time all additions to the Security Index are finally approved in this office after having previously been approved by the case supervisor, Unit Supervisor in Charge, Section Chief and Assistant Director in the Domestic Intelligence Division. This system was instituted in the Spring of 1960 by former Assistant to the Director and requires review by me of the recommendations as well as the supporting material. (See copy of memo to 5/20/60, attached.) Prior to that time final approval was rested in appropriate Section Chiefs.

While I am unable to locate in the files the background which prompted to institute this procedure, I recall that there was some concern at that time as to the large number of persons on the Security Index. In this regard, on 5/20/60 there were 12,339 persons on the Security Index as compared with 9,947 as of 5/27/66.

RECOMMENDATION:

It is recommended that authority for final approval of additions to the Security Index be rested in the Assistant Director of the Domestic Intelligence Division.

SECURITY INDEX

My memorandum of December 3, 1958, set forth the mechanics involved in the approval of an individual's name for inclusion in the Security Index (SI). Briefly, the mechanics were: (1) Review of each case by the substantive supervisor; (2) Review by the supervisor in charge of the particular unit; and (3) Final approval on the Section Chief's level except very close cases which were referred to you.

Above practice was continued until the recent past; however, upon instructions from _____ office, in addition to the above steps, all cases are now being referred to you for review and subsequently to _____ office for the final decision with respect to the inclusion of the individual's name in the SI.

The mechanics involved in the deletion of a subject's name from the SI continue to be the same as described in referenced memorandum of December 3, 1958, namely, if deletion is recommended by the field and the substantive supervisor and the supervisor in charge of the unit both concur with the field's recommendation, the deletion is made at that level. In those cases, however, where any appreciable room for doubt exists as to whether a subject's name should be deleted from the SI, the cases are referred to my office, and in some instances to you, for a final determination.

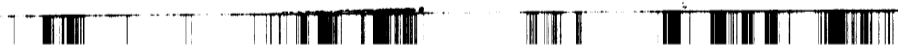

SUBJECT: DELINQUENCY IN SECURITY INVESTIGATIONS

SYNOPSIS:

Each month we follow the field closely on the status of security work by analyzing the backlog of pending active cases and delinquency in espionage, internal security, security matter, foreign intelligence and racial matters cases in classifications 65, 100, 105 and 157. Status of these cases as of May 31, 1966, is set forth below.

In May, 1966, there was an increase in pending active matters in the field in classifications 65, 100 and 105 from 20,455 to 20,536. Delinquent matters increased from 1,367 to 1,573. The percentage of delinquent matters increased from 6.7 per cent to 7.7 per cent.

During the same month, pending active matters in the 157 classification decreased from 5,101 to 4,925 while delinquent matters decreased from 589 to 572. The field-wide delinquency in this classification increased from 11.5 per cent to 11.6 per cent.

Letters are being sent to the offices indicated by asterisks on pages 4 and 5 herein, commenting on their delinquency and pointing out the necessity for bringing their cases in these classifications to a current status.

ACTION:

The field will continue to be followed closely regarding delinquency in the 65, 100, 105 and 157 classifications and you will be advised of the results of the review of the administrative report for June, 1966.

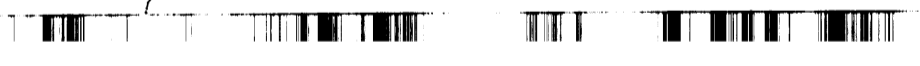

DETAILS:

The May, 1966, administrative reports for all offices indicate that the total pending active matters in classifications 65, 100 and 105 increased from 20,455 to 20,536. Delinquent items increased from 1,367 to 1,573. The percentage of delinquent items increased from 6.7 per cent to 7.7 per cent. These same reports disclose that in the 157 classification total pending active matters decreased from 5,101 to 4,925; delinquency decreased from 589 to 572; and the percentage of delinquency increased from 11.5 per cent to 11.6 per cent.

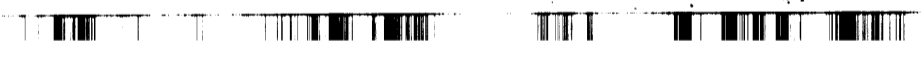

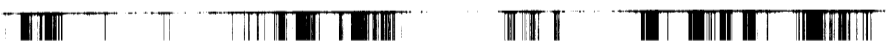

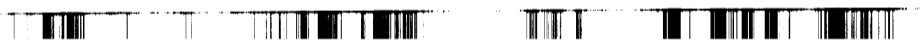

SYNOPSIS:

Each month we follow the field closely on the status of security work by analyzing the backlog of pending active cases and delinquency in espionage, internal security, security matter, foreign intelligence and racial matters cases in classifications 65, 100, 105 and 157. Status of these cases as of June 30, 1966, is set forth below.

In June 30, 1966, there was a decrease in pending active matters in the field in classifications 65, 100 and 105 from 20,536 to 19,950. Delinquent matters decreased from 1,573 to 1,355. The percentage of delinquent matters decreased from 7.7 per cent to 6.8 per cent.

During the same month, pending active matters in the 157 classification decreased from 4,925 to 4,896 while delinquent matters increased from 572 to 583. The field-wide delinquency in this classification increased from 11.6 per cent to 11.9 per cent.

Letters are being sent to the offices indicated by asterisks on pages 4 and 5 herein, commenting on their delinquency and pointing out the necessity for bringing their cases in these classifications to a current status.

Domestic Intelligence Division advised that regardless of disposition made by Secret Service locally of information submitted to it by us, local dissemination should be continued. Dissemination by a field office locally concerns individuals within the area covered by local Secret Service office and they are at least put on notice of the existence of an individual in the particular area who may represent a potential threat to the safety of the President. Discontinuance in certain instances would force our field office to make an evaluation of potential destructiveness of individual concerned which is not our responsibility but the responsibility of Secret Service. There is a time element involved also inasmuch as documents prepared in field for dissemination to Secret Service would be received by local Secret Service office prior to time that similar dissemination could be made at SOG. Finally, dissemination locally and at headquarters level add little burden to our field offices as it entails on the preparation of one additional copy of communication being disseminated. 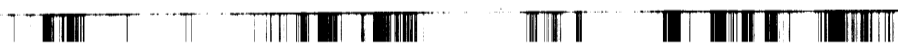

SYNOPSIS:

Each month we follow the field closely on the status of security work by analyzing the backlog of pending active cases and delinquency in espionage, internal security, security matter, foreign intelligence and racial matters cases in classifications 65, 100, 105 and 157. Status of these cases as of August 31, 1966, is set forth below.

In August, 1966, there was an increase in pending active matters in the field in classifications 65, 100, and 105 from 19,505 to 19,649. Delinquent matters decreased from 1,316 to 1,024. The percentage of delinquent matters decreased from 6.7 per cent to 5.2 per cent.

During the same month, pending active matters in the 157 classification increased from 4,762 to 5,115 while delinquent matters decreased from 477 to 353. The field-wide delinquency in this classification decreased from 10.0 per cent to 6.9 per cent.

Letters are being sent to the offices indicated by asterisks on pages 4 and 5 herein, commenting on their delinquency and pointing out the necessity for bringing their cases in these classifications to a current status.

The August, 1966, administrative reports for all offices indicate that the total pending active matters in classification 65, 100, and 105 increased from 19,505 to 19,649. Delinquent items decreased from 6.7 per cent to 5.2 per cent. These same reports disclose that in the 157 classification total pending active matters increased from 4,762 to 5,115; delinquency decreased from 477 to 353; and the percentage of delinquency decreased from 10.0 per cent to 6.9 per cent.

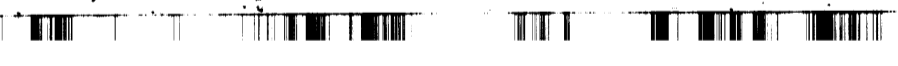

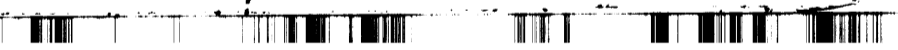

A statement that the names of those so listed have been previously furnished to the Bureau for indexing and a statement concerning the status of their investigations should be made. The same should be done concerning reports on organizations, leadership in which is grounds for inclusion in the Security Index (such as Nation of Islam and DuBois Clubs of America) except that the statement would refer to officers or leaders rather than members. Only the names of those not listed in the Security Index are indexed. When the reports reach the Subversive Control Section, supervisors normally check the indexed names to eliminate those who are informants and to check the others to make certain they are under investigation and to follow the field to insure that the names are recommended for inclusion in the Security Index. Reports concerning communist infiltration of racial movement are the only other reports checked by the Records Section against the Security Index list. All other reports on subversive organizations are completely indexed.

ADVANTAGES:

1) Would eliminate the check of Communist Party and Socialist Workers Party reports against the Security Index list by Records Section employees and would eliminate indexing of the names of members except for the names of those listed on the cover pages as not being included in the Security Index. Would eliminate much indexing of reports on other basic revolutionary organizations such as Progressive Labor. 2) Would eliminate the repeated indexing of informants' names. 3) Would eliminate indexing of the names of officers in the reports on Nation of Islam, DuBois Clubs of America and similar organizations except those listed on the cover pages as not being included in the Security Index. 4) Would make it unnecessary for the Subversive Control Section to check the names of those not marked as Security Index subjects. 5) Would place the responsibility for opening cases on individuals and recommending them for the Security Index squarely on the field, where this responsibility belongs.

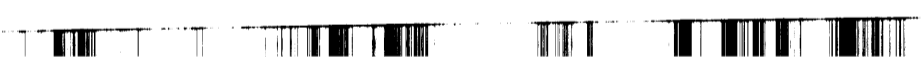

SYNOPSIS:

Each month we follow the field closely on the status of security work by analyzing the backlog of pending active cases and delinquency in espionage, internal security, security matter, foreign intelligence and racial matters cases in classifications 65, 100, 105 and 157. Status of these cases as of September 30, 1966, is set forth below.

In September, 1966, there was a decrease in pending active matters in the field in classifications 65, 100, and 105 from 19,649 to 19,045. Delinquency matters increased from 1,024 to 1,198. The percentage of delinquent matters increased from 5.2 per cent to 6.3 per cent.

During the same month, pending active matters in the 157 classification remained the same at 5,115 while delinquent matters decreased from 353 to 342. The field-wide delinquency in this classification decreased from 6.9 per cent to 6.7 per cent.

Letters are being sent to the offices indicated by asterisks on pages 4 and 5 herein, commenting on their delinquency and pointing out the necessity for bringing their cases in these classifications to a current status.

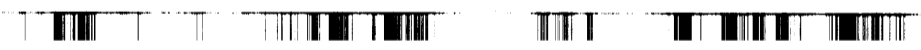

The September, 1966, administrative reports for all offices indicate that the total pending active matters in classification 65, 100, and 105 decreased from 19,649 to 19,045. Delinquent items increased from 5.2 per cent to 6.3 per cent. These same reports disclose that in the 157 classification total pending active matters remained the same at 5,115; delinquency decreased from 353 to 342; and the percentage of delinquency decreased from 6.9 per cent to 6.7 per cent.

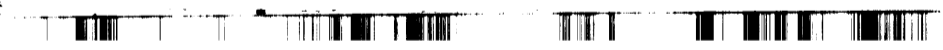
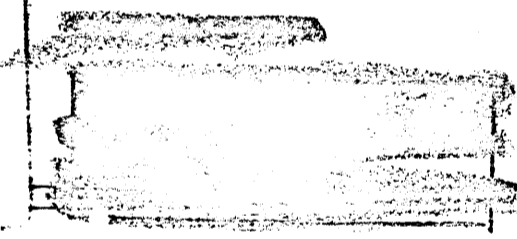

5. Case Load

As of 10/14/66, there were 9,939 SI subjects, each normally requiring at least one report a year.

Some SI cases require more frequent reports; namely, (a) top functionaries, quarterly reports. There are 28 individuals considered as "top functionaries." They represent the highest degree of leadership in subversive organizations and their activities are constantly being followed. (b) Key figures, semiannual reports are required in key figure cases presently numbering 468. These individuals represent leadership in subversive organizations on regional, district and state levels and we follow their activities closely.

6. Magnitude

This is a major program as evidenced by the fact that, with the exceptions noted above, in all SI cases investigations must be brought up to date and reports submitted at specified intervals. This does not include investigations and reports on individuals currently being nominated for the SI.

7. Administrative Controls

Each Supervisor handling security matter cases utilizes a tickler system to insure that reports are submitted when due by the field.

8. Adequacy and Currentness of Instructions

Instructions dealing with this program are found in Section 87D of the Manual of Instructions. This section of the Manual is up to date.

9. Over-all Value

Data dealing with this program is included in the budget material. In addition, this program enables us to thoroughly review the SI status of each individual subject on at least an annual basis. When information is developed clearly indicating that a subject no longer should be scheduled for apprehension, prompt action is taken to remove his name from the SI. Conversely, if the investigation develops evidence indicating that the subject presents a potential threat to the internal security in time of emergency, his name is included in the SI.

Reports in these cases are widely disseminated to various executive departments. Essentially, every security program of other branches of the Government depends to a large extent on information made available to them by us.

Each month we follow the field closely on the status of security work by analyzing the backlog of pending active cases and delinquency in espionage, internal security, security matter, foreign intelligence and racial matters cases in classifications 65, 100, 105 and 157. Status of these cases as of October 31, 1966, is set forth below.

In October, 1966, there was an increase in pending active matters in the field in classifications 65, 100, and 105 from 19,045 to 19,675. Delinquency matters remained the same at 1,198. The percentage of delinquent matters decreased from 6.3 per cent to 6.1 per cent.

During the same month, pending active matters in the 157 classification increased from 5,115 to 5,217 while delinquent matters decreased from 342 to 328. The field-wide delinquency in this classification decreased from 6.7 per cent to 6.3 per cent.

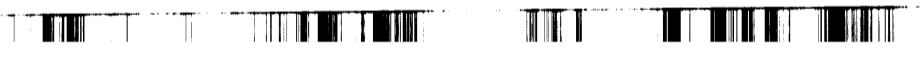

SECURITY INVESTIGATIONS OF INDIVIDUALS - Gen.

SYNOPSIS

Bureau responsibility in this field originated with Presidential Directives, the first one in September, 1939. Purpose is to identify potentially dangerous individuals who are affiliated with subversive movements. This program is field wide and is closely related to the Emergency Detention Program, which involves plans for the apprehension and detention of potentially dangerous individuals in the event of an emergency.

From November, 1965, through October 1966, there was an average of 19,728 pending active cases in classifications 65, 100 and 105. This Section's principal case load falls within the 100 classification and during the same period averaged 8,666 cases per month. Instructions are up to date and administrative controls exercised over the field by tickler system.

Other programs arise from security investigations of individuals and include interviews with subversives. We consider an interview in each case. The Security Index contains 9,936 names as of October 14, 1966. An average of 6 Fraud Against the Government cases per month have been opened since November, 1965. Requests for availability of witnesses from Coast Guard and Defense continue high. The identities of 27 potential witnesses were made available during the period November 1, 1965 through October 31, 1966.

DETAILS

1. Origin

Presidential Directives, the initial one being issued in September, 1939, and since repeated on several occasions. These Directives charge the Bureau with the responsibility for investigation of individuals in the internal security field. It is the collecting agency of the entire executive branch for subversive information and has the responsibility of seeing that such information is distributed to those Government agencies having a legitimate interest therein.

2. Purpose

The identification and investigation of individuals who, because of affiliation with subversive organizations, may present a potential threat to the internal security in the event of an emergency and the development of evidence of violations of Federal statutes on the part of these individuals. If, during the course of a security investigation, it is determined that a subject does pose a potential threat to the internal security, he is scheduled for apprehension under the Emergency Detention Program by the inclusion of his name in the Security Index.

3. Scope

Field wide.

4. Tie in With Other Programs

Closely related is the Emergency Detention Program which deals with plans for the handling of individuals included

in the Security Index in the event of an emergency. Also closely related are the various security programs of other Government agencies, such programs depending to a large extent on information developed by us and disseminated to such agencies.

5. Case Load

Basically, these cases fall in security classifications 65, 100 and 105. During the period November, 1965, through October 1966, the average field case load in these classifications was 19,728 pending active matters.

The Subversive Control Section is primarily responsible for investigations of individuals under the 100 classification although we do have cases on individuals under the 105 classification, such as the affiliates of the Nationalist Party of Puerto Rico. During the 12-month period November, 1965, through October, 1966, there was a monthly average of 8,666 pending active matters in classification 100 throughout the field.

6. Magnitude

This program is major from the standpoint of costs and manpower and, as such, is referred to in the budget material.

7. Past or Present Weaknesses

Close attention is given the entire operations in this field in efforts to insure that we are fully discharging our responsibilities thereunder.

8. Administrative Controls

The field is followed closely on its over-all delinquency in the three security classifications mentioned

previously. This is handled on a monthly basis. In addition, we follow the field by tickler on pending matters in the field of which we have knowledge and we follow the field for submission of periodic reports in Security Index cases to insure that such are submitted when due.

9. Adequacy and Currentness of Instructions

Instructions dealing with security investigations of individuals are contained in Section 87D of the Manual of Instructions and are in a current status.

10. Over-all Value

Determination of identities of individuals who should be apprehended in the event of an emergency in order to minimize possibilities of espionage, sabotage and subversion. Dissemination of information of intelligence value to other Government agencies concerning individuals and matters in which they have a legitimate interest. Budget purposes.

OTHER PROGRAMS ENCOMPASSED IN AND/OR ARISING OUT OF SECURITY INVESTIGATIONS OF INDIVIDUALS

INTERVIEWS

Interview program initiated in 1949 and is continuing. All subjects of security investigations are considered for interview prior to closing. Through these interviews we have developed voluminous intelligence data and is the greatest source for the development of security informants.

SECURITY INDEX

As noted previously herein, one of the purposes of security investigations is to determine the identities

of individuals who, because of affiliation with subversive organizations, may be considered a potential threat to the internal security in the event of an emergency. When such information is developed, the name of the individual concerned is included in the Security Index.

We presently have included in the Security Index names of 9,939 (as of October 14, 1966) individuals. Each Security Index case is thoroughly re-evaluated at least once annually at the Bureau and in the field to insure that the cases are sound in every respect should it be necessary to invoke the Emergency Detention Program. If it is found that the subject's activities no longer justify the retention of his name in the Security Index, immediate steps are taken to insure that his name is removed therefrom.

RESERVE INDEX

In June, 1960, the then Communist Index, maintained only in the field, was renamed the Reserve Index and a program of bringing the cases of individuals whose names were included therein up to date was instituted. We broke the Reserve Index into Section A and Section B. Section A contains a list of individuals who should receive priority consideration from the standpoint of investigation, interrogation or other action following implementation of the Emergency Detention Program. Section A cards are maintained at the Seat of Government and in the field. These cases are reviewed on an annual basis and brought up to date. We presently have included in Section A of the Reserve Index the names of 1,830 individuals. Section B cards are maintained only in the field.

Section B, Reserve Index, cases are completely reviewed in the field on a biannual basis.

DISSEMINATION - INCLUDING CHECKS FOR AVAILABILITY
OF INFORMANTS AND SOURCES

Security reports are disseminated to numerous interested agencies throughout the executive branch of the Government. By far the vast majority of such reports received are disseminated outside the Bureau. The responsibility of such dissemination necessitates careful and thorough evaluation of each report to assure that it is absolutely accurate both in form and content. In April, 1964, we initiated a program of dissemination of letterhead memorandum in all Security Index cases to Secret Service in connection with its responsibilities for Presidential protection. Initial dissemination was accomplished by early June, 1964, and as names of individuals are added to the Security Index appropriate letterhead memoranda are submitted to Secret Service. In addition, we keep Secret Service advised of changes in the status of these individuals on a continuing basis.

We are continuing to receive a heavy volume of requests from various departments of the executive branch of the Government for the availability of witnesses appearing in reports previously disseminated for appearance at hearings being conducted by such agencies as the Department of Defense and United States Coast Guard in efforts to remove subversives from access to classified data and/or restricted areas.

During the period November 1, 1965, through October 31, 1966, the identities of 27 potential witnesses were made available to these agencies for possible utilization at hearings.

FRAUD AGAINST THE GOVERNMENT AND OTHER VIOLATIONS ARISING
OUT OF SECURITY INVESTIGATIONS

One of the principal violations has been violation of the Fraud Against the Government Statute arising primarily from a subject's failure to list membership in a subversive organization when executing such documents as personnel security questionnaires. We have averaged opening 6 cases per month in this category during the past year and these cases are handled on one desk for uniformity. The principal difficulty in connection with these cases has been the developing of witnesses other than current active valuable informants who can testify to a subject's membership in the prescribed organization.
