 DASH R. CHAMBERS PRESENT IN WASHINGTON, D. C. FROM ONE-PM UNTIL SIX  
 THIRTY-PM TODAY AND ASSISTED WFO AGENTS DURING THIS TIME. CHAMBERS  
 MAIDS OF ALGER HISS HAD OPPORTUNITY OF VIEWING CHAMBERS, BUT ONLY ON  
 RECOGNIZED HIM. CLAUDIE CATLETT, MAID FROM APPROXIMATELY NINETEEN  
 THIRTYFIVE UNTIL SOMETIME IN THIRTYEIGHT OR THIRTYNINE, RECOGNIZED H  
 AND ASSOCIATED HIM WITH HISS RESIDENCE AT TWENTYNINE ZERO FIVE P STR  
 NORTHWEST. SHE SAYS THAT SHE MAY HAVE SEEN HIM AT THE OTHER ADDRESS  
 BUT DOES NOT RECALL IT AND WOLXXX WOULD NOT HAVE PAID ANY ATTENTION  
 HIM AFTER SEEING HIM FOR THE FIRST TIME. CHAMBERS DOES NOT RECOGNIZ  
 ANY OF THESE MAIDS. CHAMBERS AND CATLETT SPENT CONSIDERABLE TIME RE  
 CALLING INCDXXX INCIDENTS OF MUTUAL KNOWLEDGE PERTAINING TO THE HISS  
 CATLETT RECALLS RED RUG IN CLOSET OF HISS RESIDENCE ON THIRTIETH STR  
 AND RECALLS THAT MRS. HISS DID NOT USE THE RUG AT THIS ADDRESS, AND  
 HISS STATED THAT IT WAS NOT THEIR RUG. WHEN HISS MOVED TO THE VOLTA  
 PLACE ADDRESS, THIS RUG WAS PLACED IN THE ROOM OF TIMOTHY HOBSON WHI  
 ROOM IS LOCATED IN ATTIC. CHAMBERS BELIEVES THIS RUG IS THE ONE HE  
 PRESENTED TO HISS. CATLETT RECALLS AN INCIDENT WHEREBY AN UNIDENTIF  
 MAN INQUIRED FOR ALGER OR PRISCILLA HISS WHEN THE HISSES RESIDED ON  
 PLACE, NORTHWEST DURING HXXX CHRISTMAS SEASON. CATLETT RECALLS THA  
 HISSES WERE AWAY AND THAT THE MAN CAME THERE TWICE IN THE EVENING IN  
 QUIRING FOR THEM. SHE IS UNABLE TO STATE THAT THIS MAN WAS WHITTAK

WFO CONDUCTING IMMEDIWXXX IMMEDIATE INVESTIGATION TO DEFINITELY ESTABLISH TENURE OF CATLETTS SERVICE AS MAID. ADDITIONAL MAIDS WILL OBSERVE CHAMBERS FEBRUARY TWO. EXHAUSTIVE EFFORTS BEING MADE TO ASCERTAIN IDENTITY OF ANY ADDITIONAL MAIDS EVER EMPLOYED BYHXXX BY HISS IN WASHINGTON, D. C. CHAMBERS ALSO TENTATIVELY IDENTIFIED TWO APARTMENT BUILDINGS IN LINCOLN PARK AREA OF WASHINGTON ONE OF WHICH POSSIBLY USED BY DAVID CARPENTER, WA. ZIMMERMAN. INTENSIVE INVESTIGATION UNDER WAY TO ASCERTAIN OCCUPANTS OF THESE BUILDINGS DURING PERTINENT PERIOD.
