Inquiry was made at New York Public Library to ascertain the exact period Mr. CHAMBERS was listed in mast head of "New Masses" magazine as being a member of the Editorial Board.

Review reflected CHAMBERS for first time on the Editorial Board in May, 1932. Other members of the board included ROBERT EVANS, HUGO GELLERT, MICHAEL GOLD, LOUIS LOZOWICK, MOISSAYE J. OLGIN. CHAMBERS was listed continuously in this capacity to September, 1933. The latter issue listed the additional names to those listed above of WM. GROPPER, JOSHUA KUNITZ and HERMAN MICHAELSON.

It may be noted that during the period CHAMBERS was listed as being on the Editorial Board, no titles were given to note who was editor, managing editor or business manager. The June, 1931 issue listed MICHAEL GOLD, editor, WALT CARMON, managing editor and FRANCES STRAUSS, business manager. In the first issue where CHAMBERS was carried on the Editorial Board, May, 1932, WALT CARMON was listed as managing editor and FRANCES STRAUSS as business manager. This listing was not continued but instead one Editorial Board was set forth.

An anonymous woman recently advised this Office by telephone that approximately a year ago she had met a Colonel BYKOV and that this BYKOV resided with one WINIFRED MURK and posed as her husband and used the name MURY and they resided at 36 East 65th Street, New York City.

The writer ascertained that the real estate agents for 36 East 65th Street were LAYSON McL. KERRILL COMPANY.

Mr. TALBOT of LAYSON McL. KERRILL COMPANY, 1 East 57th Street, New York City, was interviewed on February 2, 1949 and advised that WINIFRED MURY was a subtenant and leased her apartment, 2-F, from one CLAUDE DA COSTA of 1 West 67th Street. He added that he had no contact with Miss MURY and knew nothing about her except that she was a slow payer. He stated that one JOHN HACKETT of 167 East 67th Street, telephone BUTTERFIELD 2-2012, was the part-time janitor of 36 East 65th Street, New York City.

JOHN HACKETT was located in an apartment house at 7016 Madison Avenue where he was employed on February 2, 1949. He advised that WINIFRED MURY and her husband resided in Apartment 2-B and have lived there for at least a year. He stated that he did not believe that the husband worked and that he could usually be found in the apartment. He stated that the MURYS were very nice people. He added that Mrs. MURY was an artist. He described Mr. MURY as follows:

In view of the fact that MURY'S description was so in variance with that of Colonel FORIS LYKOV, with alias Peter the writer proceeded to 36 East 65th Street in order to observe and interview Mr. MURY.

On February 2, 1949 the writer found both ~~WILFRED MURY~~ and the man who stated that his name is ~~CYRIL BAIKOFF~~ in the apartment. He stated that he is Miss MURY'S fiance. He stated that he was born in Bessarabia and had resided in Yugoslavia for many years and had been a citizen of Yugoslavia until TITO came to power at which time he renounced TITO and lost his citizenship and thus became stateless. He stated that he has been in the United States since 1939 and that he has applied for American citizenship and is presently waiting to receive same. He added that he had done work for Colonel ~~NEWMAN~~ and Colonel ~~FRING~~ of G-2.

From observation ~~BAIKOFF~~ appeared to be as follows:

Weight:	180 pounds
Hair:	Black, with a small amount of gray, straight and long.
Eyes:	Brown
Face:	Large and square; wide forehead; regular nose
Complexion:	Medium
Moustache:	No moustache

Languages:	Speaks Russian, French, Yugoslav, and English with a slight accent.
