On the morning of February 9, 1949, I advised Mr. H. B. Fletcher of the Bureau that we are of the definite opinion that Mrs. CHAMBERS should be interviewed at this time for all information in her possession concerning the association between the CHAMBERS family and the HISS family, persons who might be witnesses of this association, the trip of the HISSES and CHAMBERS to New Hampshire and all other phases of their association together, as well as any knowledge Mrs. CHAMBERS might have of the activities of CHAMBERS in the espionage field. Mr. Fletcher was advised that we had been holding off on this interview with Mrs. CHAMBERS because of the possibility that it would antagonize WHITTAKER CHAMBERS. However, CHAMBERS himself has now suggested that the interview be conducted. We desire to send to Baltimore SAs Frank Plant and Tom Spencer who have been interviewing CHAMBERS. We plan to interview Mrs. CHAMBERS tomorrow, Thursday, and possibly Friday and over the weekend, if necessary. It was pointed out to Mr. Fletcher that CHAMBERS is only available to us three days a week now because he has been called down to Baltimore to continue his pre-trial deposition and that quite possibly he will have to be at that hearing Friday, Saturday and Monday.

Mr. Fletcher was also advised that we believe it desirable to interview TIMOTHY HOBSON. There is some indication that HOBSON is on the outs with ALGER HISS and if he will talk, he can, of course, give considerable information of value. We cleared this interview with Mr. Donegan. We want to approach HOBSON directly without notice but if he insists of having an attorney present, we still feel we should interview him.

At 11:00 am on February 9, Mr. Fletcher called back to advise that the Bureau approved these two interviews. He further advised that the deadline for the prosecutive summary report has been moved back to March 7, 1949 inasmuch as the trial has been set back.

I also advised Mr. Fletcher that it would be well for the Bureau to know what goes on at the pre-trial deposition hearing as to our way of thinking, this will simply be a fishing expedition on the part of the defense in the perjury trial. I suggested that the Bureau find out who from the Department of Justice was going to sit in at the hearing and that we arrange to find out what goes on. I advised that furthermore, it might be desirable for the Baltimore office to question CHAMBERS each day to find out whether any additional information was brought out.

From a review of various records available in this Office, it was noted that CHAMBERS was associated with the following individuals while he was employed by the "Daily Worker" from 1925 to 1929:

BENJAMIN MANDELL who is presently connected with the House Committee on Un-American Activities and who furnished a Communist Party membership card to CHAMBERS in 1924.

BERTRAM WOLF was also associated with CHAMBERS but previous contacts with WOLF relative to general Communist matters indicated that he would not furnish any information and he was not considered reliable.

NATHAN HONIG presently residing in California but he will be present in the immediate future in New York City inasmuch as he is to testify at a trial in New York dealing with the prosecution of the eleven Communist officials.

It is further noted that PAUL MICHAEL CROUCH of Miami, Florida, may also be a witness in the above mentioned trial but he has already been interviewed relative to CHAMBERS and this information has been set out in a signed statement.

While ALGER HISS was testifying before the House Committee on Un-American Activities, he made several references to the fact that CHAMBERS had been treated for a mental condition and possibly had been in a mental institution. It was further noted at the pre-trial depositions that Mr. PERJURY, attorney for HISS, had frequently questioned CHAMBERS as to whether he had ever used the name of ROBERT CANTWELL. CHAMBERS denied that he had used the name of ROBERT CANTWELL.

During the recent interview of ~~MAXIM LIEBER~~, information was received that ~~ROBERT CANTWELL~~ who had assisted CHAMBERS in obtaining employment at Time Incorporated, had been treated for a mental condition on numerous occasions and that he had been confined to a mental institution.

It is believed that ALGER HISS made reference to CHAMBERS' mental condition inasmuch as he had confused the name of ROBERT CANTWELL with LLOYD CANTWELL, a name used by CHAMBERS in Baltimore, Maryland.

Consideration should be given to interviewing the above mentioned individuals relative to their knowledge of CHAMBERS, particularly as to his former activities and his credibility.

Consideration should also be given to interviewing some of the individuals mentioned in the insert to the report dictated by Special Agent Lawrence W. Spillane for information as to the character and credibility of CHAMBERS.

It is further noted that CHAMBERS' brother committed suicide in 1925 and that his grandmother was confined to a mental institution in 1929. It is believed that information relative to these incidents should be obtained.

On the afternoon of February 10, 1949, ASAC Lally of Baltimore called and connected me with SA T. G. Spencer, who advised as follows:

1. He requested that this office immediately teletype the Baltimore Office the information contained in recent Little Rock teletypes setting forth interviews with Mrs. BROWN, who stated that there were two GREEN families known to her during the pertinent period.

2. He stated that SPIEGEL testified that he moved to the East Madison Street address in October, 1937. This is not true. SPIEGEL moved there in November of 1936. This information should be furnished to Mr. Donegan immediately.

3. CHAMBERS has made arrangements with Baltimore lawyers and he will not need to testify in the deposition hearing on February 11, 1949. However, he will testify next Thursday and Friday. He is doing this so he can be present during the interviews with his wife by agents. CHAMBERS would ordinarily be under subpoena in New York next Thursday, but Mr. Donegan undoubtedly will have no objection to his not being here in view of the foregoing. Mr. Donegan should be advised of this immediately.

I attempted to contact Mr. Donegan on the afternoon of February 10, 1949, and was advised that he was gone for the day and would be out of town tomorrow.

At 4:20 p.m. on February 1, 1949, Special Agent F. X. Plant called from the Washington Field Office and advised that WHITTAKER CHAMBERS had definitely identified the photo of WILLIAM EDWARD CRANE as the Unknown Subject KEITH in this case. He stated that in connection with the photo of MORRIS ASIMOV, CHAMBERS was unable to identify said photo, stating that he had no definite picture in his mind as to Unsub AZIMOV.

Special Agent Plant advised that upon being shown the pictures of the various tourist homes in Thomaston, Connecticut, which had been furnished by the New Haven Office, CHAMBERS stated that he believed that the tourist home to which he referred was the Rabbit Tourist Home, as it appeared to most closely resemble the one at which he stayed. He said that his second choice would be the Goodall Tourist Home, and he eliminated all the others. Teletypes were sent to the New Haven Office advising them of the terms of identification by CHAMBERS of the tourist homes, and teletypes were sent to the Los Angeles and San Francisco Offices advising them of the results of the exhibition of pictures of CRANE and ASIMOV.

Re my memo in this case dated February 10, concerning the date when ADOLF BERLE turned over information to the Bureau concerning his interview with CHAMBERS.

On February 10, 1949, Mr. H. B. Fletcher of the Bureau called to advise that the Bureau files reflect that BERLE'S notes reflecting his interview with CHAMBERS in September, 1939, were secured by the Liaison Section of the Bureau from BERLE in June, 1943 (exact date not reflected). Mr. Fletcher further advised there is no memorandum in the files to show that Mr. E. A. TAMM ever received any information from BERLE concerning CHAMBERS. Mr. Fletcher advised that Mr. TAMM had recently been asked whether BERLE had furnished information concerning CHAMBERS prior to June, 1943 and Mr. TAMM advised that he could not recall BERLE ever giving him such information. It will be recalled that agents interviewed CHAMBERS on May 13, 1942, at which time CHAMBERS cleared with BERLE telephonically, before he would talk to the agents. Apparently, it was based on this clearance that the Bureau contacted BERLE later as a precautionary measure to secure direct information from him as to what CHAMBERS had told him, although supposedly CHAMBERS would have furnished the same information to the agents who interviewed him in 1942.

Mr. Fletcher advised that we could inform Mr. Donegan of the above information. He further advised we should make sure that ADOLF BERLE does not attempt to claim that he furnished this information to the Bureau earlier. In other words, we should make sure that BERLE does not attempt to explain any delinquency on his part by saying he gave the information to the Bureau prior to June, 1943.

On February 14, 1949, Mr. T. J. Donegan called to inquire whether Bureau agents had ever interviewed ADOLF BERLE concerning the notes that BERLE turned over to the Bureau in June, 1948. A check of our files did not reflect such an interview. Therefore, I called Mr. H. B. Fletcher of the Bureau to request that he check the Bureau files on this as it would appear that we would have interviewed BERLE on a matter of this importance.

At 12:05 pm, Mr. Fletcher called back and advised that the only record that the Bureau has of an interview with BERLE concerning anything along this line is the interview conducted by SAC Carson under special instructions from the Director in New York on September 3, 1948. Mr. Fletcher put Supervisor Jones on the telephone who advised as follows concerning this letter:

Carson interviewed BERLE on September 3, 1948, the purpose of his interview being to clear up certain statements BERLE made during his appearance before the House Committee on Un-American Activities on August 30, 1948. At that time, BERLE said that his memory was a bit indistinct and that undoubtedly the Bureau's records were correct and he was willing to abide by the Bureau's records. Carson told BERLE that the Bureau's records reflect that on February 28, 1941, BERLE requested someone from the Bureau to contact him at the State Department concerning CHAMBERS. In response to the request, Mr. Foxworth talked with him at his office on March 3, 1941 and the conversation was in effect an inquiry from BERLE to Mr. Foxworth as to whether the FBI was investigating CHAMBERS and Mr. Foxworth replied in the negative. BERLE said that he is sure that the above facts are correct and he does not recall, nor does he have any record, of any prior conversation with the FBI concerning this matter. He also agreed that he does not recall having actually furnished to Mr. Foxworth at this time information as to the conversation previously had by BERLE with CHAMBERS. BERLE stated that, as a matter of actual fact, he did not at the time feel free to divulge the content of CHAMBERS' conversation to the FBI inasmuch as CHAMBERS had indicated that he did not so desire and had further indicated that he would not back up the story. BERLE remarked that, from the past conversations with CHAMBERS, he could ascertain that CHAMBERS did not "think very much of the FBI" and did not desire the information furnished to the

FBI, particularly if the source was to be revealed. Then, it was pointed out to BERLE that our files show that the first information we had re CHAMBERS was when he was interviewed by Bureau agents in New York on May 13, 1942 and BERLE agreed that this was probably correct and recalled that CHAMBERS had, in the presence of the FBI agents, called BERLE at BERLE's home in Washington and asked permission to disclose the information previously given to BERLE to the FBI agents.

Mr. Jones advised that he had just looked over BERLE's testimony before the sub-committee of the HCUA and nowhere in the testimony did he mention anything about documents or espionage. BERLE said on one occasion CHAMBERS told him that the Communist Party had been trying to develop a group of sympathizers who might be of some use to them later in the United States Government and then he said this was not, as CHAMBERS put it, any question of espionage. There was no espionage involved in it.

I pointed out to Mr. Jones that actually, there would be no real basis for us to interview BERLE as there was no basis for espionage until CHAMBERS testified before the House Committee and brought up the espionage question. I advised Mr. Jones that, when the question comes up as to why the Bureau did not get into this espionage picture when CHAMBERS was interviewed in May, 1942, and when the Bureau got the notes from BERLE in 1943, the answer is that it was informative information about a group of individuals sympathetic to the Communist cause and there was no indication of actual espionage. Mr. Jones advised that during the two interviews with CHAMBERS in 1942 and 1945, CHAMBERS stated he had no reason to believe he was engaged in espionage. I told Mr. Jones that the whole blame can be laid on CHAMBERS' door for not bringing out the espionage angle. Mr. Jones agreed.

Mr. Jones inquired if we wanted a copy of the above letter and I told him it would be a good idea for us to have it. He stated he would send a copy to us along with a copy of BERLE's testimony before the HCUA.
