On the afternoon of February 21, SA Tom Spender called me from Thomaston, Connecticut. He advised that CHAMBERS had been driven around in an effort to locate the exact spot where he had stayed on his trip, but that CHAMBERS had been unable to locate the exact house, although the area was rather definitely fixed within a few blocks. Agent Spencer advised that an agent of the New Haven office had been with them and that they were going to recommend that agents check all of the houses in the particular area to try to come up with something definite. I advised Agent Spencer that the New Haven agent should discuss this with his office.

Agent Spencer advised they were going on to New Hampshire and requested that we advise the Boston office that they would meet the resident agent at Peterboro, New Hampshire at 9:00 am on February 22 in front of the main post office, and that they would be in a dark blue Buick with New York license tags. Supervisor Tuohy was informed of this and an appropriate teletype is being sent.

On the morning of February 21, 1949, Mr. H. B. Fletcher of the Bureau inquired as to whether Mr. Donegan intends to subpoena JOE SHERMAN before the Grand Jury. He advised that several times in the past the Bureau has attempted to interview SHERMAN and each time he has refused to be interviewed in the absence of a warrant.

I called Mr. Fletcher's attention to a teletype we sent to the Bureau and Los Angeles last week which Los Angeles had forwarded to the San Diego Division. In this teletype we pointed out that, according to CHAMBERS, when SHERMAN returned from Russia about 1937, he had told CHAMBERS that he was through with "those murderers"; that he was going to California to join the open party and at his request, CHAMBERS checked with Colonel BYKOV relative to the \$5,000 SHERMAN had brought back with him; that BYKOV authorized him to keep the \$5,000 and instructed that before he left New York he clear with the local NKVD; that SHERMAN refused to do this and requested CHAMBERS to give him a 48 hour start which CHAMBERS did. In this teletype we had pointed out to the Bureau also that SHERMAN had used a false name in obtaining his passport and that we had suggested that the agents in California utilize this violation of the Passport Law to pick SHERMAN up and interview him vigorously, even though the statute of limitations has passed. I advised Mr. Fletcher we wanted to be sure the Bureau considered this as it appeared to give a possibility of getting SHERMAN to talk.

Relative to the subpoena of SHERMAN before the Grand Jury, I advised Mr. Fletcher that we had spoken to Donegan concerning this and that Donegan's present line of thinking is to have Mr. Whearty or someone from the Department go out to the west coast to bring several persons on the west coast before the Grand Jury, including SHERMAN, FOLKOFF, CRANE and others. We will let the Bureau know of any decision the Department may make on this.

On February 16, 1949 during an interview with CHAMBERS he related that he had spoken to HARRY LAVINE a writer on "Newsweek" magazine, the previous evening and had ascertained from LAVINE that RALPH TOLEDANO at one time had a conversation with EARL BROWDER during which time BROWDER admitted knowing ALGER HISS and WHITTAKER CHAMBERS and further that ALGER HISS was a party member and that BROWDER actually had a couple of conferences with HISS either in the pertinent period of this investigation or at a later time.

LAVINE advised CHAMBERS that TOLEDANO is perfectly willing to tell what he knows to the Federal Bureau of Investigation. It is suggested, therefore, that TOLEDANO be interviewed in connection with the statements made by HARRY LAVINE.

According to CHAMBERS, TOLEDANO was a former member of the Communist Party, but is now definitely anti-Communist.

On February 23, I spoke to Mr. H. B. Fletcher of the Bureau to advise him that Mr. Donegan had indicated that Special Assistant to the AG KELLY, who is now trying the Axis Sally treason case in Washington, may be assigned to handle the HISS perjury trial.

Mr. Fletcher was further advised that, in accordance with Bureau instructions, the information furnished by CHAMBERS concerning his private life, as set forth in detail by our confidential letter of February 16th to the Bureau, had been furnished orally to Mr. Donegan. It was pointed out to Mr. Fletcher that inasmuch as we had given this information confidentially to Mr. Donegan, we could not construe this as having furnished the information to the Department. Therefore, in order that the Bureau would not be embarrassed at some future date and be charged with withholding information from the Department on this case, I suggested that the Bureau might desire to consider how this information could be furnished to the Department in such a manner as to restrict its circulation. Mr. Fletcher advised that the Bureau would consider this further.

Mr. Fletcher advised that the report of SA Zander of Washington Field dated February 4 sets forth a comparison of the 65 documents furnished by CHAMBERS against the sources of the information in these documents from the State Department files. He advised that the items in this report had been gone over and marked as to Q1, Q2, etc., so that they were correlated with the laboratory's report. At my request, he stated that a letter would be sent to this office, setting forth this correlation for our benefit also.
