On the afternoon of May 2, 1949, Mr. H. B. Fletcher of the Bureau referred to our teletype of April 26, 1949, stating that Mr. Donegan had not yet determined when and if HELEN RINGE would be brought before the Grand Jury. Mr. Fletcher advised that it might be well to again speak to Mr. Donegan concerning this inasmuch as HELEN RINGE raised such a fuss on the West Coast when she was contacted by Agents and as she drew in a representative of the American Civil Liberties Union. Mr. Fletcher thought it might be a good idea, for record purposes, to get her before the Grand Jury.

Relative to CHAMBERS' signing the statement he has furnished to the Agents, Mr. Fletcher advised that it was satisfactory to hold off on the signature of the statement by CHAMBERS until such time as the trial is over with the understanding, of course, that he would sign it at that time.

On the afternoon of May 2, 1949, I spoke to Mr. Donegan advising him of our thoughts in the matter of bringing HELEN RINGE before the Grand Jury. He advised that it is his full intention to bring her before the Grand Jury but he wants to do so at such time as he can handle her rather than Mr. Matlack. Because of the scheduled appearance of certain Congressmen before the Grand Jury and the imminent Hiss trial, he is not sure that he can arrange this in the immediate future. However, he will bear it in mind and stated that he definitely will bring her before the Grand Jury.

I mentioned to Mr. Donegan that we were in accord with his desire to hold off on CHAMBERS' signature of his statement until after the trial with the understanding that he would sign it after the trial.

RE: PAUL CROUCH
INFORMATION CONCERNING

The above individual is the subject of considerable publicity at this time as a result of his appearance before the HCUA where allegedly he has furnished information concerning the disappearance of JULIA POYNTZ, the mysterious scientist X who is under investigation by the House Committee and other matters pertaining to Russian espionage.

On the afternoon of May 10, 1949, I spoke to Assistant Director D. M. Ladd to advise him that Mr. T. J. Donegan had received a call from Mr. Campbell of the Department instructing that a subpoena be issued for CROUCH to appear before the Federal Grand Jury hearing espionage matters in New York City. As a result, the Grand Jury considered this matter and the subpoena was issued, instructing that CROUCH appear before the GJ next Tuesday, May 17th. Mr. Donegan subsequently received a call from Mr. Campbell to the effect that the HCUA and the Attorney General and himself had held a conference and that it would not be necessary to subpoena CROUCH. However, Donegan had already issued the subpoena and he told Mr. Campbell that it would be necessary to go through with the subpoena which will be served by the Marshal on CROUCH in Miami.

Mr. Ladd advised that the Department had requested that the Bureau have an agent brief Mr. Donegan on the information the Bureau has concerning CROUCH in order that Donegan will be prepared to handle CROUCH before the GJ.

It is noted that CROUCH has been a confidential informant of the Miami office for some time and has been repeatedly interviewed by that office. He furnished considerable information concerning Communist activities and furnished comments on Communist leaders known to him. In addition, he was interviewed by AUSA Frank Gordon and Larry Bailey on November 30, 1948 in New York City in the presence of SA Chester Reilly for the purpose of considering him as a possible witness at the trial of the Communist Party leaders. The results of this interview were furnished to the Bureau by this office. Subsequently, on April 7, 1949, Mr. McGohey advised that he was not going to use CROUCH as a witness because the information he possessed was too remote as it dealt back in the 1930's. The Bureau was advised of this by teletype.

It was further noted in the JAHAM case that WHITTAKER CHAMBERS mentioned the name of CROUCH and this office requested Miami to interview CROUCH concerning his knowledge of espionage activities.

I spoke to Mr. T. J. Donegan concerning CROUCH and he advised that he was not interested in the Communist information furnished by CROUCH but was interested in any information CROUCH furnished on espionage activities. Mr. Donegan pointed out that the report from Miami reflecting the interview with CROUCH on espionage activities was very short and in fact the interview was practically negative. He pointed out that it might be desirable for the Miami office to again interview CROUCH concerning his knowledge of espionage activities in view of the current publicity. In this respect, it is noted that this office did not receive any information from Miami reflecting that CROUCH had furnished information re JULIA POYNTZ or other espionage activities.

The files of this office should be checked by an agent for all information concerning PAUL CROUCH, with particular reference to any information furnished by CROUCH on espionage activities or any participation by CROUCH in espionage activities. It is suggested that the agent so assigned also discuss this with Section #7 in order that a brief statement can be included concerning the Communist information furnished by CROUCH to the Bureau. A memorandum should be drawn up which can be furnished to Mr. Donegan giving him the above information on CROUCH. In the event it appears that CROUCH has not given full information to the Bureau, the Bureau should be consulted as to the desirability of having CROUCH immediately interviewed by Miami agents to furnish any additional information in his possession.
